RECOMMENDATIONS

- 1. That council assembly reviews proportionality on the council's ordinary committees following recent membership changes on the council.
- 2. That, in light of Councillor Olajumoke Oyewunmi joining the Liberal Democrat group, council assembly adopts the following allocation as the most proportionate:

Option 3 – The total number of seats on ordinary committee remains at 35 seats, with a revised allocation on corporate parenting committee (see paragraph 8 of the report and Appendix)

BACKGROUND INFORMATION

- 3. Since the publication of the report on the main agenda, the monitoring officer has received notification that Councillor Olajumoke Oyewunmi has joined the Liberal Democrat group. As a consequence officers have updated the recommended proportionality on the council's ordinary committees and included a new option 3 in this report.
- 4. From January 19 2010 the overall allocation of seats on the council is:

KEY ISSUES FOR CONSIDERATION

Ordinary Committees

- 5. The ordinary committees on the council are: appointments, planning, audit and governance, disciplinary appeals and corporate parenting committees. The current allocation on ordinary committees is set out in the main report.
- 6. The main agenda item suggested two options for allocating places on the ordinary committees. Option 1 is no longer proportionate. Option 2 which recommended no change is still available, however this would require the unanimous agreement of all councillors present and voting. A new option 3 with the most proportionate allocation on ordinary committees is set out below.

7. The total number of seats on ordinary committees and the allocation of seats to individual committees are agreed by council assembly. This allocation must provide the lowest total discrepancy compared to the ideal proportional allocation.

Option 3

8. The total number of seats on ordinary committee remains at 35 seats (see Appendix 1). Effect: Reduces the Labour allocation on corporate parenting committee by one, and increases the Liberal Democrat allocation on this committee by one giving a revised allocation of:

There are no other changes to other committees. This gives a total discrepancy of 1.04.

Comments:

- Lowest total discrepancy
- Minimal changes to committees

Option 3 is the most proportionate option.

Other committees

9. Proportionality on other committees is unaffected by the recent changes.

Legal implications

10. Section 15 (1) of the Local Government and Housing Act 1989 states that it the "duty of the relevant authority having power from time to time to make appointments to a body to which this section applies to review the representation of different groups" where the members are divided into different political groups.

REASON FOR URGENCY

11. The recent membership change has implications for the options set out in the main report. This report updates councillors on the most proportionate option and should be considered in conjunction with the main report.

REASON FOR LATENESS

12. The monitoring officer received notification that Councillor Olajumoke Oyewunmi had joined the Liberal Democrat group after the publication of the main agenda.
