**AMENDMENT A**

**Moved:** Councillor Linda Manchester

**Seconded:** Councillor Poddy Clark

In recommendation 18 (see pages 18-19 of the main agenda) - Dates of council assembly meetings for 2011/12:

**Delete** bullet point 6 “28 March 2012”

**Add** at end:

“subject to the removal of council assembly on the 28 March 2012 in order to make room in the calendar for additional community council meetings”.

In recommendation 19 (see page 19 of the main agenda) – Council calendar:

**Delete** “noted” and **insert**:

“amended by the removal of council assembly on the 28 March 2012 in order to make room in the calendar for additional community council meetings and then noted”.

**Note:** If this amendment is agreed then it would need to be referred to the cabinet for consideration of the resource implications.

**AMENDMENT B**

**Moved:** Councillor Paul Noblet  
**Seconded:** Councillor Catherine Bowman

**Add** at the end of the recommendation at the start of the report:

“That council assembly additionally adopts the following constitutional changes that have also been considered by the constitutional steering panel and as set out in Appendix 5, pages 3-4 Constitutional changes from political groups.”

In council assembly procedure rule 2.6 (13) on speech on behalf of a deputation:

**Delete** ‘five minutes’ and **insert** ‘eight minutes’.

In council assembly procedure rule 2.6 (14) on questions to the deputation:

**Add** at end “Any underused time from the deputation’s spokesperson’s speech will be added to the time for questions.”

This would give more time for deputations to answer questions from members.

**Add** at the end of the recommendation at the start of the report:

**Amendment C1**

**Delete** all of council assembly procedure rule 2.7 – Themed meetings.

**Amendment C2**

In council assembly procedure rule 4.3(1) (a) – Establishment and selection of councillors on committees and outside bodies

**Add** at end

“However, it shall not change the area of any community council without the consent of every elected member of the relevant community council areas.”

In order to strengthen the role and authority of community councils.

### **Amendment C3**

In community council procedure rule 6 (1) - Powers of the chair - after “monitoring officer” **insert** “all agenda items,”.

### **Amendment C4**

Recommendation 6 – Community council budgets

In Part 3 of the constitution: Who takes decisions - Part 3H – Community councils  
Paragraph 2 of the Roles and Functions:

After “key areas:” **insert** “discretionary services delivered in their area”

After “schools” **delete** “and”

At end **add** “spending within its own administrative budget”

and respectfully requests the leader of the council to issue the relevant delegation notices accordingly.

**Note:** If this amendment is agreed then part C4 would need to be referred to the leader of the council to decide whether to make any executive delegations and to specify the scope of the delegations.

**AMENDMENT D**

**Moved:** Councillor Anood Al-Samerai

**Seconded:** Councillor David Noakes

**Delete** recommendation 2 and **insert:**

“Council assembly adopts the revised member allowances scheme for the forthcoming year with the following alterations:

- 1) In paragraph 16 of the report referring to paragraph 23 in the scheme, **delete** the words “, or, for elected members only, for failure to attend required training.”
- 2) In paragraph 19 of the report referring to paragraph 35 in the scheme, council does not agree to the addition of deputy cabinet members to the list of posts entitled to receive a Band 1a special responsibility allowance of £2,771 and requests the cabinet to redirect any savings made as a result to restore school crossing patrols across the borough.”

**Note:** If this amendment is agreed then the request in part 2) to redirect any savings would need to be referred to the cabinet for consideration.
