RECOMMENDATION

1. That the Dulwich Community Council considers a deputation request from representatives of Melbourne Grove Traffic Action Group.

BACKGROUND INFORMATION

2. A deputation request has been submitted by representatives of Melbourne Grove Traffic Action Group regarding traffic volume and speed in South Melbourne Grove.
3. A deputation can be submitted by a person of any age who lives, works or studies in Southwark. Deputations must relate to matters which the council has powers or duties or which affects Southwark.
4. The deputation states the following:

To ask councillors to support a consultation and our campaign on the idea of a barrier placed across our road between Ashbourne and Tell Groves, and for better signage and double yellow lines.
5. The deputation has agreed to share data which demonstrates the problem of traffic volume and speed in South Melbourne Grove.
6. At the meeting, the spokesperson for the deputation will be invited to speak up to five minutes on the subject matter. The community council will debate the deputation and at the conclusion of the deputation the chair will seek the consent of councillors to debate the subject. Councillors may move motions and amendments without prior notice if the subject does not relate to a report on the agenda. The meeting can decide to note the deputation or provide support if requested to do so. The community council shall not take any formal decision(s) on the subject raised unless a report is on the agenda
7. Any relevant resource or community impact issues will be contained in the comments of the strategic director.

KEY ISSUES FOR CONSIDERATION

8. The deputation shall consist of no more than six persons, including the spokesperson.

9. Only one member of the deputation shall be allowed to address the meeting, her or his speech being limited to five minutes.
10. Councillors may ask questions of the deputation, which shall be answered by their spokesperson or any member of the deputation nominated by her or him for up to five minutes at the conclusion of the spokesperson's address.
11. If more than one deputation is to be heard in respect of one subject there shall be no debate until each deputation has been presented. The monitoring officer shall, in writing, formally communicate the decision of the meeting to the person who submitted the request for the deputation to be received.
