- 3.1 That condition 5 be amended from:

Prior to the commencement of development, details of surface water management measures to detail how runoff rates would not be increased compared to existing rates and how run off to the River Peck would be buffered shall be submitted to and approved in writing by the Local Planning Authority, and the scheme shall thereafter be carried out in accordance with the approved details.

Reason

To prevent the increased risk of flooding, improve water quality and protect biodiversity in accordance with the National Planning Policy Framework 2012, policies 5.12 flood risk management and 7.19 biodiversity and access to nature of the London Plan 2015; Strategic Policy 13 high environmental standards of the Core Strategy 2011 and saved policies 3.1 environmental effects; 3.9 water and 3.28 biodiversity of the Southwark Plan 2007.

To:

Details of the permeable car park surfacing material (2 copies) to be used in the carrying out of this permission and details of how run off into the River Peck would be buffered to protect biodiversity shall be submitted to and approved by the Local

Planning Authority before and details any work in connection with this permission is carried out and the development shall not be carried out otherwise than in accordance with any such approval given.

Reason:

To prevent the increased risk of flooding, improve water quality and protect biodiversity in accordance with the National Planning Policy Framework 2012, policies 5.12 flood risk management and 7.19 biodiversity and access to nature of the London Plan 2015; Strategic Policy 13 high environmental standards of the Core Strategy 2011 and saved policies 3.1 environmental effects; 3.9 water and 3.28 biodiversity of the Southwark Plan 2007.
