#### RECOMMENDATION

1. That the Peckham and Nunhead Community Council considers a deputation request from residents of Highshore Road, Lyndhurst Way, Rye Lane and McDermott Road regarding the Peckham CoDesign.

#### BACKGROUND INFORMATION

- 2. The deputation request was submitted by residents of Lyndhurst Way and Peckham Rye.
- 3. A deputation can be submitted by a person of any age who lives, works or studies in Southwark. Deputations must relate to matters which the council has powers or duties or which affects Southwark.
- 4. The deputation states that:
  - 4.1 "CoDesign is a relatively new policy for Southwark, established for Peckham in 2014; bringing local constituents together with the Council and architects, to work towards a general consensus for agreeable design of the public realm, helping to smooth the path towards planning consent, without affecting rights to full Public Consultation.
  - 4.2 If this is a fair description, we support the aims of CoDesign but there appears to be sparse information/regulation regarding the governance and parameters of its application, which may lead to concern that all projects are treated consistently and equally. We would like to work further with the council and understand there is a learning curve. To help benefit future CoDesign projects Cabinet have already approved our deputation (on 9 February 2016) towards establishing a discussion and review of the process.
  - 4.3 Taking into account previous outcomes, most recently Peckham Rye Station where councillors felt there was a lack of 'co' in CoDesign, we now need to move quickly and would like to bring the first meeting regarding the evaluation forward - taking into account public feedback and constructive criticism from those involved, past and present, towards establishing and publishing guidance. This will help manage expectations for everyone. There is so much fantastic potential."
- 5. At the meeting, the spokesperson for the deputation will be invited to speak up to five minutes on the subject matter. The community council will debate the deputation and at the conclusion of the deputation the chair will seek the

consent of councillors to debate the subject. Councillors may move motions and amendments without prior notice if the subject does not relate to a report on the agenda. The meeting can decide to note the deputation or provide support if requested to do so. The community council shall not take any formal decision(s) on the subject raised unless a report is on the agenda

6. Any relevant resource or community impact issues will be contained in the comments of the strategic director.

#### **KEY ISSUES FOR CONSIDERATION**

- 7. The deputation shall consist of no more than six persons, including the spokesperson.
- 8. Only one member of the deputation shall be allowed to address the meeting, her or his speech being limited to five minutes.
- 9. Councillors may ask questions of the deputation, which shall be answered by their spokesperson or any member of the deputation nominated by her or him for up to five minutes at the conclusion of the spokesperson's address.
- 10. If more than one deputation is to be heard in respect of one subject there shall be no debate until each deputation has been presented. The monitoring officer shall, in writing, formally communicate the decision of the meeting to the person who submitted the request for the deputation to be received.
