PURPOSE

Additional objection from neighbour

- 3.1 The ramp will block access to No. 3 Newhams Row and make it impossible for emergency services to reach the building.

Officer response: The new access route to Newhams Row shows the provision of a series of steps (rather than a ramp). The drawings demonstrate that the steps would not restrict access to the building, since they terminate well short of the building entrance. A detailed design of the route would be secured by the legal agreement.

Comments from the Director of Planning

- 3.2 The additional objection has been noted. The recommendation remains that planning permission be granted with conditions, subject to the completion of a legal agreement.

REASON FOR URGENCY

4. Applications are required by statute to be considered as speedily as possible. The application has been publicised as being on the agenda for consideration at this meeting of the planning committee and applicants and objectors have been invited to attend the meeting to make their views known. Deferral would delay the processing of the applications and would inconvenience all those who attend the meeting.
