## **Executive Summary**

The Building Exploratory has been engaging local stakeholders on behalf of Southwark Council with outline proposals for Peckham Rye Park and Common since January 2014.

This interim report documents the findings from our engagement to date, and lays out some recommendations for moving forward to be discussed with the client team.

The Building Exploratory would like to thank all stakeholders and members of the Peckham Rye Park and Common community for their input thus far.

#### **Headline findings**

We consulted a wide range of park users and stakeholders and found the following headline responses:

- · Peckham Rye Park is generally loved by all, well-maintained, valued for its variety of spaces
- Positive reaction to the relocation and upgrade of changing room facilities
- Friends of adventure playground in opposition to the introduction of the play room to their area
- The rebuilding of the children's playroom is welcome
- The current play area is inadequate and new play equipment is needed
- A number of people came forward with helpful suggestions for improving the park experience

#### **Recommendations & Suggestions**

We have put forward a number of recommendations and suggestions, listed here and at the end of the report. We look forward to discussing these with the client team.

- Rationale The council needs to clearly explain the rationale as to why positioning of new facilities has been proposed in the way that it has
- Loss of green space Is there a calculation as to loss of green space and how much is being provided elsewhere? Can this be shared?
- **Online presence** Could we share the plans online with people? They are keen to hear more. Perhaps the Council website could have a page dedicated to the consultation.
- Meeting key stakeholders A meeting with key stakeholders to dispel myths and bond a little
  more with those feeling threatened by change could be a good move
- **Using feedback** Demonstrate how the consultation is feeding into the design.
- POW hut status Communicate that POW hut is to be demolished

### **Next steps**

The Building Exploratory will agree a set of actions with the client group in order to communicate design changes and new proposals following this initial consultation.

## 1. Consultation to Date

The Building Exploratory has been engaging local stakeholders on behalf of Southwark Council with outline proposals for Peckham Rye Park and Common since January 2014. A series of one to one conversations, public meetings and animated events have taken place with groups and individuals using the children's playroom, adventure playground, football pitches and children's play spaces. This document outlines the activity to date and provides a summary of the responses to the proposals and the issues that have been raised by those we have spoken with (as well as the general park users).

#### **Consultation Focus:**

The engagement programme is seeking to understand how key facilities in the Park and Common are currently used and to document responses to the Council's proposals to relocate and reorganise them. In particular we have been asking about the proposed:

- relocation and rebuilding of the children's playroom
- relocation of the football changing rooms and Caribb headquarters
- relocation of the children's fixed play area





The Adventure Playground is very popular: many respondents hoped it could be open for longer in general

### **Consultation Activity to date:**

These issues were discussed with local people during a series of meetings and events as follows:

- 20 one to one meetings with key internal and external stakeholders
- Six sessions with groups at the children's playroom
- Seven public events: 4 at the adventure playground and 3 in the Park

#### This activity has resulted in:

- 65 questionnaires completed by adults at the children's playroom
- 83 questionnaires completed by adults using the adventure playground
- 46 questionnaires completed by general adult park users
- 140 children have completed nature tiles with the project artist
- We have spoken to more than 320 adults and 200 children

## 2. Key Issues Identified

The following main responses to the proposals have been noted:

- People like the variety of Peckham Rye; enjoying its wilder parts as well as its more formal areas
- The children's playroom is a well used and treasured facility and there is widespread support for the proposed relocation
- The adventure playground is an important and treasured resource for local families. There is
  a notable opposition amongst the staff and friends to any change at all and to the proposed
  relocation of the children's playroom to the adjacent site.
- Users of the football pitches are very positive about the relocation of the changing rooms.
- There is an urgent need for a bigger and better play area in the park

Some overall suggestions and requests were made about the implementation of the proposals:

- Better toilets were requested by all the groups we consulted
- Connections between the adventure playground and the café area could be reinforced with a formal path. There were many requests for a water feature and re-visiting the 'hidden' stream
- Many expressed a desire for sustainable, interesting methods of play (nature based, natural play, tying in with Forest School)
- Strong sense that phasing the building/works processes is important so as not to interrupt activity and keep facilities open throughout
- Desire for more activities for young people and cultural, events and to draw people into the park
- A number of good precedents were introduced e.g. Brockwell Park, Ruskin Park, Burgess Park and so on (a list of these can be found in the appendix).

### 1. Stakeholder Responses

#### One to One Meetings

Prior to the events programme, a series of one to one meetings with key internal and external stakeholders helped to shape the wider public consultation. These included internal stakeholders and the wider client group: children's services, parks department, Ivydale Children's Centre, staff at the playroom, adventure playground and volunteer football club representatives. We also spoke to the Friends of Peckham Rye Park and the chair of the Peckham Society, both of whom were largely in favour of the proposals.

Liz Bough (Chair) and Pru Bland representing the Friends group thought the proposed changes were positive and long overdue commenting that they thought it made sense to bring the children's playroom and adventure playground together and for the changing rooms to move next to the football pitches. They also expressed concern that the adventure playground was underused due to its limited opening hours.


The main area of concern expressed was about the close proximity of the playground to the café, which they felt would make the café very noisy and would deter people without children. They added that they would like to see natural play items, rather than brightly coloured off the shelf climbing frames and suggested some kind of structure for parents to shelter. They argued for a fence around the children's play area – to keep dogs out and children away from bikes.

They also voiced concern about the car park – regarding it as unsightly and in the wrong location. We attended the Friends of Peckham Rye Park AGM (20 members were present) in April at which the wider group raised the need to communicate the news that the prisoner of war hut was to be demolished. They reported that a lot of people assume that the building is listed.

Peter Frost, chair of the Peckham Society, while regretful of the loss of the prisoner of war hut, said that he understood why this was necessary. He reminded us of the need to build in opportunities for the public to access the heritage of the park and common such as the history of the hut and was happy with how this particular case had been handled by Southwark Council with the interpretation board. He liked the idea that the Peck steam might be cleaned up, he thought it was some of the cleanest water in the park.



### (i). The Children's Playroom

At the children's playroom we spoke to users about why they use the facility and what they like about it before asking them for their views on the proposed relocation.

We also sought to inform the brief for the new building, asking them about their priorities for the new facility.

The playroom is currently managed by Ivydale School as part of the Ivydale Children's Centre offer by manager Miles Smith.

It provides three open access sessions for the under fives and their carers and hosts a wide range of other groups for target families and a session for childminders. We participated in four stay and play sessions and attended childminders' and also attended the Muslim women's sessions.

In total, we had conversations with 98 adult users of the playroom, of whom sixty-five completed questionnaires. There were few negative responses to the proposed relocation. Most liked the idea and the opportunity it presented to observe older children in the adventure playground.

We asked respondents about their journey to the playroom and discovered that the overwhelming majority (68%) walk to the facility with their children. Though 16 people (25%) stated that they drove, seven of these came to the Muslim Women's Group and lived further afield in Lewisham, Kennington and Westminster.

# (ii). Stay and Play (Monday PM, Tuesday AM & PM, Thursday PM)

Stay and play sessions are held three times a week and last two and a half hours, attracting families largely from the immediate area. All stay and play sessions are drop in, those in the mornings and towards the beginning of the week are most popular with parents and carers. Sessions provide an opportunity for children and parents to use the play room building and resources, take part in messy play, art activities and use the home corner and baby play areas. They can also use the outside space, which has some fixed play equipment and large wheeled toys such as bikes and the extremely popular cars.

We asked attendees at these sessions how often they visited the playroom, establishing that 88% visit at least once or twice a week, the remainder visiting two to three times a week.

#### Why families come and what they like

The children's playroom is a highly regarded facility providing a unique opportunity for diverse local families to share play experiences with their children and to socialise with each other. It was widely agreed by users that there is nothing else like it in the area and that ideally there would be more open access sessions:

"It's amazing and well thought out ... every week there are creative activities. Southwark is to be commended for providing it. Seven stars out of five."

When asked to explain why they visited the playroom, the key responses, not in order of priority, were:

- It's local to where we live and the setting is lovely
- The staff are inviting and friendly and know us and the children
- The mix of activities inside the play area is widely appreciated
- The outdoor play area is important as are the large outside toys
- The social support and interaction, for parents and children
- The freedom for children to play as they wish
- Option for free flow inside/outside is good and important

Additional reasons stated for attendance included:

- Proximity to the café
- Free of charge and drop in
- For the messy play
- It is enclosed and safe
- It has a good mix of toys

### Priorities for the new building

There was widespread agreement about the range of improvements that needed to be made in the new building. In its current form, the indoor space gets very crowded and the outside space has poor drainage and gets very muddy when it rains. The following thoughts about the new building were communicated to us:

### **Indoor Space:**

- A bigger building to address the over crowding
- Toilets need to be improved and changing area provided
- More and better storage is needed
- Bigger windows more natural light
- Better storage arrangements
- Better heating, kitchen, toilets and baby changing
- Buggy store
- Breast feeding area
- Sandpit
- A sensory space

### Access and security:

- Access to the building and visibility throughout could be improved
- The new building should be an interesting design not just a shed
- Better relationship between the inside and outside spaces

## **Outdoor Space:**

- As much outdoor space as possible
- A better surface in the playground
- A covered outdoor space
- More outdoor benches for carers
- Better outdoor structures/equipment

# (iii) Child minders' Group Wednesday Mornings

The majority of this group come every Wednesday morning. A number work together, for example a mother and daughter and a married couple that run their own child minding businesses from home.

Child minders also come for the social opportunities both for the children and for themselves. They enjoy having contact with other child minders and technical support and advice on child minding issues from Lindsay Barrett the professional who runs the group.

They come because they enjoy the variety of activities: crafts, logic, wet and dry facilities and culturally themed activities, which they have throughout the year.

The sessions are affordable @ £1 per child minder per session which provides fruit for the children. (See comments from Lindsay Barrett, Child minder coordinator)

This group have a high level of understanding about children's developmental, social and educational needs. On the whole their observations and feedback are similar to those raised above with an emphasis on:

- Improving entrance arrangements
- Providing a better buggy shed
- Improving the surface of the play area
- A bigger building to address overcrowding
- Defined spaces for toddlers and babies

# (iv) Muslim Women's Group Thursday Mornings

The Muslim Women's Group is a parent led group that meets every Thursday with children ranging in age from a few months to 12 years old.

In the main they use the playroom because it is local and has a contained outdoor space, most of the families do not have gardens. As with the other groups, most of the women come for support and to socialise with "women and children who share the same values".

The majority of their children are home educated and this is an important opportunity for parents to share ideas and support their learning and for the children to learn with each other.

On the day we attended the parents had organised for the local fire bridgade to visit the children with one of their engines and talk to them about fire prevention.

The group was particularly supportive of the proposed relocation of the playroom next to the adventure playground, due to the age range of the children attending.

They had few particular requirements or interests rather their needs seemed to be largely similar to other families using the space.

There was slightly more interest from the group in the security of the building with a suggestion that the fence could be higher and gates that are clearly visible from the building, but these were not unique to the Muslim Women's Thursday group.

## 2. The Adventure Playground

#### Consultation based at the Adventure Playground

The adventure playground was used as a base on five separate occasions during the initial consultation phase. Sessions were well advertised in advance and open to everyone to come and speak to us about the Revitalise Peckham Rye proposals. Each session attracted a slightly different audience and provided an array of interesting responses. In total we spoke to more that 130 adults and received 80 completed questionnaires. We found that those involved in the friends of the adventure playground group were largely against the proposal to locate the children's playgroup next to the adventure playground, however a wider majority of users either thought it was a positive move to collocate the facilities though careful consideration of the distinct role of each would be required by the designers.

The majority of those who participated in the consultation lived locally and come to the playground regularly, more than once a week in good weather and during school holidays. There were many positive comments about the role of the adventure playground as a safe environment for children within the park and about the commitment of the staff, particularly the lead play worker.

The adventure playground is currently open for children aged five to eighteen during term time on Tuesdays to Fridays after school from 3.30pm to 6.30pm and on Saturdays from 10 to 4pm. During holidays it is open during week days from 11am to 5pm, but closed on Saturdays. On Sundays there is a two-hour session for children with special needs.



#### **Consultation: February and March 2014**

At the pilot session during February half term we took large scale plans showing the proposed areas for change in the park, heritage resources, and an artist to work with the children. A range of families were present and shared their views about the park which were largely spread across the scale from those who were against any type of change to those that were positive.

A month later, as we prepared for sessions on the 28th and 29th March, we were warned by play staff that the friends group were very unhappy with the proposals to move the children's play room to the site adjacent to the adventure playground and to expect protest and antagonism at the events. We also learned that one of the friends had started a petition against the proposal for which he was seeking signatures.

On the Friday we found around 20 children aged eight to thirteen using the playground. There were very few parents present at this session, in total three parents who were extremely antagonistic to the plans dominated.

The following day was the warmest of the year to that date and the playground was packed. We observed children in the ball area for most of the day, children and families all over the play equipment and in the bushy area at the eastern end of the playground. A few families used the grassy area for short periods of time. This was an intense day dominated by the antagonism of the friends group though a wider range of opinions and support for the proposals were recorded. At the remaining sessions on the 5th and 11th of April 2014 we recorded a more balanced range of opinions on these occasions and people engaged with the wider changes being proposed to the play areas and football changing rooms.

### Fear of loss of space among some groups

There is a reasonably widespread fear amongst some parents of losing space in the adventure playground, specifically the grassy picnic area, ball area and the garden. The following statements are representative of the opposition to the proposals coming from the Friends of the Adventure Playground group some of which are shared by the wider user group.

"I don't want any change at all – it works fine and we like it as it is."

"We don't want to loose the picnic area, ball games area or the garden."

"There's not enough space as it is – especially on a hot summers day"

"Changes to the caged surfaced play area not tenable, kids use it all the time to play football."

"An inappropriate mixing of ages is proposed, teenagers and under fives don't mix."

"Consider older kids, we need places for teenagers – there are too few."

"There'll be a lot more parking – needed if the children's room is next door, it will cause congestion on Holmestall Road."

"The current location of the children's room is more convenient for the people that use it."

### Adventure play popular, opening hours could be consistent, new ideas offered

Those who were open to some change at the adventure playground emphasized how popular it is and that the opening hours need to be more consistent and expanded. Many people liked the proposal to locate the children's room next to the adventure play, some emphasized the need to keep access to each facility separate. Some considered that the proposal might provide an opportunity to make improvements to the playground. Ideas for improvements included:

"I like the thought of these facilities being located next to each other as I have children of different ages."

"Please could we modernise the playground?"

"Provide more play equipment for younger children"

"We could do with a café at this end of the park"

"I love the idea of a tree house in the adventure playground"

"More fruit trees please and a bigger garden"

"It would be great to see the play structures updated"

"More table tennis tables"

#### Children's Viewpoint

A number of older children, aged 11 to 13 years, visit the adventure playground alone after school while their parents are still at work, but on the weekends we were present there were children from a few weeks of age to 13 years present.

We asked the children, the median age of those who spoke to us was eight years, about their favourite things and they agreed unanimously that huge rope swings and the areas behind the bushes at the back of the playground were their top places.

Children of the Friends of the Adventure Playground group told us that they did not want any changes, but did not give us reasons for this. The majority engaged with the artist and made their plaster tiles, but not with the idea of change at the playground.

#### **Small Acres School**

Small Acres School is a registered free school renting the adventure playground and building three days a week during school hours. They clearly have a sense of ownership of the place and would like to increase their use of it to five days a week. While not as antagonistic as the Friends of the Adventure Playground to the proposal to locate the children's playroom next door, they were reluctant to see shared access.

They use the space the same time as the playroom and largely have primary aged children - about 10 of them at present, one of whom has been referred by Southwark Council.

### **Analysis of Responses**

In response to the antagonism of the friends group, we looked again at the completed forms and analysed the responses of adults who completed forms to the proposals. In doing so we found that:

- 17 were outright opposed to the proposals at the Adventure Playground
- 27 said they supported change, but that it needed to be qualified to ensure maintenance of service
- **34** were **positive or unconcerned** about the proposed changes, but most of them had specific changes they would like to see happen.

Of the 17 opposed to any change at the Adventure Playground, the majority suggested changes to other locations.

Our observations on the use of the space and reluctance to change indicate that it is already being used by children with a very wide age range. The majority of children using the space at weekends are 11 or under. There is a smattering of older children. The rationale behind some of the objections was unclear and could be addressed by the design (e.g. access, separation, ages not mixing). Those against any change seemed very committed to their positions and were not open to engaging with the potential of collocation of the two facilities or comforted by that fact that they would largely be open at different times.

## 3. Play Area

#### Consultation on the proposed play area

On Saturdays 5th and 19th April 2014 we spent time outside the current play space opposite the football pitches and by the small play space and children's room adjacent to the café in order to gather views about the proposed relocation of the play space and about what local people thought these spaces should provide. There was unanimous agreement that there was a great need for a bigger and better play area at Peckham Rye Common.

#### Thoughts on the current gated play area

The current gated play area was described by some as inadequate, those using it would like to see more swings for small children as there is often a queue for them.

The majority of people liked the proposal for a new larger play area on the site of the current playroom and football changing rooms and were positive about the idea of a play space next to the café. Some however argued that current location suited them better and worried that a play area near to the café would result in children asking for treats, others argued for two play spaces, one in each location.



Many people expressed disappointment with the natural play area next to the playroom completed recently and pleaded that lessons would be learnt from its failures. The water feature was specifically criticised. There were a great many ideas about what a new play area might include:

"It's important to provide a range of equipment for different ages."

"Sensory play and natural play including sound and sand"

"Traditional equipment such as swings and slide and climbing"

"Accessibility - provide equipment that disabled children can use"

"Water features that work"

"A paddling pool"

"Astroturf football pitch"

"A lot more swings"

"Good toilets close by"

Adults requested better access to the stream by the adventure playground and resources that they could use for fitness activities such as:

- Tennis courts
- Access to the games area outside of adventure playground opening



The stream was identified as an opportunity: could it be developed into more of a feature in its own right?

### 4. Football Changing Rooms

#### Positive response to proposals to relocate changing rooms

The proposed relocation of the football changing rooms adjacent to the pitches has been very positively received:

- Footballers and coaches are all very keen to have changing facilities next to the pitches
- The current lack of toilets near the pitches is a huge problem
- Caribb and United All Stars FCs are both positive about the proposal
- The least disruption possible to the running of activities appreciated
- The size of changing rooms is dictated by the Football Association

We met with key stakeholders Carlton Scafe (Southwark Caribb) and Joe Dobson (Peckham All Stars) over the course of the consultation period, to establish their needs and responses to the proposals.

Southwark Caribb and Peckham All Stars (approx 120 members in total) are set to merge at the end of this season and to be renamed Southwark All Stars. Carlton Scafe will step down as manager and take a place on the management board of the new club.



### **Current facilities: Southwark Caribb**

Southwark Caribb currently have a small shipping container on the site next to the adventure playground building which acts as a club headquarters housing an office, small kitchen, office storage and computer equipment. A temporary marquee acts as a changing room for the children attending training sessions on a Saturday morning and matches on Sundays. The latter is inadequate. Ocassionally the club will book the changing rooms by the café, particularly if there are matches on the pitches close by.

Carlton Scafe was supportive of proposals put forward at the two meetings, as long as the club has the resources it has at present. With regard to moving up to the car park temporarily, Carlton was also supportive of this: he did request a letter of comfort with regard to management and use of the facility following completion of the capital project.

Facilities are currently stretched and there is a likelihood that this situation will worsen once the two teams merge. In the meeting, Joe Dobson expressed embarrassment regarding the condition of the current facilities for team visits.

Southwark Council and The Building Exploratory are consulting local park users and visitors to find out what they think about the options to move some of the amenities in Peckham Rye Park and Common and to introduce two new buildings to the area nearby the Adventure Playground.

## Revitalise Peckham Rye Frequently Asked Questions

#### What is the timescale for the project?

We aim to submit a planning application by autumn 2014 and to begin work in early 2015.

#### What is the scope of the planned works?

The project will include a new children's play room within the adventure playground area, new changing rooms opposite the football pitches and a new children's play area adjacent to the café.

#### What will happen to the existing changing room containers?

The existing changing room containers will be removed

#### Will the adventure playground building be altered?

No there will be no changes to the existing adventure playground building. It will remain as it is.

#### Will the adventure playground lose the large games area?

No, the games area may change in size or orientation however, as a minimum it will be large enough to host a five a side football match.

#### Ongoing Consultation – Project Reference Group

We are seeking local people with a committed interest in the project to join a reference group to help see us through the design and construction phases.

#### What is the purpose of the consultation?

The current consultation is seeking to understand how people use the current facilities in Peckham Rye and inviting feedback on of each of the three proposed elements of the project. This will help us to develop briefs for the designers. There will be further opportunities to comment on the design at a later stage.

#### Will the Prisoner of War hut be demolished?

Yes the hut currently housing the children's playroom will be demolished. It has been substantially altered over the years to make it useable and is no longer fit to house community activities. The heritage has been documented and a panel explaining this can be viewed on the site.

#### What will the new Children's Play Area contain?

The new children's play area will contain play equipment logically arranged for children of varying ages. We would like to hear what park users think should be included in the play area.







#### Notes

Anne Barwick presented the scope of "Revitalise Peckham Rye" and explained some of the preferred options for the children's playroom, the changing rooms and possible new play space.

The project was on the whole very well received by Liz and Pru who thought the proposed changes were positive and long overdue.

They thought it made sense to bring the children's playroom and adventure playground together and for the changing rooms to move next to the football pitches.

They said they would like to see natural play items, not brightly coloured off the shelf climbing frames. They don't like water play – it's a mess and doesn't work most of the time. They expressed concern that the adventure playground was underused due to limited opening hours.

The main area of concern expressed was about the close proximity of the playground to the café. As currently proposed they felt that this would make the café very noisy and would deter people who did not have children.

They asked whether the playground had to come right up to the café?

And suggested that the boundary might be set back from the café with a barrier of some sort between the café area and play area.

They also suggested some kind of shelter/ gazebo for parents to shelter under.

Could there be railings? To stop dogs from entering the playground?

They voiced concern about the car park - once the play area is built the car park will become fuller – could there be a screen between the car park and the common so that you don't see the cars when looking across the common?

They would like to have copies of the maps showing the proposals once they were public.

The Friends group has about 120 members.

Their AGM takes place in April and invited us to speak about the project at it.

#### Revitalise Peckham Rye

#### **Notes**

Anne Barwick gave an overview of proposals for the reorganising of play and football changing facilities in the Park using the maps she had prepared.

Carlton said that he thought the plans were excellent, specifically the proposed location of the changing rooms close to the football pitches. He said that as long as the club has the resources it has at present, he supported the plans.

#### Southwark Caribb Football Club

Carlton described the history of the organisation in Peckham Rye and talked through its future plans.

The club has charitable status and is a member of the Football Association.

He said the club started in Burgess Park but moved from to PR years ago. Their first home was in two of the then three prisoner of war huts, subsequently demolished.

Raised £120K for portacabin changing rooms.

Need an office space for admin as well as other activities including IT workshops, knife crime,

teenage pregnancy, bike workshops and gardening acitivites.

The Club draws children from around seven wards including Rotherhithe, Camberwell, Peckham.

It has around 100 members, mainly boys and just a few girls. Activities include:

- Saturdays for training between 12 and 2pm. Aged Under 7 to Under 14 years.
- Matches home & away take place on Sunday's.
- A four-week summer programme for children aged 11 to 14 years focussing on a range of sports.
- Once 14 members can do refereeing and coaching qualifications.

#### Merger

The club is in the process of merging with United All Stars (UAS) run by Joe Dobson (Chairman) who are in the same league (Tandridge League) as Southwark Caribb.

UAS also have 100 boys and currently share the pitch, changing rooms and storage areas.

Southwark All Stars is likely to be the new name and the merger should take place by the end of the season. Carlton will step down as manager and take a place on the management board of the new club. He would also remain as the key point of contact for Revitalise Peckham Rye.

Simon Mars produces a Matrix, which shows the use of the pitches – Carlton to forward.

Quadrant who do the maintenance on the Park, also do the bookings.

#### Income

The Club runs a balanced budget with income deriving from the membership fee of £40 per annum.

+ £3 per member for training

- + £4 per player for matches to cover pitch permits and transport, referee and refreshments.
- + A tuck shop brings in small sums.

Youth Service provided funding post cuts.

Police have funded and run bike workshops.

Football Foundation

FA doesn't provide any funds. They tend to support capital investment such as Dulwich Astroturf.

#### **Changing Rooms**

Changing rooms just about work but the spaces are too small for the bigger boys. The girls, they use the referees' changing rooms.

Anne thought that the changing rooms did not meet the FA's current guidelines, and would look into these.

Carlton thought that new changing room need just to be dry and light. He said that not much use was made of the showers so they didn't need to take up so much space. The spaces are not big enough at present to house a whole team of 15 especially in the older age groups.

Referees changing is too big and the changing for kids too small.

We just need to get the sizes right.

Not much adult football is played in the Park - Loughborough FC and a church team. There is one senior pitch and one changing room for seniors.

#### Storage

The 40 foot storage container houses:

- Football kit for every team (black & red). For training boys get a blue & black kit
- Goals
- Balls, cones...

Other teams using the resources are – Dulwich Commoners (storage)

Galic Football – (have a storage space at the back of the changing room behind the café). They play in the summer so don't coincide with traditional football activity.

#### Office Space

The Current Headquarters in the shipping container is divided into four with a toilet and office storage space at one end, a fitted kitchen (They do not prepare food – the facility is for staff use only) at the other and a large office space in between.

#### Adventure Playground

Carlton reported that the Club has an excellent relationship with the Adventure Playground, often running joint events. They use the building for presentations and club members head to the AP when football is cancelled due to poor weather. Around 20% of the boys go there following training on a Saturday.

#### Other Business

Fiona at the Café should be consulted as she had particular views.

Schools using the pitches include Harris Boys and Girls Secondary Schools, Ivydale School use grounds and are expanding and splitting sites and Breadinghurst School.

NC said that she would keep Carlton informed about the engagement programme and would send through posters which he agreed to display.

### **Peckham Rye Park**

#### **Notes**

AB described the proposals to move Southwark Carrib FC's headquarters to the car park by the café temporarily whilst works were under way.

CS suggested that the Council be careful with how timescales are communicated as the duration of stay at the temporary location is unknown.

CS stated that the move to the car park was sensible (next to the café, changing rooms etc). The club would also need a 10x10 storage unit to be moved to this location. Training would then take place on the Common. All groups would have to be alerted and some advertising might be needed.

CS stated that the use of the changing rooms on a Saturday was essential for his group.

CS wishes to receive a written document from AB and the Southwark team, acting as a Letter of Comfort. This should confirm agreements of use post the capital project.

Football season finishes on 30th April. Pitch usage was explained by CS:

## Revitalise Peckham Rye Public Engagement Event, 7 May 2016

## **Summary**

A public engagement event was held on Saturday 7 May 2016 at the Children's Playroom, Peckham Rye Common, to present concept designs for Southwark Council's Revitalise Peckham Rye initiative. The designs by Turkington Martin and Curl la Tourelle Head provide a new play area, new changing rooms, a new children's playroom and landscaping works. The event ran from 12 noon to 5pm and successfully engaged a diverse range of park users.

Members of the design team, Southwark Council's project manager and staff from the Building Exploratory were present to speak to those attending. In total conversations with 71 people were held and 36 questionnaires were completed on the day. A further three questionnaires were received subsequently and a number of phone conversations have taken place.

Feedback on concept design was largely positive and some useful perspectives of park users were documented as follows:

## Overall proposal

The concept designs for the new facilities were well received overall and commended for their thoughtful approach:

"A sensible reorganisation." "Excellent idea, good low impact please."

"An excellent idea. Very well thought out and welcome development for a much-loved park."

"It seems that every care has been taken to accommodate all needs. I like the concept design a lot."

## Play space

The majority of those with children were excited by the extent of the new play area and thought it long overdue. Some of those without children were concerned about the size of the play area and the interruption of views across the Common towards the new facility.

Parents were unequivocally excited about the new facility identifying the following positive benefits:

- Accommodation of play for all ages
- Proximity to the cafe and the provision of seating for parents
- Variety of types of play being offered.
- Design is respectful of its setting on the edge of the common.

"Great idea! Good play space for all ages at Peckham Rye is needed." "It's great to see a proposal offering play for all age groups"

"Seems good, well considered and respectful of sightlines and trees and users."

"Superb. Long overdue. Great that it's close to the café."

The key elements people would like to see developed in the next design build upon this positive feedback:

"Overall good, essential that older kids play is also considered."

"I really like the concept design. Ensure that any water play feature is constructed fit for purpose."

"Differentiate play provision across the park, and consider the relationship with the adventure playground"

Older park users and those without children were in the minority on the day, however a number of those present expressed concerns about the size of the playground and the view of it across the Common from the north west. There was also a request for people without children to be considered.

"It should just occupy the car park area and not extend into the common. It must be screened/designed so that it does not visually intrude on the view across the common."

"It's too large. It should stay within the footprint of the existing car park and not build onto green site. It should be screened – the existing boundary hedge is a good start – it should also be locked at night."

"We are already loosing part of the common to the new car park and the old car park site is huge. Please do not extend the site unnecessarily."

"It seems more inclusive and less isolated from the café. Please ensure that non-family users of the area are considered, especially around the café.

## **Changing rooms**

The changing room evoked very little controversy. Most people agreed that it was an essential provision, urgently needed, and that the proposed location with its proximity to the football pitches was perfect.

"I think it's a great idea as most people playing sport seem to change by their cars."

"Much, much more sensible location. Make sure there are bins by the

changing rooms. Make sure the whole project has a holistic approach. I will absolutely use the facilities once built."

A few raised issues about the view across the park and the loss of space in the adventure playground:

"Much needed, but make sure they are big enough, but well designed and not large in bulk. They should be integrated into landscape and not dominate the area."

"Please consider views from the park, which currently doesn't have buildings overlooking it."

"Don't loose any high usage area i.e. adventure play area."

One park user urged the team to consider the existing café building when developing the design for the new changing rooms and children's playroom.

"It would be great if the building shared the qualities of the park café – creating a family of buildings within the park."

## **Playroom**

In the main respondents considered the proposed location of the playroom to be good and most appreciated the proximity to the adventure playground. As with the changing rooms, concern was expressed about how much of the adventure playground space would be needed for the playroom and its outside play area. People were genuinely pleased to learn that the existing small play area between the lake and the adventure playground would remain.

Of the proposed location, people commented:

"It makes good sense. I use it daily."

"Fine location. Please less Tarmac for outside play."

"Great, we'll use it when our kids are older."

"Please retain the existing playground by the pond. It's really well used and has good balance of sun and shade."

The loss of space from the adventure playground was the main concern expressed by respondents who urged the design team to minimise the space taken for the new buildings. One suggested switching the two proposed facilities around in order to maximise views of the park:

"The design should not take up too much space from the adventure playground. There should be no overall loss of public open space."

"Should make use of existing views over the park and allow lots of light into the building. Could the playroom/changing room positions be swapped to allow more light into playroom and views across the park? Low level windows, fun design features."

One person expressed disappointment at hearing that the existing children's playroom would be demolished: "Please retain the old POW building." a significant feature of the history of the park and should, in my view be retained."

## **Adventure Playground**

Many respondents expressed concern about the future of the adventure playground and repeated rumours they had heard about its closure. There was a frequently expressed request to consider the role of the adventure playground both with respect to the use of its open space and its role in the Revitalise Peckham Rye initiative.

"I've heard rumours that the adventure playground it's shutting. I really hope that's not going to happen. It's such a great resource."

"Just don't loose the adventure or Terry! I am very relieved as there have been many rumours about losing large parts of the adventure and that doesn't seem to be the case!"

"It seems that every effort will be made to keep as much of the adventure playground as possible and definitely the sports cage, which is <u>very</u> important to me."

A more active consideration of the adventure playground in the initiative was suggested by several respondents who suggested clarifying the types of play offered at Peckham Rye in order to create a positive relationship between the new play area and the adventure playground and ensure that the latter is not undermined:

"I would like to see the adventure playground viewed as a positive."

"We use the adventure playground a lot. Please ensure that it stays and is consulted/supported in all decisions."

### Other

A number of general issues were raised by individuals including:

- Poor toilet provision near the new play area
- Need to consider vehicle access near the play area
- Disability access across the inititative

## **Summary of key points**

The following key points emerged during the public engagement event on 7 May 2016 and should be taken into consideration during next stage of design:

- Variety of play and facilities for all ages
- Size of play area and views to it across the common
- Presentation of play opportunities across the park
- Changing and playroom design to enhance location
- Extent of adventure play ground site used

## **Revitalise Peckham Rye**

Report on Public Consultation and Engagement Event Saturday 9 July 2016





## **Summary**

A public engagement event was held on Saturday 9 July 2016 at the Peckham Rye Adventure Centre, Peckham Rye Park, to present Stage 3 designs for Southwark Council's Revitalise Peckham Rye initiative. The designs by Turkington Martin and Curl la Tourelle Head provide for a new play area, new changing rooms, a new children's playroom and landscaping works. The event ran from 12 noon to 5pm and successfully engaged a diverse range of park users.

Members of the design team and staff from the Building Exploratory were present to speak to those attending. In total conversations with 75 adults were held and 35 questionnaires were completed on the day. A further two questionnaires were received subsequently along and a number of phone conversations and email exchanges have taken place.

A wide range of families with children of different ages participated in the consultation and people without children came specifically to view the more developed designs for the new leisure facilities.

Feedback on the design was positive and a range of perspectives of park users were documented. There were requests for greater clarification of intention in some areas and suggestions for additions or changes in others. The response received is outlined in detail below.

## **Proposed Play Area**

The designs for the new facilities were generally well received and widely commended for their thoughtful and inclusive approach.

"I like the use of such a good location for playground - replacing the car park."

"Looks amazing – a great development for the park"

"Love it, great new space for children without retracting from the Rye, good use of space and catering to the huge young population."

"Looks exciting! Children need these spaces."

The proposed play area was considered by most to be varied and well thought out. Those responding particularly liked:

- The three zone approach, with its combination of different areas.
- That varying needs appeared to have been thoughtfully accounted for, with activities for all ages
- The natural look of the overall design and the play equipment.

People responded well to the types of equipment and play opportunities being put forward by the design team and referred specifically to the inclusion of sand and water play:

"Water play is crucial."

"Excellent! Especially the sand and water area. My son loves it!"

Some felt that the images of the play area on display were a little sparse in terms of equipment and could do with a little more to meet the potential demand:

"The play area needs more climbing equipment for younger children, bars, things to climb on. Diggers are fun but they break easily."

The main queries were around execution of the works and the speed of delivery. Questions about the programme and quality of the work were asked along with requests that lessons learnt from the small play area on the common were remembered. The following statements sum up the feedback in this area:

- Great in principle so long as there are no compromises in quality.
- Build seems very slow, can it go faster than 2018? I hope the project does not take long to build and is done by the right time of the year.
- Avoid the issues of the "play area" by one o'clock club "it is not a success. Make sure the water feature is designed correctly as the existing one does not work."

A few additional comments and concerns about issues such as maintenance of the play area once complete and requests for the inclusion of specific features and facilities in the play area were received.

- A significant number of people expressed a "need for more toilets/changing facilities by the new play area", citing the small number available in the café and the poor standard of those by the park office.
- What effect will wet weather have on the sandy play area, how it will work in winter?
- "What are the maintenance requirements of the sand and water play areas? Won't it be expensive to run them?"
- Please ensure that the boundaries of the play area are dog proof.

## **Proposed Changing Rooms**

Those present at the event agreed that the changing rooms were in a sensible location and "much needed" by the local community. There were comments on access and the use of the new facilities, specifically that they were affordable and available to everyone. There were a some specific responses to the design of the accommodation being provided.

"It helps benefit those in sport and helps accommodate them in the park, which is important for young people."

There was an enthusiasm to see the new changing rooms well used and to make sure that they were easy to book and affordable to all community sports groups in the area:

"Include all sports teams – don't put any of the off!"

- "It's not apparent that any user groups, other than footballers have been considered."
- Permanent storage space for other users of Peckham Rye Park such as the weekly Parkrun group was suggested: "Parkrun – they have around 200 runners each week."

There were a few questions about the extent of facilities being provided, which were largely concerned with the space available and washing areas:

- Make sure teams have enough room and good access
- "Four showers doesn't seem enough if 44+ people have been playing football."
- Make sure that there are designated toilets next to it.

A number of respondents addressed the design of the proposed changing rooms and had requests and suggestions about how they looked:

"Great! It will look far better than the existing pre-fabs!"

- I like the shape of the building, but think it could be more colourful.
- Could children take part in the designs and add their own personal stamp on it? For example murals, landscaping?
- "Not too many big buildings please, keep it green."

Very few people we spoke to raised concerns about the impact of the changing rooms on the adventure playground, despite the fact that it is part of the bigger scheme which includes the proposed children's playroom.

"Good to have more facilities to cater for more people as long as it doesn't take over too much from the adventure playground."

### **Proposed Children's Playroom**

Only a few respondents commented on the design of the children's playroom, beyond a general acknowledgement that it was a positive improvement to the facilities currently provided. There were concerns expressed about the impact on the adventure playground, however these were largely to do with a wider concern about the future of the service and not the principle of co-location, though. There were also comments on the loss of sightlines to the "MUGA" from the adventure playground building.

"It will be lovely to have something purpose built"

"Good use of space"

"In theory excellent, great as something for under 5's"

General feedback on the playroom design was as follows:

- "I like the openness."
- Good to get indoor space
- The outside space in the existing play area is well used is there enough in the new plan?
- "It looks great, keep up the communication."

A number of those responding reflected on the proximity of the children's playroom and the adventure playground:

"You shouldn't put under 5s next to a park where older kids swear and skate park as the older boys in the skate park smoke."

"Make sure the pre-school area is closed or kept separate from adventure. Perhaps some play equipment for young children on the garden area of the new playroom, so little ones are kept separate?"

"To have a under 5's building on the same premises as an over 8's adventure playground (8-15) does not seem practical."

One comment post the event suggested that a stay and play in the proposed location would not attract the current stay and play audience, however this is at odds with previous consultation with users of the current playroom. If there are concerns about the location, further consultation with this group could be undertaken.

## Impact on the Adventure Playground



The people we spoke to during the consultation event clearly adored the adventure playground and were concerned about its future as a service. With respect to co-location with the children's playroom the main concern was to ensure that the adventure playground was not over run by younger children, and that older children still feel it was their space. Many of those we spoke to considered there to be few public facilities in the area for older children.

"The adventure playground is an important part of the community."

"I am very pleased that we can keep the existing adventure playground."

On the day of the public event, the weather was good and the adventure playground was packed for the duration. Notably it seemed to be occupied by families with children of all ages, including many under fives and their siblings. There were few teenagers or unaccompanied children over eight, though they may come more often during the week after school. People commented on the irony of holding an event discussing new facilities at a time when the future of a treasured facility and its staff team was uncertain. Though this included a number of parents who were concerned at what they had "heard" or were under the impression was going to happen. The majority of these respondents were relieved that the adventure playground was not currently under threat of closure.

There were some concerns expressed about the proximity of the playroom and the adventure play centre and the mix of younger and older children that

implied. However there was much less concern about the loss of space from the adventure playground than was anticipated or encountered during previous consultation events.

"My main concern is what will happen to the existing adventure playground. When will we be told? What about provision for older children who are under served even with the adventure playground and who will be even more so if it closes."

"Please protect the adventure playground. My entire family use it regularly, it's a great place to come, and I trust the staff to look out for my children."

"I really think it's all a bad idea as I think the old kids should have a good place like the adventure and shouldn't have to worry about other baby's screaming. I live so far away but I come down here every week just so my older boys have somewhere safe/fun."

#### Views to the MUGA

Being able to observe the football pitch from the adventure playground was raised as being of importance by a number of those we talked with. The position of the new children's playroom results in the loss of sightlines of the MUGA from the adventure playground building.

"The location of the proposed building will block the view of the MUGA from the adventure playground building meaning staff will not be able to monitor behaviour/safety issues. In my view this is a serious health & safety concern."

"I'm glad the adventure playground, and the log and ditch are staying. My kids are older now, but I always thought the existing toddler playground (swings) could use with an upgrade too."



#### Other

A number of general issues were raised by individuals about the impact of the Revitalise Peckham Rye project and the opportunities it presented to the local area. There was a lack of engagement with the design team's suggestion that the River Peck might become a focus for community engagement at previous consultation events, but this came up as an area of interest for some:

"It would be amazing to use the River Peck and turn that into a water play area – it's a natural resource so use it!"

The loss of the prisoner of war hut which houses the currently children's playroom was also raised by a few.

"The POW hut may not be fit for it's current use, but it is a historic building and shouldn't be simply demolished without due consideration."

"What is going to be put on the POW cabin site as a reminder of what was there?"

Finally there were pleas about the Rye's existing play areas, some arguning for their retention:

"I don't understand why the climbing frame and bars by the 1 o'clock club are going. It cost a lot of money to put in, why spend more money ripping this out?"

## **Summary of key points**

The following key points emerged during the public engagement event on 9th July 2016 and should be taken into consideration during next stage of design:

- Design is thoughtful and inclusive
- There is a good variety of play and facilities for all ages
- The changing rooms are much needed, and not controversial
- Sightlines from adventure play building to the MUGA need to be considered
- Consider the mix of older and younger children
- There are concerns about the adequate provision of toilets and baby changing facilities

## **Revitalise Peckham Rye**

Report on Community Engagement and Consultation
On proposals for the creation of a new play area and relocation of car park

The Building Exploratory September 2015

### **Summary**

The Building Exploratory carried out a period of public consultation from July to September 2015 on Southwark Council's proposals to move the car park on Peckham Rye to "the mound" area and to create a new super play area on the site of the existing car park.

Those we engaged with were broadly supportive of the proposal with the majority approving of the plan to move the car park from the common to the more discrete location proposed. Plans for the new play area enjoyed the most support from children and parents, who greeted them with great excitement. There were qualifications from some residents, but on the whole, these focused on detail rather than the plan in its entirety.

We also spoke to residents about their use of recycling facilities in the car park a third of whom reported using the facility on an irregular basis.

A small number of emails and phone calls were received from local residents have been received by the Building Exploratory from residents unable to attend the public event. In addition 15 people completed a questionnaire published on Southwark Council's website. Some of these presented more negative responses to the proposals and some offered suggestions for the wider Revitalise Peckham Rye project.

## **Approach**

The Building Exploratory was appointed by Southwark Council in June 2015 to engage and consult key stakeholders and local residents on the revised Revitalise Peckham Rye proposal.

Building upon the consultation undertaken during 2014, the Council had in the intervening period reviewed plans for improving play and sports facilities in the park to provide a new children's playroom, football changing rooms, a new play area and to move the car park off the common to a more discrete location.

The consultation, carried out during the three months from July to September 2015, focused primarily on the proposal to create a new state of the art play area on the current site of the car park and to relocate the car park to the area known as the "Mound".

The consultation consisted of the following:

- One to one conversations with key stakeholders; representatives of service providers and user groups including: the children's playroom manager, Southwark Allstars Football Club, the adventure playground manager, the park and café managers and the Friends of Peckham Rye Park.
- A half day event held at the children's play room on 25 July 2015
- A day long event at the Friend of Peckham Rye Park summer fete on 5 September 2015

An online questionnaire published on Southwark Council's website

#### **Consultation Material**

Four A0 graphic boards presenting the Council's proposals were prepared for the public event. Turkington Martin Landscape Architects created visual diagrams and layouts to enhance these. The boards consisted of:

- Plans showing the original proposal alongside the new proposal
- Text outlining the Council's response to the previous consultation
- Diagrams indicating the proposed locations of the car park and play area and outlining a possible layout for the car park
- A mood board of children using play areas and equipment

A questionnaire was designed to document responses at the public event. It invited feedback on the proposals with questions focused on the play area, car park and recycling facilities. The graphic material and the questionnaire can be viewed in Appendix 1 and Appendix 2 at the end of this report.

#### Online

Following the consultation events in July and September, consultation material was made available on line by Southwark Council's regeneration team.

A deadline of 22 September was set for responses. The responses received, twenty in total, are incorporated into this report.

#### **Public Events**

A public information and consultation event was held at the Children's Playroom on Saturday 25<sup>th</sup> July 2015 from 2-5pm.

The event was supported by Ivydale Children's Centre, who provided use of the Peckham Rye Children's Playroom and by Southwark Play who provided a bouncy castle, which attracted a great many families to the event.

The event was hosted by representatives of the project team who worked together to engage attendees, including:

- Two members of the Building Exploratory team, plus one volunteer
- Southwark Council's regeneration project lead
- Turkington Martin, landscape architects
- Faithful & Gould, project managers

In addition two play workers oversaw the use of the bouncy castle.

In advance of the event, 60 promotional posters were distributed across the park and nearby shops and cafés and emails were sent to a 130 strong

mailing list of those who have requested to be kept informed of progress with the Revitalise Peckham Rye programme.

On Saturday 5<sup>th</sup> September 2015, the Building Exploratory took a stall at the Friends of Peckham Rye Park annual Summer Fete (11 to 5pm). The event was well attended despite the poor weather and we were able to speak to a large number of people who live locally and who use the park and common on a regular basis. Once again we received a largely positive response to the new proposals being put forward by Southwark Council.

In total we spoke in depth to 121 people and received 51 completed questionnaires. Respondents were more diverse than those spoken to on 25<sup>th</sup> July event and included a larger number of people without children.

#### **Consultation Outcomes**

Attendees at the public events included those who had received email invitations and individuals and families using the park on the day or attending the summer fete. Over the course of the two events, we spoke to 172 people and received 86 completed questionnaires.

The majority of those who completed questionnaires considered the locations proposed for the car park and play area positively. No one made a case for retaining the car park in its current location, or thought that placing children's play area on the current car park site was a bad idea. Though a small number of people questioned the need for any change.

#### 1. Play Area Proposal

The play area proposal met with great excitement from most people we met. Many were parents with children (75%), so this is not surprising. However those responding without children also recognised the need for better opportunities for physical play at Peckham Rye.

In total 88% of those completing questionnaires supported the proposal, while the remaining 12% did not answer the question, but were either in support or did not commit. No one we spoke to at the event expressed any opposition to the new play area.

"The location is really good – close to the café and nice open spaces."

"Accessible to a wide age group. Love the fact that the existing play area/playroom will be re-landscaped."

We asked people about the age of children the play area should be aimed at, what type of play equipment it should contain, how it should look and feel and for examples of existing playgrounds elsewhere that the design team could refer to. The following responses were obtained in each case:

### Age groups

Respondents felt that the play area should cater for children aged zero to 12 years of age, and that there should be some delineation of areas for each age group, specifically those for the under fours.

0-4 years, 74% 5-9 years, 78% 10-12 years, 52%

The majority of those responding thought play equipment should be aimed primarily at the five to nine year old age group. On the whole people thought that the 10 to 12 year olds were well catered for at the adventure playground.

## Play equipment

Families told us that they would like to see a mix of traditional and new styles of play equipment that challenged children physically and encouraged controlled risk taking. Many also requested tactile play opportunities, specifically sand and water. Ideas put forward were:

- Traditional equipment including: swings, slides, climbing frames, roundabouts, see saws and balancing equipment
- New play features such as water and sand play
- · Please provide drinking water
- Please provide seats for adults

#### Look and feel

We asked people to comment on how they would like the play area to look and feel. We received a clear message that they would like the design to make the most of the existing environment of the park and common, which is held in high regard. Comments received included the following:

"We love the whole park. It should enhance what is already there."

"Green, integral, making the most of naturally occurring resources Mix of traditional and landscaping, wood and metal."

"Exciting, but sympathetic to the look and feel of the park. Natural, lots of wood and use of natural elements."

"Welcoming, multi-cultural, more shade."

"Exciting, colourful, but blend in – wood."

"Natual, wood, willow."

"Screen the playground from the common."

"Desserts and forests."

"It should make you feel happy and comfortable, safe. Lots of grass and soft floors."

### **Exemplary play areas**

The following is a list of the play areas that respondents have visited and considered to be exemplary. Goose Green was that most frequently mentioned by those we spoke to.

Brockwell Park, for sand and water play Myatt's Fields Burgess Park Diana Memorial Park Ruskin Park and playground Dulwich Park Archbishop Park, Lambeth

### 2. Cark Park Proposal

#### **Use and Location**

Everyone we spoke was in favour of moving the car park from its current prominent location on the common to the more discrete area, which the Council proposes. We asked people about how often they use the car park and whether they had any safety concerns that should be taken into account by the designers.

With regards to use, findings around travel and the use of car park facilities corresponded to those of the previous consultation exercise undertaken in 2014 with those using the children's playroom and adventure playground.

- More than three quarters, (78%) of those we spoke to had walked to the park and said that this was their most usual method of travel.
- One third (37%) reported to sometimes use their cars to travel to the park and used the car park when doing so, though many told us that they also parked in Strakers Road.
- No one we spoke to reported any problems in finding a parking space

#### Safety Concerns: café, playground, car park

We were surprised by how few people raised concerns about safety in relation to the car park on the edge of the park. Those that did told us the following:

### Cars

"I don't like having to walk through between the park office and the café with my toddler"

"Car park too near café at present. Not great for small kids."

### **Dogs**

"Currently I don't like the dog access to the playground near café."

"A lot of dogs are off their leads."

### Lighting

"Would need to have decent lighting."

### 3. Recycling Facilities

Though not initially part of this phase of consultation, early conversations with the project team raised questions about the presence of recycling bins in the car park and we added an assessment of the use and the value that local residents place on the facility to the questionnaire.

Exactly one third 33% of respondents at the public event told us that they used the recycling bins, but only half of them on a regular basis, i.e. more than twice a year.

Respondents who use the recycling facility find it useful for recycling items that cannot recycled through their door step service, such as clothes, shoes and electrical goods and on those occasions where their home recycling overflows. Christmas was the key time of use for additional mixed recycling and disposal of Christmas trees.

Many of the key stakeholders we spoke to, who are based at Peckham Rye including: children's playroom staff, park warden, café staff and park staff were particularly concerned that the recycling was being used for fly-tipping:

"The recycling area is regularly used by people to dump rubbish. I believe this is because it is in a secluded location. If there is still to be a recycling area in the park, it should be overseen or supervised to prevent fly- tipping."

#### Some other voices

At the time of writing, we had received five emails from local residents who were unable to attend the public events, but who wished to comment on the proposal. They had received an email informing them of the consultation, but had not seen the revised proposals. They have subsequently been sent the link to the material on the Council's website and been invited to comment on the proposals as presented. We received a phone call from a further resident who did not think there was a need for any change to be made to the park and common and that they should remain as they are.

One recurring comment was about the WW2 prisoner of war hut, stressing its historic importance and questioning whether it had to be knocked down.

Chair of the Friends of Peckham Rye Park has recently sent us the following list of issues that they would like to raise:

Is the relocated car park big enough? (We have been re-assured that there are only three spaces less than the existing car park.)

There must be some landscaping at the end of the playground to screen it from the open common.

The play equipment must be sympathetic to the MOL on which it is situated.

The playground should be fenced and locked at night.

The re-cycling 'depot' should be removed. There is an ongoing problem with fly-tipping and the entrance to a tier one park is not a suitable location.

A child-free area adjoined to the cafe?

#### **Conclusions and Recommendations**

The responses received from key stakeholders and local residents have been considered and we have reached the following conclusions and subsequent recommendations.

## (i). Conclusions

### Car Park and Recycling

- Most people consulted supported the relocation of the car park on Peckham Rye to the more discreet location proposed.
- Concerns about safety were expressed only by a few of those consulted and focused on pedestrian routes to the café and play area
- No one at the public event reported having any difficulty finding a parking space in the current car park. (Though the Friends group are concerned about the reduction in spaces.)
- The recycling facility in the car park is used only by a third of those consulted at specific times of the year and for items that cannot be recycled through their domestic collection.

### **New Play Area**

- Nearly everyone spoken to was excited at the prospect of a new play area and considered the proposed location to be good.
- There was a desire to see good quality equipment offering children a range of physical challenges
- People expressed delight at the special environment of the park and common and a desire to see the play area reflect its uniqueness.
- Safety concerns surrounding the play area were expressed by only a few, however dogs and the proximity of cars were a concern for some.

 Respondents agreed that the play area should cater for diverse ages and reflect cultural interests.

#### Other

 There is some concern at the proposed demolition of the WW2 prisoner of war hut.

## (ii). Recommendations

### Car Park and Recycling

- Consider the visual impact of the car park by landscaping.
- Consider how routes from the car park to the café and playground can be made safe for pedestrians, especially those with small children, and ensure that the car park is adequately light.
- Reducing the number of spaces in the car park would not seem to create difficulty for the majority of park users
- Consider whether provision of recycling facilities is required in the park and whether uses to which it is put could be catered for by other means.

### **New Play Area**

- The new play area should provide a range of challenging play opportunities, which are educational and tactile, traditional and modern. Consider whether sand and water play can feature in the design.
- The play area should look and feel as natural as possible in order to blend in with the special nature of the park and common.
- Consider the boundaries of the play area so that it does not impact on the common and discourages dogs entering and children leaving the area.
- Cater for children aged 0 to 12 with a focus on five to ten year olds.

#### Other

 Could the heritage of the WW2 prisoner of war hut be referred to in the landscaping following its demolition.
