#### RECOMMENDATION

 That cabinet considers whether or not to hear a deputation request from some residents of Galleria Court, Peckham SE15 in respect of noise nuisance from dogs on the Brideale Close Travellers Site.

#### **BACKGROUND INFORMATION**

- 2. When considering whether to hear the deputation request, cabinet can decide:
  - To receive the deputation at this meeting or a future meeting; or
  - That the deputation not be received; or
  - To refer the deputation to the most appropriate committee/sub-committee.
- 3. A deputation shall consist of no more than six people, including its spokesperson. Only one member of the deputation shall be allowed to address the meeting for no longer than five minutes. After this time cabinet members may ask questions of the deputation for up to five minutes. At the conclusion of the questions, the deputation will be shown to the public area where they may listen to the remainder of the open section of the meeting.

#### **KEY ISSUES FOR CONSIDERATION**

4. The deadline for receipt of deputation requests for this cabinet meeting was Midnight 12 September 2018. The request was received in line with this constitutional deadline.

### **Deputation requests**

#### Galleria Court residents, Peckham SE15

- 5. A deputation request has been submitted by some residents at Galleria Court asking to address cabinet in respect of noise nuisance coming from dogs on the Brideale Close Travellers site.
- 6. The site is overlooked by Galleria Court and the residents report that they are being disturbed throughout the night and day by the chronic barking, howling and yapping of multiple dogs on the site.
- 7. The residents have indicated that they have frequently contacted council officers, but the problem remains and therefore wish to bring the matter to the attention of the cabinet.

8. The Southwark Constitution allows for deputations to be made by groups of people resident or working in the borough.
