A memo from the Environmental Protection Team advising of the withdrawal of their objection was circulated at the meeting. An additional written submission from the applicant was also circulated at the meeting.

4. DISCLOSURE OF INTERESTS AND DISPENSATIONS

There were no disclosures of interests or dispensations.

5. THOMAS A BECKETT, 320-322 OLD KENT ROAD, LONDON SE1 5UE

The licensing officer presented her report. She advised the sub-committee that the request relating to the Sunday extension was from midnight to 5.00am, (not 3.00pm to 5.00am as listed in the officer report).

There were no questions to the licensing officer.

The applicant addressed the sub-committee. Members asked questions of the applicant.

The police representative addressed the sub-committee. Members of the sub-committee and the applicant asked questions of the police representative.

All parties were given five minutes to sum up.

The sub-committee went into closed session at 11.37am to consider the application.

The meeting resumed at 12.30pm and the chair read out the decision as follows:

RESOLVED:

That a variation to the premises licence in respect of the application made by Mr Mohammed Abdul Kashim in respect of the premises known as Thomas A Beckett, 320-322 Old Kent Road, London SE1 5UE be granted in relation to on the premises sales only as follows:

- Monday to Thursday from 3.00am to 5.00am
- Friday and Saturday from 7.00am to 10.00am
- Sunday from 12.00am to 2.00am

Reasons for decision

This was a hearing of an application by Mohammed Kashim to vary the premises licence in respect of the premises known as Thomas A Beckett on Old Kent Road. The applicant sought to extend the hours for licensable activities from Monday to Thursday from 3.00am to 5.00am, on Friday and Saturday from 5.00am to 10.00am and on Sunday from midnight to 5.00am.

The sub-committee heard evidence from the applicant that the granting of this application will not have any adverse impact on the licensing objectives. The applicant presented evidence to the sub-committee to show that they have been managing the premises in a responsible manner and that in the last six months the way that the premises had been run improved significantly and this is supported by the information provided by the police. The applicant also submitted that they are seeking the extension of hours to cater for one-off events and that it was not their intention to utilise all the hours sought. The applicant also submitted that they have been working very close with the police in relation to a variety of issues affecting both the premises as well as the surrounding areas. The applicant also referred to statistic information from the Metropolitan Police website which clearly shows that there has not been any increase in crime and disorder in the area since

the opening of these premises in April 2011.

The sub-committee then heard from the Environmental Protection Team that they decided to withdraw their objection following a visit to the premises and that they no longer considered the premises to have adverse impact on public nuisance objective in the Act.

Next the sub-committee heard submissions from the Metropolitan Police objecting to the granting of the extension. The police relied heavily on six or seven incidents which took place in 2011 during permitted licensed hours as evidence that the granting of the application will have adverse impact on the crime and disorder objective in the Act. The main submission that the police made was in relation to extending the hours on Friday and Saturday thereby creating a 24 hour licence.

The police submitted that if such extension is granted, then the premises are likely to remain open from Friday morning to Monday morning continuously and that this will allow excessive drinking and will have adverse impact on the licensing objectives. The police accepted that they had no supporting evidence but could only speculate on the impact of the extension. The police also accepted that the current management of the premises was a responsible one.

Following the police submissions, the applicant suggested that there will be a break in the operation of the premises on Saturday and Sunday mornings between 5.30am and 7am and that they were no longer looking for a 24 hour licence in that respect as it was not their intention to run the club as a 24 hour club. The applicant further offered to reduce the application in respect of Sunday by 2-3 hours and said they would be happy to close earlier as long as some extension is given.

On the basis of all their presentations made and the concessions made by the applicant, the sub-committee decided to grant the variation as detailed above.

The sub-committee considered that the extension addressed the concerns raised by the police and is proportional under the Licensing Act. The sub-committee also noted that no local residents objected to this application. For the avoidance of any doubt the extension as far as sale and supply of alcohol is concerned, is only in relation to "on the premises sales" and not for "off the premises sales".

Appeal Rights

That the licensee and any person who made relevant representations in relation to the application may appeal against the decision. Any appeal must be made to the magistrate court for the petty sessions area in which the premises are situated. Any appeal must be commenced by notice of appeal given by the appellant to the designated officer for the magistrates' court within the period of 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision appealed against.

5. LICENSING ACT 2003 - PAYLESS, 94-96 PECKHAM ROAD, SE15 5PY

The licensing officer presented his report. Members had questions for the licensing officer. The applicant addressed the sub-committee. Members had questions for the applicant.

The trading standards officer addressed the sub-committee. Members had questions for the trading standards officer.

All parties were given five minutes to sum up.

The sub-committee went into closed session at 11.10am to consider the application.

The meeting resumed at 11.54am and the chair read out the decision as follows:

RESOLVED:

That the application made by Mohammad Zaheer Ali for a premises licence in respect of the premises known as: Payless, 94-96 Pelican House, Peckham Road, London SE15 5PY be refused.

Reasons

This was a hearing of an application by Mohammed Zaheer Ali (M Ali) for a premises licence in respect of the premises known as Payless, 94-96 Pelican House, Peckham Road, London SE15.

The sub-committee heard from the applicant's representative that this was a new application by a new individual and that the application had nothing to do with Mr Shafait Ali (S Ali). At the outset of the hearing the applicant's representative produced an agreement dated 25 February 2011 made between Mr S Ali and Pelican Payless Limited whereby Mr S Ali gave control to Pelican Payless Limited over the premises for a fee. The applicant's representative further submitted that Mr Arshad Ali (A Ali) is the sole director of Pelican Payless but that the application was made in the name of M Ali as Mr A Ali had no personal licence. The applicant's representative submitted that Mr S Ali had no control or involvement in the premises any more and even was willing to offer an undertaking that Mr S Ali will not be allowed on the premises if a licence is granted. The applicant's representative also submitted that there are no objections from the police or the fire brigade. Finally, the applicant's representative submitted that they will not be an adverse impact on the area in light of the fact that the area is designated as a saturation zone but did not give any particulars in that respect.

The sub-committee heard from the council's trading standards department that they object strongly to the granting of this licence on the basis that they consider that Mr S Ali is still in control of the premises despite the documents provided this morning. Trading standards submitted that Mr S Ali had a history of convictions for selling tobacco and alcohol to minors and therefore was not a proper person to manage and run licensed premises. Trading standards submitted that the agreement which was produced this morning was a mere sham as this agreement was entered into in February 2011 but since then Mr S Ali made two applications for a premises licence in respect of these premises despite the alleged agreement. Trading standards also submitted that the applicant in this application

had the same home address as Mr S Ali.

Firstly, the sub-committee considered whether the applicant had satisfied the sub-committee that there will not be an adverse impact on the licensing objectives by granting this application in a saturation zone. The sub-committee found that the applicant did not demonstrate either in their operating schedule or at the hearing today that there will be no negative cumulative impact on the licensing objectives. Clearly granting a new application for sale of alcohol from 6.30am to 11.00pm is likely to have adverse impact on the licensing objectives in an area specifically designated as a saturation zone.

Secondly, the sub-committee considered the submissions made by trading standards in this matter and decided in light of the evidence that there is a strong indication that Mr S Ali will have some control over the premises despite the submissions made by the applicant to the contrary. The sub-committee made this finding on the basis of the agreement which was produced today dated 25 February 2011. The said agreement was entered into some 15 months ago and yet since this alleged agreement was entered into, Mr S Ali did make two licence applications in relation to these premises which, on the balance of probabilities, suggest that Mr S Ali is still in control of the premises. This was also in direct contradiction to the evidence given at the sub-committee by Mr A Ali that he has been in control of the premises and had been paying rent to Mr S Ali since February 2011 as clearly if this was correct then the previous applications made in December 2011 and February 2012 would have been made by Mr A Ali and not Mr S Ali.

For the above reasons this application is herewith refused.

Appeal rights

That the licensee and any person who made relevant representations in relation to the application may appeal against the decision. Any appeal must be made to the magistrate court for the petty sessions area in which the premises are situated. Any appeal must be commenced by notice of appeal given by the appellant to the designated officer for the magistrates' court within the period of 21 days beginning with the day on which the appellant was notified by the licensing authority of the decision appealed against.

5. LICENSING ACT 2003 - TEMPORARY EVENT NOTICE: ROYAL STANDARD, 42 HARPER RD, LONDON SE1 6AD

The licensing officer presented her report. Members had no questions for the licensing officer,

It was noted that the applicant was not in attendance.

The environmental protection officer.addressed the sub-committee. Members had no questions,

The meeting went into closed session at 12.03pm to consider the application.

The meeting resumed at 12.22pm and the chair read out the decision as follows:

RESOLVED:

That a counter notice be issued under Section 105 of the Licensing Act 2003 in respect of the Temporary Event Notice given by Guido Medellin for the Royal Standard, 42 Harper Rd, London SE1.

Reasons

This was an application for a temporary event notice in relation to the premises known as Royal Standard at Harper Road.

The applicant did not turn up to the hearing despite the hearing commencing two hours later then arranged.

The sub-committee heard from the council's environmental protection team (EPT) that they are objecting to this application on the basis of the prevention of public nuisance objective in the Licensing Act. The EPT further submitted that there has been about nine noise complaints concerning the premises in the last 12 months and that their major concern was noise escape.

In view of the above the sub-committee resolved to refuse this application for the promotion of the prevention of public nuisance objective in the act. It was therefore resolved to issue a counter notice.

Appeal rights

Where the relevant counter notice under Section 105(3) is given the premises user may appeal against the decision. Where counter notice is not given, the chief officer of the environmental protection team may appeal against that decision. The appeal must be made to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against. No appeal may be brought later than five working days before the day on which the event begins.

6. LICENSING ACT 2003 - TEMPORARY EVENT NOTICE: ECLIPSE 54B SOUTHAMPTON WAY, LONDON SE5 7TT

It was noted that the applicant, Nurten Lisa Halil was not in attendance. However, another director, Mr Roberto Baliazar, and two members of staff from the premises were in attendance.

The sub-committee went into closed session at 10.20am to 10.25am to take legal advice.

On returning to the open session, at the request of the sub-committee, Mr Baliazar, director of Steak Restaurants UK Limited undertook to provide the licensing officer, by 4.00pm on the day of the licensing sub-committee meeting, with a letter from Miss Halil in which she confirms that the application was made on her behalf by Mr Baliazar.

The licensing officer presented her report. Members had no questions for the licensing officer.

The applicant addressed the sub-committee. Members had questions for the applicant.

The environmental protection officer addressed the sub-committee. Members had questions for the principal environmental protection officer.

The environmental advised the sub-committee that he would withdraw his objection to the application subject to his conditions being implemented by the applicant.

The sub-committee went into closed session at 11.15am to consider the application.

The meeting resumed at 11.55pm and the chair read out the decision as follows:

Reasons

This was an application for a temporary event notice in relation to the premises known as Eclipse at Southampton Way, London SE5.

The application was made by Miss Halil who did not attend the sub-committee hearing. Following submissions on the subject, Mr Baliazar, director of Steak Restaurants UK Limited undertook to provide licensing by 4pm today with a letter from Miss Halil in which she confirms that the application was made on her behalf by Mr Baliazar.

The application itself was for a one-off temporary event to take place between midnight and 6.00am on Sunday, 13 May 2012.

The sub-committee heard evidence from the applicant that they have been running the premises since February of this year and that they have introduced many upgrades and changes to the premises in order to deal with noise issues. The applicant also submitted that they had several temporary event notices approved in recent months and that all these events progressed without any major complaints.

The sub-committee then heard from the council's environmental protection team (EPT) that they are objecting to this application on the basis of the prevention of public nuisance objective in the Licensing Act. The EPT further submitted that there has been six noise complaints concerning the premises since February 2012 and that their major concern was noise escape.

Following the above submissions, the EPT officer indicated that he had a discussion with the applicant this morning whereby the applicant agreed to arrange for breeze blocking of the front windows to be completed prior to the event taking place and that further the applicant agreed to remove the concrete table from the front of the premises prior to the event taking place. On the basis of these proposals by the applicant, and on the basis that conditions 312 and 343 from the premises licence will be attached to the TEN, the EPT officer withdrew his objection.

In view of the above the sub-committee resolved to grant this application and to use this opportunity to make it clear to the applicant that if the proposed works are not completed to a satisfactory standard prior to the event taking place, then the event should not be held. In addition conditions 312 and 343, as above, will apply to this temporary event notice.

Appeal rights

Where the relevant counter notice under Section 105(3) is given the premises user may appeal against the decision. Where counter notice is not given, the chief officer of the environmental protection team may appeal against that decision. The appeal must be
