The chair welcomed councillors, members of the public and officers to the meeting and thanked Harris Academy Peckham for hosting the community council meeting at the school.

2. APOLOGIES

An apology for lateness was received from Councillor Victoria Mills.

5. MINUTES FROM THE PREVIOUS MEETING

6. DEPUTATIONS/PETITIONS (IF ANY)

No deputations or petitions were received.

7. COMMUNITY ANNOUNCEMENTS AND PRESENTATIONS

The following announcements and presentations were made:

Winter campaign

Rosemary Watts from NHS Southwark Clinical Commissioning Group spoke about the winter campaign that had been launched by NHS Southwark Clinical Commissioning Group. Information leaflets were available at the meeting. The scheme had been put in place to address and signpost people to other health-based services if their illness was not considered life threatening. This would avoid the hospital's A&E department being used for non emergency illnesses. Rosemary explained that had been some media coverage about the difficulty people had getting a doctor's appointment and therefore people used the A&E services because of the time delay. People were reminded to only use A&E services if they felt it was life threatening.

Rosemary also spoke about the review of the health services and development of a strategy so the situation could be addressed. People were encouraged to sign up to NHS Southwark's email list which they were able to do during the course of the meeting. In addition there was a lot of publicity on how people use the A&E and GP services.

Peckham Vision's Town Centre Exhibition

Eileen Conn from Peckham Vision spoke about the group's Peckham Town Centre exhibition that was held on 16 to 18 December 2013 during the day and evening. The group wanted volunteers to help out in the coffee shop along Bellenden Road. More information was available during the break.

Peckham and Nunhead – Youth Community Council

Sharon Pryce, Youth Development Worker, who was accompanied by representatives of the youth community council reported on proposals to improve community councils and the activities that had taken place following the money they received from the restoration fund. The young people went on a boat trip, and attended a Black history event in Liverpool.

The representatives from the youth community council took it in turns to briefly outline what they thought about the last community council meeting they attended in September 2013.

The young people outlined the following:

- They felt the last community council was interesting and covered topics on the budget consultation and public toilets in Rye Lane. Its theme on the Peckham Town Centre and Rye Lane was quite engaging.
- The meetings were too long and there should be more of a focus on young people.
- Use less jargon so it could be more easily understood.
- They thought people were always complaining about crime amongst young people.
- The local area had far too many congested pavements and a number of meat / butcher shops that left food waste on pavements.

The chair thanked the young people for sharing their ideas and some of the issues raised about multiple shops which had also been a concern for the community council. The chair stated that she would welcome them back to a “youth theme” community council meeting next year.

Community council fund 2014

Marian Farrugia, Community Council Development Officer talked about the community council fund, funding schemes that take place each year. It was aimed at community activities and one off events.

The deadline for applications was Friday, 13 December 2013 and no late applications would be accepted. Forms were available at the meeting and more details about the funding scheme could be viewed on the council’s website.

In response to questions Marian explained the applications would be assessed by councillors and the decisions announced at the community council meeting in February 2014 so events and activities could take place in summer 2014.

The chair announced the following:

East Dulwich Christmas cracker

The East Dulwich Christmas Cracker event on Saturday 7 December 2013, at Lordship Lane and North Cross Road between 10am and 5pm which would have music, dancing, carol singing and entertainment for everyone.

Christmas tree switch-on

The Christmas tree switch-on to be held on Friday 6 December 2013 at 5pm which involved a school choir and the Southwark mayor.

Council Assembly theme debate

The council assembly meeting would have a theme debate on local business and enterprise on 27 November 2013.

Police Inspector Upton

The chair paid tribute to Inspector Linda Upton who was due to retire from the police. Councillor Soanes thanked her for all her hard work and wished her all the best for the future. Inspector Upton said ward officers in the safer neighbourhood teams were still available and contactable on the non emergency telephone number 101. She also thanked those involved in the community and asked people to keep safe.

INTRODUCTION TO THE THEME: PECKHAM TOWN CENTRE AND RYE LANE

Councillor Fiona Colley, cabinet member for regeneration and corporate strategy introduced theme and the speakers who were present for items on theme.

8. PECKHAM TOWN TEAM - UPDATE

Peter Williams from the "Means" gave the meeting an update on the Peckham Town Centre initiative. It came about after the Mary Porter initiative, to tackle the decline of old shops in town centres.

Peter explained the project were unsuccessful in a bid they put through to the DLCC (Department for Local Communities & Local Government). Following that the group received money from the cleaner greener safer funding programme which specifically looked into improvements to the high street. He said anything was achievable if money could be invested in these sorts of schemes. He emphasised the importance of giving support to the local high street.

Peter felt that the publicity on free parking in the borough's town centres which was part of a "shop local campaign" during the Christmas period had not been widely publicised. He said people should be given special dispensation to park free of charge during the day or in the evening.

Peter briefly mentioned the pop up shop located at 91 High Street next to Peckham Space. The pop up shop is used to test new business ideas and ventures on the high

street.

9. PECKHAM TOWNSCAPE HERITAGE

The item was considered in conjunction with item 10, Rye Lane Peckham Conservation area management plan.

Michael Tsourkaris, design & conservation officer spoke about the Peckham Townscape Heritage which involved repairs and restoration works to historic features. Officers had identified 45 buildings on Peckham High Street. Illustrated plans were on display at the meeting. He reported that a stage two bid was held in January 2014. He hoped to hear back about their bid to the heritage lottery fund in order for them to agree to the restoration.

Michael spoke about the management plan for Rye Lane copies of which were available at the meeting. The officer mentioned the council were seeking views of residents, local stakeholders and community businesses about the management plan. The consultation period was held for 12 weeks until 21 February 2014. The officer said any comments from the community council and the management plan would be presented to the planning committee and the Heritage Lottery Fund.

The officer responded to questions and agreed to attend community based meeting and arrange drop in sessions at local libraries. He also took on board people's concerns about the lack of consultation and community engagement with residents and the short timescales for the consultation.

The chair thanked officers for their presentation and encouraged people to speak with representatives at the break.

10. RYE LANE PECKHAM CONSERVATION AREA MANAGEMENT PLAN

This item was considered in conjunction with item 9.

SHORT FILM SHOWN DURING THE BREAK

Deborah Oduyoye a film producer of the "Meet the Adebajjos" talked briefly about how she started her career after she attended university. She spoke about the talent of local people, what opportunities there were for young people and how she was proud to be a resident of the borough. The meeting were shown a clip of the film, "Meet the Adebajjos" during the break.

The chair thanked Deborah for attending the community council meeting.

11. PUBLIC QUESTION TIME

Q1

A local resident from Asprey Road residents association asked about some of the shops that had closed down around Queens' Road train station and Pomeroy Street. This included the recent closure of a dry cleaners shop which seemed profitable and busy; she wondered whether that was due to the proposed regeneration in Queens Road. She said local residents had been concerned about the closure of shops and wondered why this was happening?

A1

Councillor Colley responded by saying she could not comment as to why some shops closed. It might be that the shops were not making money which was usually the reason for shops closing. Councillor Colley reported there had been some improvements to shop fronts in the area but would find out about the timelines for the proposed programme of works from officers and understood further investment needed to be made in the area.

Councillor Mills added that through the community restoration fund around £440,000 would be used towards improvements to the five town centres in the borough. The council also brought a "town centre growth initiative" which had been a pot of money (£600k) that would be open in the new year. Business led organisations could come forward with proposals to help their local town centre or high street to thrive and be more successful. Councillor Mills said as Queens' Road missed out in the last round, there would be an opportunity for local residents and businesses to put in a bid for the next round.

Q2

A market trader from Rye Lane said why had there been only three Christmas lights up on Rye Lane.

A2

Councillor Hargrove said he was surprised by this, because that had not happened like that in previous years. He agreed to look into the matter and report back to the meeting.

Q3

A resident from Rye Lane said Pocket Places Peckham had been an interesting concept throughout the year. It involved developing ideas and engaging with the community. He said he hoped some of the projects would be successful and valuable to the community especially as there was funding available for this year and the next. What would the council do to ensure these projects remained sustainable in the long term and not go into disrepair?

A3

Councillor Hargrove responded by saying that Pocket Places was a joint funded project between the council and Sustrans. He felt that it was important for the community to show support because there might not be another opportunity to make a change to the area of Peckham so he urged people to have confidence to ensure its success.

Q4

Local resident asked about the Peckham area action plan?

A4

Councillor Colley explained that the Peckham area action plan was produced in 2005 and was now in it's the final stages. The planning inspector had held an examination of the council's proposals and people were given an opportunity to express their views in its final

stages. The planning inspector had indicated to the council that the findings were sound but suggested a few changes. This would mean another “light” consultation for those who had expressed a view previously. She said information and further details could be found on the council’s website.

QUESTION TO THE CABINET MEMBER FOR REGENERATION AND CORPORATE STRATEGY FROM COUNCILLOR CLEO SOANES (PECKHAM AND NUNHEAD COMMUNITY COUNCIL)

Please could you provide an update on the consultation process, scheduled works and timescale for Network Rail Peckham Rye Station redevelopment project. Given that a lot of the arts based economic activity continues to recognise the established creative industries and will encourage new creative industries to emerge?

RESPONSE

Consultation and engagement

The Gateway to Peckham project is identified in the Peckham and Nunhead Area Action Plan, which has been prepared and consulted on over the past eight years and forms the basis of the project moving forward.

In June 2013, we appointed business support consultants Greater London Enterprise (GLE) to aid and assist businesses throughout the life of the project. The council then wrote to all businesses in July 2013 and in November 2013, informing them of the project, advising of the appointment of the architects and offering support through the appointed business support GLE. All letters were hand delivered to ensure they reached those operating on the sites.

The focus of the GLE work has been on building one to one relationships and, through this, understanding of individual business needs and ambitions. GLE have offered support to a majority of businesses operating, focussing on the front of the station having made contact with 27 out of 31 known businesses and provided a range of support including investigating relocation opportunities and assistance with business rates.

In addition to the work of the council, Network Rail have been actively discussing the project with tenants and have been advising of available tenancies elsewhere in their portfolio. GLE have also offered support with Network Rail to three of the nine businesses operating to the rear of the station.

Architects were appointed by Network Rail in November 2013 and attended the 25 November Peckham and Nunhead Community Council to introduce them to the community.

A public event to gather information on how the local community currently feel about and use the site to inform the development of initial designs was held on 30 November 2013. This was attended by nearly 200 people. The presentation materials were displayed in Peckham Library and made available on the website, inviting feedback. To ensure that the views of station users were captured over 500 flyers were handed out to station users in a morning and evening peak. In addition flyers were also distributed to properties within 100m of the site.

A second set of public events are planned for 18 and 20 January 2014. To improve awareness of this consultation, press releases and leaflet drops, including over 500

to commuters and local networks circulating the leaflet, took place. This will be followed by a week long exhibition at Peckham Library.

In addition, Weston Williamson will be attending February community council, a number of youth community groups and will be meeting with the Peckham Town Team. Once designed, a planning application will be submitted to the council by Network Rail. As part of the planning permission process a statutory consultation process will be undertaken.

A contact list is being collated and regular e-newsletters will be provided to keep people up to date on project progress.

Schedule

Works to bring the northern tower retail unit (formerly a William Hill) back into operation are underway. Network Rail is currently advertising this unit and we expect a new tenant to be in place by spring 2014.

Accessibility is an issue at Peckham Rye, particularly for those with disabilities and young children and an application has been made to the Department for Transport for funding to install lifts. We expect to be notified in early 2014 if the station has been successful.

Following a structural survey of the floor of the Old Waiting Room (also known as the former Billiard Room), further improvement works are being investigated with the hope that the space can be brought into a safe and usable condition – with further progress early in Spring 2014. Alongside this, we are also looking to improve the lighting of the front of the station to accentuate the design of the building, again starting in spring 2014.

It is anticipated that a planning application will be made in early spring and has been informed by the consultation events outlined above. The programme set out in the Mayor's regeneration fund requires delivery of the project by March 2016. As mentioned above, the council will be providing regular updates to ensure the community is kept informed of project progress.

Cultural businesses

The council will be working with local cultural organisations and businesses to develop a cultural programme of events and activities alongside the regeneration. This will compliment all the amazing things already happening in Peckham. The council will soon be approaching local arts groups and others to help create and design the programme of events. The project is in its early stages and we hope to update the community in the next few months.

RECOMMENDATION

1. That Peckham and Nunhead Community Council approve the re-allocation of a total of £26,864 to projects in the 2014/2015 cleaner greener safer programme.

BACKGROUND INFORMATION

2. Cleaner greener safer (CGS) is part of the council's capital programme. Between 2003 and 2013 £7.45m has been made available local residents to apply for awards to make Peckham and Nunhead a better place to live. The programme attracts hundreds of proposals ranging from a few hundred pounds for bulb planting to brighten up open spaces to tens of thousands of pounds to create community gardens. These projects often introduce new ideas such as outdoor gyms in public spaces, community gardens, public art and energy saving projects which not only make the borough cleaner, greener and safer but greatly contribute to a sustainable public realm by involving residents in the funding process and in the delivery of projects.

KEY ISSUES FOR CONSIDERATION

3. Appendix 1 highlights five projects with a total underspend of £26,864.
4. It is recommended that £10,000 under spend from the completed project Shards Mews environmental improvements, project reference [02175], is reallocated to projects where additional expenditure is required.
5. It is recommended that the £4,000 under spend from the completed project Marmont Road/Dunstall House grot spot lighting, project reference [105874], is reallocated to projects where additional expenditure is required.
6. It is recommended that the £5,000 under spend from the completed project Lighting at Caroline Gardens, project reference [105623], is reallocated to projects where additional expenditure is required.
7. It is recommended that the £3,064 under spend from the completed project Nunhead and Peckham Rye Smart Meter scheme, project reference [01896], is reallocated to projects where additional expenditure is required.
8. It is recommended that the £4,800 under spend from the completed project A safe crossing for Brockley Way, project reference [105593], is reallocated to projects where additional expenditure is required.

Policy implications

Community impact statement

10. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
11. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The cleaner greener safer programme is an important tool in achieving community participation.
12. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been given to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decision to the need to:
- a. Eliminate discrimination, harassment, victimisation or other prohibited conduct.
 - b. Advance of equality of opportunity between persons who share a relevant protected characteristics and those who do not share it.
 - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
13. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
14. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
- a. Remove or minimise disadvantages connected with a relevant protected characteristic.
 - b. Take steps to meet the different needs of persons who share a relevant protected characteristic.
 - c. Encourage persons who share a relevant protected characteristic to participate in public life or any other activity in which they are under-represented.

Resource implications

15. This is the reallocation of existing CGS funding that was originally awarded in 2009/10, 2012/13 and 2013/14. CGS funding is devolved to community councils to spend on suitable projects. Management of the reallocation of the funding will be contained within existing budgets.

16. Management of the reallocation of the funding will be contained within existing budgets. The reasons for variances to the individual projects spend and their proposed reallocation are set out in Appendix 1 to this report.
17. The total expenditure and sources of funding for CGS schemes will be monitored and reported on as part of the overall capital programme.

Consultation

18. All Cleaner Greener Safer projects require consultation with stakeholders, including the project applicant, local residents and tenants and residents associations where appropriate.

Legal implications

19. The allocation of the cleaner greener safer capital fund (CGS) is an executive function, delegated by the Leader to community councils.
20. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the Leader.
21. This report is recommending that the Peckham and Nunhead community council approve the reallocation of available funds from the 2009/2010, 2012/2013 and 2013/2014 programmes as specified at appendix 1 to the 2014/15 capital funding allocation. The power for this function is derived from Part 3H paragraph 11 of the constitution which states that community councils have the power of "approval of the allocation of funds to cleaner, greener, safer capital and revenue schemes of a local nature, using the resources and criteria identified by the cabinet".
22. The cabinet member for transport environment and recycling approved the funding for the 2013/14 programme in October 2012 and the 2014/2015 programme in October 2013 by exercising his powers under Part 3D paragraph 2 of the constitution. Where funding needs to be reallocated the community council approval being sought here is therefore the appropriate constitutional step in the process.
23. Community council members also have powers under paragraph 12 of Part 3H of the constitution to oversee and take responsibility for the development and implementation of the local schemes.
24. In allocating funding under the CGS community councils must have regard to the council's equality duty set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties need to be considered in the body of the report at paragraphs 14 to 17 in the community impact statement.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Strategic Director of Finance and Corporate Services

25. The report requests the approval of Peckham and Nunhead community council for the re-allocation of a total of £26,864 to projects in the 2014/2015 cleaner greener safer programme, as set out in Appendix 1.
26. The strategic director of finance and corporate resources notes the resource

implications contained within the report, and confirms that the capital funding for the CGS programme has been approved as part of the overall council capital programme.

27. Officer time and any other costs connected with this recommendation will be contained within existing budgeted revenue resources.

RECOMMENDATION

1. To approve the allocation of funds for the 2014-15 Cleaner Greener Safer (CGS) capital programme in the Peckham and Nunhead community council area from the list of applications set out in Appendix 1.

BACKGROUND INFORMATION

2. The council's cleaner greener safer capital programme has been running since 2003.
3. In the first eleven years of the CGS programme, £28,513,000 has been allocated to community councils leading to 1,758 projects being approved.
4. In the Peckham and Nunhead community council area, £7,450,500 has been allocated to 422 projects, 360 of which have been completed to date.
5. For 2014/15, community councils have also been able to allocate CGS revenue and applications were invited for both capital and revenue ideas. The allocation of revenue is dealt with by a separate report on this meeting's agenda.
6. Examples of the types of projects that have been funded include:
 - Parks, community gardens, landscaping, tree planting and wildlife areas
 - Children's playgrounds, youth facilities, ball courts and cycle tracks
 - Lighting, security measures, pavements, streets, and tackling 'grot spots'
 - Grants to local groups to self-deliver projects

KEY ISSUES FOR CONSIDERATION

7. There is £402,857 available for the 2014/15 CGS capital programme for new projects in the Peckham and Nunhead community council area.
8. Eligible proposals must bring about a permanent improvement and make an area cleaner, greener or safer.
9. Proposals with revenue costs, including salaries or computer equipment, feasibility studies, costs for events, festivals, workshops or other one-off events

are not eligible for capital funding. CCTV proposals, internal improvements to housing property, works on schools where there is no access to the general public are also not eligible. Works on private property are not eligible unless there is a long-term guarantee of public access or a demonstrable public benefit.

10. The application form invited expressions of interest for the applicants to deliver projects themselves. A due diligence exercise to ensure that this is both practical and realistic has been undertaken as part of the feasibility process. In such cases, the council would give the funding allocation to the applicant in the form of a capital grant, with appropriate conditions attached.

Policy implications

11. The cleaner greener safer programme is fully aligned with the council's policies around sustainability, regeneration and community engagement.

Community impact statement

12. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
13. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The cleaner greener safer programme is an important tool in achieving community participation.
14. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been given to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decision to the need to:

17. All ideas for CGS projects come directly from the local community via a simple project nomination form available in electronic and paper format.

Resource implications

18. The funding for the 2014/15 CGS capital programme was approved by the cabinet and is part of the council's overall capital programme as detailed in the launch of cleaner greener safer capital programme 2014/15 report dated September 2013.
19. All professional fees related to the project are also treated as the capital costs of the project. Where projects are awarded as a grant to organisations, the community council award letter will not include the professional fees which will be charged direct to project costs.
20. CGS projects must be completed within two years of award of funding. Projects that are unlikely to be completed within two years will be reported to community council and available budgets may be reallocated to other projects. Revenue costs not covered by maintenance or the contractual liability period will fall upon the asset owner. The business unit will be notified of the likely costs before the schemes proceeds, in order to secure permission to implement the scheme.
21. After the defects and liability period, or three year maintenance period in the case of planting works, all future maintenance is assumed by the asset owner, for example housing, parks, highways, or in some cases external asset owners. Therefore, there are no revenue implications to the public realm projects business unit as a result of approving the proposed allocation.
22. The total expenditure and sources of funding for the scheme will be monitored and reported on as part of the overall capital programme.

RECOMMENDATION

1. That the Peckham and Nunhead community council allocate the full available cleaner greener safer (CGS) revenue budget of £90,000 to successful applicants in 2014/15. The projects to be considered for allocation are set out in Appendix 1.

BACKGROUND INFORMATION

2. A cleaner, greener, safer revenue Fund consisting of £210,000 across the borough, with an allocation of £10,000 per ward, was introduced as part of the budget strategy agreed at the council assembly meeting on the 29 February 2012. At the council assembly meeting which took place on the 27 February 2013, it was agreed to allocate an additional £10,000 per ward making a total revenue fund available of £420,000 across the borough allocated at £20,000 per ward.
3. The aim of this fund is to give community councils decision making powers over significant amounts of revenue funding that they can allocate to meet locally determined priorities. It is anticipated that the availability of the revenue fund will enhance and complement the effectiveness of the capital fund.
4. On 1 March 2012 the Leader of the Council delegated the executive function to each community council to take the cleaner, greener, safer revenue funding decisions in their areas.

KEY ISSUES FOR CONSIDERATION

5. The community councils will use the criteria set out below for the allocation of this funding.
 - a. Proposals that make an improvement to an area on the basis of making it cleaner, greener or safer or a combination.
 - b. CGS applications from the capital round which were ruled out because they were revenue applications.
 - c. The revenue fund could be used to meet the revenue costs associated with a CGS capital award.
 - d. A community council may choose to allocate some or all of their revenue resources to their CGS capital allocations.

- e. Subject to the availability of resources, the revenue fund may be used to buy services from the council.
6. While the allocation is based on £20,000 per ward, a community council can, if it chooses, decide to aggregate all or part of the funding and spend more than £20,000 per ward.
 7. Community councils will be free to indicate whether they would like expenditure to be an ongoing commitment over more than one financial year or spending over a fixed timescale for a one-off project. Commitments will be subject to final agreement of the council budget and a decision by each community council on an annual basis.
 8. As with any executive decision taken by community councils this is subject to the council's existing scrutiny arrangements.

Delivery

9. Once the community council has made their selections by the method of their choice they will be designed and delivered as soon as possible in 2014/15. Any under spends or projected overspends will be reported back to community council for resolution or reallocation.

Community impact statement

10. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
11. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The cleaner greener safer programme is an important tool in achieving community participation.
12. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been given to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decisions to the need to:
 - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct.
 - b. Advance of equality of opportunity between persons who share a relevant protected characteristic and those who do not share it.
 - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
13. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
14. Having due regard to the need to advance equality of opportunity is further defined in S.149 as having due regard to the need of:
 - a. Remove or minimise disadvantages connected with a relevant protected characteristic.

- b. Take steps to meet the different needs of persons who share a relevant protected characteristic.
- c. Encourage persons who share a relevant protected characteristic participate in public life or any other activity in which they are under- represented.

Financial implications

- 15. The total amount available for the Peckham and Nunhead CGS revenue fund in 2014/15 is £90,000. In addition, any underspend in 2013/14 will be carried forward into 2014/15. All allocations are subject to the approval of the 2014/15 Revenue budget by council assembly on 26 February 2014.

Policy implications

- 16. The CGS Revenue Fund is fully aligned with the council's policies toward sustainability, regeneration and community engagement.

Consultation

- 17. Decisions will reflect longstanding ward priorities and may be complementary to the decisions made in the CGS capital fund allocation. In this first year of the scheme consultation took place at the community council meetings and is therefore now an integral part of the decision making process.

Legal Implications

- 18. The Local Government Act 2000 [as amended] ('the Act') gives the leader the power to delegate any executive function to whoever lawfully can undertake the function. The allocation of the cleaner, greener, safer revenue fund (CGS) is an executive function.
- 19. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the leader.
- 20. In allocating funding under the CGS community councils must have regard to the council's equality duties set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties have been considered in the body of the report at paragraphs 12, 13 and 14 in the community impact statement.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Strategic Director of Finance and Corporate Services

- 21. For 2013/14, the council's base budget for funding the Peckham and Nunhead CGS revenue fund is £90,000. At present this is expected to remain at the same level for 2014/15. In addition, any underspend in 2013/14 will be carried forward into 2014/15. However, it must be noted that the council's 2014/15 budget setting process is not yet completed, and thus there is no guarantee that the level of funding eventually approved will be the same as the amount shown in this report.

RECOMMENDATION

1. That the Peckham and Nunhead community council allocates the full available community council fund (CCF) budget of £26,160 to successful applicants in 2014/15. There is an additional £1090 to be allocated from an unallocated amount from the 2013/14 round. The projects to be considered for allocation are set out in Appendix 1.

BACKGROUND INFORMATION

2. The community council fund provides revenue grants of between £100 and £1,000 for community projects. Applications are considered by the borough's five community councils, which have a total of £122,079, for projects that will benefit the community.
3. The community council fund was first launched in 2004. It is intended to encourage small and 'hard to reach' groups to organise activities and events which would benefit their community. It is designed to promote the work of community councils and provide opportunities to engage with some marginalised communities. The fund is targeted to build and improve community cohesion by creating opportunities for bringing different communities together in local activities.

KEY ISSUES FOR CONSIDERATION

Community impact statement

4. The allocation of the Peckham and Nunhead community council fund will, in the main, affect the people living in the Peckham and Nunhead community council area. However, in making the area a better place to live and improving life chances for local people, the Peckham and Nunhead community council fund activities will have an impact on the whole of Southwark.
5. The Peckham and Nunhead community council fund aims to increase community participation and activity within the area and provide such groups with the support that they would have not been able to access otherwise (appendix 2).
6. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that

affect the area.

7. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The community council fund is an important tool in achieving community participation.
8. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been given to the council's duty under the Equality Act 2010 which requires the council to have due regard when taking decisions to the need to:
 - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct.
 - b. Advance of equality of opportunity between persons who share a relevant protected characteristic and those who do not share it.
 - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
9. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation. In this process there are no issues that contravene the Equality Act 2010.
10. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
 - i. Remove or minimise disadvantages connected with a relevant protected characteristic.
 - ii. Take steps to meet the different needs of persons who share a relevant protected characteristic.
 - iii. Encourage persons who share a relevant protected characteristic participate in public life or any other activity in which they are under-represented.
 - iv. Due consideration was given to equalities impact assessment during the design of this awards process and no adverse impact was evident.
 - v. Due consideration was given to equalities impact assessment during the design of this awards process and no adverse impact was evident.

11. The total amount available for the Peckham and Nunhead community council fund in 2014/15 is £26,160, which is to be spent by 31 March 2015. In addition, any underspend in 2013/14 will be carried forward into 2014/15. All allocations are subject to the approval of the 2014/15 Revenue budget by council assembly on 26 February 2014.

Legal implications

12. The Localism Act 2011 gives councils a general power of competence whereby they have power to do anything that individuals generally may do. This power

can be used even if legislation already exists that allows a local authority to do the same thing. However the general power of competence does not enable a local authority to do anything which it was restricted or prevented from doing under that previous legislation.

13. This general power of competence would include the power to:

Community council fund 2014

About the community council fund

Southwark's community councils have a total of £122,000 to support activities run by local groups for local people across the borough.



What kind of things can be funded?

The community council fund can fund projects benefitting people who live in the community council area, for example:

- One off events such as fun days and festivals
- Workshops or activities involving members of the local community
- Publicity or merchandise to advertise an event you are doing

Who can apply?

- New and emerging local groups
- Small local organisations
- Any constituted local group
- Any group or individual that has a constituted local organisation to administer the funds on their behalf
- Groups that are based within the community council area

Who cannot apply?

- Organisations not established in the UK
- Organisations which do not have any local links
- Political groups or organisations

What kind of things will not be funded?

- Loans or interest payments
- Political groups or activities promoting political beliefs
- Activities which have happened or started before the grant decision date
- Activities that finish after 31 March 2014

- Activities that do not benefit people living in the community council area
- Anything which is capital funding, for instance building works or large playground equipment

How much can groups apply for?

- From £100 up to £1,000. Groups can only submit one application per community council area. In exceptional circumstances awards in excess of £1,000 may be considered.

How can people apply?

- By completing the application form attached
- By completing an online application form at: www.southwark.gov.uk/communitycouncilfund
- Contacting the officer for the relevant community council area, as listed on page two, to request an application form

Closing date for receipt of all applications is **12pm Friday 13 December 2013.**

Late or partially filled applications will not be considered.

How can I get more information or support?

Visit www.southwark.gov.uk/communitycouncilfund for more information or for alternative funding opportunities. If you would like help with filling in the application please contact the officer for the relevant community council area as listed overleaf.

How does the scheme work?

Applications will be screened to make sure they meet the criteria. Remember that eligibility for the fund is also conditional on the applicant providing all the necessary information outlined in the application form, which includes evidence on how they are, or will be, complying with appropriate safeguarding and health and safety policies.

Applications not fulfilling any of the above criteria will not be considered.

Elected councillors will be responsible for making decisions on all the eligible applications using the priorities outlined below

- Applications that show a high level of involvement from the local community
- Applications that involve groups working together
- Activities delivered by:
 - New and emerging groups/individuals
 - Groups who have not previously received community council funding
 - Groups who are based in the community council area
- Activities taking place within the community council area, unless they involve an outing, or there is lack of space for it within the area
- Where the majority of people benefitting from the activity live within the community council area

Decisions for applications will be made and announced by councillors at the community council meeting which will take place in January or February 2014.

So, when planning your activity, please make sure that you give enough time for this and that it does not start before 1 April 2014.

Every applicant will be notified of decisions by a letter no longer than 15 working days after the decision is taken. Successful applicants will be asked to sign and return a condition of funding agreement. It is only once this agreement has been received that we can release the funding.

Please note that groups that are not constituted or individuals who would like to apply with project ideas should get in touch with the community council

development officer (contact details below) for advice as soon as possible.

All necessary documentation must be submitted with the application before it can be considered. It is the responsibility of the applicant to ensure that they or their sponsor group have the appropriate safeguarding policies, insurance, risk assessments, constitution and current bank account details.

Remember all applications, whether online, email or post must reach us by 12pm Friday 13 December 2013.
