#### 1. INTRODUCTION AND WELCOME

The chair welcomed residents, councillors and officers to the meeting.

#### 2. **APOLOGIES**

Apologies for absence were received from Councillors Al-Samerai, Hamish McCallum and Eliza Mann.

#### 3. DISCLOSURE OF MEMBERS' INTERESTS AND DISPENSATIONS

There were none.

#### 4. ITEMS OF BUSINESS THAT THE CHAIR DEEMS URGENT

#### 5. MINUTES

#### **RESOLVED:**

#### 6. DEPUTATIONS / PETITIONS (IF ANY)

#### 7. COMMUNITY ANNOUNCEMENTS

#### **Youth Community Council**

Councillor Evelyn Akoto (vice-chair) introduced the members of the youth community council (YCC) and explained that she had recently attended one of their meetings. One of the biggest issues for the YCC was police profiling. The YCC were concerned that young black males in the area were being picked on. There was an extensive discussion which concluded that profiling was used by police in identifying potential criminals but some times it can be abused. Local police would be invited to a future meeting of the YCC. In terms of interaction with the main community council, young people wanted more interaction, visuals, stalls and less jargon. The YCC meet fortnightly at 5pm at the Canada Water Library. All are welcome to attend.

Three members of the YCC attended and gave their views on transport.

- Buses were often overcrowded and non-school users often had to put up school children making lots of noise during journeys. Perhaps more buses and schools only buses could be considered.
- Oyster card delivery delays were mentioned.
- Safety on public transport was a big issue for young people. Passengers under the influence – drink or other drugs - could often be frightening for young girls. Transport for London (TfL) should not allow people on board that are under the influence.
- Bus drivers should take care when opening and closing doors as injuries have occurred to young people when not done properly.

Councillor Michael Situ, cabinet member for community safety, explained that the

administration had recently introduced a women's safety charter (WSC) to support the experience of women, especially during the night. As part of the work there was dialogue with TfL to improve the travel experience of women and girls on public transport. The YCC said they would interact with work done by the council and TfL on that.

#### Petition for improved C10 bus service

Councillor Stephanie Cryan explained that the C10 bus is often affected by congestion on Jamaica Road and often stops near the Rotherhithe tunnel to regulate the service before cutting out the peninsula and Canada Water area and going back down Jamaica Road. Councillors Cryan, Whittam and Williams, had got together a petition to ask Transport for London (TfL) to include the peninsula in the C10 route. Residents were encouraged to sign the petition. Councillor David Hubber added that a recent email from TfL indicated that following a review of both the C10 and 381 routes new schedules were being introduced in January 2015, which would hopefully improve the situation.

#### **Southwark Cycling Strategy**

The chair announced that the council was keen to know what they could do to improve safety conditions for all road users along the route. Comments would inform the design of the route. The council wanted to work with residents, cyclists, pedestrians and motorists to develop the route.

#### Southwark Statement of Licensing Policy 2015 – 2020 consultation

Dave Swaby, licensing officer, explained that public consultation was currently running on the latest version of the Southwark statement on licensing policy. The council was seeking the views of residents about licensing policy on matters including alcohol and regulated entertainment.

- Is the policy clear
- Is it fair and balanced
- Does it adequately deal with the licensing objectives of crime and disorder, protection, nuisance and the protection of children from harm.

Consultation runs until 30 March 2015.

#### **Charity Trustees**

Councillor David Hubber explained that from time to time the council had to appoint charity trustees. Volunteers were currently being sought to become trustees. A range of charities and level of involvement was available to volunteers. Anyone interested could apply by completing the application forms available at the meeting.

#### The Blue Bermondsey, Business Improvement District

Councillor Leo Pollak, explained that a major survey of the area was being launched. People in the area would be asked what type of shops and stalls they wanted to see in The Blue and on Southwark Park Road.

#### 8. COMMUNITY SAFETY UPDATE

Zander Gibson, Borough Commander presented.

#### Safer Neighbourhood Board

Commander Gibson explained that the Mayor's office for policing and crime (MOPAC) had required each borough to have a main conduit for engagement. That would be the Safer Neighbourhood Board (SNB). It replaces the police consultative group and links together all the ward panels. There were about 24 board members, most of those were from the community. Quarterly meetings would be held. At the start of each meeting there would be a one hour open forum session for members of the community to raise any concerns.

In response to questions, Commander Gibson made the following points:

- There had not yet been a meeting of the full SNB.
- Dates of meetings should be checked to avoid, where possible, meeting clashes.
- Each of the four clusters in Southwark would have a representative from their panels that would sit on the SNB.
- Each group of ward panels were asked to self select board members.
- There was a member from the multi-faith forum on the SNB.
- The continued feedback from the community was essential to tackle crime and that had been a key part of last week's operation that had followed 6-7 months of police work.

There was some disagreement from ward panel chairs present who said they had not been consulted about board membership at all.

Inspector Richard Auty was introduced as the new Inspector for the area. He explained that he had been a police officer in Southwark for three years. In response to a question on police numbers, Inspector Auty explained there had been some officer movements recently but there would remain an experienced ward officer along with a police community support officer (PCSO). There were currently 41 officers in the North East cluster who would be used where they were needed.

#### 9. TRANSPORT THEME ITEM

David McKenna, Transport for London (TfL), presented. He explained that he worked in the road space management directorate in connection with modifications to the road network. David made the following points:

- Several schemes on Tower Bridge Road were due to start within a month. One was safety improvements at the junction with Abbey Street, where a cyclist had died some time ago. Another was an upgrade to the footways. A diagonal crossing was planned for pedestrians at Bermondsey Square.
- Consultation was currently taking place on the Southwark Quietways cycle route in the area of Tower Bridge Road, Webb Street and Rothesay Street.
- TfL colleagues were working on Cycle Superhighway 4 in the area of Jamaica Road. There would be public consultation in due course.

In response to questions, David made the following points:

- An enhancement in the frequency of the 381 and 21 bus services routes had recently taken place. Usage would be monitored.
- Curtailments of the service can be frustrating and sometimes they happen due to road works or incidents. Some time curtailments happen when operators try to avoid bus bunching and followed by a long gap in the service.
- Driver training programmes dealt with handling of incidents of bad behaviour on buses. David said he would find out more specifics and report back.
- The work on the Abbey Street junction would take about eight weeks starting in February 2015.
- Jamaica Road presented challenges: Tower Bridge Road had the inner ring road and competing demands for green time at the signals, whilst at the other end the width restriction at the Rotherhithe roundabout was necessary to protect the structure of the tunnel but resulted in traffic queues.
- The Old Kent Road junction with East Street at the corner of the library was noted as an accident heavy area.
- A resident's concerns about buses with disability ramps that were faulty and so denied access to wheelchair users was noted. It would be fed back to TfL.
- David was aware of the proposed programme of works related to the Thames tunnel. Detailed discussions were taking place between TfL and Thames Water. TfL would be pushing Thames Water construction lorries to have the latest safety equipment including bleepers and signage as well as driver training. He agreed with the general safety concerns about the construction.

Councillor Mark Williams, cabinet member for regeneration, planning and transport explained that transport policy was about the council serving existing and future needs. He made the following points:

- A lot of work was done with TfL who controlled about 5% of the roads in Southwark as well as the overground and underground trains.
- Problems with certain buses including the C10, 381 and 415 in the area had been highlighted. Ward councillors and the assembly member had been lobbying TfL to improve the routes.

- The council had been lobbying the Government with other boroughs to push for TfL to run all train services coming into London. Unfortunately the Government turned the latest request down.
- Walking and cycling were being promoted by the council. They were sustainable and healthy methods of transport as well as often being the quickest way of getting around. The target was to double the number of cyclists whilst making it as safe and direct as possible.
- The Old Kent Road was not the best environment for pedestrians. The council had lobbied TfL for improvement works on the Old Kent Road.
- Future pressures on the transport system would flow from developments on the Rotherhithe peninsula at Surrey Quays. The council was looking at taking out the Lower Road gyratory and paid for by developments as a condition in the planning process. In Canada Water, the council wanted to improve the green links and cycle links.
- There was also pressure being put on TfL to get the tube extended from the Elephant & Castle down to Lewisham and Hayes. The council's position was for both routes through Southwark via Camberwell and Peckham and via the Old Kent Road.
- The council also supported the Brunel bridge project to link Rotherhithe peninsula to Canary Wharf but were not keen on the tolling of Silvertown tunnel and Blackwall tunnel, as that could lead to increased use of the Rotherhithe tunnel.

In response to questions, Councillor Williams made the following points:

- The removal of the gyratory on Lower Road was a key issue. Through the planning process there would be a lot of section 106 money from the Surrey Quays development which would be put towards that end.
- There was a council commitment to extend the cycle hire scheme and TfL had been lobbied about that. The council had offered to match fund expansion on capital costs but as yet TfL have not agreed. As each new large development comes forward in Southwark we are trying to get the developer to pay for cycle hire docking stations as part of those.
- Working with Lewisham to push on with development on their side of the border so that the Surrey Canal Road station can be built.
- The multi-modal study was a useful piece of work but things have moved on. It will feed in to the work being done by British Land with our transport planners and there will be new piece of work to take into account increased numbers of homes in the peninsula.
- The council are trying to push down the number of car spaces for new developments on the peninsula so dwellers use public transport and walking/cycling instead of cars.
- Re the neighbourhood forum, no decision has been made on the boundaries. The feedback from residents is that tenants groups on the western side of the peninsula were not supportive of a neighbourhood forum. However, those on the eastern side were more supportive. The council was meeting regularly with the proposed neighbourhood forum ahead of any formal decision on the boundary.
- The decision on the extension of the Bakerloo line was in the hands of the Mayor of London and TfL. The sooner the better so that funding mechanisms can be agreed and commitments made with central government and TfL.

Susannah Pettit, planning officer, presented the item.

#### **Revised Canada Water Area Action Plan 2013**

- The council are revising the area action plan (AAP) to put in place a policy framework to guide a redevelopment of Harmsworth Quays and take account of the implications of this for the wider area.
- The council consulted on the revised draft AAP in 2013 and 2014, and an examination in public was held at the beginning of October 2014.
- A further consultation would take place in spring 2015.
- A decision was expected in summer of 2015.

#### **Old Kent Road**

A 15 year area action plan (AAP) was taking shape and once agreed would be used to make decisions on planning applications. It would also be an opportunity area planning framework (OAPF) and would be endorsed by the Mayor of London.

- A new opportunity area has been designated by the Mayor around Old Kent Road and a strategy for growth in jobs and businesses
- Locations for housing, including new council homes
- New shopping and town centre facilities
- The designs and heights of buildings and spaces
- Improvements for pedestrians and cyclists, including new links and making existing routes safer
- Public transport improvements
- The infrastructure that would be needed to support growth, such as schools, open space and public realm, health and other community facilities

The plan was at an early stage. Officers had been out talking to businesses to gather information to be used for a business atlas.

#### 12. PUBLIC QUESTION TIME

The following public questions were asked at the meeting:

- Many people across the area, notably Rotherhithe and the Canada Estate, have 1 ongoing anxieties in regard to 'misrepresentation' and inappropriate motivation by existing tenants and residents associations (TRAs). Many residents have been actively 'discouraged' from voicing their concerns in the way their estates and blocks are being represented and feel bullying, intimidation and misrepresentation is pandemic. Please could you assure the floor that all residents – irrespective of being private or council tenants are - actively encouraged by Southwark Council to have a voice in the way their communities are being managed by the council. Councillor Livingstone responded, that as a council we want to encourage as much participation as possible. Different TRAs would have different constitutions about how they were represented within that estate. They might have individual block representatives or something less formal. All those constitutions had to be agreed with the council and SGTOs (Southwark groups of tenants organisations) are usually consulted as well. It's very important that the council ensures that the TRAs are representative. If residents had any complaints about their TRAs then they need to report those to be investigated.
- 2. The speed humps on Rotherhithe New Road, from the Bonamy estate to the Old Kent Road, are still creating noise when large lorries go over them early in the morning as well as in the evenings. Residents can hear the impact and the chains rattling along. The chair said he would ask officers to look into it.
- 3. A resident said that in Rotherhithe Street (Surrey Docks Farm end), near the new community hall, a fire engine had recently crashed into a car on its way to a fire. After dealing with the same fire, the fire truck couldn't get past the turning due to parked cars.
  Councillor David Hubber said he was hoping to have a meeting with developers / officers in the area soon which would look at the issue of parking in the whole area. It may be necessary to introduce parking restrictions to. Councillor Cryan added that the council were looking at controlled parking zones (CPZs) around Canada Water and the peninsula. Residents should advise of any suitable places they thought should have CPZs. If taken forward the schemes would be subject to resident consultation.
- 4. On Southwark Park Road the parking situation is atrocious. Traffic wardens park for several hours yet residents are restricted to 30 minutes. Who tickets them? The chair asked for this to be followed up with officers.
- 5. The Ship York public house had recently closed and has received planning permission for flats above it and a bistro where the pub used to be. Unfortunately, a group have gone in there and opened a shisha bar that children can look through the window and see the smoke. It had become a private function room and was bringing the area down. Councillor David Hubber said licensing officers had been there with the police and had difficulty entering as the doors were bolted. It was an increasing problem and some thing to watch out for it with any empty premises.

6. A resident flagged up the North Southwark Environment Trust as a source of funding. The trust helped fund a range of local projects and interested residents should look into the funding available if they had a project needing help.

#### **RECOMMENDATION**

1. That Bermondsey and Rotherhithe Community Council approve the re-allocation of a total of £38,168 to two projects in the 2014/2015 cleaner greener safer (CGS) capital programme, one project in the 2012/13 CGS capital programme and as part of the 2015/2016 programme, as set out in Appendix 1.

#### **BACKGROUND INFORMATION**

2. CGS is part of the London Borough of Southwark's capital programme. Between 2003 and 2014 £7.40m has been made available local residents in Bermondsey and Rotherhithe to apply for awards to make their local area a better place to live. The programme attracts hundreds of proposals ranging from a few hundred pounds for bulb planting to brighten up open spaces to tens of thousands of pounds to create community gardens. These projects often introduce new ideas such as outdoor gyms in public spaces, community gardens, public art and energy saving projects which not only make the borough cleaner, greener and safer but greatly contribute to a sustainable public realm by involving residents in the funding process and in the delivery of projects.

#### **KEY ISSUES FOR CONSIDERATION**

- 3. Appendix 1 highlights nine projects which have a total under spend of £37,820 and a recommendation for the reallocation of £348.00 between two existing projects.
- 4. It is recommended that the under spend of £3,900 from Spa Park outdoor gym, project reference [106230], is reallocated to projects where additional funding is required.
- 5. It is recommended that the under spend of £3,700 from the big Tower Bridge Road clean ip, project reference [105928], is reallocated to projects where additional funding is required.
- 6. It is recommended that the under spend of £6,450 from Bermondsey Boer War memorial restoration, project reference [103958], is reallocated to projects where additional funding is required.
- 7. It is recommended that the under spend of £1,500 from re-design Cherry

- Gardens, project reference [105443], is reallocated to projects where additional funding is required.
- 8. It is recommended that the under spend of £16,000 from Frean Street lighting, project reference [105933], is reallocated to projects where additional funding is required.
- 9. It is recommended that new ceiling for Wade Hall, project reference [105932], is cancelled and the grant of £1,000 is reallocated to projects where additional funding is required. The works were undertaken by local residents at no cost and the funding is no longer required.
- 10. It is recommended that citizens advice bureau shop windows, project reference [105541] is cancelled and the grant of £370 is reallocated to projects where additional funding is required. The citizens advice bureau no longer intend to undertake the works and the funding is no longer required.
- 11. It is recommended that the under spend of £3,700 from Shuttleworth Park lighting, project reference [105841], is reallocated to projects where additional funding is required.
- 12. It is recommended that the under spend of £1,200 from Rennie and Manor Estate notice board, project reference [106422], is reallocated to projects where additional funding is required.
- 13. It is recommended that £348.00 from Whites Grounds information board, grant reference [105533], is reallocated to Whites Grounds/Tyers in bloom, grant reference [105532], for the plaque for the community sculpture installed as part of this project.
- 14. It is recommended that Riverside ward allocate £9,950 to Bermondsey hanging baskets, project reference [106468] to continue the annual hanging basket contract through 2014/2015.
- 15. It is recommended that £1,800 is reallocated to St Crispins MUGA netting, project reference [106410]. This project was awarded £3,900 in 2014/2015. Quotations for the proposed work are in excess of the original budget. The additional funding will allow the replacement of the existing damaged netting to proceed.
- 16. It is recommended that the remaining £26,070 is reallocated as part of the 2015/2016 CGS programme.

### **Community impact statement**

18. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.

- 19. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The CGS programme is an important tool in achieving community participation.
- 20. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been give to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decision to the need to:
  - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct:
  - b. Advance of equality of opportunity between persons who share a relevant protected characteristics and those who do not share it;
  - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
- 21. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
- 22. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
  - a. Remove or minimise disadvantages connected with a relevant protected characteristic:
  - b. Take steps to meet the different needs of persons who share a relevant protected characteristic;
  - c. Encourage persons who share a relevant protected characteristic to participate in public life or any other activity in which they are underrepresented.

#### **Resource implications**

- 23. This is the reallocation of existing CGS funding that was originally awarded in 2010/2011, 2012/2013, 2013/2014 and 2014/2015. CGS funding is devolved to community councils to spend on suitable projects.
- 24. All professional fees related to the project are also treated as the capital costs of the project. Where projects are awarded as a grant to organisations, the community council award letter will not include the professional fees which will be charged direct to project costs.
- 25. CGS projects must be completed within two years of award of funding. Projects that are unlikely to be completed within two years will be reported to community council and available budgets may be reallocated to other projects. Revenue costs not covered by maintenance or the contractual liability period will fall upon the asset owner. The business unit will be notified of the likely costs before the schemes proceeds, in order to secure permission to implement the scheme.
- 26. After the defects and liability period, or three year maintenance period in the case of planting works, all future maintenance is assumed by the asset owner, for example housing, parks, highways, or in some cases external asset owners. Therefore, there are no revenue implications to the public realm projects business unit as a result of approving the proposed allocation.

27. The total expenditure and sources of funding for the scheme will be monitored and reported on as part of the overall capital programme.

#### Consultation

28. All CGS projects require consultation with stakeholders, including the project applicant, local residents and tenants and residents associations where appropriate.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Director of Legal Services**

- 29. The allocation of the CGS capital fund is an executive function, delegated by the leader to community councils.
- 30. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the leader.
- 31. This report is recommending that the Bermondsey and Rotherhithe Community Council approve the reallocation of available funds from the 2010/2011, 2012/2013, 2013/2014 and 2014/2015 programme as specified at appendix 1 to the 2014/2015 capital funding allocation. The power for this function is derived from Part 3H paragraph 11 of the constitution which states that community councils have the power of "approval of the allocation of funds to cleaner, greener, safer capital and revenue schemes of a local nature, using the resources and criteria identified by the cabinet".
- 32. The cabinet member for transport environment and recycling approved the funding for the 2010/2011 programme in October 2009, the 2012/2013 programme in October 2011, the 2013/2014 programme in September 2012 and the 2014/2015 programme in October 2013 by exercising his powers under Part 3D paragraph 2 of the constitution. Where funding needs to be reallocated the community council approval being sought here is therefore the appropriate constitutional step in the process.
- 33. Community council members also have powers under paragraph 12 of Part 3H of the constitution to oversee and take responsibility for the development and implementation of the local schemes.
- 34. In allocating funding under the CGS community councils must have regard to the council's equality duty set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties need to be considered in the body of the report at paragraphs 14 to 17 in the community impact statement.

#### **Strategic Director of Finance and Corporate Services**

- 35. The report requests the approval of Bermondsey and Rotherhithe Community Council for the re-allocation of a total of £38,168 to projects in the 2014/2015 and 2015/2016 CGS programmes, as set out in Appendix 1.

#### RECOMMENDATION

1. That the Bermondsey and Rotherhithe Community Council allocates a total of £205,664 of the neighbourhoods Fund 2015/16 from the list of applications outlined in Appendix 1. This amount consists of two elements, namely £165k available for 2015/16 and £40,664 of unallocated funding carried forward from previous years revenue programmes, known as cleaner, greener, safer revenue (CGS revenue) and community council fund (CCF).

#### **BACKGROUND INFORMATION**

- 2. The neighbourhoods fund is a new funding programme, which was created by the merger of two former revenue programmes known as CGS revenue and CCF.
- 3. The CGS revenue fund was established in February 2012, initially consisting of £210,000 borough-wide funding budget with an allocation of £10,000 per ward. In February 2013, council assembly agreed to increase the funding programme to £420,000, each ward receiving £20,000.
- 4. The purpose of introducing the CGS revenue fund in 2012 was to give community councils decision making powers over significant amounts of revenue funding, that they could allocate to meet locally determined priorities, and also to enhance and complement the effectiveness of the CGS capital funding programme.
- 5. Community councils also took decisions on the CCF and awarded revenue grants of between £100 and £1,000 for community projects. The total fund available boroughwide for projects in 2014/15 amounted to £122,000.
- 6. Both the CGS revenue and CCF will cease on 31 March 2015 as separate funding programmes and will be replaced by a single neighbourhoods fund. During the 2015-16 budget setting process, a further £88,000 was allocated to the neighbourhoods fund, bringing the allocation per ward to £30,000. The criteria for the new fund will, in the main, remain the same as previous programmes but have been streamlined to reflect the new brand.

#### **KEY ISSUES FOR CONSIDERATION**

7. The cabinet member for communities, employment and business authorised the amalgamation the CGS revenue fund and CCF, into a single funding programme to create a new neighbourhoods fund for the 2015-16 round and onwards. This decision (IDM) was taken on 12 December 2014.

- 8. Each ward will have £30,000 of revenue grants to allocate. It is proposed that any unallocated funds from both CGS revenue and CCF are to be carried forward from previous rounds (years) and added to the financial year commencing 1 April 2015.
- 9. The community councils will use the criteria set out below for the allocation of this funding.
  - a. Creating opportunities for people from different backgrounds to get on well together; (e.g. community cohesion)
  - b. Establishing projects which treat each other with respect and consideration (e.g. being a good neighbour, inter-generational contacts)
  - c. Encouraging residents to be responsible for their own neighbourhood (e.g. community clean-ups; volunteering initiatives)
  - d. Specific measures to enhance a neighbourhood's environment (e.g. increased cleaning)
- 10. A community council may choose to allocate some of their neighbourhoods fund resources to their CGS capital allocations.
- 11. Subject to the availability of resources, the neighbourhoods fund may be used to 'buy' services from the council.
- 12. As with any executive decision taken by community councils this is subject to the council's existing scrutiny arrangements.

#### **Community impact statement**

However, in making the area a better place to live and improving life chances for local people, Bermondsey and Rotherhithe neighbourhoods fund activities will have an impact on the whole of Southwark.

- 17. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been given to the council's duty under the Equality Act 2010 which requires the council to have due regard when taking decisions to the need to:
  - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct;
  - b. Advance of equality of opportunity between persons who share a relevant protected characteristic and those who do not share it
  - c. Foster good relations between those who share a relevant characteristic and those that do not share it.

- 18. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation. In this process there are no issues that contravene the Equality Act 2010.
- 19. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
  - Remove or minimise disadvantages connected with a relevant protected characteristic.
  - Take steps to meet the different needs of persons who share a relevant protected characteristic.
  - Encourage persons who share a relevant protected characteristic participate in public life or any other activity in which they are under- represented.
  - Due consideration was given to equalities impact assessment during the design of this awards process and no adverse impact was evident.

#### Consultation

21. Neighbourhoods fund projects may require consultation with stakeholders, including the project applicant, local residents and tenants and residents associations where applicable.

#### **Financial implications**

- 22. The Bermondsey and Rotherhithe neighbourhoods fund has been allocated a total of £165,000 for 2015/16. In addition to this, funds totaling £40,664 remain unallocated from previous years' allocations and thus also available to allocate.
- 23. It is recommended that community councils set aside some of the unallocated funds from previous years in order to prevent an over allocation of funds, as well as act as a contingency from which urgent or incidental requests can be funded throughout the year. It must also be noted that the unallocated figures reported in the previous paragraph represent current best estimates as the 2015/16 funding round is only finally over on 31 March 2015.
- 24. Projects that are unlikely to be completed within the year will be reported to the community council and available funding may be allocated to other projects or carried over to the following financial year.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Director of Legal Services**

- 25. The Local Government Act 2000 ('the 2000 Act') gives the leader the power to delegate any executive function to whoever lawfully can undertake the function. The allocation of the neighbourhoods fund is an executive function.
- 26. Community councils are 'area committees' within the meaning of the 2000 Act and

- executive functions can be delegated to them by the Leader.
- 27. The Localism Act 2011 gives councils a general power of competence whereby they have power to do anything that individuals generally may do. This power can be used even if legislation already exists that allows a local authority to do the same thing. However the general power of competence does not enable a local authority to do anything which is was restricted or prevented from doing under the previous legislation.
- 28. The general power of competence includes the power to:
  - (a) incur expenditure
  - (b) give financial assistance to any person
  - (c) enter into arrangements or agreements with any person
  - (d) co-operate with or facilitate or co-ordinate the activities of any person
  - (e) exercise on behalf of any person any functions of that person; and
  - (f) provide staff, goods, services or accommodation to any person.
- 29. The provision of funding under the neighbourhoods fund falls within the scope of the kind of activities the council can undertake under the general power of competence as this includes the power to give financial assistance to any person.
- 30. In allocating funding under the neighbourhoods fund community councils must have regard to the council's equality duties set out in section 149 of the Equality Act 2010. ## **Strategic Director of Finance and Corporate Services**

31. The 2015/16 budget allocation for the new Neighbourhoods fund has been agreed by council assembly. It stands at £30,000 per ward and thus £165,000 has been awarded to Bermondsey and Rotherhithe community council. A further £40,000 has been carried forward from previous years and is thus also available for allocation.

#### RECOMMENDATIONS

- 1. It is recommended that the following local traffic and parking amendments, detailed in the appendices to this report, are approved for implementation subject to the outcome of any necessary statutory consultation and procedures
  - Ilderton Road install a loading only bay on Penarth Street to service recently redeveloped building on Ilderton Road.
- 2. It is recommended that the community council consider the following local traffic and parking amendment and resolve whether to approve it for implementation, subject to the outcome of any necessary statutory consultation and procedures:
  - Bermondsey Wall East removing an existing solo motorcycle parking bay.

#### **BACKGROUND INFORMATION**

- 3. Part 3H of the Southwark constitution delegates decision making for nonstrategic traffic management matters to the community council.
- 4. Paragraph 16 of Part 3H of the Southwark constitution sets out that the community council will take decisions on the following local non-strategic matters:
  - the introduction of single traffic signs
  - · the introduction of short lengths of waiting and loading restrictions
  - the introduction of road markings
  - the setting of consultation boundaries for consultation on traffic schemes
  - the introduction of destination disabled parking bays
  - statutory objections to origin disabled parking bays.
- 5. This report gives recommendations for two local traffic and parking amendments, involving traffic signs, waiting restrictions and road markings.
- 6. The origins and reasons for the recommendations are discussed within the key issues section of this report.

#### **KEY ISSUES FOR CONSIDERATION**

#### **Ilderton Road / Penarth Street**

- 7. The council was contacted by the developers of 180 Ilderton Road, V22 London Ltd, requesting loading facilities in Penarth Street and Hatcham Road to service the redeveloped building which has recently been subdivided into artists' studios.
- 8. Penarth Street and Hatcham Road are part of self-contained group of streets surrounding an industrial estate off Ilderton Road.
- 9. Parking is prohibited on junctions and narrow sections of the street (or adjacent to vehicle crossovers) to ensure the free flow of traffic and to maintain legal access to off-street parking and loading areas. The remaining lengths of kerb are free and unrestricted but have high levels of parking occupancy.
- 10. The high demand for parking space reduces opportunity for loading and unloading into those premises that do not have off-street provisions.
- 11. An officer met with a representative from the developers on site, 13 February 2015, to discuss potential options for a convenient loading facility for the studios at 180 Ilderton Road. It was noted that:
  - kerb space should be prioritised in favour of loading/unloading above general unrestricted parking for reasons of good parking management and health and safety (this principle is established in adopted council policy in the Parking Hierarchy)
  - the two main entrances to the studios are on Penarth Street and at the junction of Penarth Street and Ilderton Road (as shown on plan).
  - locations for a possible loading bay were considered on Hatcham Road and Penarth Street
  - if a loading bay was installed it could be used by used by anyone, as it would be situated on the public highway.
- 12. The developer explained that demand for a loading facility would be between Monday and Saturday and between 10am and 7pm as this loading only bay will be available for all businesses it is recommended that the bay operates at any time with a max stay of 1 hour.
- 13. In view of the above it is proposed, as shown in appendix 1, that an at any time loading only bay is installed in Penarth Street adjacent to the junction with Hatcham Road so that is can service the two main entrances to the building as well as surrounding industrial and commercial premises.

### **Bermondsey Wall East**

- 14. The Cherry Gardens Pier Residents Group contacted the council with concerns regarding the early morning noise made by motorcycles using the existing solo motorcycle bay on Bermondsey Wall East.
- 15. Bermondsey Wall East is part of the Bermondsey (G) controlled parking zone which operates Monday to Friday 8.30am 6.30pm, the street is primarily residential. There is access to the river via Cherry Gardens Pier.

- 16. The existing parking arrangements for this section of Bermondsey Wall East are a combination of permit holders (G) parking bay, a solos motorcycle bay outside Nos.144 -154, loading only bay adjacent to Cherry Gardens Pier and double and single yellow lines
- 17. Cherry Garden Pier Residents Group wrote and explained that motorcycle noise has been an issue for some time. They have provided 'an indicative log' (Appendix 2) of times and dates that disturbances have taken place during the period September to November 2014. In their correspondence they have told us that:
  - motorcycles that arrive during the night cause a disturbance
  - arrivals mostly occur between midnight and 1am or between 5am and 6am
  - they believe that the motorcycle owners are employees of City Cruises
  - the group have contacted Southwark Council's noise and nuisance team on a number of occasions who most recently advised them to speak directly to City Cruises to ask if their staff could be more considerate;
  - They have spoken directly to a motorcycle rider about the noise and whose response was 'quite threatening'.
- 18. It is not possible for highway project officers to verify many of the details of the complaint, however we have confirmation by the noise and nuisance team that complaints have been made and investigated. The noise and nuisance team did not pursue these complaints as the motorcycles were parked in a bay designated for motorcycles.
- 19. It has been suggested that the motorcycle bay is deleted from Bermondsey Wall and re-provided in Fulford Street as this location does not have any residential frontages and therefore the noise will not be a nuisance. Whilst this option is legally open to the council, as traffic authority, it does have limitations and disadvantages as follows:
  - The parking zone only operates Mon-Fri 8.30am to 6.30pm. Outside of those hours anyone (including motorcyclists) can park in the permit bays or single yellow lines. It will therefore be ineffective in dispersing the problem if vehicles are parked outside out of zone hours.
  - Relocating the bay to a location is not overlooked may compromise motorcycle security
  - Local residents who use the motorcycle bay may be disadvantaged by the bay's removal (although they may apply for a resident permit to park within the permit bays)
  - There is another motorcycle bay in Paradise Street that is closer to Bermondsey Wall East than Fulford Street so logically motorcycles would displace there instead. This bay is also located outside a residential apartment block.
- 20. In view of the above, as shown in Appendix 3, it is recommended that the community council give consideration to removing the motorcycle bay from Bermondsey Wall East (and not providing a new facility in Fulford Street) so as to reduce the reported noise nuisance to local residents.

#### **Policy implications**

21. The recommendations contained within this report are consistent with the

polices of the Transport Plan 2011, particularly

Policy 1.1 – pursue overall traffic reduction

Policy 4.2 – create places that people can enjoy.

Policy 8.1 – seek to reduce overall levels of private motor vehicle traffic on our streets

### **Community impact statement**

- 22. The policies within the transport plan are upheld within this report have been subject to an equality impact assessment.
- 23. The recommendations are area based and therefore will have greatest affect upon those people living, working or traveling in the vicinity of the areas where the proposals are made.
- 24. There is a risk that new restrictions may cause parking to be displaced and, indirectly, have an adverse impact upon road users and neighboring properties at that location. However this cannot be entirely preempted until the recommendations have been implemented and observed.
- 25. With the exception of those benefits and risks identified above, the recommendations are not considered to have a disproportionate effect on any other community or group.
- 26. The recommendations support the council's equalities and human rights policies and promote social inclusion by:
  - Providing improved access for key services such as emergency and refuge vehicles
  - Improving road safety, in particular for vulnerable road users, on the public highway.

#### **Resource implications**

27. All costs arising from implementing the recommendations will be fully contained within the existing public realm budgets.

### Legal implications

- 28. Traffic Management Orders would be made under powers contained within the Road Traffic Regulation Act (RTRA) 1984.
- 29. Should the recommendations be approved the council will give notice of its intention to make a traffic order in accordance with the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996.
- 30. These regulations also require the council to consider any representations received as a result of publishing the draft order for a period of 21 days following publication of the draft order.
- 31. Should any objections be received they must be properly considered in the light of administrative law principles, human rights law and the relevant statutory powers.

- 32. By virtue of section 122, the council must exercise its powers under the RTRA 1984 so as to secure the expeditious, convenient and safe movement of vehicular and other traffic including pedestrians, and the provision of suitable and adequate parking facilities on and off the highway.
- 33. These powers must be exercised so far as practicable having regard to the following matters
  - a) the desirability of securing and maintaining reasonable access to premises
  - b) the effect on the amenities of any locality affected including the regulation and restriction of heavy commercial traffic so as to preserve or improve amenity
  - c) the national air quality strategy
  - d) facilitating the passage of public service vehicles and securing the safety and convenience of their passengers
  - e) any other matters appearing to the council to be relevant.

#### Consultation

- 34. Where public or stakeholder consultation has already been completed, this is described within the key issues section of the report.
- 35. The implementation of changes to parking requires the making of a traffic order. The procedures for making a traffic order are defined by national Regulations which include statutory consultation and the consideration of any arising objections.
- 36. Should the recommendations be approved the council must follow the procedures contained within Part II and III of the Regulations which are supplemented by the council's own processes. This is process is summarised as:
  - publication of a proposal notice in a local newspaper (Southwark News)
  - publication of a proposal notice in the London Gazette
  - display of notices in roads affected by the orders
  - consultation with statutory authorities
  - making available for public inspection any associated documents (eg. plans, draft orders, statement of reasons) via the council's website or by appointment at 160 Tooley Street, SE1
  - a 21 day consultation period during which time any person may comment upon or object to the proposed order
- 37. Following publication of the proposal notice, any person wanting to object must make their objection in writing, state the grounds on which it is made and send it to the address specified on the notice.
- 38. Should an objection be made that officers are unable to resolve so that it is withdrawn, it will be reported to the community council for determination. The community council will then consider whether to modify the proposals, accede to or reject the objection. The council will subsequently notify all objectors of the final decision.

## **Programme timeline**

- 39. If these items are approved by the community council they will progressed in line with the below, approximate timeframe:
  - Traffic orders (statutory consultation) May to June 2015
  - Implementation July to August 2015





#### **RECOMMENDATION**

1. That the community council comment upon the consultation areas detailed in paragraphs 12 to 24 along with the consultation methods detailed in paragraphs 25 to 26.

### **BACKGROUND INFORMATION**

- 2. Part 3D of the Southwark constitution sets out that decisions relating strategic transport issues, including parking zones, are a matter for decision by the relevant cabinet member.
- 3. Part 3H of the Southwark constitution identifies that the community council should be consulted on strategic transport decisions, such as the method of consultation and whether to create a new parking zone.
- 4. This report is presented to the community council for the purposes of consultation on the boundary and method of a strategic parking project.

#### **KEY ISSUES FOR CONSIDERATION**

### **Project scope**

- 5. The council plan to carry out three highway parking projects as follows:
  - A. Combined 1<sup>st</sup> and 2<sup>nd</sup> stage parking zone consultation on the principle and detail of a possible new zone in:
    - i) Five streets off Lower Road (Appendix 1)
    - ii) Two streets off existing H CPZ (Appendix 2)
  - B. Southwark Park consult upon the proposal to introduce a time limit on parking in the carpark and road through the park.
  - C. Review parking layouts in Canada Street and Quebec Way.

## Primary aims of parking zones

- 6. Improve availability of parking spaces: Give priority to certain groups i.e. residents and their visitors, loading and business short-stay parking over and above commuter parking (see parking hierarchy, Appendix 3).
- 7. Reduce overall traffic levels: Parking, by definition, is preceded by a trip and the

- council has a clear policy to reduce traffic levels with the aim of reducing congestion, improving air quality and amenity and to encourage sustainable transport modes (walking/cycling) by deterring non-essential journeys.
- 8. Improve road safety and smooth traffic flow: Zones reduce the level of parking occupancy and provide natural passing spaces enabling pedestrians to cross the street more safely and for vehicles to pass one another more easily.
- 9. Reduce parking demand such that streets can be used for purposes other than just parking such as tree planting or on-street cycle parking: Studies have also shown that streets with lower levels of traffic have a positive effect on social interaction.
- 10. Assist control on future development (enabling planning department to make new developments parking permit exempt).

## History of parking zones in the area

11. The recommended consultation area has been consulted previously and is adjacent to other, existing parking zones that have been amended on a number of occasions, as outlined in Figure 2.

#### **Consultation areas**

#### Parking zone consultation areas (street off Lower Road and Zone H)

- 12. The two areas recommended for consultation are identified in maps contained in Appendix 1 and Appendix 2. The surrounding CPZs (and non-CPZ areas) are also shown on the maps.
- The areas recommended reflect:
  - A. correspondence (see paragraphs 15 to 18)
  - B. a logical grouping of streets that adjoin the existing, neighbouring parking zones
  - C. parking policy
  - D. the origin and purpose of the highway project funding a section 106 (s106/137053) commitment to undertake a parking study in the area, associated with planning permission granted for Canada Water Site A (09-Ap-1870).
- 14. Note that the project relates only to the public highway and not to any Housing estate carparks or roads.
- 15. Requests from the public to introduce a parking zone, or to consult upon the introduction thereof, are one indicator that assists in the development of proposals.
- 16. Where requests are geographically concentrated it is likely to indicate:
  - A. some degree of broad public support to prioritise parking
  - B. 'parking stress' (where demand for parking is approaching or exceeding the available supply)
- 17. It is important that requests should only be used as an indicator and these are no substitute for a proper consultation. Research has shown that "customers very rarely complain to the service/ product provider. Instead they will tell their friends, who will in turn tell their friends, creating a pyramid of dissatisfaction." Equally, those members of the public who do not consider there to be a problem are fairly unlikely to write to the council to ask to keep the status quo.
- 18. The council collates requests for parking zone consultations in a map system to assist in the identification of patterns that may be more localised than street level, especially where they originate from a long road which may have different parking characteristics are different ends. In the interests of data protection this information is presented in Appendix 4 in a table format.

#### Southwark Park consultation area

- 19. The project originates from a request by Parks and Open Spaces officers to review parking within Southwark Park. This includes the road that runs between Gomm Gate and Southwark Park Road Gate, as well as the carpark off Hawkstone Road.
- 20. The general scope of the project is to consider the introduction of a time limit for parking in these areas. This is being considered to ensure turn-over of space and to prevent all-day parking by non-park using motorists. This will give genuine visitors to the park greater opportunity to find a parking space.

21. There will not be a specific letter drop to a defined area for this project as it is a public park with visitors from a wide area. There will, however, be notices installed within the park and direct consultation will take place with the Friends of Southwark Park.

#### Review of existing parking arrangements in Canada Street and Quebec Way

- 22. Parking in these streets is mostly controlled by waiting restrictions (double yellow lines) to ensure the safe movement of traffic. There are, however, some unrestricted lengths of kerb where free parking can take place.
- 23. At this stage permit parking bays do not seem viable and therefore this area has not been included within the scope of the above parking zone project outlined in paragraphs 12 to 18.
- 24. The project will review these unrestricted lengths in the context of future development due to take place adjacent to the highway. It is anticipated that this may lead to a further consultation on the introduction of further parking changes.

#### Consultation methods for the parking zones and Southwark Park projects

- 25. The method of consultation and decision making is fundamentally determined by the council constitution and the strategic transport decision making process (Appendix 5).
- 26. Parking zone consultations follow a standard process that was established in the Parking and Enforcement Plan and is summarised in Figure 1 as published on the council's website.

- 29. The recommendations are area based and therefore will have greatest affect upon those people living, working or traveling in the vicinity of the area where the proposals are made.
- 30. The implementation and operation of a parking zone contributes to an improved environment through the elimination of on-street commuter parking and the associated reduction of local and borough-wide traffic volumes.
- 31. The introduction of yellow lines at junctions gives benefit to all road users through the improvement of inter-visibility and therefore road safety. This is being recommended separately on today's agenda for this area as part of the council's local parking amendment programme.
- 32. There is a risk that new restrictions may cause parking to be displaced and, indirectly, have an adverse impact upon road users and neighboring properties at that location. However this cannot be entirely preempted until the consultation is completed and any resulting recommendations implemented and observed.
- 33. The consultation leaflets will meet communication guidance with a languages page with advice of how to access the council's translation services. Large format leaflets will be available for those with visual impairment.
- 34. With the exception of those benefits and risks identified above, the recommendations are not considered to have a disproportionate effect on any other community or group.
- 35. The recommendations support the council's equalities and human rights policies and promote social inclusion by:
  - Providing improved access for key services such as emergency and refuge vehicles.
  - Improving road safety, in particular for vulnerable road users, on the public highway.
  - Prioritising parking to those who most need it, in accordance with the council's parking hierarchy.

#### **Resource implications**

- 36. The cost of the project and implementation (if supported) of the parking zone will be met from a contribution established for this purpose in a section 106 agreement (s106/137053) associated with planning permission granted for Canada Water Site A.
- 37. The costs of the Southwark Park consultation and implementation (if supported) will be met by the parks and opens spaces business unit.
- 38. A better estimate of the costs and potential parking income from this scheme will be reported at the end of the consultation.
- 39. Details of future consultation are contained within the body of this report.







#### RECOMMENDATION

1. It is recommended that local traffic and parking amendments relating to the reinstatement of double yellow lines at the corner of Stanworth Street and Millstream Road, Bermondsey are approved for implementation.

#### **BACKGROUND INFORMATION**

- 2. Part 3H of the Southwark constitution delegates decision making for nonstrategic traffic management matters to the community council.
- 3. Paragraph 16 of Part 3H of the Southwark constitution sets out that the community council will take decisions on the following local non-strategic matters:
  - the introduction of single traffic signs
  - the introduction of service road markings
  - the setting of consultation boundaries for consultation on traffic schemes
  - the introduction of disabled parking bays
  - statutory objections to origin disabled parking bays.
- 4. This report recommends the re-instatement of double yellow lines at the corner of Stanworth Street and Millstream Road, Bermondsey.
- 5. The origins and reasons for the recommendations are discussed within the key issues section of this report.

#### **KEY ISSUES FOR CONSIDERATION**

- 6. Stanworth Street, immediately east of its junction with Millstream Road is housing estate land for a distance approximately 25m (Appendix 1 and Appendix 2).
- 7. The council's corporate estate boundary does not reflect the red line of the title plan, see black line (Appendix 3).
- 8. The council's corporate estate boundary is therefore incorrect for the purposes of traffic management.
- 9. In view of this inaccuracy, we did not survey or make a housing estate traffic

- order (as part of the wider project in 2012) for this service estate road.
- 10. The council has received complaints from an adjacent lessee in the rail arches, sighting there is a gap in the yellow lines and vehicles constantly park there. This is not only obstructive for pedestrians (as the footway is narrow) but is also dangerous due to its proximity to a junction.
- 11. Due to confusion over land ownership this area has been overlooked by Housing and Highways in the past.
- 12. The council boundary does not match the title boundary to avoid any confusion in the future.

#### **Community impact statement**

- 13. The recommendations are area based and therefore will have greatest affect upon non-residents and non-visitors of those areas where the proposals are made.
- 14. The benefits of re-instating double yellow lines at the corner of Stanworth Street and Millstream Road will be the removal of danger related to parking due to its proximity to a junction, and the obstruction removed for pedestrians due to a narrow footway.
- 15. With the exception of those benefits and risks identified above, the recommendations are not considered to have a disproportionate affect on any other community or group.
- 16. The recommendations support the council's equalities and human rights policies and promote social inclusion by:
  - Providing improved access for key services such as emergency and refuge vehicles.
  - Improving road safety, in particular for vulnerable road users, on the public highway.

#### **Resource implications**

17. All costs arising from implementing the recommendations will be fully contained within the existing public realm budgets.

#### Legal implications

- 18. Traffic Management Orders would be made under powers contained within the Road Traffic Regulation Act (RTRA) 1984.
- 19. Should the recommendations be approved the council will give notice of its intention to make a traffic order in accordance with the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996.
- 20. These regulations also require the council to consider any representations received as a result of publishing the draft order for a period of 21 days following publication of the draft order.

- 21. Should any objections be received they must be properly considered in the light of administrative law principles, human rights law and the relevant statutory powers.
- 22. By virtue of section 122, the council must exercise its powers under the RTRA 1984 so as to secure the expeditious, convenient and safe movement of vehicular and other traffic including pedestrians, and the provision of suitable and adequate parking facilities on and off the highway.
- 23. These powers must be exercised so far as practicable having regard to the following matters
  - a) the desirability of securing and maintaining reasonable access to premises
  - b) the effect on the amenities of any locality affected including the regulation and restriction of heavy commercial traffic so as to preserve or improve amenity
  - c) the national air quality strategy
  - d) facilitating the passage of public service vehicles and securing the safety and convenience of their passengers
  - e) any other matters appearing to the council to be relevant.

#### Consultation

- 24. No informal (public) consultation has been carried out.
- 25. Consultation with stakeholders is not required, as no yellow lines were in place.
- 26. Should the community council approve the items, statutory consultation will take place as part of the making of the traffic management order. The process for statutory consultation is defined by national regulations.
- 27. The council will place a proposal notice in proximity to the site location and also publish the notice in the Southwark News and the London Gazette.
- 28. The notice and any associated documents and plans will also be made available for inspection on the council's website or by appointment at its 160 Tooley Street office.
- 29. Any person wishing to comment upon or object to the proposed order will have 21 days in which do so.
- 30. Should an objection be made that officers are unable to informally resolve, this objection will be reported to the community council for determination, in accordance with the Southwark constitution.




