2.1 The chair announced that there is a late and urgent item for SlaM Place of Safety proposal - item 11 on the supplemental agenda.

5. INTERVIEW WITH THE CABINET MEMBER FOR ADULT CARE AND FINANCIAL INCLUSION

The interview with the Cabinet Member for Adult Care and Financial Inclusion, Councillor Stephanie Cryan, took place on the following themes:

- 1. Update on Tower Bridge Care Home, Burges Park and Camberwell Green care homes. Since lifting, or partially lifting, the embargo on Tower Bridge and Burgess Park care homes what has happened? How many residents, if any, remain at Camberwell Green care home since the recent planned closure? (a briefing on this has been provided, and was published under item 9 of the agenda)
- 2. Council Home Care provider's attitude with regard to not providing pay slips to personal assistants

On this item the cabinet lead responded that as a result of a member raising a concern on this matter the council had contacted Care Direct, who are a spot provider of care services rather than a council contractor - Care Direct have said that they do provide hard copies of payslips, and can provide duplicates to employees by contacting a local branch.

3. Council tax adult social care precept

The cabinet member said this will be introduced. £1.7 million pounds will be raised by the precept but £33 million projected cut will need to be made due to cuts to the council budget.

RESOLVED

The proposal from SLaM to introduce a centralised Place of Safety will be treated as a Substantial Variation. Southwark will contact other affected boroughs to see if they wish to constitute a Joint Health Overview & Scrutiny Committee.

Hospital Discharges – Southwark

Southwark Hospital Integrated Discharge (HID) teams have one of the lowest rates of delayed discharges in London and across the country.

The table below indicates the achievements of Southwark HID in comparisons to other London Boroughs. Southwark LA has been below both Lambeth and London levels in every month of 2015/16.

HID Teams operate a 7 day a week service to enable safe discharge of patients at weekends. The HID teams liaise with the wards to identify and resolve issues which are likely to cause a delay in discharge. The team ensure that the right level of support is offered in a way which maximises the person's strengths and abilities. The team also work in partnership with health professionals to ascertain the long term needs of patients in advance of their discharge.

The team work with Care Brokers to locate appropriate residential placements for patients who require a higher level of support. The HID Team have commissioned two 'step down flat's which are used to provide interim period of rehabilitation outside of the confines of a hospital or care home. This has provided a period of additional support to patients who are medically fit to leave hospital but need a period of more intensive support that can not be facilitated in their own home. These temporary placements have on average saved approximately 5 to 10 bed days per person.

The majority of Delayed discharges are the result of difficulties in locating nursing home placements due to a national shortage of nursing home provision.
