5. MINUTES

RESOLVED:

That the minutes of the meeting held on 11 July 2016 be agreed as a correct record of that meeting.

6. YOUNG PEOPLE IN CAMBERWELL

Councillor Victoria Mills, cabinet member for children and schools, introduced the theme item. Councillor Mills highlighted some of the good things available for young people in Southwark:

- Local schools have seen a big improvement in the last 6-10 years. 91% of Southwark schools are regarded by Ofsted as good or outstanding
- More of our young people are going to university
- The council has created 400 new apprenticeships in the last year alone
- Investment and regeneration in the area means that more people were employed in Southwark than at any time in the current or last century
- The council's youth fund had created a range of opportunities for local young people, including scholarships to university or paying education maintenance allowance.

The council was committed to protecting the most vulnerable young people of Southwark and had ring fenced council spending on children's social care. Councillor Mills asked for the views of young people on what would make them happy, healthy, active and safe. Also, what would prepare them for the future they wanted and what should the council be prioritising to that end.

Dog Kennel Hill Adventure Playground

The manager of the Dog Kennel Hill Adventure Playground (DKHAP) explained that DKHAP had arranged play and youth provisions in the community for decades and had seen generations grow up using the facilities. There was a great need in the area to continue with those provisions. DKHAP offered young people a wide variety of different experiences in arts & crafts, sports and gardening. He said it was integral to children's development and it catered for children ranging in ages from 5 – 15, though older ones return to volunteer.

Kate, a play worker, explained that she had been working for about 17 years as a play worker and at DKHAP for about eight years. She had seen in recent years in other boroughs the available facilities change and not be so focused on play. Yet DKHAP was unique and maintained its play focus which was very important.

Young people in attendance gave examples of the various activities they had enjoyed at DKHAP. These included: sports tournaments, cooking and outdoor play. They explained the playgrounds were essential as they gave them something positive to do in an environment that felt like their own. They described it as a place that was close to their

hearts.

Health & Wellbeing of Young People in Camberwell

Kirsten Watters, consultant in public health, gave a presentation.

Young and diverse borough

- 68,542 under 20 years old
- Over 50% of the young population are in the 1-9 year old age group
- 66% of the population under 20 are BME.

High but falling levels of deprivation

- Southwark ranks 9th in London and 18th in England against the child poverty index
- 28% of children and young people in Southwark are living in poverty compared with 24% in London and 19% in England.

Children and Young People's Health is improving

- Our children start reception with a good level of development
- Issues with low birth weight and infant mortality are falling
- Numbers of children immunised against infectious diseases increasing
- Compared to London and England fewer Southwark young people smoke or drink alcohol to harmful levels
- Significant decrease in teenage conceptions since 2000
- Overall upward trend in education attainment from primary school to GCSE level
- Children and young people attend school and go on to jobs, training and education.

Sex, drugs, mental health

- High levels of sexually transmitted infections amongst under 25s with chlamydia most common infection
- Southwark seems to have lower hospital admission rates due to substance misuse among young people aged 15 to 24, compared to London and England averages.
- In 2014, 37% of Year 10 boys and 28% of Year 10 girls said they had been offered cannabis
- 67% of pupils reported that, in general, they were satisfied with their life either quite a lot or a lot
- Southwark has higher numbers of young people with poor mental health compared to London and England but lower rates of self-harm.

Summary

- Build on successes, in particular our achievements in school readiness and educational attainment but a number of challenges remain
- New Healthy Weight Strategy
- Working with Southwark Clinical Commissioning Group to improve the way Southwark delivers services and through Children and Young People Health Partnership for Lambeth and Southwark
- Looking at how Southwark delivers services to young people risk and resilience
- Looking at mental health services and improving access to support

- Working with and supporting schools to be health promoting places.

Southside Young Leaders Academy

Daniel, Darren and Kumar spoke of their experience of living in the area and attending Southside Young Leaders (SYLA). They expressed concerns over traffic, litter, gangs and police sirens. The boys enjoyed trips, English lessons and how they felt better about opportunities for the future.

SYLA was a small charity working with about 50 boys. SYLA worked in partnership with schools and parents to provide a 'wrap-around' service, bringing about transformation for marginalised and vulnerable young people, already showing signs of risk.

Some recent achievements:

- Jessie Duffet tenants had received 9 planters built and painted by boys to brighten up the local community

- Boys organised community days in local area for families and children
- 11 SYLA young leaders obtained scholarship places

Youth Futures

Joseph Duncan, director of Youth Futures (YF), explained it was a small charity that had been working in the Camberwell area for about 7 years. There were youth work sessions, a personal development programme, a mentor programme and leadership programme. Joseph added that YF was stretched and looking for new premises. The charity worked on complex issues including some child protection cases and would welcome a new base to work from.

Young people from YF explained that the support available had helped them navigate through various difficult phases of their lives. The support they received felt like a big family and helped them to reach their goals and potential.

The chair thanked all those who had taken part in the presentations.

7. YOUTH SERVICES CONSULTATION QUESTIONNAIRE

Jess Leech, community engagement manager, highlighted two items: the youth services consultation and proposals for a new youth council.

Youth Services Consultation Questionnaire

The document was circulated and available online. Residents were being asked what they thought the priorities should be for the kinds of activities that the council should invest in for young people going forward from 2017. The comments received would inform the youth and play strategy and services over the next few years.

Southwark Youth Council

Jess explained that Southwark Youth Council (SYC) was the way the council wanted to engage with young people and ensure that they were at the heart of the council's thinking and decision making. The SYC would give young people real influence over the kinds of policies and decisions being made. The SYC would likely mirror what existed in the council with a cabinet and wider council meeting group comprised of young people. The plan was to elect two representatives from each secondary school. There would also be representatives from the youth and voluntary sector on the SYC.

Councillor Victoria Mills highlighted the work being done with young people by the voluntary and community sector. She added that the council was working strategically with local groups to make the most of the facilities available.

8. **COMMUNITY SAFETY UPDATE**

PC Trevor Fox, local school liaison officer, gave an insight into the work police are doing with schools and young people in the community. A lot of the work was to do with prevention and education and aimed at not criminalising young people. Officers work with school assemblies and cover issues including: personal safety, online security, bullying, drugs, gangs and travelling safely on public transport. There was also a junior citizenship scheme.

PC Adam Hall gave an update on recent activities in the area.

COMMUNITY ANNOUNCEMENTS 9.

SE5 Forum, update on vision for Camberwell

Craig Stansfield, from the SE5 Forum, explained that the workshops from the last meeting had been very useful. Some of the main things suggested for inclusion in the vision were:

- 1. Wanting to ensure that while making Camberwell a better place, people were not priced out of Camberwell.
- 2. Increasing employment and incomes in the area, including the London living wage and apprenticeships.
- 3. More detail on Camberwell Station Road and reopening the station.
- 4. Support for protecting the view of St Paul's Cathedral from Camberwell Road.

Old Kent Road Area Action Plan

Laura Hills, planning policy team, explained that the Old Kent Road Area Action Plan was a draft planning document currently being consulted on. The consultation period would run until 5 November 2016. The draft document represented a plan for the area for the next twenty years. It looked at issues including new houses and the Bakerloo Line extension. Residents were encouraged to submit their comments.

Cleaner, Greener, Safer (CGS) Capital Programme 2017-18 launch

Michelle Normanly, senior project manager, explained that the CGS programme had been running for fourteen years. Applications for 2017-18 could now be submitted and the closing date for applications was 31 October 2016. Many of the projects previously submitted had been quite innovative and that was because residents had explained the type of projects that would work in their area. Michelle Normanly, senior project manager, explained that the council was still in the early stages of the process. Following comments made at the July community council meeting, officers had fed back concerns raised about the size of the play area. Subsequently, the play area has been revised and a plan would be available to view on the council website from next week.

10. DEPUTATIONS/PETITIONS (IF ANY)

A deputation report had been submitted regarding a request for parking restrictions on St. Francis Road, Camberwell.

Councillors noted the report. Councillor Peter John said that he would be making representations, on behalf of the deputation, about a controlled parking zone in that area.

11. PUBLIC QUESTION TIME

The following public questions were raised at the meeting:

- Q1 In response to a public question about the provision of public toilets in the development plans for the Elephant & Castle shopping centre, Councillor Peter John said he would look into that issue as the development plans went through the planning process. The planning application had yet to be submitted and he would look out for what provision was planned for shoppers who needed to use a toilet.
- Q2 In response to a question about an underground train station in Camberwell, the chair responded that local councillors were in agreement that there should be an underground line in Camberwell. He added that the Bakerloo line should be extended to come to Camberwell and Peckham but under the government's approach there was currently no money available for that to happen.
- Q3 In response to a question about what was the council's approach to dealing with 6

anti-social behaviour by tenants, Councillor Peter John said anyone affected should contact their housing officer. The council did take it seriously and occasionally people were evicted for reason of anti-social behaviour. The council also had a noise nuisance team.

The chair read out a couple of written questions (Q4 and Q5) that had been submitted in writing:

- Q4 "What is the status of Southwark's Streetleader scheme and are the council committed to this."The chair explained that an officer response would be sought ahead of the next meeting.
- Q5 "Now that Windsor Walk is permanently blocked off at the Champion Park end, should the Grove Lane end include a cul-de-sac sign." Councillor Ian Wingfield explained that it was due to bridge works required by Network Rail. The temporary closure was likely to last a couple of years. He added that he did not think a cul-de-sac sign was a good idea.
- Q6 In response to an enquiry about a Camberwell over ground station, the chair explained that Transport for London (TfL) and the Mayor of London had been very positive about re-opening the old station. They would need to take over the franchise in order to do that.

Councillor Ian Wingfield added that Mike Brown, TfL commissioner, had recently visited the site with Councillor Mark Williams, cabinet member for regeneration and new homes, and had been positive about the prospect.

RECOMMENDATION

1. That the Camberwell Community Council consider a deputation request from a group of residents regarding traffic control on Grove Lane, particularly between Champion Park and Stories Mews.

BACKGROUND INFORMATION

- 2. A deputation request has been submitted by representatives of the group of residents mentioned above. A deputation can be submitted by a person of any age who lives, works or studies in Southwark. Deputations must relate to matters which the council has powers or duties or which affects Southwark.
- 3. The deputation refers to traffic control on Grove Lane.

The deputation states:

"The issue of traffic control on Grove Lane particularly between Champion Park and Stories Mews should be addressed. There have been a number of serious accidents over the last few years."

- 4. At the meeting, the spokesperson for the deputation will be invited to speak up to five minutes on the subject matter. The community council will debate the deputation and at the conclusion of the deputation the chair will seek the consent of councillors to debate the subject. Councillors may move motions and amendments without prior notice if the subject does not relate to a report on the agenda. The meeting can decide to note the deputation or provide support if requested to do so. The community council shall not take any formal decision(s) on the subject raised unless a report is on the agenda.
- 5. Any relevant resource or community impact issues will be contained in the comments of the strategic director.

KEY ISSUES FOR CONSIDERATION

- 6. The deputation shall consist of no more than six persons, including the spokesperson.
- 7. Only one member of the deputation shall be allowed to address the meeting, her or his speech being limited to five minutes.

- 8. Councillors may ask questions of the deputation, which shall be answered by their spokesperson or any member of the deputation nominated by her or him for up to five minutes at the conclusion of the spokesperson's address.
- 9. If more than one deputation is to be heard in respect of one subject, there shall be no debate until each deputation has been presented. The monitoring officer shall, in writing, formally communicate the decision of the meeting to the person who submitted the request for the deputation to be received.

RECOMMENDATION

1. That the Camberwell Community Council approve the implementation of a cycle hangar in Bellenden Road, subject to necessary statutory procedures.

BACKGROUND INFORMATION

- 2. In accordance with Part 3H paragraph 20 of the Southwark constitution, community councils are responsible for determining non-strategic traffic matters.
- 3. Full details of the results associated with the study can be found in Appendix 1, the 'consultation summary'.
- 4. The ward members awarded cleaner greener safer (CGS) funding for the scheme at the community council meeting on 11 July 2016

KEY ISSUES FOR CONSIDERATION

- 5. Informal public consultation took place with all residents within the consultation area from 2 August 2016 until 22 August 2016.
- 6. 93% of respondents to the public consultation in Bellenden Road were in favour of the scheme (a total of 13 responses out of 14).
- 7. There was one additional positive response via email from a dwelling adjacent to the consultation area.
- 8. Additional consultation with the 3rd Camberwell Scout Group was undertaken. A recent CGS project improved the accessibility of the hall and it was important to ensure that this was not compromised or that any activities carried out by the scouts were not affected. They have no objection to the scheme provided that adequate loading space is allowed outside the scout hut.
- 9. Ten cycle parking spaces have been requested via the consultation which is an oversubscription of 66%.
- 10. The uptake of spaces in the cycle hangar will be monitored. Should it be proven that there is not sufficient use of the hangar, it will be relocated.
- 11. Any residents who are not aware of the proposal in the identified location have a further opportunity to object during the statutory consultation stage of the

experimental traffic order. Any such objections will need to be formally considered prior to implementation.

12. A 2 metre double yellow line to the east of the hangar will be installed to give access to pedal cyclists

Community impact statement

14. The implementation of any transport project creates a range of community impacts. All transport schemes aim to improve the safety and security of vulnerable groups and support economic development by improving the overall transport system and access to it. Cycling infrastructure proposals also have the added advantage of improving the environment though reduction in carbon emissions and social health and fitness benefits. No group has been identified as being disproportionately adversely affected as a result of these proposals. Cyclists will benefit.

Resource implications

- 15. This project is funded via the 2016-17 CGS capital programme.
- 16. The funding for the 2016-17 CGS capital programme was approved by the cabinet and is part of the council's overall capital programme as detailed in the launch of CGS capital programme 2015/16 report dated August 2014.
- 17. All professional fees related to the project are also treated as the capital costs of the project.
- 18. The total expenditure and sources of funding for the scheme will be monitored and reported on as part of the overall capital programme.

Consultation

- 19. Informal public consultation was carried out in August 2016, as detailed above.
- 20. If approved for implementation this will be subject to statutory consultation required in the making of an experimental traffic management order. The statutory consultation will run for the experimental period and the order made permanent on the basis of the trial results. If objections are received in the experimental period, they will be the subject of a further report for determination.

Consultation Report

Installation of a secure cycle hangar on Bellenden Road

Details of the consultation and summary of responses.

Camberwell Community Council awarded funding via the Cleaner Greener Safer Programme, to install a secure cycle hangar on Bellenden Road on 11 July 2016.

The initial idea had been suggested by a resident in the area near the proposed location.

In order to ensure that there was sufficient demand for the cycle hangar, an informal postal consultation was carried out between 2nd and 22nd of August 2016.

Residents of properties 189 – 247 Bellenden Road and 1- 13 Avondale Rise were invited to fill in a small survey. This asked whether they supported or did not support the installation of the hangar, whether they would like a cycle parking space, and for any other comments.

A total of 16 responses were received. Only 1 of these expressed an objection.

An additional response was received from No.249 Bellenden Road.

Details of these responses are shown below.

In addition to consulting residents, it was also considered necessary to consult with the 3rd Camberwell Scout Group as the proposed installation of the locker is outside the Scout hut.

A recent Cleaner Greener Safer project improved the accessibility of the hall and it was important to ensure that this was not compromised or that any activities carried out by the scouts were not affected.

Looking down the road there is a pleasant sense of cohesion, reflecting other efforts locally, such as the Big Lunch gatherings, to promote a sense of neighbourliness, mutual support and security. I do however, object strongly to the proposed installation of a Cyclehoop hangar. New hangars painted plain dark green may be unobtrusive. However, from what I have seen visiting Lambeth over the past few years (Josephine Avenue and Leander Road) where hangars have been in place for some time, they do become an eye-sore after a while, when they become worn, covered with graffiti, and as in those locations, at times used as sites for flytipping, with rubbish dumped next to the dirty metal-work. The hangars there have had to be renewed recently. I think Council money could be better spent in this area to promote local environmental improvements which would benefit more than the 6 people who might choose to use a hangar. While bike hangars have their uses in some places such as adjacent to blocks of flats or offices, this is a residential road where, as your map indicates, houses have both front and rear gardens. Cyclehoop is a business, clearly more concerned for their profit than for safety. Their promotional material features cyclists setting off down the road from a hangar without a wearing a safety helmet.

RECOMMENDATIONS

- 1. It is recommended that the following local traffic and parking amendments, detailed in the appendices to this report, are approved for implementation subject to the outcome of any necessary statutory consultation and procedures:
 - 1.1 Kerfield Place to install new single yellow lines outside Nos. 8 and 9 and adjacent to the existing private parking areas to maintain access to off street parking and to improve intervisibility with vehicles on Kerfield Place
 - 1.2 Pelham Close to install double yellow lines and a 10 metre parking bay to maintain access and to prevent obstructive and dangerous parking for all road users
 - 1.3 Tower Mill Road to install double yellow on junctions and adjacent to footway build outs to maintain access and to prevent obstructive and dangerous parking and to improve intervisibility at junctions for all road users

BACKGROUND INFORMATION

- 2. Paragraph 20 of Part 3H of the Southwark constitution sets out that the community council will take decisions on the following local non-strategic matters:
 - the introduction of single traffic signs
 - the introduction of short lengths of waiting and loading restrictions
 - the introduction of road markings
 - the setting of consultation boundaries for consultation on traffic schemes
 - the introduction of destination disabled parking bays
 - statutory objections to origin disabled parking bays
 - determination of objections to traffic management orders that do not relate to strategic or borough-wide issues.
- 3. This report gives recommendations for local traffic and parking amendments, involving traffic signs, waiting restrictions and road markings.
- 4. The origins and reasons for the recommendations are discussed within the key issues section of this report.

KEY ISSUES FOR CONSIDERATION

- 5. A local parking amendment (LPA) is small project to change an existing parking restriction or to introduce a new one.
- 6. These tend to be carried out in locations where we have had a request to look at dangerous or obstructive parking and where small lengths of restrictions could provide a solution.
- 7. Local parking amendments are batched together and carried through a quarterly programme. During the second quarter of 2016-17, the council is proposing three LPA's as summarised in figure 1.
- 8. The rationale for each proposal is discussed in the associated appendix. A detailed design of the proposal is included.

Policy implications

- 9. The recommendations contained within this report are consistent with the polices of the Transport Plan 2011:
 - Policy 1.1 pursue overall traffic reduction
 - Policy 4.2 create places that people can enjoy.
 - Policy 8.1 seek to reduce overall levels of private motor vehicle traffic on our streets.

Community impact statement

- 10. The policies within the transport plan are upheld within this report have been subject to an equality impact assessment
- 11. The recommendations are area based and therefore will have greatest effect upon those people living working or traveling in the vicinity of the areas where the proposals are made.

- 12. The introduction of yellow lines at junctions gives benefit to all road users through the improvement of inter-visibility and therefore road safety.
- 13. There is a risk that new restrictions may cause parking to be displaced and, indirectly, have an adverse impact upon road users and neighbouring properties at that location. However, this cannot be entirely preempted until the recommendation have been implemented and observed.
- 14. With the exception of those benefits and risks identified above, the recommendations are not considered to have a disproportionate effect on any other community or group.
- 15. The recommendations support the council's equalities and human rights policies and promote social inclusion by:
 - Providing improved access for key services such as emergency and refuse vehicles.
 - Improving road safety, in particular for vulnerable road users, on the public highway.

Resource implications

16. All costs arising from implementing the recommendations will be fully contained within the existing public realm budgets

Legal implications

- 17. Traffic management orders would be made under powers contained within the Road Traffic Regulation Act (RTRA) 1984.
- Should the recommendations be approved the council will give notice of its intention to make a traffic order in accordance with the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996.
- 19. These regulations also require the council to consider any representations received as a result of publishing the draft order for a period of 21 days following publication of the draft order.
- 20. Should any objections be received they must be properly considered in light of administrative law principles, human rights law and relevant statutory powers.
- 21. By virtue of section 122, the council must exercise its powers under the RTRA 1984 so as to secure the expeditious, convenient and safe movement of vehicular and other traffic including pedestrians, and provision of suitable and adequate parking facilities on and off the highway.
- 22. These powers must be exercised so far as practicable having regard to the following matters:
 - a) The desirability of securing and maintaining reasonable access to premises
 - b) The effect on the amenities of any locality affected including the regulation and restriction of heavy commercial traffic so as to preserve or improve

amenity.

- c) The national air quality strategy
- d) Facilitating the passage of public service vehicles and securing the safety and convenience of their passengers
- e) Any other matters appearing to the council to be relevant.

Consultation

- 23. For the recommendations in paragraph 1, the implementation of changes to parking requires the making of a traffic order. The procedures for making a traffic order are defined by national regulations which include statutory consultation and the consideration of any arising objections.
- 24. Should the recommendations be approved the council must follow the procedures contained with Part II and III of the regulation which are supplemented by the council's own processes. This process is summarised as:
 - a) publication of a proposal notice in a local newspaper (Southwark News)
 - b) publication of a proposal notice in the London Gazette
 - c) display of notices in roads affected by the orders
 - d) consultation with statutory authorities
 - e) making available for public inspection any associated documents (eg. plans, draft orders, statement of reasons) via the council's website or by appointment at 160 Tooley Street, SE1
 - f) a 21 day consultation period during which time any person may comment upon or object to the proposed order.
- 25. Following publication of the proposal notice, any person wanting to object must make their objection in writing, state the grounds on which it is made and send to the address specified on the notice.
- 26. Should an objection be made that officers are unable to resolve so that it is withdrawn, it will be reported to the community council for determination. The community council will then consider whether to modify the proposal, accede to or reject the objection. The council will subsequently notify all objectors of the final decision.

Programme Timeline

- 27. If theses item are approved by the community council they will be progressed in line with the below, approximate timeline:
 - Traffic orders (statutory consultation) January 2017
 - Implementation February to March 2017.



A major highway safety concern is the turning circle at the end of the close. There were three vehicles parked there at the time of the visit and they were obstructing access to off street parking for residents.					
At the time of the site visit it was noted that there was blue badge disabled bay in faded condition. A revoke notice was placed on street furniture adjacent to the bay. 

Local parking amendment

A local parking amendment (LPA) is small project to change an existing parking restriction or to introduce a new one.

These tend to be carried out in locations where we have had a request to look at dangerous or obstructive parking and where small lengths of restrictions could provide a solution.

Request

The council received a number of requests from residents for double yellow lines to prevent obstructive and dangerous parking on Tower Mill Road during weekdays and weekends.

Location

Tower Mill Road is mainly unrestricted except for small sections on double yellow lines and disabled parking bays.

The street has a high residential density. This along with being close to the boundary of an existing parking zone, as well as Burgess Park, means that there is likely to be high demand for on-street parking.

Investigation and conclusions

Officers have carried out a number of site visits and on each occasion it was noted that vehicles were parked close to the road junctions.

A major concern that was observed is the obstructive parking adjacent to the junction with Pearse Street. During the visit the officer noted that large delivery vans were having difficulty manoeuvring past the parked vehicles. The way vehicles were parked would effectively block the road for emergency and refuse sized vehicles.

During 2016 the council has received four requests from residents for a parking zone; this indicates that parking stress is increasing in the area. There are currently no plans to carry out a consultation on the possible introduction of a parking zone. However there is clearly a safety concern with dangerous and inconsiderate parking that requires safety measures.

As the entire highway is unrestricted and vehicles are parking wherever possible including, this reduces the highway width and makes access difficult for large vehicles.

Recommendation

Based on our investigation and conclusions the council are recommending the introduction of double yellow lines on all road junctions on Tower Mill Road and in sections of the street where parking is deemed unsafe. This is to maintain access and prevent obstructive parking at any time.


