#### 3. ITEMS OF BUSINESS THAT THE CHAIR DEEMS URGENT

The chair announced that item 11 had been withdrawn so that councillors could consult with residents before meeting with officers to discuss a way ahead.

#### 8. CLEANER GREENER SAFER (CGS) 2017-18 WORKSHOPS

Michelle Normanly, senior project manager, introduced the ward-based workshops on the cleaner, greener, safer (CGS) capital programme for 2017-18. The workshops lasted one hour and were member-led.

#### 9. QUICK FEEDBACK FROM THE CGS WORKSHOPS

The chair thanked everyone who had taken part in the workshops and said that it had been a valuable exercise. He added that it had brought the applications to life.

Councillors commented that there were several bids for funding in Southwark Park that were from different wards and for a variety of projects. Some work would be needed following the meeting to ensure that contributions from several wards were made to achieve the funding required for a project.

#### 10. COMMUNITY ANNOUNCEMENTS - PART TWO

#### Rotherhithe to Canary Wharf Bridge

Cliff Matsuya, Business & Quality Manager at Sustrans, explained that Sustrans had put together a feasibility study for the bridge which identified a real need for the bridge in the area. The bridge would see over 13,000 journeys a day: effectively emptying 15 full Tube trains or 160 full buses of passengers. The study demonstrated that a bridge connecting the two sides of the river was feasible between Durand's Wharf park and Westferry Circus. The bridge would open on average three times per day, but would otherwise provide 24-hour a day access for free. Cliff added that Transport for London (TfL) were considering options.

Councillors thanked Cliff and Sustrans for their work on the study and the campaign for the bridge. There was general agreement that it was an excellent idea and many said that TfL should focus on making it happen, instead of putting resources into the garden bridge elsewhere on the Thames.

#### 11. ROTHERHITHE PARKING STUDY

#### 12. LOCAL PARKING AMENDMENTS

Note: This is an executive function for decision by the community council.

Councillors considered the information contained in the report.

#### **RESOLVED**:

- 1. That the objections received against two non-strategic traffic management orders be noted and determined as follows:
  - Middleton Drive reject objections and install double yellow lines

adjacent to junctions with Stanhope Close, Hawke Place and off street parking areas to improve traffic flow and access.

- Snowsfields reject objections and proceed to convert Snowsfields to one-way working (eastbound) with a cycling contraflow and to formalise the two zebra crossings at the western end of Snowsfields and the northern end of Crosby Row.
- 2. That the following local traffic and parking amendments, detailed in the appendices to the report be rejected:
  - All Bermondsey and Rotherhithe Community Council wards to install new double yellow lines to improve inter-visibility and road safety for all road users.

Councillors commented on their rejection decision and asked that officers note the following points:

- Requests for double yellow lines should come from the community rather than officers.
- Ward members should have been notified in advance that these proposals were being considered before they were included in a report for decision.

#### 13. LOCAL POLICE UPDATE

The local police were not in attendance.

#### 14. REALLOCATION OF NEIGHBOURHOODS FUND 2016-17

Councillors considered the information contained in the report.

#### **RESOLVED**:

That the Shad Thames Area Management Partnership be authorised to use an underspend of £700 from their 2016-17 Neighbourhoods Fund grant to fund the revenue costs of another local project, Shad Thames Green wall.

#### 15. PUBLIC QUESTION TIME

The following public questions were raised at the meeting:

Q1 In response to a question on what would happen next following the Cleaner Greener Safer (CGS) workshops, the chair explained that members and officers would follow up on issues raised and discuss how best to allocate funding. The next community council meeting would formally take the decisions.

Q2 In response to a question about progress on installing box junctions on Jamaica Road, Councillor Al-Samerai thanked the more than 500 residents who had signed the petition requesting box junctions. Councillors were in agreement that Transport for London (TfL) needed to improve the situation as a matter of urgency. The traffic flow to and from the Rotherhithe roundabout needed to be addressed.

#### RECOMMENDATION

1. That Bermondsey and Rotherhithe Community Council approve the re-allocation of a total of £104,514, as set out in Appendix 1.

#### **BACKGROUND INFORMATION**

2. Cleaner Greener Safer (CGS) is part of the London Borough of Southwark's capital programme. Between 2003 and 2016 £8.38m has been made available local residents in Bermondsey and Rotherhithe to apply for awards to make their local area a better place to live. The programme attracts hundreds of proposals ranging from a few hundred pounds for bulb planting to brighten up open spaces to tens of thousands of pounds to create community gardens. These projects often introduce new ideas such as outdoor gyms in public spaces, community gardens, public art and energy saving projects which not only make the borough cleaner, greener and safer but greatly contribute to a sustainable public realm by involving residents in the funding process and in the delivery of projects.

#### **KEY ISSUES FOR CONSIDERATION**

- 3. Appendix 1 highlights twenty one projects which have a total under spend of £100,840.
- 4. Appendix 1 also highlights a total of £3,674 from the 2016/17 programme which was unallocated.
- 5. It is recommended that the under spend of £1,000 from Durand's Wharf planting for wildlife, project reference [105429], is returned to community council for reallocation.
- 6. It is recommended that the under spend of £1,900 from Cherry Gardens tree pit improvements, project reference [CGS105443], is returned to community council for reallocation.
- 7. It is recommended that the under spend of £180.00 from Surrey Docks Adventure Playground Phase 2, project reference [105937], is returned to community council for reallocation.
- 8. It is recommended that Bermondsey Wall West junction with George Row,

project reference [105897], is cancelled and the remaining funding of £9,000 is returned to community council for reallocation. Work on the project ceased when the Quietway 14 non-grid cycle route project was initiated to avoid superseding CGS designs. The original deadline for the funding has now passed.

- 9. It is recommended that Whites Grounds community sculpture, project reference [106462], is cancelled and the remaining funding of £7,500 is returned to community council for reallocation. The project has not progressed and the original deadline for funding has passed.
- 10. It is recommended that the under spend of £1,600 from Tower Bridge Road heritage shop front lighting, project reference [106461], is returned to community council for reallocation.
- 11. It is recommended that the under spend of £5,000 from Magdalen TRA notice boards, project reference [106408], is returned to community council for reallocation.
- 12. It is recommended that the under spend of £3,000 from Wrayburn House lighting, project reference [106520], is returned to community council for reallocation.
- 13. It is recommended that Tustin Estate bin stores 2016/17, project reference [107146], is cancelled and the remaining funding of £9,000 be returned to community council for reallocation. There are plans for major works on the estate which include a review of the existing refuse collection. The bin stores which were to be improved with CGS funding are within the area of these potential works.
- 14. It is recommended that the under spend of £3,400 from Slippers Place netting, project reference [106506], is returned to community council for reallocation.
- 15. It is recommended that the under spend of £5,000 from Cathay Street landscaping, project reference [106492], is returned to community council for reallocation.
- 16. It is recommended that the under spend of £5,000 from Southwark Park nature garden outdoor classroom, project reference [106926], is returned to community council for reallocation.
- 17. It is recommended that the under spend of £2,500 from Surrey Docks Adventure Playground fencing works, project reference [106490], is returned to community council for reallocation.
- 18. It is recommended that Acorn Walk access improvements, project reference [106495], is cancelled and the remaining funding of £6,760 is returned to community council for reallocation. The project is unable to progress due to major works planned for the estate.
- 19. It is recommended that Acorn Walk staggered gates, project reference [106496], is cancelled and the remaining funding of £2,300 is returned to community council for reallocation. The project is unable to progress due to major works planned for the estate.

- 20. It is recommended that the under spend of £1,200 from Paterson Park information board, project reference [107078], is returned to community council for reallocation.
- 21. It is recommended that the under spend of £3,000 from Pedworth rear garden improvements, project reference [106925], is returned to community council for reallocation.
- 22. It is recommended that Russia Dock Woodland pond signage, project reference [106947], is cancelled and the remaining funding of £2,400 is returned to community council for reallocation. The scope of works changed beyond the available budget.
- 23. It is recommended that Bermondsey Street CCTV, project reference [107115] is cancelled and the remaining funding of £27,200 is returned to community council for reallocation. Local businesses in Bermondsey Street unwilling to meet the four year revenue costs required as a condition of funding.
- 24. It is recommended that the under spend of £3,000 from Lucey Way and Linsey Street CCTV, project reference [107116], is returned to community council for reallocation. One camera was installed on Linsey Street. It was agreed that a permanent CCTV camera was not the appropriate solution for ASB on Lucey Way. Alternative methods to address the issues are underway.
- 25. It is recommended that the under spend of £900.00 from Longfield and Setchell TRA hall sign, project reference [107109], is returned to community council for reallocation.
- 26. It is recommended that the unallocated 2016/2017 CGS programme funding of £162.00 from Livesey ward and £3,512 from Rotherhithe ward is allocated as part of the 2017/18 CGS programme.
- It is recommended that £6,000 is allocated to Bermondsey Village Hall storage, project reference [106524] which was originally awarded £30,000 as part of the 2015/2016 CGS programme. The estimated cost of works exceeds the original budget.
- 28. It is recommended that £7,340 is allocated to Bermondsey Hanging Baskets 2016/17, project reference [107085]. This is to bring the Riverside contribution to a total of £14,000, the cost of the 2016/17 annual hanging basket contract in Riverside ward.
- 29. It is recommended that £2,400 is allocated to Russia Dock Woodland Rain Shelter, project reference [106499]. This is the unspent funding from the Russia Dock Woodland pond signage, project reference [106947]. The rainwater shelter project is the priority for the Friends of Russia Dock Woodland and the estimated cost of works exceeds their original 2015/2016 grant award.
- 30. It is recommended that £1,100 is allocated to Keetons Estate chicanes (Tranton Road), project reference [107124]. Additional funding is required to install a second set of staggered gates to ensure the measures to deter motorcyclists and speeding cyclists are effective.
- 31. It is recommended that £4,000 is allocated to a new project to undertake a

feasibility study for a pedestrian crossing at the junction of Drummond Road, Raymouth Road and Southwark Park Road.

32. It is recommended that the remaining £83,674 is reallocated as part of the 2017-2018 CGS programme.

#### Policy implications

33. There were none.

#### Community impact statement

- 34. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
- 35. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The CGS programme is an important tool in achieving community participation.
- 36. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been give to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decision to the need to:
  - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct;
  - b. Advance of equality of opportunity between persons who share a relevant protected characteristics and those who do not share it;
  - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
- 37. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
- 38. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
  - a. Remove or minimise disadvantages connected with a relevant protected characteristic;
  - b. Take steps to meet the different needs of persons who share a relevant protected characteristic;
  - c. Encourage persons who share a relevant protected characteristic to participate in public life or any other activity in which they are under-represented.

#### **Resource implications**

39. This is the reallocation of existing CGS funding that was originally awarded in 2010-2011, 2013-2014, 2014-2015, 2015-2016 and 2016-2017.

- 40. CGS funding is devolved to community councils to spend on suitable projects.
- 41. All professional fees related to the project are also treated as the capital costs of the project. Where projects are awarded as a grant to organisations, the community council award letter will not include the professional fees which will be charged direct to project costs.
- 42. CGS projects must be completed within two years of award of funding. Projects that are unlikely to be completed within two years will be reported to community council and available budgets may be reallocated to other projects. Revenue costs not covered by maintenance or the contractual liability period will fall upon the asset owner. The business unit will be notified of the likely costs before the schemes proceeds, in order to secure permission to implement the scheme.
- 43. After the defects and liability period, or three year maintenance period in the case of planting works, all future maintenance is assumed by the asset owner, for example housing, parks, highways, or in some cases external asset owners. Therefore, there are no revenue implications to the public realm projects business unit as a result of approving the proposed allocation.
- 44. The total expenditure and sources of funding for the scheme will be monitored and reported on as part of the overall capital programme.

#### Consultation

45. All CGS projects require consultation with stakeholders, including the project applicant, local residents and tenants and residents associations where appropriate.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Director of Law and Democracy**

- 46. The allocation of the CGS is an executive function, delegated by the leader to community councils.
- 47. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the leader.
- 48. This report is recommending that the Bermondsey and Rotherhithe Community Council approve the reallocation of available funds from the 2010-2011, 2013-2014, 2014-2015, 2015-2016 and 2016-2017 programme as specified at Appendix 1 to the 2017-2018 capital funding allocation. The power for this function is detailed in Part 3H paragraph 14 of the constitution which states that community councils have the power of "approval of the allocation of funds to cleaner, greener, safer capital and revenue schemes of a local nature, using the resources and criteria identified by the cabinet".
- 49. The appropriate cabinet member approved the funding for the 2010-2011, 2013-2014, 2014-2015, 2015-2016 and 2016-2017 programme by virtue of his powers under Part 3D paragraph 2 of the constitution. Where funding needs to be reallocated the community council approval being sought here is therefore the appropriate constitutional step in the process.

- 50. Community council members also have powers under paragraph 16 of Part 3H of the constitution to oversee and take responsibility for the development and implementation of the local schemes.
- 51. In allocating funding under the CGS community councils must have regard to the council's equality duty set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties need to be considered in the body of the report at paragraphs 34 to 38 in the community impact statement.

#### Strategic Director of Finance and Governance

- 52. The report requests the approval of Bermondsey and Rotherhithe Community Council for the re-allocation of a total of £104,514, originally allocated to projects under the CGS programme, as set out in Appendix 1.
- 53. The strategic director of finance and governance notes that the re-allocation of the CGS funding will be contained within the existing departmental capital budgets for CGS programme allocated as part the council's capital programme.
- 54. Staffing and any other costs connected with this recommendation to be contained within existing departmental revenue budgets.

#### RECOMMENDATION

1. To approve the allocation of funds for the 2017-18 cleaner greener safer (CGS) capital programme in the Bermondsey and Rotherhithe Community Council area from the list of applications set out in Appendix 1.

#### **BACKGROUND INFORMATION**

- 2. The council's CGS capital programme has been running since 2003.
- 3. In the first fourteen years of the CGS programme, £34,153,000 has been allocated to community councils leading to 2,500 projects being approved.
- 4. In the Bermondsey and Rotherhithe Community Council area, £8,384,293 has been allocated to 514 projects, 469 of which have been completed to date.
- 5. Examples of the types of projects that have been funded include:
  - Parks, community gardens, landscaping, tree planting and wildlife areas
  - Children's playgrounds, youth facilities, ball courts and cycle tracks
  - Lighting, security measures, pavements, streets, and tackling 'grot spots'
  - Grants to local groups to self-deliver projects.

#### **KEY ISSUES FOR CONSIDERATION**

- 6. There is £492,381 available for the 2017/18 CGS capital programme for new projects in the Bermondsey and Rotherhithe Community Council area.
- 7. Unallocated funding from previous years' programmes will also be reallocated subject to approval in a separate report.
- 8. Eligible proposals must bring about a permanent improvement and make an area cleaner, greener or safer.
- 9. Proposals with revenue costs, including salaries, costs for events, festivals, workshops or other one-off events are not eligible for capital funding. CCTV proposals and internal improvements to housing property and works on schools where there is no access to the general public are also not eligible. Works on private property are not eligible unless there is a long-term guarantee of public access or a demonstrable public benefit.

10. The application form invited expressions of interest for the applicants to deliver projects themselves. A due diligence exercise to ensure that this is both practical and realistic has been undertaken as part of the feasibility process. In such cases, the council would give the funding allocation to the applicant in the form of a capital grant, with appropriate conditions attached.

#### **Policy implications**

11. The CGS programme is fully aligned with the council's policies around sustainability, regeneration and community engagement.

#### Community impact statement

- 12. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
- 13. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The CGS programme is an important tool in achieving community participation.
- 14. In fulfilling the above objectives of community councils to bring together and involve Southwark's diverse local communities, consideration has also been given to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decision to the need to:
  - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct;
  - b. Advance of equality of opportunity between persons who share a relevant protected characteristics and those who do not share it;
  - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
- 15. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
- 16. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
  - a. Remove or minimise disadvantages connected with a relevant protected characteristic;
  - b. Take steps to meet the different needs of persons who share a relevant protected characteristic;
  - c. Encourage persons who share a relevant protected characteristic participate in public life or any other activity in which they are under-represented.
- 17. Ideas for CGS projects come from the local community, the majority via a simple project nomination form available in electronic and paper format.

#### **Resource implications**

- 18. The funding for the CGS capital programme from 2011 to 2021 was approved by the cabinet and is part of the council's overall capital programme as detailed in the capital programme 2011–2021 report dated 21 June 2011.
- 19. The funding for the 2017-18 CGS capital programme was approved by the cabinet member for transport environment and recycling as detailed in the launch of the CGS Capital Programme 2015-16 report dated August 2014.
- 20. All professional fees related to the project are also treated as the capital costs of the project. Where projects are awarded as a grant to organisations, the award amount announced at community council includes professional fees. The community council award letter to grant recipients details the grant amount only, excluding these fees.
- 21. CGS projects must be completed within two years of award of funding. Projects that are unlikely to be completed within two years will be reported to community council and available budgets may be reallocated to other projects. Revenue costs not covered by maintenance or the contractual liability period will fall upon the asset owner. The department will be notified of the likely costs before the schemes proceeds, in order to secure permission to implement the scheme.
- 22. After the defects and liability period, or three year maintenance period in the case of planting works, all future maintenance is assumed by the asset owner, for example housing, parks, highways, or in some cases external asset owners. Therefore, there are no revenue implications to the Highways division as a result of approving the proposed allocation.
- 23. The total expenditure and sources of funding for the scheme will be monitored and reported on as part of the overall capital programme.
- 24. Value for money will be ensured when the contract is procured by following the council's contract standing orders.

#### Consultation

25. All CGS projects require consultation with stakeholders, including the project applicant, local residents, tenants and residents associations and local community groups where appropriate.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Director of Law and Democracy**

- 26. The allocation of the CGS capital fund is an executive function, delegated by the leader to community councils.
- 27. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the Leader.
- 28. This report is recommending that the Bermondsey and Rotherhithe Community Council approve the allocation of funds to the individual projects specified at

Appendix 1. The power for this function is detailed in Part 3H paragraph 14 of the constitution which states that community councils have the power of "approval of the allocation of funds to cleaner, greener, safer capital and revenue schemes of a local nature, using the resources and criteria identified by the cabinet".

- 29. The cabinet member for transport environment and recycling approved the funding for the 2017-2018 programme in August 2014 by exercising his powers under Part 3D paragraph 2 of the constitution; and the community council approval being sought here is therefore the next constitutional step in the process.
- 30. Community council members also have powers under paragraph 16 of Part 3H of the constitution to oversee and take responsibility for the development and implementation of the local schemes.
- 31. In allocating funding under the CGS community councils must have regard to the council's equality duty set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties need to be considered in the body of the report at paragraphs 12 to 17 in the community impact statement.

#### Strategic Director of Finance and Governance

- 32. This report seeks the approval of the Bermondsey and Rotherhithe Community Council for the allocation of funds (£492,381) for the 2017-18 CGS programme in the Bermondsey and Rotherhithe Community Council area from the list of applications set out in Appendix 1.
- 33. The strategic director of finance and governance notes the resource implications in the report that the proposed allocations will be contained within the council's capital programme.
- 34. It is also noted that officers' time and any other costs connected with this recommendation will be contained within existing departmental revenue budgets.
