  - c) That the premises kitchen is inspected by Southwark's Food Safety Team after 15 April 2017 following the service of the Hygiene Improvement Notice dated 23 March 2017 served pursuant to regulation 6 of the Food Safety and Hygiene (England) Regulations 2013 and report to the Licensing Sub-Committee on the condition of the said kitchen.
  - d) That the applicant be permitted to respond to Southwark's findings in respect of a to c (above) before 4.00pm on 28 April 2017.
