RECOMMENDATION

1. That the licensing sub-committee considers an application made by Kyle Shearer to vary the premises licence granted under the Licensing Act 2003 in respect of the premises known as Elephantastic Pizza, Unit 5, The Artworks, Elephant Road, London SE17 1AY.

2. Notes:

- a) This application seeks to vary the premises licence held under current legislation in respect of the premises known as: Elephantastic Pizza, Unit 5, The Artworks, Elephant Road, London SE17 1AY under section 34 of the Licensing Act 2003. Existing permitted licensable activities are not under consideration at this meeting. The variation application is subject to outstanding representations submitted by local residents and is therefore referred to the sub-committee for determination.
- b) Paragraphs 10 to 14 of this report provide a summary of the application under consideration by the sub-committee. A copy of the full application is attached as Appendix B.
- c) Paragraphs 15 to 16 of this report deal with the representation submitted in respect of the application. A copy of the representation submitted by the council's licensing department is attached to this report in Appendix C. A map showing the location of the premises is attached to this report as Appendix E.
- d) A copy of the council's approved procedure for hearings of the sub-committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing regulations, has been circulated to all parties to the meeting.

BACKGROUND INFORMATION

The Licensing Act 2003

- 3. The Licensing Act 2003 provides a licensing regime for:
 - The sale of and supply of alcohol
 - The provision of regulated entertainment
 - The provision of late night refreshment.

- 4. Within Southwark, the licensing responsibility is wholly administered by this council.
- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:
 - The prevention of crime and disorder
 - The promotion of public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to
 - The Act itself
 - The guidance to the act issued under Section 182 of the Act
 - Secondary regulations issued under the Act
 - The licensing authority's own statement of licensing policy
 - The application, including the operating schedule submitted as part of the application
 - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.

KEY ISSUES FOR CONSIDERATION

The current premises licence

- 8. The current premises licence issued in respect of the premises known as Elephantastic Pizza, Unit 5, The Artworks, Elephant Road, London SE17 1AY was issued on 16 March 2016 and allows the following licensable activities:
 - The sale of alcohol to be consumed on the premises Monday to Sunday from 12:00 to 23:00
 - Opening hours: Monday to Sunday from 12:00 to 23:00.
- 9. A copy of the existing premises licence is attached as Appendix A.

The variation application

- 10. On 31 May 2017, Kyle Shearer applied for a full variation of the premises licence at Elephantastic Pizza, Unit 5, The Artworks, Elephant Road, London SE17 1AY. The application was to increase the area for the provision of alcohol (to both on and off sales) with a change of layout, to include the whole of the courtyard area within the Artworks, immediately outside the premises.
- 11. Mr Shearer was advised that as the courtyard area is used by a number of other licensed premises in the immediate vicinity, this could potentially make his premises

liable for the actions both the other businesses and their customers. From the licensing authority's enforcement perspective, it may be difficult to ascertain from which premises customers had purchased alcohol for consumption in that area. Mr Shearer subsequently withdrew that application.

- 12. Mr Shearer submitted a replacement application on 14 June 2017. This current application seeks to add off sales to the existing premises licence to account for deliveries and the use of the courtyard area, and to add an additional hour to the morning of alcohol sales.
- 13. The application and is summarised as follows:
 - The supply by retail of alcohol (both on and off sales)
 Monday to Sunday from 11:00 to 23:00
 - Opening hours Monday to Sunday from 11:00 to 23:00
 - The designated premises supervisor of the premises continues to be Kyle Shearer (also the Applicant) who holds a personal licence from the London Borough of Southwark.
- 14. A copy of the application is attached to this report in Appendix B.

Representations from responsible authorities

- 15. A representation has been received from this council's licensing authority in relation to the licensing objectives for the prevention of crime and disorder and the prevention of public nuisance. The author states that there are no further measures added to the operating schedule to address how the premises will discourage patrons from drinking alcohol sold for 'off sales' in the street. Additional conditions have therefore been requested to be added to the operating schedule, namely:
 - Any 'off sales' of alcohol shall be provided in sealed containers and taken away from the premises.
 - That clear legible signage shall be prominently displayed at the premises, where it can be easily seen and read, requesting.
- 16. A copy of the representation is available in Appendix C.

Representations from other persons

17. No other representations have been received.

Conciliation

18. The applicant was sent a copy of the representation. The applicant has responded stating that the reason for making the application was specifically to use the courtyard, that these conditions would prevent that; further that he had followed the advice of the licensing authority. A copy of that response is available in Appendix D.

Premises history

- 19. There is currently a premises licence in place. A copy of the current licence is available for information in Appendix A.
- 20. There is no history of complaints associated with the premises received by the licensing authority. An inspection was carried out on 17 February 2017. A number of breaches of the current licence were found, namely:
 - 1. The Premises Licence Summary (or certified copy) was not on display and/or the Premises Licence (or certified copy) was not kept at the premises. This is in breach of Sections 57(2) & (3) of the Licensing Act 2003.
 - 2. The CCTV installed at the premises was not working and as such the CCTV footage which should be kept for a period of 31 days was not available. Contrary to conditions 288 and 289 on the premises licence.
 - 3. Staff training records regarding responsibilities under the licensing act 2003 were not available for inspection, contrary to condition 340 on the premises licence.
 - 4. Notices requesting customers 'to respect the needs of local residents and leave the area quietly' were not displayed at the premises, ccontrary to condition 311 on the premises licence
 - 5. There was no signage regarding 'Challenge 25' on display at points of sale or where alcohol is displayed for sale, as such and after speaking to staff, there was no evidence that a 'Challenge 25' policy has been established at the premises, contrary to condition 4AC and 4AG on the premises licence.
- 21. A warning letter was provided for the offences found. A revisit inspection was carried out on 5 May 2017. All issues were found to be resolved and the inspection was found to be fully satisfactory. The licence holder was again written to in order to confirm that all was satisfactory at the revisit.

Deregulation of entertainment

- 22. On 6 April 2015 entertainment became deregulated and as a result:
 - Live unamplified music is deregulated between 08:00 and 23:00 on any premises.
 - Live amplified music is deregulated between 08:00 and 23:00 at on-licensed premises provided the audience does not exceed 500 people. However, live music can become licensable in on-licensed premises if the licensing authority removes the effect of the deregulation following a licence review ('licence review mechanism').

Map

- The provision of regulated entertainment in the form of films (indoors)

- The provision of regulated entertainment in the form of live music, recorded music, plays and the performance of dance (all indoors)
 - Sunday to Thursday from 23:00 to 23:30

 - Sunday to Thursday from 11:00 to 02:30 (the following day)
 - Friday and Saturday from 11:00 05:00 (the following day).

Southwark council statement of licensing policy

24. Council assembly approved Southwark's statement of licensing policy 2011-14 on 12 October 2011. Council assembly approved Southwark's statement of licensing

policy 2016-20 on 25 November 2015. The policy came into effect on 1 January 2016.

- 25. Further sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
 - Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this authority relies in determining licence applications
 - Section 5 Determining applications for premises licences and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
 - Section 6 Local cumulative impact policies. This sets out this authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy
 - Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this authority might consider appropriate by type of premises and (planning) area classification.
 - Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective
 - Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective
 - Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective
 - Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective.
- 26. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.
- 27. Within Southwark's statement of licensing policy, the premises are identified as being outside of a cumulative impact zone but inside the Elephant and Castle major town centre. Relevant closing times recommended in the Statement of Licensing Policy is as follows:
 - Restaurants and cafes:
 - Sunday to Thursday until 00:00
 - Friday and Saturday until 01:00

- Public houses:
 - Sunday to Thursday until 23:00
 - Friday and Saturday until 00:00.

Resource implications

28. A fee of £190.00 has been paid by the applicant company in respect of this application being the statutory fee payable for premises within non-domestic rateable value bands D/E.

Consultation

29. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local newspaper and similar notices were exhibited outside of the premises for a period of 28 consecutive days.

Community impact statement

30. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Director of Law and Democracy

- 31. The sub-committee is asked to determine the application to vary the premises licence under Section 34 of the Licensing Act 2003.
- 32. The principles which sub-committee members must apply are set out below.

Principles for making the determination

- 33. Section 35 of the Licensing Act 2003 sets out the licensing authority's powers and duties in considering the determination of an application for variation.
- 34. The general principle is that applications for variation must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 35. Relevant representations are those which
 - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
 - Are made by an other party or responsible authority
 - Have not been withdrawn
 - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious.

- 36. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to
 - Add to, omit, and/or alter the conditions of the licence or,
 - Reject the whole or part of the application for variation.

Conditions

- 37. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the variation, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.
- 38. The four licensing objectives are
 - The prevention of crime and disorder;
 - Public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 39. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 40. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to late night refreshment and take away aspect of the licence must relate to the night time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 41. The Licensing Act requires mandatory conditions in respect of supply of alcohol, the exhibition of films and in respect of door supervisors. The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2003 introduced 3 new conditions in respect of irresponsible promotions, the oral dispensing of alcohol and free tap water. In October 2010 an additional 2 conditions will come into force age verification policy and smaller measures for alcoholic drinks.
- 42. Members are also referred to the Home Office revised guidance issued under section 182 of the Licensing Act 2003 on conditions, specifically section 10.

Reasons

43. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for to vary the premises licence, it must give reasons for its decision.

Hearing procedures

44. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:

- The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations
- Members of the authority are free to ask any question of any party or other person appearing at the hearing
- The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
 - Address the authority
 - o If given permission by the committee, question any other party.
 - o In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
- The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives
- The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.
- In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 45. This matter relates to the determination of an application to vary a premises licence under section 34 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

The council's multiple roles and the role of the licensing sub-committee

- 46. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 47. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.
- 48. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future

- event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 49. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 50. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 51. Under the Human Rights Act 1998, the sub committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.
- 52. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the Magistrates' Court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

Guidance

53. Members are required to have regard to the Home Office guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

Strategic Director of Finance and Governance

54. The head of regulatory services has confirmed that the costs of this process over and above the application fee are borne by the service.



Annex 1 - Mandatory conditions

- 100 No supply of alcohol may be made under the Premises Licence -
- (a). At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
- (b). At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- **101** Every supply of alcohol under the Premises Licence must be made, or authorised by, a person who holds a Personal Licence.
- **485** (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
- (a) games or other activities which require or encourage, or are designed to require, encourage, individuals to -
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional poster or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; and

- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- **487** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- **488** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
- (a) a holographic mark; or
- (b) an ultraviolet feature.
- 489 The responsible person shall ensure that -
- (a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
- (i) Beer or cider: 1/2 pint;
- (ii) Gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) Still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- **491** 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purpose of the condition set out in paragraph (1):
- (a) "duty" is to be construed in accordance with the Alcoholic Liquur

Duties Act 1979;

(b) "permitted price" is the price found by applying the formula $P = D + (D \times V)$,

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- (i) the holder of the premises licence:
- (ii) the designated premises supervisor (if any) in respect of such a licence; or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (iv) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (v)"value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax;
- (2) the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 - Conditions consistent with the operating Schedule

288 That a CCTV system be installed at the premises and be maintained in good working order and be continually recording at all times the premises are in use under the licence. The CCTV System must be capable of capturing a clear facial image of every person who enters the premises.

289 All CCTV footage be kept for a period of 31 days and shall on request be made immediately available to officers of the police and the council. There will be at least one person on duty at all times that is familiar with the operation of the CCTV and able to download the footage upon reasonable request.

340 That all staff are trained in their responsibilities under the licensing act 2003 and training records to be kept and updated every 6 months and shall, upon request, be made immediately available to Officers of the Police and the Council.

341 Intoxicating liquor shall not be sold or supplied on the premises other than to persons taking table meals and is for consumption by such person as an ancillary to this meal. Alcohol will only be provided by waiter/waitress service.

311 That notices shall be displayed requesting customers to respect the needs of local resident and to leave the area quietly.

342 That the toilet areas will be supervised and drugs awareness training given to staff.

343 That windows and doors will be kept closed where possible.

4AG The premises shall operate a 'Challenge 25' policy whereby customers purchasing alcohol who appear to be under 25 years of age will be asked for an approved form of proof of age to verify their age.

Approved forms of proof of age shall comprise a photographic driving licence, passport, photographic UK armed services ID card or a Proof of Age Standards Scheme (PASS) approved proof of age card.

4AC Age Check "Challenge 25" signage shall be displayed at to the premises, areas where alcohol is displayed for sale and at points of sale to inform customers that an age check "Challenge 25" policy applies and proof of age may be required

344 That children wil only be allowed in the company of an adult.



RECOMMENDATION

 That the licensing sub-committee considers an application made by Respite Management Limited for a premises licence to be granted under the Licensing Act 2003 in respect of the premises known as Londrino Restaurant, 36 Snowsfields Yard, London SE1 3QQ.

2. Notes:

- a) This application forms a new application for a premises licence, submitted under Section 17 of the Licensing Act 2003. The application is subject to representations from responsible authorities and is therefore referred to the sub-committee for determination.
- b) Paragraphs 8 to 10 of this report provide a summary of the application under consideration by the sub-committee. A copy of the full application is attached as appendix A.
- c) Paragraphs 11 to 16 of this report deal with the representations submitted in respect of the application. A copy of the representation submitted by the Licensing Authority is attached as Appendix B and copies of representations by local residents are found in Appendix C. A map showing the location of the premises is attached to this report as Appendix D.
- d) A copy of the council's approved procedure for hearings of the sub-committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing regulations, has been circulated to all parties to the meeting.

BACKGROUND INFORMATION

The Licensing Act 2003

- 3. The Licensing Act 2003 provides a licensing regime for:
 - The sale of and supply of alcohol
 - The provision of regulated entertainment
 - The provision of late night refreshment.
- 4. Within Southwark, the licensing responsibility is wholly administered by this council.

- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:
 - The prevention of crime and disorder
 - The promotion of public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to
 - The Act itself
 - The guidance to the act issued under Section 182 of the Act
 - Secondary regulations issued under the Act
 - The licensing authority's own statement of licensing policy
 - The application, including the operating schedule submitted as part of the application
 - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.

KEY ISSUES FOR CONSIDERATION

The premises licence application

- 8. On 9 June 2017 Respite Management Limited applied to this council for the grant of a premises licence in respect of Londrino Restaurant, 36 Snowsfields Yard, London SE1 3QQ. The premises are described within the application as follows:
 - "36 Snowsfields is part of a new development. The restaurant is collaboration between a well known hotel and restaurant operator, Peng Loh, and highly experienced Portuguese Chef Leandro Carreira. This will be a beautifully designed premises with a focus on quality food and drink in a non-fussy atmosphere.
 - The premises sit in a busy mixed use commercial area very close to the iconic Shard. Whilst the premises are just within the Borough cumulative impact area, we respectfully submit that it should not contribute to any concerns with the licensing objectives as customers will be seated and served, and dining at different times. The new restaurant and bar will contribute to the excellence of Southwark's food and drink facilities.
 - The formal restaurant area is to the left of the entrance with a seasonal terrace. To the right is an informal area for lighter snacks and drinks without the need for a full meal where customers will be seated and served by waiter or waitress. We would request up to 12 persons to be able to stand at the bar whilst waiting for a table. There will not be any regulated entertainment, only background recorded music".

- 9. The application is summarised as follows:
 - The supply by retail of alcohol (both on and off sales)
 - Sunday to Wednesday from 10:00 to 23:30 (midnight)
 - Thursday to Saturday from 10:00 to 00:00 (midnight)
 - Seasonal Variation
 - From the terminal hour on New Year's Eve to the commencement of regulated hours the following day. Sundays prior to Bank Holidays to be treated as Saturdays for the purposes of regulated hours and activities.
 - Non-standard Timings
 - Off sales only in a sealed container and only until 23:00.
 - The provision of late night refreshment (indoors):
 - Sunday to Wednesday from 23:00 to 00:00 (midnight)
 - Thursday to Saturday23:00 to 00:30 (the following day)
 - Opening hours
 - Sunday to Wednesday 09:00 to 00:00 (midnight)
 - Thursday to Saturday 08:00 to 00:30 (the following day)
 - The proposed designated premises supervisor of the premises is Martina Baxter who has been granted a personal licence by London Borough Ealing.
- 10. The premises licence application form provides the applicant's operating schedule. Parts A, B, C, E, F, G, H, I, J, K, L, and M of the operating schedule set out the proposed licensable activities, operating hours and operating control measures in full, with reference to the four licensing objectives as stated in the Licensing Act 2003. Should a premises licence be issued in respect of the application the information provided in part M of the operating schedule will form the basis of conditions that will be attached to any licence granted subsequent to the application. A copy of the application is attached to this report in Appendix A.

Representations from responsible authorities

- 11. A representation was initially submitted by the Metropolitan Police Service (Licensing Division) but this was subsequently withdrawn.
- 12. The licensing authority's representation has been submitted in respect of the prevention of crime and disorder and the prevention of public nuisance licensing objectives. The representation is concerned essentially with the location of the premises, which sits within the Borough and Bankside cumulative impact zone. The representation is looking to condition the following:
 - 1) An accommodation limit for the outside area as indicated on the plans and an accommodation limit or the inside of the premises;
 - 2) To provide a written dispersal policy for the premises;

- 3) Alcohol shall be supplied only to those seated and taking a table meal at the premises except for persons who may wait at the bar whilst waiting for a table;
- 4) 'Off sales' of alcohol shall be sold in closed containers and taken away from the premises;
- 5) That clear legible signage shall be prominently displayed where it can be easily seen and read, requesting that alcohol sold as 'off sales' should not be opened and consumed in the vicinity of the premises;
- 6) That clear legible signage shall be prominently displayed where it can be easily seen and read, requesting that customers leave the area in a quiet and orderly manner.
- 13. A copy of the representation submitted by the licensing authority is attached in Appendix B.

Representations from other persons

- 14. Representations have been submitted by eight other persons whom remain anonymous for the purposes of the report. Many of the representations are borderline in their validity. Almost all refer to the planning permissions granted for the site. Other representations were received that were subsequently rejected as they failed to address the licensing objectives in any way. There is however an overriding concern with the potential for noise and anti-social behaviour resulting from the granting of an additional premises licence in such close proximity to residential addresses.
- 15. A copy of the redacted representations are available in Appendix C.

Conciliation

16. Copies of representations have been provided to the applicant's legal agent. At the point of this report being published, conciliatory responses had not been received.

Premises history

17. The venue is a new build has not been in possession of a premises licence previously, nor has it been subject to temporary events notices.

Deregulation of entertainment

- 18. On 6 April 2015 entertainment became deregulated and as a result:
 - Live unamplified music is deregulated between 08:00 and 23:00 on any premises.
 - Live amplified music is deregulated between 08:00 and 23:00 at on-licensed premises provided the audience does not exceed 500 people. However, live music can become licensable in on-licensed premises if the licensing authority removes the effect of the deregulation following a licence review ('licence review mechanism').

Southwark council statement of licensing policy

- 20. Council assembly approved Southwark's statement of licensing policy 2011-14 on 12 October 2011. Council assembly approved Southwark's statement of licensing policy 2016-20 on 25 November 2015. The policy came into effect on 1 January 2016.
- 21. Further sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
 - 1. Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this authority relies in determining licence applications
 - 2. Section 5 Determining applications for premises licences and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
 - 3. Section 6 Local cumulative impact policies. This sets out this authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy
 - 4. Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this authority might consider appropriate by type of premises and (planning) area classification.
 - 5. Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective
 - 6. Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective

- 7. Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective
- 8. Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective.
- 22. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.
- 23. Within Southwark's statement of licensing policy, the premises are identified as being within the Borough and Bankside cumulative impact zone. Relevant closing times recommended in the statement of licensing policy for licensed premises in residential areas are as follows:
 - Closing time for restaurants and cafes:
 - Sunday to Thursday: 00:00 (midnight)
 - Friday and Saturday: 01:00 (the following day)
 - Closing time for public houses, wine bars or other drinking establishments:
 - Sunday to Thursday: 23:00
 - Friday and Saturday: 00:00 (midnight)
 - Closing time for off-licences and alcohol sales in grocers and supermarkets:
 - o Monday to Sunday: 00:00
 - Closing time for take-away establishments:
 - Sunday to Thursday: 00:00 (midnight)
 - Friday and Saturday: 01:00 (the following day).

Resource implications

24. A fee of £100.00 has been paid by the applicant company in respect of this application being the statutory fee payable for premises within non-domestic rateable value bands D/E.

Consultation

25. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local newspaper and similar notices were exhibited outside of the premises for a period of 28 consecutive days.

Community impact statement

26. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Director of Law and Democracy

- 27. The sub-committee is asked to determine the application for a premises licence under section 17 of the Licensing Act 2003.
- 28. The principles which sub-committee members must apply are set out below.

Principles for making the determination

- 29. The general principle is that applications for premises licence applications must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 30. Relevant representations are those which:
 - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
 - Are made by an interested party or responsible authority
 - Have not been withdrawn
 - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious.
- 31. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to:
 - To grant the licence subject to:
 - The conditions mentioned in section 18 (2)(a) modified to such extent as the licensing authority considers necessary for the promotion of the licensing objectives
 - Any condition which must under section 19, 20 or 21 be included in the licence
 - To exclude from the scope of the licence any of the licensable activities to which the application relates
 - To refuse to specify a person in the licence as the premises supervisor
 - To reject the application.

Conditions

32. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the application, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.

- 33. The four licensing objectives are:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 34. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 35. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to night café and take away aspect of the license must relate to the night time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 36. Members are also referred to the Home Office revised guidance issued under section 182 of the Licensing Act 2003 on conditions, specifically section 10.

Reasons

37. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for a premises licence application, it must give reasons for its decision.

Hearing procedures

- 38. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
 - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
 - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
 - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
 - Address the authority
 - If given permission by the committee, question any other party.
 - In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
 - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
 - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.

- In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 39. This matter relates to the determination of an application for a premises licence under section 17 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

Council's multiple roles and the role of the licensing sub-committee

- 40. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 41. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.
- 42. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 43. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 44. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
 - The sub-committee can only consider matters within the application that have been raised through representations from other persons and responsible authorities. Other persons must live in the vicinity of the premises. This will be decided on a case to case basis.
- 45. Under the Human Rights Act 1998, the sub-committee needs to consider the balance between the rights of the applicant and those making representations to the

- application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.
- 46. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

Guidance

47. Members are required to have regard to the DCMS guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

Strategic Director of Finance and Governance

48. The head of regulatory services has confirmed that the costs of this process over and above the application fee are borne by the service.

- Supply of alcohol (on and off the premises) on Sunday to Wednesday from 10:00 to 23:30 and on Thursday to Saturday from 10:00 to 00:00
- Overall opening times shall be on Sunday to Wednesday from 09:00 to 00:00 and on Thursday to Saturday from 10:00 to 00:30 the following day

The application describes the premises as

'36 Snowsfields is part of a new development. The restaurant is collaboration between a well known hotel and restaurant operator, Peng Loh, and highly experienced Portuguese Chef Leandro Carriera. This will be a beautifully designed premises with a focus on quality food and drink in a non-fussy atmosphere. More can be read in the attachments. The premises will sit in a busy mixed used commercial area very close to the iconic Shard. Whilst the premises are just within the Borough cumulative impact area, we respectfully submit that it should not contribute to any concerns with the licensing objectives as customers will be seated and served, and dining at different times. The new restaurant and bar will contribute to the excellence of Southwark's food and drink facilities. The formal restaurant area is to the left of the entrance with a seasonal terrace. To the right is an informal are for lighter snacks and drinks without the need for a full meal where customers will be seated and served by waiter or waitress. We would request up to 12 persons to be able to stand at the bar whilst waiting for a table. There will not be any regulated entertainment, only background recorded music'

The premises is situated in Bankside and Borough District Town Centre Area and also falls within the Borough and Bankside CIP Area.

My representation is based on the Southwark Statement of Licensing policy 2016 – 2020 and relates to the licensing objectives for the prevention of crime and disorder and the prevention of public nuisance.

Section six of the policy (from page 32) deals with Southwark's local cumulative impact policies. This premises sits in the Borough and Bankside policy area as defined in paragraph 129 of the policy and as a restaurant this premises falls into the class of premises in 130 of the policy.

Therefore under 119 of the policy there is a rebuttable presumption that applications for new premises licences that are likely to add to the existing cumulative impact will normally be refused or subject to certain limitations. In such circumstances, it is for the applicant to demonstrate that the application will not, if granted, further contribute to the negative local cumulative impact on any one or more of the licensing objectives.

The applicant has not addressed the presumption to refuse this application within the operating schedule. I would recommend refusal of this application unless the applicant can demonstrate that the premises will not be contributing to crime and disorder and public nuisance within the policy area, the following conditions would address my concerns and could assist the applicant in this rebuttal.

Due to the limited information on the application form and to promote the licensing objectives I ask the applicant to provide the following information:

- An accommodation limit for the outside area as indicated on the plans and an accommodation limit for the inside of the premises. (to be conditioned)
- To provide a written dispersal policy for the premises. (to be conditioned)

Add further conditions to the operating schedule as follows:

- Alcohol shall be supplied only to those seated and taking a table meal at the premises except for 12 persons who may wait at the bar whilst waiting for a table.
- 'Off sales' of alcohol shall be sold in closed containers and taken away from the premises.
- That clear legible signage shall be prominantely displayed where it can be easily seen and read, requesting that alcohol sold as 'off sales' should not be opened and consumed in the vicinity of the premises.
- That clear legible signage shall be prominantely displayed where it can be easily seen and read, requesting that customers leave the area in a quiet and orderly manner.

I therefore submit this representation and welcome any discussion with the applicant to consider the above representation.

I therefore request that the application is limited to A3 restaurant use, with the normal provision in such circumstances that drink shall only be sold with food and its consumption shall be ancillary to that food.


You should also be aware that the original planning permission (ref 13/AP/3059) imposes hours of use restrictions such that the permitted use of the premises cannot be carried on outside the hours of 07:00 to 23:00 on Monday to Saturday and not at all on Sundays or Bank Holidays. This is to "safeguard the amenity of neighbouring residential properties". You should note also that other premises on Snowsfields also operate zero or restricted hours on Sundays.

Please can you ensure that the licensing hours mirror this restriction.

You should further be aware that a recent planning permission for a new shopfront with fold and slide panels (ref 17/AP/1505) included a Condition that the fold and slide panels must be fully closed by no later than 9pm on each day that the units are operational. This is "in the interests of preventing noise outbreak that might adversely affect the amenity of residential occupiers immediately above" the premises.

Please can you ensure that any Licence conditions also support this restriction, particularly also with regard to any outside seating.

I am writing to submit my formal objection to the Premises Licence Application Ref: 859122.

It has come to my attention that there are discrepancies between the hours of operation and use originally granted as part of the 2013 planning application and therefore held by the premises and the requests that are being made in this Premises Licence Application. The premises in question hold permission for A3 restaurant use (with additional A1 and B1 use), however the aforementioned application seems to seek permission for use more in line with an A4 bar licence. I therefore ask that the application is limited to the use stated in the original planning application, and that alcoholic drinks are only sold alongside food, as is the case in other establishments in the nearby area.

In addition, the original planning application for the premises (REF 13/AP/3059), states a set of hours of operation which are once again not reflected in the relevant Premises Licence Application. The original permission stated that the permitted use 'shall not be carried on outside the hours of 7:00 to 23:00 on Monday to Saturday and on Sundays and Bank Holidays'. It would be advantageous to the immediate neighbours and residents of Snowsfields that the licensing hours granted to the premises reflect these operating hours, thus actively attempting at 'safeguarding the amenity of neighbouring residential properties, as originally stated in the 2013 planning permission.

Furthermore, I wish to highlight the importance of the Pre-Occupation Condition imposed in the granted planning permission Ref 17/AP/1505, which states that the fold and slide panels 'will be fully closed by no later than 9pm on each day the unit is operational' in 'the interest of preventing noise outbreak that might adversely affect the amenity of residential occupiers immediately above'.

Due to the heavily residential nature of the area, I would like to add how inappropriate the presence of an establishment with such extended operational hours would be. The allowed sale of alcohol until the late hours would potentially lead to heavy noise pollution for the neighbouring residential properties.

I hope that the contents of this letter will be taken into consideration for the final decision regarding the Premises Licence Application, and that the interest of the residents be kept as a priority in the decision making process, in order to limit the detrimental effect of this establishment in the area.


