RECOMMENDATION

1. That the licensing sub-committee considers an application made by Rinneroon Ltd for a premises licence to be granted under the Licensing Act 2003 in respect of the premises known as Rinneroon, 130 Druid Street, London SE1 2HH.

2. Notes:

- a) This application forms a new application for a premises licence, submitted under Section 17 of the Licensing Act 2003. The application is subject to representations from responsible authorities and other persons and is therefore referred to the sub-committee for determination.
- b) Paragraphs 8 to 11 of this report provide a summary of the application under consideration by the sub-committee. A copy of the full application is attached as Appendix A.
- c) Paragraphs 12 to 20 of this report deal with the representations submitted and any further correspondence in respect of the application. Copies of the representations are attached as Appendices B, C, D and E.
- d) Paragraph 24 deals with licensed premises within a 100 metre radius of the premises. A map of the area is attached as Appendix F.
- e) A copy of the council's approved procedure for hearings of the sub-committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing regulations, has been circulated to all parties to the meeting.

BACKGROUND INFORMATION

The Licensing Act 2003

- 3. The Licensing Act 2003 provides a licensing regime for:
 - The sale of and supply of alcohol
 - The provision of regulated entertainment
 - The provision of late night refreshment.
- 4. Within Southwark, the licensing responsibility is wholly administered by this council.

- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:
 - The prevention of crime and disorder
 - The promotion of public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to
 - The Act itself
 - The guidance to the act issued under Section 182 of the Act
 - Secondary regulations issued under the Act
 - The licensing authority's own statement of licensing policy
 - The application, including the operating schedule submitted as part of the application
 - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.

KEY ISSUES FOR CONSIDERATION

The premises licence application

- 8. On 7 June 2018, Rinneroon Ltd applied to this council for the grant of a premises licence in respect of Rinneroon, 130 Druid Street, London SE1 2HH. The premises is described as Network Rail archway with a small area outside the premises on the road. The premises is currently empty, however it will be transformed into a home for a community led running club. It will store merchandise, have an office space and have a section where running relate foods and beverages can be sold.
- 9. The application is summarised as follows:
 - Supply of alcohol (on the premises)
 - Monday to Sunday from 12:00 to 23:00.
 - Operating hours
 - Monday to Saturday from 12:00 to 23:00
 - Sunday from 11:00 to 23:00.
- 10. The premises licence application form provides the applicant's operating schedule. Parts J, K, L, and M of the operating schedule set out the proposed licensable activities, operating hours and operating control measures in full, with reference to the four licensing objectives as stated in the Licensing Act 2003. Should a premises licence be issued in respect of the application the information provided in the operating schedule will form the basis of conditions that will be attached to any

licence granted subsequent to the application. A copy of the application is attached to this report as Appendix A.

Designated premises supervisor

11. The proposed designated premises supervisor (DPS) Tim Jones has a personal licence issued by the Southwark Council.

Representations from responsible authorities

- 12. There are representations from the Metropolitan Police Service, environmental protection team (EPT), licensing (as a responsible authority) and health and safety.
- 13. The police representation states that the premises are located in a railway arch in a mainly residential street and there are large residential blocks opposite. The premises does not benefit from an outside area on Druid Street and opens directly onto the pavement/loading bay which is a public highway with no border to the road. The area where the premises is located is becoming saturated with licensed premises and the use of outside areas is having a cumulative impact on the area causing public nuisance to local residents including public urination and obstructions to passing traffic putting people in danger. They have proposed a number of conditions to the applicant for consideration.
- 14. The EPT were concerned that the controls listed in the application were insufficient to ensure the prevention of public nuisance licensing objective. Specifically they had concerns about noise and nuisance from people externally and dispersal from the premises affecting residents directly opposite. Further to that, they were concerned that there was no usable external area to the premises as this opens directly onto a loading bay which forms part of the carriageway. A number of conditions were proposed to the applicant for consideration. The EPT and the applicant have now conciliated and the EPT have since withdrawn their representation.
- 15. The licensing representation states that due to the limited information on the application form and in order to promote the licensing objectives, they have asked the applicant to provide additional information. Furthermore the application has not left any time between the last sale of alcohol 'on sales' and the closing time when patrons should have left the premises and have requested that the application be amended so that the 'on sales' of alcohol shall cease at least half an hour before the closing time of the premises. They have also proposed a number of conditions for consideration.
- 16. Health and safety have asked the applicant to explain how he will deal with public safety. They are concerned that customers who want to sit outside drinking will be sitting on the public highway where cars drive by and there is a risk of vehicles driving into customers drinking outside in the proposed area. They also requested for a risk assessment to be submitted. The necessary information has since been submitted and the representation has now been withdrawn.
- 17. The representations are attached as Appendix B.

Representations from other persons

18. There are 16 representations from other persons. Four of the representations are opposed to the application and 12 of the representations are in support of the application.

- 19. The people opposed to the application state that the area is already saturated by outlets providing alcoholic beverages. The behaviour of the patrons to the above outlets is noisy and anti-social and consists of (loud chanting and singing, people right outside homes and gardens using the estate to sit and consume their alcohol, urinating on the estate (all in front of children), sitting on the pavements with legs in the road causing passing motorists to have to sound their hooters to get past).
- 20. Those in support of the applicant believe that the club increases the social bond in the community by bringing together people from all walks of life. The club, being a running club, encourages the health and well being of its members as well as networking amongst members before and after running events.
- 21. The representations are attached as Appendix C.

Conciliation

22. The representations were forwarded to the applicant's representative. The applicant has responded with a conciliation statement which has been circulated to all parties concerned. The EPT and health and safety have withdrawn their representations after conciliating with the applicant. The conciliation statements and the subsequent withdrawal emails are attached as Appendices D and E. The licensing subcommittee will be updated on 3 August 2018 of any developments.

Deregulation of entertainment

- 23. On 6 April 2015 entertainment became deregulated and as a result:
 - Live unamplified music is deregulated between 08:00 and 23:00 on any premises.
 - Live and recorded amplified music is deregulated between 08:00 and 23:00 at on-licensed premises provided the audience does not exceed 500 people, however, live music can become licensable in on-licensed premises if the licensing authority removes the effect of the deregulation following a licence review ('licence review mechanism').

Map of the local area

24. A map of the area is attached to this report as Appendix F. For purposes of scale only the circle on the map has a 100 metre radius. The following licensed premises terminal hours are also shown on the map.

- 25. Within the Southwark statement of licensing policy 2016 2020 the following closing times are recommended as appropriate within this area for this categories of premises as follows:
 - Closing time for restaurant, cafés, public houses wine bars or other drinking establishments:
 - o 23:00 daily.

Southwark council statement of licensing policy

26. Council assembly approved Southwark's statement of licensing policy 2016 - 2020 on 25 November 2015. The policy came into effect on 1 January 2016. Sections of the

statement that are considered to be of particular relevance to the sub-committee's consideration are:

- Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this authority relies in determining licence applications.
- Section 5 Determining applications for premises licences and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
- Section 6 Local cumulative impact policies. This sets out this authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy.
- Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this authority might consider appropriate by type of premises and (planning) area classification.
- Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective.
- Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective.
- Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective.
- Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective
- 27. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.

Resource implications

28. A fee of £190.00 has been paid by the applicant company in respect of this application being the statutory fee payable for premises within non-domestic rateable value band B.

Consultation

29. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local newspaper and similar notices were exhibited outside of the premises for a period of 28 consecutive days.

Community impact statement

30. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Director of Law and Democracy

- 31. The sub-committee is asked to determine the application for a premises licence under section 17 of the Licensing Act 2003.
- 32. The principles which sub-committee members must apply are set out below.

Principles for making the determination

- 33. The general principle is that applications for premises licence applications must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 34. Relevant representations are those which:
 - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
 - Are made by an interested party or responsible authority
 - Have not been withdrawn
 - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious.
- 35. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to:
 - To grant the licence subject to:
 - The conditions mentioned in section 18 (2)(a) modified to such extent as the licensing authority considers necessary for the promotion of the licensing objectives
 - Any condition which must under section 19, 20 or 21 be included in the licence.
 - To exclude from the scope of the licence any of the licensable activities to which the application relates.
 - To refuse to specify a person in the licence as the premises supervisor.
 - To reject the application.

Conditions

36. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the application, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the

control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.

- 37. The four licensing objectives are:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 38. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 39. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to night café and take away aspect of the license must relate to the night time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 40. Members are also referred to the Home Office Revised Guidance issued under section 182 of the Licensing Act 2003 on conditions, specifically section 10.

Reasons

41. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for a premises licence application, it must give reasons for its decision.

Hearing procedures

- 42. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
 - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
 - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
 - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
 - Address the authority
 - o If given permission by the committee, question any other party.
 - o In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
 - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
 - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing

- so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.
- In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 43. This matter relates to the determination of an application for a premises licence under section 17 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

Council's multiple roles and the role of the licensing sub-committee

- 44. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 45. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.
- 46. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 47. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 48. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 49. The sub-committee can only consider matters within the application that have been raised through representations from other persons and responsible authorities. Other persons must live in the vicinity of the premises. This will be decided on a case to case basis.

- 50. Under the Human Rights Act 1998, the sub-committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.
- 51. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

Guidance

52. Members are required to have regard to the Home Office Revised Guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

Strategic Director of Finance and Governance

53. The head of community safety and enforcement has confirmed that the costs of this process are borne by the service.

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The venue's purpose is to house our running club which been going for over 8 years. The emphasis therefore is promoting free exercise and giving advice and help to our thriving running community. We've won 3 awards for volunteering and are supported by MP Neil Coyle as we were by his predecessor Simon Hughes. We've also featured recently on BBC breakfast promoting our Couch to 5k programme, as well as on ITV news and the local press. All of this makes us quite unlike any of the breweries and establishments nearby which we feel will help us provide something new in the area promoting health and wellbeing.

We have been meeting in other venues along Druid Street for many years, and therefore are not going to be increasing the volume of people visiting the area once our venue opens. For over a year we have been meeting within 100 feet of the new venue in a nearby pub without any complaint from nearby residents.

As a long established club, we already have terms and conditions to ensure that the safety and welfare of the public is protected. We revoke membership of the club to anyone who behaves non-respectfully to other members, the venue staff, or members of the public. Over the years this has happened very rarely and we have a community of long-established members, many of whom are well-respected professionals and members of the local community. A number of our members live in the housing estate directly opposite the venue.

The venue will also serve and be visited by members of the public outside of our main club session times, but they would be in the minority and are expected to observe our rules in relation to the license objectives.

Very few of our runners smoke so there should not be a need for large numbers to continually congregate outside. In warmer weather some runners may stand in the outside space on Druid Street next to the road, but we will make sure this number is always low and we'll ensure that it is cordoned off and that the number of people never exceeds 30. SIA staff will be employed if necessary to make sure that the number doesn't go over x25 in order to give us a buffer.

Often we will have running related workshops within the arch, but these will be ticketed to limit numbers and will not be heard from the outside of the venue. We give water to our members on running nights and these will be served in recyclable cups with our logo. All bottles and refuge will be disposed of very quietly and before 10pm at night.

All staff will be trained to enforce Challenge 25 and to use the incident log in case of any incidents.

Any music will just be ambient music kept at low volume. Tuesday is our busiest night of the week and usually almost all runners have left the venue by 9.30pm

b) The prevention of crime and disorder

CCTV will be put on the premises both at the counter and the entrance to the property. The staff will be trained to look out for any suspicious activity and if crimes are suspected this will be reported to the police.

c) Public safety

If at any point a member of staff sees a customer who appears to be intoxicated they will immediately inform the duty manager. Service will be refused should they try to buy another drink. The duty manager will ask them politely to leave explaining that it's not personal but it's for professional reasons. They will also be offered water. If they become unruly they will be asked to leave the premises and on all occasions this will be recorded in the service log.

Glassware will be regularly collected from inside and outside the area and any broken glass swept up and disposed of immediately. We will also conduct regular head counts inside and outside the property every half an hour. We'll have all the relevant fire and safety notices in place.

d) The prevention of public nuisance

Any patrons inside who are causing nuisance by shouting, chanting or causing trouble which could cause annoyance to nearby residents will be asked to keep the noise down. If they ignore this then they will be reported to the duty manager and they will be asked to leave. The incident will be recorded in an incident log. We'll add posters on drinking and driving in the toilets and drink aware posters.

e) The protection of children from harm

Membership of our running club is only open to adults over the age of 18. Children do occasionally visit the club but always accompanied by a parent/guardian and under no circumstances would ever be served alcohol.

We will use challenge 25 to prevent anyone under the age of 18 buying or consuming alcohol. Staff will be trained to recognise the internationally recognised IDs and will check the photos and dates.





Police are in receipt of an application from the above for a new premises licence.

The premises are located in a railway arch in a mainly residential street and there are large residential blocks opposite. The premises does not benefit from an outside area on Druid Street and opens directly onto the pavement/loading bay which is a public highway with no border to the road. The area the premises is located is becoming saturated with licensed premises and the use of outside areas is having a cumulative impact on the area causing public nuisance to local residents including public urination and obstructions to passing traffic putting people in danger.

I have attached two images taken from street view indicating the outside area and the close proximity to residential premises.

Any use of outside area as shown on plans will only cause further public nuisance to the resident opposite and possible obstruct the highway and possibly be hazardous to traffic and customers due to passing traffic.

The application described the operation as follows:- A community running club to be used to store merchandise, running related food and beverages with an office.

The area has a considerable amount of brewery, food and alcohol lead type venues with groups of people moving between the different licensed premises having consumed alcohol leading to a high possibility of intoxication within the area.

We object to the granting of the licence unless the outside area is removed from the plans and further conditions are placed on the licence to negate complaints about anti-social behaviour, noise nuisance and crime and disorder. The applicant has offered a number of control measure within the application which we welcome and would like to see the wording we have suggested to avoid ambiguity.

- That a CCTV system be installed at the premises and be maintained in good working order and be continually recording at all times the premises are in use under the licence. The CCTV System must be capable of capturing a clear facial image of every person who enters the premises and all areas the public have access including outside areas.
- 2. All CCTV footage be kept for a period of 31 days and shall on request be made immediately available to officers of the police and the council.
- 3. A member of staff should be on duty at all times the premises is open that is trained in the use of the CCTV and able to view and download images to a removable device on request of Police or council officer.
- 4. That all staff are trained in their responsibilities under the licensing act 2003 and training records to be kept and updated every 6 months and shall, upon request, be made immediately available to Officers of the Police and the Council.
- 5. No customers should be allowed to take drinks from the licensed area other than to take away and they must be in a sealed container.
- 6. Customers shall use no outside area other than those who temporarily leave the premises to smoke a cigarette and No more than 5 people at one any time.
- 7. After 22.30hrs only off sales may be made and must be sold in sealed containers and opened away from the premises.

We would welcome the opportunity to conciliate with the applicant. If they wish to contact me on the above email.

Please could you pass these comments on to the applicant? No email address has been provided.

I have considered the above application and I would like to object on the grounds that the controls listed in the application are insufficient to ensure the prevention of public nuisance licensing objective. Specifically I am concerned about noise and nuisance from people externally and dispersal from the premises affecting residents directly opposite. Further, there is no usable external area to the premises as this opens directly onto a loading bay which forms part of the carriageway.

I would be happy to withdraw my objections if the applicant can agree to the following conditions:

FIRST OF ALL THANK YOU FOR CONSIDERING ALL MATTERS. I HOPE MY RESPONSES BELOW WILL PROVIDE YOU WITH SUFFICIENT COMFORT. OUR ENTIRE MODEL IS BASED ON ADDING VALUE TO THE COMMUNITY SO WE WILL BE TAKING ALL MATTERS SERIOUSLY TO ENSURE WE DO NOT CAUSE ANY NEGATIVE IMPACT. STAFF WILL ACTIVELY ENSURE THAT CUSTOMERS ACT IN ACCORDANCE WITH OUR STRONG COMMUNITY VALUES, AND HAVE A MINIMAL IMPACT ON OUR NEIGHBOURING BUSINESSES AND RESIDENTS.

• That customers shall not use any outside area to the front of the premises other than those who temporarily leave the premises to smoke, and no more than 5 people shall be permitted to do so at any one time. No drinks shall leave the premises other than off sales that are sold in a sealed container for consumption away from the premises.

WE AGREE WITH THIS BUT WE WOULD REQUEST THAT THE RESTRICTION ON THE MAXIMUM NUMBER OF PEOPLE OUTSIDE BE RESTRICTED TO 20 AT ANY ONE TIME AND WE'LL CORDON OFF THE AREA. We have a solution in principle but please could you clarify – is the 'cordon' marked on the plan the extent of your demise? i.e. please confirm this area does not encompass any of the loading bay.

I would suggest you need to resubmit the plan to clarify exactly which area will be used for external drinking (i.e. hatch or shade in red on plan) and with a red boundary line marking the total extent of the licensable area. You need to amend a proper plan as attached rather than the sketch it is too inaccurate to be clear and enforceable for everyone involved.

Please could you also confirm whether you have Planning Consent for change of use of the arch (and the proposed physical works to the facade) and\or if you do not, whether you are in the process of applying for this?

Subject to the above I will be happy to withdraw my objections on the basis that the external area is fully within the licensable area of the premises and does not intrude onto the loading bay, also subject to the following final list of conditions:

I write with regards to the above application for a premises licence submitted Rinneroon Limited under the Licensing Act 2003, which seeks the following licensable activities:

- Supply of alcohol (on the premises) on Monday to Sunday from 12:00 to 23:00

The premises is described as

'This is a Network Rail archway on Druid Street not far from Tower Bridge. It currently is completely empty other than one disused toilet. There is a small area outside the premises on the road that other businesses nearby have cordoned off for outside space. The archway will be turned into a home for our community led running club that has been going for 9 years. We've won various awards for volunteering. We'll store merchandise, have office space and have a section where running related foods and beverages can be sold'

This premises is in a residential area and my representation is submitted under the prevention of crime and disorder and the prevention of public nuisance licensing objectives and has regard to the Southwark Statement of Licensing Policy.

Due to the limited information on the application form and to promote the licensing objectives I ask the applicant to provide the following information:

- An accomodation limit for the premises. (to be conditioned)
- To provide a written dispersal policy for the premises. (to be conditioned)

Furthermore the application has not left any time between the last sale of alcohol 'on sales' and the closing time when patrons should have left the premises, this can lead to conflict between staff and the customer having purchased an alcoholic drink for consumption on the premises minutes before closing time and being asked to either finish the drink or hand it back and to leave the premises. Additionally this will encourage patrons to rush consumption of alcoholic drinks at the same time of closing which can lead to antisocial behaviour problems when patron have left the premises.

Therefore I also ask the applicant to consider:

 Amending the licensable activities so that the 'on sales' of alcohol shall cease at least half hour before the closing time of the premises. (22:30) To further promote the licensing objectives add the following conditions to the operating schedule as follows:

- That no drinks in opened containers shall be allowed outside the premises, which includes the area directly outside the front exit door
- The management shall provide information on the premises of local taxi companies





This is to the detriment of our internal plans but alleviating your concerns are our priority and this is a viable solution to allow a controlled environment. This means that there will be a space of approximately 7 to 8 square metres within the footprint of our premises which will take our customers off the pavement area.
