#### RECOMMENDATION

1. That the licensing sub-committee considers an application submitted by an 'other person' under Section 51 of the Licensing Act 2003 (the Act) for the review of the premises licence held by Underdog Art Company Limited in respect of the premises known as Underdog Gallery, Railway Arch 6, Crucifix Lane, London SE1 3JW.

#### 2. Notes:

- a) The grounds for the review are stated in paragraph 13 of this report. A copy of the review application is attached as Appendix A.
- b) 'Other persons' have submitted representations in respect of the application. Copies of the representations are attached as Appendix D. Details of the representation are provided in paragraph 17.
- c) A copy of the current premises licence issued in respect of the premises is attached to this report as Appendix B. A map of the area that the premises are located in is attached as Appendix E.
- d) A copy of the council's approved procedure for hearings of the sub-committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing regulations, has been circulated to all parties to the meeting.

#### **BACKGROUND INFORMATION**

#### The Licensing Act 2003

- 3. The Licensing Act 2003 provides a new licensing regime for:
  - The sale of and supply of alcohol
  - The provision of regulated entertainment
  - The provision of late night refreshment.
- 4. Within Southwark, the licensing responsibility is wholly administered by this council.
- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:

- The prevention of crime and disorder
- The promotion of public safety
- The prevention of nuisance
- The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to:
  - The Act itself
  - The guidance to the act issued under Section 182 of the Act
  - Secondary regulations issued under the Act
  - The licensing authority's own statement of licensing policy
  - The application, including the operating schedule submitted as part of the application
  - Relevant representations.
- 7. The applications process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.
- 8. The premises licence once issued remains valid for the life of the business unless surrendered or revoked. However, under section 51 of the Act it remains open to any responsible authority or other person to apply to the local licensing authority for a review of the premises licence where there are ongoing concerns regarding one or more of the four stated licensing objectives.

#### **KEY ISSUES FOR CONSIDERATION**

#### The premises licence

- 9. The premises licence allows the provision of licensable activities as follows:
  - The sale of alcohol to be consumed on premises:
    - Monday to Thursday from 11:00 to 23:00
    - o Friday and Saturday from 11:00 to 00:30 the following day
    - Sunday from 11:00 to 22:30.
  - Plays, Films, Live music and recorded music:
    - Monday to Thursday from 09:00 to 23:00
    - o Friday and Saturday from 09:00 to 00:30 the following day
    - Sunday from 09:00 to 22:30.

#### Late night refreshment:

Friday and Saturday from 23:00 to 00:30 the following day.

#### Opening times:

- Monday to Thursday from 09:00 to 23:30
- o Friday and Saturday from 09:00 to 01:00 the following day
- Sunday from 09:00 to 23:00.
- 10. The licence is subject to the mandatory conditions set down under the Act and further conditions consistent with the operating schedule submitted with the application for the licence. A copy of the full premises licence is attached as Appendix B.

#### **Designated premises supervisor**

11. The current designated premises supervisor (DPS) named on the licence is Sammy James Forway.

#### The review application

- 12. On 15 June 2018 an application was submitted by an 'other person', under Section 51 of the Licensing Act 2003, for the review of the premises licence held by Underdog Art Company Limited in respect of the premises known as Underdog Gallery, Railway Arch 6, Crucifix Lane, London SE1 3JW.
- 13. The review application was submitted in respect of the prevention of public nuisance licensing objective and in summary states:
  - That excessive noise nuisance is caused as a result of the operation of the premises. The sources of the noise nuisance are extremely loud music emanating from the premises and the premises' customers congregating at and in the vicinity of the premises. The customers engage in noisy activities such as shouting and jeering.
  - That the premises operate outside of permitted hours sometimes hosting 'club nights' that allegedly finish between 04:00 and 05:00 hours.
  - That condition 844 of the premises licence issued in respect of the premises has allegedly been breached on numerous occasions. Condition 844 states: "That the premises shall not operate as a night club."
  - That staff at the premises have acted aggressively to or not been receptive to residents when residents have sought to address directly with premises' staff noise nuisance emanating from the premises.
- 14. Full details of the grounds for the review are provided within the review application. Further evidence was also provided by the review applicant in a letter and compact disk. The licensee submitted a letter in reply to the review application addressing the allegations in the review application and containing a copy of the rules for hirers of the premises. Copies of the review application, the letter from the review applicant with further evidence in support of the review application and the letter from the licensee in reply to the review application are attached as Appendix A.

#### Representations from responsible authorities

- 15. The licensing responsible authority has submitted, a representation in support of the review application in relation to the prevention of public nuisance and the prevention of crime and disorder licensing objectives. The representation contends that it seems that the premises are now operating as a nightclub. The representation notes that there have been several complaints made to the licensing unit in regards to noise, that licensing officers have witnessed the premises being operated in breach of the conditions of the premises licence issued in respect of the premises and that a warning has been issued regarding breaches of the premises licence. Further evidence, relating to TENs submitted in respect of the premises and also visits to the premises by police and council officers has been submitted by the licensing responsible authority.
- 16. Copies of the representation submitted by the licensing responsible authority and further evidence in relation to the representation are attached as Appendix C.

#### Representations from other persons

- 17. Four representations have been submitted by 'other persons' (referred to as parties 1 to 6). All of the representations support the review application and all relate to similar allegations as put forward in the grounds for the review application in paragraph 13 above.
- 18. Copies of the representations submitted by the other persons are attached as Appendix D.

#### **Operating History**

- 19. On 2 October 2014 a premises licence was issued in respect of the premises to Underdog Art Company Limited. The DPS of the premises was specified as Sammy James Forway.
- 20. On 15 June 2018 an application was submitted by an 'other person', under Section 51 of the Licensing Act 2003, for the review of the premises licence issued in respect of the premises.
- 21. Details of Temporary Event Notices (TENs) submitted in respect of the premises are attached in Appendix C as part of evidence in support of the representation submitted by the Licensing Responsible Authority.
- 22. Details of complaints received by the licensing unit, in respect of the premises, are attached in Appendix C as part of evidence in support of the representation submitted by the licensing responsible authority.

#### The local area

23. A map of the local area is attached as appendix E. The following premises are shown on the map and are licensed as stated below.

  - Monday and Tuesday from 08:00 to 01:00
  - Wednesday to Friday from 08:00 to 02:00
  - Saturday from 11:00 to 02:00
  - Sunday from 11:00 to 00:00.
- Late night refreshment:
  - Monday and Tuesday from 23:00 to 01:00
  - Wednesday to Friday from 23:00 to 02:00
  - Saturday from 23:00 to 02:00
  - Sunday from 23:00 to 00:00.

#### Globe House, 37 Bermondsey Street, London SE1 3XF licensed for:

- The sale of alcohol:
  - Monday to Sunday from 12:00 to 00:00.

## International Wine and Spirit Centre, 39-45 Bermondsey Street, London SE1 3XF licensed for:

- The sale of alcohol:
  - Monday to Sunday from 08:00 to 21:00.

## The Bermondsey Yard Cafe, 40 Bermondsey Street, London SE1 3UD licensed for

- The sale of alcohol:
  - o Monday to Sunday from 11:00 to 01:00 the following day.
- The provision of late night refreshment:
  - Monday to Sunday from 23:00 to 01:00 the following day.
- Recorded music:
  - o Monday to Sunday from 07:00 to 01:00 the following day.

#### Southwark council statement of licensing policy

- 24. Council assembly approved Southwark's Statement of Licensing Policy 2016 20 on 25 November 2015. The policy came into effect on 1 January 2016. Sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
  - Section 3 Purpose and scope of the policy. This reinforces the four licensing objectives and the fundamental principles upon which this authority relies in determining licence applications.
  - Section 5 Determining applications for premises licences and club premises certificates. This explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
  - Section 6 Local cumulative impact policies. This sets out this authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy
  - Section 7 Hours of operation. This provides a guide to the hours of licensed operation that this authority might consider appropriate by type of premises and (planning) area classification.
  - Section 8 The prevention of crime and disorder. This provides general guidance on the promotion of the first licensing objective.
  - Section 9 Public safety. This provides general guidance on the promotion of the second licensing objective.

- Section 10 The prevention of nuisance. This provides general guidance on the promotion of the third licensing objective.
- Section 11 The protection of children from harm. This provides general guidance on the promotion of the fourth licensing objective.
- 25. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.
- 26. Within Southwark's statement of licensing policy 2016 2020 the premises are identified as being within Bankside, Borough & London Bridge strategic cultural area. Closing times are recommended in the Statement of licensing policy for different types of licenced premises in this area as below:
  - Public houses, wine bars or other drinking establishments:
    - Sunday to Thursday: 23:00
    - o Friday and Saturday: 00:00.
  - Nightclubs:
    - Monday to Thursday: 01:00
    - Friday and Saturday: 03:00
    - o Sunday: 00:00.

#### **Resource implications**

27. There is no fee associated with this type of application.

#### Consultation

28. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003.

#### **Community impact statement**

29. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

#### SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

#### **Director of Legal Services**

30. The sub-committee is asked to determine, under Section 51 of the Licensing Act 2003, following an application, made under Section 51 of the same act, for a review of premises licence. At any stage, following the grant of a premises licence, a responsible authority or any other person may ask the licensing authority to review the licence because of a matter arising at the premises in connection with any of the four licensing objectives.

31. The principles, which sub-committee members must apply, are set out below.

#### Principles for making the determination

- 32. Under Section 52 the licensing authority must hold a hearing to determine the review and any relevant representations.
- 33. The four licensing objectives are:
  - The prevention of crime and disorder
  - The protection of public safety
  - The prevention of nuisance
  - The protection of children from harm.
- 34. Each objective must be considered to be of equal importance. The authority must, having regard to the application and any relevant representations, take such of the following steps as it considers appropriate for the promotion of the licensing objectives. The steps are to:
  - Modify the conditions of the licence by altering, omitting or adding any condition
  - Exclude a licensable activity from the scope of the licence
  - Remove the designated premises supervisor
  - Suspend the licence for a period not exceeding three months
  - Revoke the licence.
- 35. For the purpose of determining a relevant representation under section 52 of the Act a "relevant representation" means representations which:
  - Are relevant to one or more of the licensing objectives
  - Are made by the holder of the premises licence, a responsible authority or an other person within the prescribed period
  - Have not been withdrawn
  - If made by an other person (who is not also a responsible authority), that they are not, in the opinion of the relevant licensing authority frivolous or vexatious.
- 36. Modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months.
- 37. The authority may decide that no action is necessary if it finds that the review does not require it to take any steps appropriate to promote the licensing objectives.
- 38. In deciding what remedial action if any it should take, the authority must direct its mind to the causes or concerns that the representations identify. The remedial action should generally be directed at these causes and should always be no more than an appropriate and proportionate response.
- 39. It is of particular importance that any detrimental financial impact that may result from a licensing authority's decision is appropriate and proportionate to the promotion of the licensing objectives in the circumstances that gave rise to the application for review.

#### Reasons

- 40. Where the authority determines an application for review it must notify the determination and reasons why for making it to:
  - The holder of the licence
  - The applicant
  - Any person who made relevant representations
  - The chief officer of police for the area (or each police area) in which the premises are situated.

#### **Hearing procedures**

- 41. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
  - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
  - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
  - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
    - Address the authority
    - o If given permission by the committee, question any other party.
    - o In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
  - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
  - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.
  - In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 42. This matter relates to the determination of an application for a premises licence under section 17 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

#### Council's multiple roles and the role of the licensing sub-committee

43. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to

consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.

- 44. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.
- 45. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 46. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 47. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 48. The sub-committee can only consider matters within the application that have been raised through representations from other persons and responsible authorities. Other persons must live in the vicinity of the premises. This will be decided on a case to case basis.
- 49. Under the Human Rights Act 1998, the sub-committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.
- 50. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

#### Guidance

51. Members are required to have regard to the Home Office Revised Guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.

#### **Strategic Director of Finance and Governance**

52. The head of community safety and enforcement has confirmed that the costs of this process are borne by the service.

#### **GROUNDS FOR REVIEW OF LICENCE**

As a resident of Crucifix Lane I hereby apply for the review of the Premises Licence granted to Underdog Art Company Limited trading as The Underdog ('Underdog') situated at Arch 6 Crucifix Lane, SE1 3JW.

The section of Crucifix Lane in question is a narrow road approximately 10 meters wide and includes pavements on both sides. It is bordered to the north by railway arches and to the south by residential dwellings, save a pub and an office block further along to the east. The furthest residential dwelling from the Underdog is approximately 45 metres away as the crow flies. Underdog occupies arch number 6, neighbouring arches 7-11 are vacant and small offices and businesses occupy the remainder.

I live in a third floor flat, situated 15 m as the crow flies from the Underdog entrance, therefore 60 degrees down the road with respect to the normal of Underdog's facade. One of our bedrooms and the living room look out to the Underdog's entrance.

Underdog has been granted a licence to remain open from 09:00 till 23:30 from Monday to Thursday, till 01:00 on Friday and Saturday and till 23:00 on Sunday. The licence permits the performance of live music and the playing of recorded music indoors which is supposed to end half an hour before closing time.

Late club nights are routinely held at Underdog mainly but not only at the weekends. The Underdog also hosts club nights till 04:00 or 05:00 in the morning, outside its permissible licensed hours, sometimes on consecutive nights.

We have long been experiencing persistent nuisance as a result of the noise from both live and recorded music played at the Underdog. Crowds of revellers shouting and jeering in the venue compound this disturbance.

Underdog is usually hired out to third party organisers who charge fees for entry to the event. It is a venue that is favoured by heavy metal, psychedelic and stoner rock bands that rely heavily on loud percussion. The inordinate use of base drums and cymbals and generally being loud are an especially disturbing pre-requisite to the sorts of performances that are hosted at venue.

The the flyer of the 'Retribution Alive' night held at the Underdog on the 19<sup>th</sup> May 2018 (attached) boasts: 'The Retribution club night keeps the neighbours awake until 1AM!' It is a promise delivered.

In addition to the nuisance caused from within the venue there is also the sound of loud talking, laughing and shouting from people, often 15 or more, loitering and smoking outside the premises all through the evening that causes further disturbance. Closing time subjects us to the sound of noisy boisterous people leaving the club, which can take anything up to 45 minutes. This is often followed by band members and groupies noisily and drunkenly packing their vehicles with their instruments. This involves triggering car alarms and slamming doors and also often occurs far later than the advertised end of the gig, since they hang around in the venue for some time once the general public have left.

Additionally, the Underdog strives to assume a distinctly aggressive attitude towards residents. The anti-establishment values that it seeks to uphold instead has resulted in a hostile environment and the enactment of anti-social behaviour from the organisers and staff.

On one occasion when Mr attempted to take a photograph of the premises from the pavement as an event was going on he was threatened and chased into our building where he had to take refuge against an aggressive bouncer threatening to delete footage. Other residents have similarly experienced antagonistic behaviour when they have approached staff and management at Underdog. They have been warned off and refused access to Mr. Forway when they have sought to complain about the noise disturbance.

The Underdog frequently and fragrantly acts outside the terms and conditions of the licence:

In hosting music/ cub nights at the Underdog it is operating as a night club.

This is demonstrated by the facts:

- 1. there is door security,
- 2. there are scheduled nights with a line-up of bands and DJs,
- 3. dancing occurs,
- 4. there is a door charge,
- 5. there is an age limit
- 6. the premises are hired out to third parties.

The above are criteria used by Southwark Planners in previous cases to determine whether activities of an establishment are that of a bar or a nightclub. Furthermore club nights held at the Underdog are often listed on the Resident Advisor website which is the foremost directory of club events in the country. Under Condition 844 of the Licence Underdog is expressly barred from operating as a night club. These activities should be immediately stopped and enforcement proceedings taken.

- An event took place on the 27<sup>th</sup> January 2018 night with blaring music till 05:00 on 28<sup>th</sup> morning. A crowd of some 25-30 stood around on the pavement till 05:40 talking loudly, smoking and waiting for taxis as they dispersed. On checking the register I saw that a TEN that was not served.
- Another late night event was held on the 11<sup>th</sup>/12th May 2018 until at least 05:00 wherein loud music and shouting was heard all night. Checking the register I find that no notice for a TEN was served. Several residents have confirmed this noise but Mr. Forway denies that any event took place at all. A short clip (IMG\_0404.mov, attached) taken from our 3<sup>rd</sup> floor bedroom window at 05.01 on Saturday 12<sup>th</sup> May records the loud music and cheering and shouting emanating from Underdog and confirms that it did. An online programme for 'RA:kabuki. All nighter at Arch Gallery' listed on the Resident Adviser website is further attached as evidence.

I list below other occasions in May 2018 when we have been disturbed and robbed of the right to enjoy our lives and sleep uninterrupted by raucous music and loud people on the street:

- i) Saturday 12<sup>th</sup> May 2018 Nosepicker Peace Off Album Launch. An extract from Nosepicker's Facebook page 'A huge CHEEEERRSS to everyone who made it through the rains to our album launch last night. You were the few, but you were the LOUD which kinda sounds familiar!!' Loud music and cheers accompanied by loud talking and clamour outside the venue during the event and after till 12:00.
- ii) Saturday 19<sup>th</sup> May 2018. Retribution Alive Event described as 'a celebration of everything doom, sludge, stoner, groove'. A copy of the online event leaflet is attached. Blaring music continued till after 12:00. Groups of up to 10 people outside the premises talking loudly and smoking intermittently till 12:50.
- iii) Saturday 26<sup>th</sup> May 2018. Lacertilia, Derelics & Green Lung In it's own words: 'fully stacked bar, loud live music, 3 nutty bands', 'Lacertilia are a throbbing psychosonic groove rock colossus'. A copy of the online event leaflet is attached. Recordings and photographs taken from out 3<sup>rd</sup> floor bedroom window are sent with this application.

IMG.0288.JPG/ IMG.0286.JPG photo taken at 21:53 – some 20 people congregated outside Underdog

IMG.0581.mov film taken at 21:53 – at least 15 people standing talking loudly outside Underdog

IMG.0582.mov film taken at 21:56- loud talking and loitering continues

IMG.0583.mov film taken at 22:09 - blaring music and large congregation outside laughing and chatting.

IMG.0573.mov film taken at 22:37 - music, loud drums and cymbals blaring as well as at least five people talking loudly outside the venue.

IMG.0433 is a photo taken at 23:46 showing at least 10 people standing around and talking at the Underdog doors can be heard.

Mr Forway has long been aware of the noise complaints by the residents against the Underdog, this he acknowledges. He has chosen to ignore them. As late as December 2016 he assured Mr Orton, Southwark Council Licensing Officer, of his plans to install double doors at the entrance. This was not done. On 18<sup>th</sup> May when once again confronted with further complaints by a member of the Licensing Team, a sound reduction curtain was proposed; of which we assume either nothing has been effected or is grossly ineffective.

My complaints gain specificity with respect to events held on the 19<sup>th</sup> and 26<sup>th</sup> May. These were both subsequent to the last visit by the Licensing Officer, following which no attempt has been made by the proprietor to keep the music or disturbance down and is evidenced by the film and photographs provided.

The music events at Underdog result in an unacceptable noise nuisance to the local residents and negatively impact our ability to sleep and to enjoy our daily life in our homes. In granting the licence to Underdog to play live and recorded music the Council fails to protect its residents and fulfil its 'prevention of public nuisance objective'.

I call for the exclusion of live and recorded music, by way of an additional condition to the licence if necessary, as an activity that the Underdog is authorised to undertake. Further, the licensed opening hours should be restricted to 09:00 to 23:00 on all days of the week.

I refer to my application for review of licence granted in respect of the above premises.

Additional evidence in support of my representations that I would like to be considered by the Licencing Sub-Committee and the Responsible Authorities is sent with this letter.

The evidence is in respect of two events held at Underdog.

1 Breaking Convention 2017 – Official After Party held on Sunday 2 July 2017.

The evening was uncontrolled chaos from the outset. The description given below is not of an isolated incident but the state of affairs that prevailed without break all evening till at least 01:00. Photographs and short film clips taken at random points during the evening are sent with this letter, files are chronologically numbered and annotated with the time they were taken.

Large crowds, at their height 100-125 strong, were milling around outside Underdog all evening, sitting on the pavement, drinking, loudly

talking and laughing and generally spilling out on the road, across the street by the houses and flats and on Shand Street under the arches.

Crucifix Lane and Shand Street were both blocked to by 40-50 people standing in the middle of the road unmindful of the traffic. Vehicles had to honk and slowly push their way through sometimes having to reverse out. This created an extremely unsafe environment with a high risk of an accident and injury.

The licensed hours for music at the Underdog on Sunday are till 22:30. The event and music continued long after this. An hour later at 23:32 (17 BC 2017 23.32) and at 00:29 (18 BC 2017 00.29) 2 hours later 40-50 people can be seen partying and crowding the pavement and road. There were more people under the arch on Shand Street that are not in the photograph.

An extract of the Facebook comments on The Breaking Convention After Party 2017 page (attached) are revealing. They support the above account of events and expose the willingness of Underdog management to be 'flexible' and serve to demonstrate a pattern of behaviour wherein it flouts its license without compunction.

#### 2 Event held on Sunday 1 July 2018

The photographs and film clips are taken after the event had ended, from 23:00 to 23:26 .To begin with you can see at least 40 people lingering outside Underdog talking very loudly, shouting and laughing. Some 25 minutes after closing 12-14 people remain, mainly the organisers of the event, who continue to shout and talk loudly and one of who blasts music from his convertible car as they load up their gear.

I represent Mr Sammy Forway who is the proprietor of the above named premises. Further to your application for a review of the premises license dated 15<sup>th</sup> June 2018. I have read your grounds for the application for a review and taken full instructions from Mr Forway and wish to write to you to address your concerns and if possible avoid the need for the matter to proceed to the hearing which I understand is listed for 1<sup>st</sup> August 2018.

In reading your representations, I wish to make clear that Mr Forway and his staff take very seriously your concerns and do not wish to antagonise their neighbours or make your lives uncomfortable as appears to be the case. I wish to respond to the main points set out in your representation and confirm the steps which Mr Forway has indicated he has already taken or is in the process of taking to address your concerns.

#### Trading Outside of Licensable Hours

I can confirm that Mr Forway has already attended an interview under caution with the Council along with legal representation. Mr Forway has at no time sanctioned the premises trading outside of its license hours and certainly deplores any such occurrence. I can confirm that Mr Forway has taken action to summarily dismiss a previous Designated Premises Supervisor (DPS) who was responsible for previous occasions where the premises traded outside of its licensed hours.

#### Noisy Bands

In your representation, you indicate that the venue is favoured by 'heavy metal, psychedelic and stoner rock bands that rely heavily on loud percussion'. I am instructed that The Underdog attracts a broad cross section of artists and indeed, this is part of its ethos in the community.

Winston Brown LLB (Hons) - Principal Joseph Golstein (LLB Hons) Consultant Clerk/Retired Solicitor Ian Sandy LLB (Hons)- Consultant Solicitor Nevertheless, Mr Forway is conscious that certain types of bands produce music which may be particularly loud. To this end, Mr Forway has implemented the following measures.

- Mr Forway has advised all their promotors of the times of opening of the premises and that noise levels must be kept to an acceptable level.
- ii. Mr Forway notes the reference to a flyer entitled 'Retribution Alive' held at the premises on 19th May 2018 and that it boasted that 'The Retribution Club keeps the neighbours awake until 1am'. Mr Forway has no control over the literature which promoters use to promote the events which they are involved in. However, Mr Forway will now be writing to all promoters to confirm the issues which the premises have had with noise nuisance and to ensure that the bands keep the noise levels to an acceptable level. I attach with this letter a copy of the communication now sent out as a matter of course to all promoters of events at the venue.

#### Noise from Patrons Standing Outside

Mr Forway takes issue with the suggestion that up to fifteen or more people loiter outside of his premises making a loud noise. The Underdog is one of a number of licensed premises on Crucifix Lane and there is, as you know, a pub directly opposite the premises called the Suchard and it is quite reasonable to suppose that a number of the persons seen congregating on Crucifix Lane (which as you say, is a narrow road) could actually be patrons of the pub as opposed to The Underdog. In addition there are several public houses and bars in close proximity to neighbouring buildings who emit as much noise and have a large number of people drinking and smoking outside their venues. In order to further address this matter however, Mr Forway proposes to cordon off an area just outside of his premises where up to five persons as a maximum will be allowed to stand and smoke as permitted under his premises license. As such, Mr Forway is taking active measures to reduce persons standing outside of the premises, so this should not be a problem going forward. My client will also introduce a more strict dispersal procedure and will remind patrons to leave the venue quietly.

#### Aggressive Attitude Towards Residents

Mr Forway does not accept that The Underdog is seeking a 'distinctively aggressive attitude' towards residents. Mr Forway realises that the only way that his business can survive is if he has a healthy relationship with residents such as yourselves and is concerned that this is the impression that appears to be had of him.

Mr Forway cannot comment on the assertion in your representation that a bouncer chased Mr
who was attempting to take a photograph of the premises. My client instructs me
that Mr. approached his door staff shouting and swearing and being extremely rude
towards them. Mr. Forway confirms that he has witnessed Mr. being aggressive towards
his own staff in the past and also attempted to speak to Mr. Forway in a similar manner. Mr.
Forway told Mr. in no uncertain terms that he would not be spoken to in such an
unacceptable manner and believes that Mr. has been resentful of him ever since. While
I do not expect you to 'take sides' or to know the truth of the specific allegations or counter
allegations it is worth noting that there are two sides to every story and in this instance an
entirely different interpretation of Mr. involvement.

#### The Underdog Operating as a Nightclub

Mr Forway does not accept that the premises are operating as a nightclub. Mr Forway readily accepts that he runs a 'lively' venue and some of the bands will be louder than others. This, however, does not confirm that his premises are operating as a nightclub. I am further instructed to confirm that while there is security in place in accordance with the premises license. Mr Forway does not have the decision on whether there will be a charge made at the door. This will come down to the promoter of the event.

In relation to the points you make about how the Underdog is operating please note the following:

- My client is required to have security as a condition of their premises license
- My client holds a lot of their own art driven events. They also hold music cabaret and
  live entertainment events. Most of these events are free. On occasion they also hold
  private hire corporate, birthday and wedding parties and events run by external
  promoters. These private events are sometimes charged for entry on the door but the
  money goes to the promoter to help them recoup their costs.
- My client is required to have an age limit in accordance with their premises license

#### Specific Events

I note the specific events referred to in your representations, namely the events occurring on 27<sup>th</sup> January 2018, 11<sup>th</sup> to 12<sup>th</sup> May 2018, 19<sup>th</sup> May 2018 and 26<sup>th</sup> May 2018.

As said already, Mr Forway has taken decisive action to prevent any recurrence of the premises trading outside of the hours on its license. In relation to the levels of noise nuisance which I regard as your main concern, Mr Forway has taken the following measure to address the noise issue:

- Mr Forway has installed a porch between the main door and the auditorium which will provide a buffer for noise.
- 2. New sound limiters namely Formula Sound AVC 2 has been installed on the equipment. The music will cut out when the noise reaches a certain level.
- 3. All sound technical staff are aware of the acceptable levels and bands and promoters are now aware of Underdog's strict noise restrictions and house rules. My client is also installing a second sound limiter (Formula Sound 073 Sentry System) which automatically cuts all power to the stage over a certain noise level.

Mr. Forway also invites you and any other resident with concerns about noise levels at the Underdog to participate with Mr. Forway to set the level of the noise limiter to a level which you would find acceptable.

#### Noise Complaints

Mr. Forway denies ignoring complaints about noise nuisance. He instructs me that has not received any formal noise complaints and that he has always welcomed local residents into the gallery and maintains that he values their feedback. Mr. Forway I surprised that he has not had the opportunity to address the issues together with yourself and he is concerned that this may be a vexatious application for a review of his premises license and he was only aware of these complaints when he had a conversation with Andrew Heron of the council's licensing department.

#### Proposed Exclusion of Live and Recorded Music

Mr Forway does not agree to the exclusion of live and recorded music from the premises license as he is confident that the rigorous measures already in place will be sufficient to curtail any noise disturbance.

I understand that Mr Forway has already invited you and other residents to attend a meeting to discuss your concerns, but this has been declined. I would again reiterate this invitation. I would also confirm that you are invited to attend the premises at any time to inspect for yourself the measures which have been put in place to combat noise escaping from the premises. I would be grateful if you could carefully consider my comments in this letter and indicate to the Council within seven days from the date of this letter if you will be prepared to withdraw your application for a review.

To reiterate Mr. Forway hereby extends the following invitations to you and any other objectors:

- Attend his premises to participate in setting the level of permitted noise for the new noise limiter
- 2. Attend a meeting with him and/or his manager to discuss your concerns and a way forward

If (as is your right) you prefer to carry on with your review application, then of course, this letter would be tabled before the members of the Licensing Committee. The council has set a review hearing for 24 August 2018 at 10am. If you are satisfied by the responses and undertakings made in this letter on behalf of my client I would invite you to withdraw your application by close of business on 6 August 2018. If you have any queries in response to this letter please do not hesitate to email me your queries. I will be on leave from 1 August 2018 – 17 Aust 2014 but will access emails intermittently thanks. I have also sent a copy of this letter to the council's licensing team.



- (a). At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
- (b). At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.

- **348** That all speakers used for licensed entertainment within the premises shall be isolated from the structure of the premises by anti-vibration mountings or mats.
- **349** That customers shall use no outside area after 22.00hrs other than those who temporarily leave the premises to smoke a cigarette. Only 5 persons at any one time shall be permitted to leave the premises temporarily to smoke a cigarette.
- **350** That after 22:00 alcoholic drinks shall not be permitted to be taken outside of the premises.
- **351** That external waste handling, collections, deliveries shall only occur between the hours of 08.00hrs and 22.00hrs.
- **352** That there shall be no movement of musical, amplification or equipment associated with the gallery from the premises between the hours of 22.00hrs and 08.00hrs.
- **353** That announcements shall be made requesting that patrons leave in a quiet and orderly manner that is respectful to neighbours.

- 354 That no amplified music, song or speech be broadcast externally at any time.
- **355** That any doors at the premises leading directly to the outside of the premises will be fitted with door bottom and perimeter acoustic seals.
- **356** That a lobby entrance will be installed to minimise sound escape from the premises. The doors in the lobby entrance will be fitted with door bottom and perimeter acoustic seals.
- **357** That any ventilation intake and/or extract vents installed shall be fitted with sound insulation to reduce sound escape from the premises to ensure that public nuisance will not be caused.
- **427** That clearly legible notices shall be prominently displayed where they can easily be seen and read at all public exits requesting to the effect that patrons leave the premises in a quiet and orderly manner, respecting the needs of local residents.

I write with regards to the above application to review the premises licence submitted by Amala Desai under the Licensing Act 2003.

The application is submitted under the prevention of public nuisance licensing objective and the grounds for the review are:

'The applicant has been experiencing persistent noise nuisance caused by the operation of the premises. The noise nuisance caused by live music; recorded music and by noisy patrons attending the premises and congregating in the locale. It is alleged that staff at the premises react aggressively towards local residents who approach the premises to raise residents concerns. It is further alleged that the premises operate as a nightclub in breach of condition 844 of the premises licence issued in respect of the premises. Condition 844 of the licence prohibits the premises from operating as a nightclub'

My representation is concerned with the prevention of public nuisance and the prevention of crime and disorder.

This premise is situated within the Bankside, Borough, London Bridge Strategic Cultural & London Bridge District Town Centre Area and also falls within the Borough and Bankside CIP Area.

When the premises licence was originally applied for it was described within the application as an 'Art Gallery'. There were several representations from other persons and responsible authorities. The licence was granted with conditions by the licensing sub committee on 17 October 2014. I attach the notice of decision of the licensing sub committee to this representation.

It would seem that the nature of the operation of the premises has changed and the premises is now operating as a night club / music venue.

There have been several complaints to the licensing unit regarding noise and licensing officers have witnessed breaches of the premises licence conditions. Several warnings have been issued regarding the offences which I attach as supporting information to this representation.

I may provide further supporting information to this representation at a later stage.

#### 3. Reasons

This was an application submitted by Underdog Art Company Ltd for the grant of a premises licence issued under the Licensing Act 2003 in respect of Arch 6, Crucifix Lane, London SE1 3JW

The licensing sub-committee heard evidence from the applicant and their representative who informed the sub-committee that they had sought to reduce the operation hours in respect of the original application and considered the new proposed hours to be reasonable. They advised that the premises operated as an art gallery and the licensable activities are required to compliment the current operation.

The applicant stated that he had been trading as an art gallery since 2006 and had been in operation at the premises since 2011.

The applicant sought to reassure the sub-committee that the premises would not operate as a nightclub and highlighted that they had conciliated and accepted all of the conditions proposed by the environmental protection team and the police. As further reassurance, the applicant stated that they would be happy for a condition stating that the premises would not operate as a nightclub to be imposed on the licence.

The applicant also highlighted that the conditions proposed and accepted would serve as further control in respect of the operation of the premises and stated their willingness to ensure that all conditions are adhered to.

The licensing sub-committee heard from two other persons, one of whom was speaking on behalf of four other residents. The residents stated that they considered the premises to operate as a nightclub and had concerns with regards to the noise nuisance emanating from the premises. They also raised issues with the proposed licensable hours. The residents referred to previous temporary event notices that had occurred at the premises and expressed their dissatisfaction with the operation of these events.

The residents also stated that they had concerns regarding patrons smoking outside the premises and questioned the need for the sale of alcohol to commence at 9.00am. The residents further stated that they would be satisfied if a condition was imposed on the licence which prohibited the use of the premises as a nightclub. The residents also stated that a reduction in hours would assist in alleviating their concerns.

In reaching this decision the sub-committee had regard to all the relevant considerations and the four licensing objectives.

The licensing sub-committee considered that it was appropriate and proportionate to attach these conditions in order to address the licensing objectives.

#### 4. Appeal rights

The applicant may appeal against any decision

- a) To impose conditions on the licence
- b) To exclude a licensable activity or refuse to specify a person as premises supervisor.

<u>Licensing Act 2003 – Warning Letter</u> Underdog Gallery – Railway Arch 6, Crucifix Lane, London, SE1 3JW

Further to correspondence sent to you on 4 April and 1 June, you were formally invited to attend an interview under caution, which took place on Monday 25 June at the Council offices.

This process followed an increasing number of complaints from local residents in relation excess music noise from the premises; from noisy patrons gathering to smoke outside and upon egress; and also that the premises has been operating beyond its hours without a suitable premises licence or a Temporary Events Notice in place - in particular, it was reported that an event took place from 21:00hrs on Friday 11<sup>th</sup> May 2018 until 05:00hrs on Saturday 12<sup>th</sup> May 2018.

During the interview under caution, you conceded that the event had indeed taken place, but that the gentleman that had arranged the night, Mr Nadeem Salem, has since been dismissed from your employment as a result of this unlicensed event. You stated that you did not know that the event was going to take place. You claim not to have arranged the advertising found on the Resident Advisor website.

You further admitted to two additional offences; that the CCTV had indeed not been recording and that you had been unable to provide it to the local authority, as required under the terms of the licence. You state that this had taken place unknowingly and that you have now resolved all issues with the CCTV, so that it is now operational.

You stated in the interview that you did have a sound limiter installed, but that bands had found a way to bypass the 'shut-off' feature, by simply increasing the volumes on their individual amplifiers, therefore circumventing the requirement in the licence that all audio and musical equipment be played through a sound

limiting device. I struggle to accept your explanation that all music was going though the mixer, if it is so easy to override the system specifically set up to control noise levels. Having experienced the noise levels myself, I remain concerned that you indeed did knowingly permit music to be played without the full use of a sound limiting device.

You state that you have since had a new sound limiting device installed. I am still awaiting the photographs of the devices and their serial plates from both the old and new systems – please provide these at your earliest opportunity. You also state that you have since employed an acoustician and invested in additional dampening equipment for any drum kits.

You advised in the interview that you no longer intend to have double doors into the premises, but that a sound curtain is now in place. You have made promises to ensure that no further licensable activities take place and that you intend to be a responsible manager of the premises and wish to have a better working relationship with your neighbours. You stated that you also intend to feature different live music which should, in your opinion, have a reduced impact on surrounding residential properties.

In light of the assurances given by you moving forward and that you have rectified each breach; whilst offences have been admitted, this Authority is minded to issue you with a formal warning, as this is your first offence. However, I remind you that the above are prosecutable offences that you have admitted to; please note that should any further breaches take place, we will have no other option other than to take enforcement action, which could include a prosecution and/or a review. Any evidence from this investigation will be used in any future prosecution.

As you are aware, local residents have already initiated a review of the premises licence. The hearing will take place 13 August at the Council offices. Copies of all correspondence leading to this warning will be provided to all parties involved in the Hearing, so that Members of the Sub Committee can make a fully informed decision.

GROUNDS FOR REVIEW OF LICENCE -

As a resident of Crucifix Lane I hereby support the application for the review of the Premises Licence granted to Underdog Art Company Limited trading as The Underdog ('Underdog') situated at Arch 6 Crucifix Lane, SE1 3JW.

The section of Crucifix Lane in front of the underdog is a narrow road. I live the Underdog entrance with my 2 young children. Two of our bedrooms and the living room to the Underdog's entrance.

Late club nights are routinely held at Underdog mainly but not only at the weekends. The Underdog also hosts club nights till 04:00 or 05:00 in the morning, outside its permissible licensed hours, sometimes on consecutive nights.

We as a family have long been experiencing persistent nuisance as a result of the noise from both live and recorded music played at the Underdog. Crowds of revellers shouting and jeering inside and outside the venue compound this disturbance. I also experience groups of people standing and smoking in front of my house and playing games such as pulling up the potted plant leaves and jumping to swing my hanging basket, there are hand prints all over the wall where this game is regularly played by revellers.

This collecting of people from the venue is not limited to the frontage of my house. There is often loud talking, laughing and shouting from large groups of people loitering, smoking and urinating outside the premises and in the tunnel. Closing time is often the peak time for these issues and it lingers on for some time after the event has finished - unchallenged by staff.

Underdog bouncers are very unresponsive and rude when I have tried to talk to them in the past. On one occasion insisting there was no one for me to talk to about the noise, no management on site and refused to let me inside. I felt very intimidated by them. On another occasion they were derisive, inviting me in for a drink! When I have had the noise police attend my property in the past I feel intimidated as it is very public for me to complain due my proximity to Underdog. The bouncers always take an interest and as they have been difficult and uncooperative in the past i feel uncomfortable. In fact I feel uncomfortable/vulnerable writing this letter. I live alone with my 2 children since loosing my husband to cancer 2 years ago. I have not complained either in person or to the noise police about issues at Underdog since.

I am also disappointing that there is no soundproofing at the venue despite this being discussed at the last meeting that residence were invited to.

Finally I would like to confirm that on 11th/12th May 2018 until very late there was loud music and shouting.

I am in agreement with the local community in feeling that Underdog present an unacceptable noise nuisance. They negatively impact our ability to sleep and to enjoy our daily life in our homes. In granting the licence to Underdog to play live and recorded music the Council fails to protect its residents and fulfil its 'prevention of public nuisance objective'. I call for the exclusion of live and recorded music, by way of an additional condition to the licence if necessary, as an activity that the Underdog is authorised to undertake. Further, the licensed opening hours should be restricted to 09:00 to 23:00 on all days of the week.

I would like to make a representation in support of review application number 863705 in regards to Underdog Gallery, Arch 6, Crucifix Lane, SE1 3JW.

As a resident of Crucifix Lane I submit this representation in relation to the prevention of a public nuisance.

My understanding of the Underdog is that it is ostensibly a gallery, which planned to host occasional events and performances to coincide with its exhibition program. When the application for its licence was motioned to residents this was the premise. Most galleries host opening events for new shows and some occasionally involve music, either live or recorded, and some form of party atmosphere.

My actual experience of living near the gallery is that it is primarily used as an event space and bar in and out of the specified hours of operation

Before the Underdog opened Arch 6 had long been home to the Pierre Garoudi gallery, which hosted art and fashion exhibitions and the occasional live catwalk event. I attended these events on several occasions and Pierre was a welcome and active part of the local community.

As far as I understand, the Underdog gallery has been granted a licence to remain open from 09:00 till 23:30 from Monday to Thursday, till 01:00 on Friday and Saturday and till 23:00 on Sunday. Hardly gallery hours!

As far as I understand, the licence permits the performance of live music and the playing of recorded music indoors during these hours. This seems contrary to the concept of a gallery and to me more akin to that of a bar or club. If the Underdog operates in this way then I would expect that it follow strict guidelines and protocol as to how to do this without affecting the lives of local residents. I have friends who run music venues and appreciate the efforts and means they must go to avoid falling foul of the terms of their licence and or disturbing their immediate community.

In my mind, the Underdog operates without this due care. And when neighbors have been upset by the subsequent noise little respect has been shown to them and little action taken to avoid this disturbance.

Since opening, club nights have been routinely held at Underdog but not only at the weekends. In fact I would suggest that there have been many more music or performance related events at the gallery than exhibitions. The Underdog has also on occasion, hosted club nights till the early hours, outside its permissible licensed hours, sometimes on consecutive nights. I do not have specific evidence of this but can assure the fact. The problem is compounded by the type of music represented by the promoter which is generally guitar and drum based, heavy stoner doom rock and psych-noise. The frequencies of sound created by this kind of music are hard to contain in the type of space the underdog occupies and cannot fail but to disturb the local area.

Sound checks and audience reaction add to this.

Residents have long been experiencing persistent nuisance as a result of the noise from both live and recorded music played at the Underdog. It seems to me that the venue is not equipped for this type of event with little sound proofing or baffling and or control of its pavement side activities, with crowds on occasion blocking the entire section of Crucifix lane and Shand street tunnel.

Underdog is also often hired out to third party organisers who charge fees for entry to the event. This peaked a couple of years ago when there were club nights back to back from Friday to Sunday and a totally different clientele attending.

I must state that I am not against live music or events in London or even on my doorstep but in this case it seems to me that there is a blatant misuse of the licence and the gallery's managements behavior takes little care or interest in the well being of its neighboring community.

I have met Sammy on several occasions and found him to be fine but on many occasions he is not or has not been present or in control of the events. For several years the gallery was run day to day by another individual who seemed to me, to take great pride in presenting an aggressive and intentionally noisy and disruptive approach to running the space. This particular individual would listen to extremely loud music whenever he felt like it, even when the gallery was closed and often til 2am or on Sundays. I once asked him to close the doors to the venue during a particulary loud heavy metal sound check on a Saturday afternoon and was told to "f... off, I will do what I what..." and personally and aggressivleey insulted. This anti-social "punk" attitude underlies the gallery's MO and while I am not against "punk" ideals or alternative musical culture at all I think it is contrary to the premise of the Underdog being a fine art gallery.

Since that time the events have been less frequent but not less disruptive.

I would ask that the gallery decide what it wants to be, a gallery for art and occasional events or a live music venue and bar. And in that I believe the licence granted to the Underdog should be under review based on its flagrant abuse of the terms of its issuance.

In my mind you cannot be both a gallery and a live music venue on a tiny quiet mostly residential street in central London. I of course want to support the cultural diversity of the area but must point out that it is increasingly becoming an area driven by the late night economy of eating and drinking and with this comes a lot of noise and nuisance.


