RECOMMENDATION

1. That the licensing sub-committee considers an application made by Leon Restaurants Limited for a premises licence to be granted under the Licensing Act 2003 in respect of the premises known as Leon, SU 43 London Bridge Station, Railway Approach, London SE1 9SP.

2. Notes:

- a) This application forms a new application for a premises licence, submitted under Section 17 of the Licensing Act 2003. The application is subject to representations from responsible authorities and is therefore referred to the sub-committee for determination.
- b) Paragraphs 8 10 of this report provide a summary of the application under consideration by the sub-committee. A copy of the full application is attached as Appendix A.
- c) Paragraphs 11 to 17 of this report deal with the representations submitted and any further correspondence in respect of the application. Copies of the representations are attached as Appendix B.
- d) Paragraph 18 deals with licensed premises within a 100m radius of the premises. A map of the area is attached as Appendix C.
- e) A copy of the council's approved procedure for hearings of the sub-committee in relation to an application made under the Licensing Act 2003, along with a copy of the hearing regulations, has been circulated to all parties to the meeting.

BACKGROUND INFORMATION

The Licensing Act 2003

- 3. The Licensing Act 2003 provides a licensing regime for:
 - The sale of and supply of alcohol
 - The provision of regulated entertainment
 - The provision of late night refreshment.
- 4. Within Southwark, the licensing responsibility is wholly administered by this council.

- 5. The Act requires the licensing authority to carry out its functions under the Act with a view to promoting the four stated licensing objectives. These are:
 - The prevention of crime and disorder
 - The promotion of public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 6. In carrying out its licensing functions, a licensing authority must also have regard to
 - The Act itself
 - The guidance to the act issued under Section 182 of the Act
 - Secondary regulations issued under the Act
 - The licensing authority's own statement of licensing policy
 - The application, including the operating schedule submitted as part of the application
 - Relevant representations.
- 7. The premises licence application process involves the provision of all relevant information required under the Act to the licensing authority with copies provided by the applicant to the relevant responsible bodies under the Act. The application must also be advertised at the premises and in the local press. The responsible authorities and other persons within the local community may make representations on any part of the application where relevant to the four licensing objectives.

KEY ISSUES FOR CONSIDERATION

The premises licence application

8. On 2 August 2018, Leon Restaurants Limited applied to this council for the grant of a premises licence in respect of Leon, SU 43London Bridge Station, Railway Approach, London SE1 9SP. The premises is described as a restaurant and bar within London Bridge Station. The premises will also sell products for consumption off the premises as part of a takeaway meal.

The application is summarised as follows:

Latenight refreshment (indoors & outdoors)

Mon - Sun 23:00 - 01:00

• Supply of alcohol (on & off the premises)

Mon - Sun 11:00 - 00:30

Operating hours

Mon - Sun 05:00 - 01:00

9. The premises licence application form provides the applicant's operating schedule. Parts I, J, K, L, and M of the operating schedule set out the proposed licensable activities, operating hours and operating control measures in full, with reference to the four licensing objectives as stated in the Licensing Act 2003. Should a premises licence be issued in respect of the application the information provided in the operating schedule will form the basis of conditions that will be attached to any

licence granted subsequent to the application. A copy of the application is attached to this report in Appendix A.

Designated premises supervisor

10. The proposed designated premises supervisor John Brooks who has a personal licence issued by the Bath and North East Somerset Council.

Representations from responsible authorities

- 11. There are two representations from Licensing (as a responsible authority) and Public Health.
- 12. The Licensing representation is based on the Southwark Statement of Licensing policy 2016 2020 and relates to the licensing objectives for the prevention of crime and disorder and the prevention of public nuisance and the protection of children from harm. The premises is situated in the Bankside, Borough, London Bridge Strategic Cultural & Bankside and Borough District Town Centre Area and also falls within the Borough and Bankside CIP Area. Under the Southwark Statement of Licensing Policy 2016 2020 the Local CIP applies to night clubs, public houses & bars, restaurants & cafes, off-licences, supermarkets, convenience stores and similar premises and the appropriate closing times for restaurant and cafes in this area on Sunday to Thursday is 00:00 hours and for Friday and Saturday is 01:00 hours. They recommend further conditions to the applicant to be added to the licence application and the hours sought be brought in line with those recommended by the Southwark's Statement of Licensing Policy.
- 13. The Public Health representation also state that this premises is located within the Borough Bankside Cumulative Impact Policy area and in this premises is located within the Borough Bankside Cumulative Impact Policy area and the applicant has not adequately rebutted the presumption that this premises will contribute to the cumulative impact of alcohol-related harm in the local area. They also propose further condition to the applicant which if agreed will form part of the licence conditions if granted.
- 14. The representations are attached as Appendix B.

Representations from other persons

15. There are no representations from other persons

Conciliation

16. The representations were forwarded to the applicant representative. The licensing sub-committee will be updated on 2 October 2018 of any developments.

Deregulation of entertainment

17. On 6 April 2015 entertainment became deregulated and as a result:

- Live unamplified music is deregulated between 08:00 and 23:00 on any premises.
- Live and recorded amplified music is deregulated between 08.00 and 23.00 at on-licensed premises provided the audience does not exceed 500 people, however, live music can become licensable in on-licensed premises if the licensing authority removes the effect of the deregulation following a licence review ('licence review mechanism').

Map of the local area

18. A map of the area is attached to this report as Appendix C. For purposes of scaleonly the circle on the map has a 100-metre radius. The following licensed premises terminal hours are also shown on the map.

- The View From The Shard, 32 London Bridge Street, London SE1(24 hrs)
- Out Patients Diagnotics Centre, 32 London Bridge Street, London SE1 (Mon to Sun until 00.00)
- Shangri-La The Shard, 31 St Thomas Street, London SE1 (24 hrs)
- New Express The Shard, Unit A The Shard Tower, London SE1 (Mon Sun until 05:00)
- Delice De France, Shard Tower, Unit 12, London Bridge Station, London SE1 (Mon Sun until 05:00)
- Upper Crust Shard, Unit B, London Bridge Station, London SE1 (Mon Sun until 05:00)
- West Cornwall Pastry Co, Unit 3 The Shard, Railway Approach, London SE1 (Mon
 – Sat until 00:30)
- FCB Coffee, Unit 264, Railway Approach, London SE1 (Mon Sat until 23:00; Sun until 22:30)
- 19. Within the Southwark statement of licensing policy 2016 2020 the following closing times are recommended as appropriate within this area for this categories of premises as follows:
- Closing time for Restaurants and Cafes: Sunday to Thursday is 00:00 hours and for Friday and Saturday is 01:00 hours. There are no restriction times for hotel bars and guest houses.

Borough & Bankside Cumulative Impact Zone

21. Council assembly approved the introduction of a special policy for Borough and Bankside on the cumulative impact of a concentration of licensed premises (saturation/cumulative impact policy) on 5 November 2008, and extended the area in April 2011. This application falls within the policy area.

- 22. The decision to introduce saturation policy was taken with regard to the committee's concern over rising trends of late night alcohol related violence against the person and late night disorder and rowdiness associated with late night licensed premises in the area.
- 23. The effect of this special policy is to create a presumption that applications for new premises licences or variations that are likely to add to the existing cumulative impact will normally be refused, following relevant representations, unless the applicant can demonstrate in their operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives.
- 24. The applicant has been advised to address the committees concerns around cumulative impact at the meeting.

Southwark council statement of licensing policy

- 25. Council Assembly approved Southwark's statement of licensing policy 2011-14 on 12 October 2011 Council Assembly approved Southwark's Statement of Licensing Policy 2016-20 on 25 November 2015. The policy came into effect on 1 January 2016.
- 26. Further sections of the statement that are considered to be of particular relevance to the sub-committee's consideration are:
 - Section 3 Purpose and Scope of the Policy Which reinforces the four licensing objectives and the fundamental principles upon which this Authority relies in determining licence applications
 - Section 5 Determining Applications for Premises Licences and Club Premises certificates - Which explains how the policy works and considers issues such as location; high standards of management; and the principles behind condition setting.
 - Section 6 Local Cumulative Impact Policies Which sets out this Authority's approach to cumulative impact and defines the boundaries of the current special policy areas and the classifications of premises to which they apply. To be read in conjunction with Appendix B to the policy.
 - Section 7 Hours of Operation Which provides a guide to the hours of licensed operation that this Authority might consider appropriate by type of premises and (planning) area classification.
 - Section 8 The Prevention of Crime and Disorder Which provides general guidance on the promotion of the first licensing objective
 - Section 9 Public Safety Which provides general guidance on the promotion of the second licensing objective
 - Section 10 The Prevention of Nuisance Which provides general guidance on the promotion of the third licensing objective
 - Section 11 The Protection of Children from Harm Which provides general guidance on the promotion of the fourth licensing objective.

27. The purpose of Southwark's statement of licensing policy is to make clear to applicants what considerations will be taken into account when determining applications and should act as a guide to the sub-committee when considering the applications. However, the sub-committee must always consider each application on its own merits and allow exceptions to the normal policy where these are justified by the circumstances of the application.

Resource implications

28. A fee of £100.00 has been paid by the applicant company in respect of this application being the statutory fee payable for premises within non-domestic rateable value band A.

Consultations

29. Consultation has been carried out on this application in accordance with the provisions of the Licensing Act 2003. A public notice was published in a local newspaper and similar notices were exhibited outside of the premises for a period of 28 consecutive days.

Community impact statement

30. Each application is required by law to be considered upon its own individual merits with all relevant matters taken into account.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Director of Law & Democracy

- 31. The sub-committee is asked to determine the application for a premises licence under section 17 of the Licensing Act 2003.
- 32. The principles which sub-committee members must apply are set out below.

Principles for making the determination

- 33. The general principle is that applications for premises licence applications must be granted unless relevant representations are received. This is subject to the proviso that the applicant has complied with regulations in advertising and submitting the application.
- 34. Relevant representations are those which:
 - Are about the likely effect of the granting of the application on the promotion of the licensing objectives
 - Are made by an interested party or responsible authority
 - Have not been withdrawn
 - Are not, in the opinion of the relevant licensing authority, frivolous or vexatious

- 35. If relevant representations are received then the sub-committee must have regard to them, in determining whether it is necessary for the promotion of the licensing objectives to:
 - to grant the licence subject to:
 - The conditions mentioned in section 18 (2)(a) modified to such extent as the licensing authority considers necessary for the promotion of the licensing objectives
 - Any condition which must under section 19, 20 or 21 be included in the licence
 - to exclude from the scope of the licence any of the licensable activities to which the application relates
 - to refuse to specify a person in the licence as the premises supervisor
 - to reject the application.

Conditions

- 36. The sub-committee's discretion is thus limited. It can only modify the conditions put forward by the applicant, or refuse the application, if it is necessary to do so. Conditions must be necessary and proportionate for the promotion of one of the four licensing objectives, and not for any other reason. Conditions must also be within the control of the licensee, and should be worded in a way which is clear, certain, consistent and enforceable.
- 37. The four licensing objectives are:
 - The prevention of crime and disorder
 - Public safety
 - The prevention of nuisance
 - The protection of children from harm.
- 38. Members should note that each objective is of equal importance. There are no other licensing objectives, and the four objectives are paramount considerations at all times.
- 39. Conditions will not be necessary if they duplicate a statutory position. Conditions relating to night café and take away aspect of the license must relate to the night time operation of the premises and must not be used to impose conditions which could not be imposed on day time operators.
- 40. Members are also referred to the Home Office Revised Guidance issued under section 182 of the Licensing Act 2003 on conditions, specifically section 10.

Reasons

41. If the sub-committee determines that it is necessary to modify the conditions, or to refuse the application for a premises licence application, it must give reasons for its decision.

Hearing procedures

- 42. Subject to the licensing hearing regulations, the licensing committee may determine its own procedures. Key elements of the regulations are that:
 - The hearing shall take the form of a discussion led by the authority. Cross examination shall not be permitted unless the authority considered that it is required for it to consider the representations.
 - Members of the authority are free to ask any question of any party or other person appearing at the hearing.
 - The committee must allow the parties an equal maximum period of time in which to exercise their rights to:
 - Address the authority
 - o If given permission by the committee, question any other party.
 - o In response to a point which the authority has given notice it will require clarification, give further information in support of their application.
 - The committee shall disregard any information given by a party which is not relevant to the particular application before the committee and the licensing objectives.
 - The hearing shall be in public, although the committee may exclude the public from all or part of a hearing where it considers that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing, taking place in private.
 - In considering any representations or notice made by a party the authority may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the hearing or, with the consent of all the other parties, at the hearing.
- 43. This matter relates to the determination of an application for a premises licence under section 17 of the Licensing Act 2003. Regulation 26(1) (a) requires the subcommittee to make its determination at the conclusion of the hearing.

Council's multiple roles and the role of the licensing sub-committee

- 44. Sub-committee members will note that, in relation to this application, the council has multiple roles. Council officers from various departments have been asked to consider the application from the perspective of the council as authority responsible respectively for environmental health, trading standards, health and safety and as the planning authority.
- 45. Members should note that the licensing sub-committee is meeting on this occasion solely to perform the role of licensing authority. The sub-committee sits in quasi-judicial capacity, and must act impartially. It must offer a fair and unbiased hearing of the application. In this case, members should disregard the council's broader policy objectives and role as statutory authority in other contexts. Members must direct themselves to making a determination solely based upon the licensing law, guidance and the council's statement of licensing policy.

- 46. As a quasi-judicial body the licensing sub-committee is required to consider the application on its merits. The sub-committee must take into account only relevant factors, and ignore irrelevant factors. The decision must be based on evidence, that is to say material, which tends logically to show the existence or non-existence of relevant facts, or the likelihood or unlikelihood of the occurrence of some future event, the occurrence of which would be relevant. The licensing sub-committee must give fair consideration to the contentions of all persons entitled to make representations to them.
- 47. The licensing sub-committee is entitled to consider events outside of the premises if they are relevant, i.e. are properly attributable to the premises being open. The proprietors do not have to be personally responsible for the incidents for the same to be relevant. However, if such events are not properly attributable to the premises being open, then the evidence is not relevant and should be excluded. Guidance is that the licensing authority will primarily focus on the direct impact of the activities taking place at the licensed premises on members of the public, living, working or engaged in normal activity in the area concerned.
- 48. Members will be aware of the council's code of conduct which requires them to declare personal and prejudicial interests. The code applies to members when considering licensing applications. In addition, as a quasi-judicial body, members are required to avoid both actual bias, and the appearance of bias.
- 49. The sub-committee can only consider matters within the application that have been raised through representations from other persons and responsible authorities. Other persons must live in the vicinity of the premises. This will be decided on a case to case basis.
- 50. Under the Human Rights Act 1998. The sub-committee needs to consider the balance between the rights of the applicant and those making representations to the application when making their decision. The sub-committee has a duty under section 17 Crime and Disorder Act 1998 when making its decision to do all it can to prevent crime and disorder in the borough.
- 51. Other persons, responsible authorities and the applicant have the right to appeal the decision of the sub-committee to the magistrates' court within a period of 21 days beginning with the day on which the applicant was notified by the licensing authority of the decision to be appealed against.

Guidance

Members are required to have regard to the Home Office Revised Guidance in carrying out the functions of licensing authority. However, guidance does not cover every possible situation, so long as the guidance has been properly and carefully understood, members may depart from it if they have reason to do so. Full reasons must be given if this is the case.



I write with regards to the above application for a premises licence submitted by Leon Restaurants Limited under the Licensing Act 2003, which seeks to add the following licensable activities:

- Late night refreshment (indoors and outdoors) on Monday to Sunday to from 23:00 to 01:00 the following day.
- Supply of alcohol (on and off the premises) on Monday to Sunday from 11:00 to 00:30 the following day
- Overall opening times shall be on Monday to Sunday from 05:00 to 01:00 the following day

The premises is described as 'The premises will trade predominantly as a restaurant, serving food, soft drinks and alcohol for consumption on the premises. The premises may also sell products for consumption off the premises as part of a takeaway meal'.

My representation is based on the Southwark Statement of Licensing policy 2016 – 2020 and relates to the licensing objectives for the prevention of crime and disorder and the prevention of public nuisance.

This premise is situated within the Bankside, Borough, London Bridge Strategic Cultural & London Bridge District Town Centre Area and under the Southwark Statement of Licensing policy 2016 - 2020 the appropriate closing for restaurants and cafes on Sunday to Thursday is 00:00 hours and for Friday and Saturday is 01:00 hours

The premises is also situated within the Borough and Bankside CIP Area. Under the Southwark Statement of Licensing Policy 2016 - 2020 the Local CIP applies to night clubs, public houses & bars, restaurants & cafes, off-licences, supermarkets, convenience stores and similar premises.

Section six of the policy (from page 32) deals with Southwark's local cumulative impact policies. This premises sits in the Borough and Bankside policy area as defined in paragraph 129 of the policy and, as a restaurant or bar this premises falls into the class of premises in 130 of the policy.

Therefore under 119 of the policy there is a rebuttable presumption that applications for new premises licenses that are likely to add to the existing cumulative impact will normally be refused or subject to certain limitations. In such circumstances, it is for the applicant to demonstrate that the application will not, if granted, further contribute to the negative local cumulative impact on any one or more of the licensing objectives.

The applicant has not addressed the presumption to refuse this application within the operating schedule. I would recommend refusal of this application unless the applicant can demonstrate that the premises will not contributing to crime and disorder and public nuisance within the policy area.

To promote the licensing objectives I ask the applicant to consider amending the closing times so that they are in line with the licensing policy, to bring the licensable activities in line with this and to allow at least half an hour drink up time between the sales of alcohol 'on sales' and the closing times, as follows:

- Closing times: to finish on Sunday to Thursday at 00:00 hours and for Friday and Saturday at 01:00 hours.
- Late night refreshment: to cease on Sunday to Thursday at 00:00, and to cease on Friday and Saturday 01:00
- Alcohol 'off sales' to finish on Sunday to Thursday at 00:00 hours and for Friday and Saturday at 01:00 hours.
- Alcohol 'on sales' to finish on Sunday to Thursday at 23:30 hours and for Friday and Saturday at 00:30 hours. (this will allow for half an hour drinking up time)

Further to the above and due to the limited information provided with the application the following conditions would further address the licensing objectives and could assist the applicant in this rebuttal:

I ask the applicant to provide the following information:

- An accomodation limit for the premises. (to be conditioned)
- To provide a written dispersal policy for the premises. (to be conditioned)

I therefore submit this representation and welcome any discussion with the applicant.


Alcohol related health issues are a concern for this location. Grange had the 3rd highest number (9%) of alcohol related ambulance call-outs between 2016 - 2018.

On analysis of Figure 1, 24% of all licensed premises are takeaway establishments, thus this new license has the potential to add to the cumulative negative impact of takeaways in the area. Research recently undertaken by the public health team; T.Boshari, C.Sharpe (Public Health Policy Officers) and R. Pinder (Consultant in Public Health) indicates that each late night licensed takeaway in Southwark is associated with a 1.3% increase in alcohol-related violence. This research is currently awaiting academic publication. Thus measures must be taken to reduce the impact of takeaways in this area.

Furthermore, this premises is located in the Borough and Bankside Cumulative Impact Policy (CIP) area. In my opinion, the proposed premises will potentially contribute to the alcohol related disorder in the area (i.e. through crime, anti-social behaviour and alcohol-related health impacts). The attached report shows that the Borough and bankside CIP area contributes to 13.5% of Southwark's rowdy behaviour and street drinking, 20.5% of Southwark's Ambulance call-outs, and 18.8% of Southwark's non-domestic violence (these are the highest percentages of the CIP areas in Southwark).

Recommendations

I recommend that the opening hours be amended to be in line with the Southwark Statement of Licensing Policy's recommended hours for a takeaway/restaurant (see table below).



As shown by the map below, Southwark has three CIP areas and three monitoring areas. As requested by Southwark's Licensing Committee, Shad Thames has been included in this report.



The table below shows the proportion each area accounts for of the borough total. It shows that in most instances, the proportions do not change much from one financial year to the next. One exception worth mentioning is the 6.4 percentage point increase from FY15/16 to FY16/17 in non-domestic, alcohol-related Violence. The figures behind this change show a 12.8% increase in the CIP areas total against a borough-wide decrease of 7.2%.

Of the six CIP and monitoring areas, Borough and Bankside accounts for the largest proportion of alcoholrelated reports.






