- Tackle child trafficking and Modern Slavery

## 2 What outcomes could realistically be achieved? Which agency does the review seek to influence?

Outcomes:

- A better informed / positively influence the emerging VAWG strategy in Southwark
- Raised awareness of nature and extent of VAWG in Southwark
- Improved services
- Increased reporting of crime
- A better understanding and new strategies in place to prevent sexual violence and harassment in schools and on our streets
- A better understanding of what is taught in schools around healthy relationships
- A better understanding and new strategies in place to safeguard young women and girls from violence , reduce victimisation, tackle peer on peer violence and prevent girls and young women from becoming associated and/or exploited by gangs
- A better understanding of child trafficking in our borough and how the modern slavery charter can be put into practice

**The initial review:** What Southwark Council is doing overall to tackle VAWG

**General questions:*****Tackling sexual violence and harassment in schools and on our streets***

What data is available about the extent of sexual violence and harassment in schools and on our streets in Southwark? What data do the police, schools ,social care and the education department have on the extent of sexual abuse in schools and how could this be improved ?

What resources are available in Southwark to prevent sexual violence and harassment in schools and on our streets ?

Are there examples of effective practice to prevent harassment in other areas?

What projects and innovations have developed in response to girls' and women's experiences of harassment?

What are the future challenges to delivering successful awareness raising work?

Does Southwark Council have a programme to improve safety in public spaces at all times of day and night including , unwanted behaviour on the transport network, tackling attitudes of everyday sexism and misogyny?

Sex/relationship education -what role does the council and the NHS have in this ? What is the uptake on material offered? How much influence does the council have over content and delivery in the range of Southwark schools?

How are we working to encourage positive attitudes, behaviours and healthy relationships amongst children and young people , including specialist advocates in schools?

*What is the council currently doing to tackle child trafficking in our borough?*

*What actions should be doing to tackle child trafficking in our borough?*

#### **Safeguarding data – harassment and abuse**

- In school
- On way to school
- In the community
- At home

#### **Survey: to all schools primary and secondary school head / safeguarding leads, higher education institutions and youth groups in Southwark**

Potential questions:

Do they teach students about healthy relationships?

If yes, do they follow a specific curriculum? Where do they get their resources from? Who teaches the lessons? Would they be willing to share their resources with the council?

How effective do they think the resources are?

Is there anything the council can do to help e.g. provide educational resources

Do they have specific processes with dealing with different types of abuse e.g. street harassment, online abuse etc...

How to they think sexual violence and harassment can be reduced?

Would they and some of their students (14-18 years old) be willing to take part in a roundtable discussion

### **Roundtable discussion with 4 schools, higher education institutions or youth clubs**

*(Notes William Hounbo said he is willing to talk to the Salmon Centre about hosting a roundtable discussion and he can chair a group, I am going to talk to COLA in South Bermondsey, I was also going to talk to Lisa Dalton a local community activist to see if she has any suggestions. I am also talking to a number of councillors who are teachers to get their advice)*

Suggested talking points for a round table discussion:

What is a healthy relationship

Who taught you what a healthy relationship looks like

Can you give examples of an unhealthy relationship

What is harassment

Have you ever been harassed and where

Did you report it/ do you know where to report it?

#### **Other activities:**

Before the next commission: Leanne to talk to all of the relevant cabinet members and to conduct research into what other councils are doing to promote healthy relationships, tackle sexual violence and harassment of girls and combat
