1. PRELIMINARY BUSINESS

- That the following recommendations contained in the report of Scrutiny which are set out in Appendix 2 to the report, be agreed:-
 - a. That Council Assembly accepts the findings of the District Auditor and apologises to the directors of THK Entertainments Ltd for the failings identified in the District Auditors and Local Ombudsman's report.
 - b. That the Council as a whole, including elected members, should accept its own share of responsibility for the events that have led to the District Auditor's and Local Government Ombudsman's report.
 - c. That Council Assembly urges all parties to take the necessary steps to identify and resolve the legal issues as soon as possible. The Executive and Directors of THK Entertainments Limited to take all necessary steps to expedite the process in line with the strategy recommended by Nabarro Nathanson in their advice.

However Council Assembly has made clear its view on the appointment of council representatives on the Alliance Board on several occasions. Council Assembly therefore reiterates its request for the Southwark Alliance to amend its standing orders and requests the Leader of the Council to raise this matter again at the next meeting and inform the Southwark Alliance Executive in writing that until this matter is resolved the Alliance will not enjoy the confidence of the majority of elected members in the borough in its governance.

- The East Dulwich community centre is an essential community resource for people in East Dulwich and Peckham Rye; is used by people of all ages, ethnic groups and religious faiths; has been run by volunteers for over two decades; and includes the only outside space for young people to use in East Dulwich;
- The Executive have put forward plans to dispose of the site and, as part of a private development, build housing on the site and flats over a re-built community centre that would retain a third of the existing outside play space;
- At the May Dulwich Community Council many members of the public strongly opposed incorporating housing on to this site.
- 2. That Council calls upon the Executive to note the unanimous resolution of the Dulwich Community Council of 18th May 2004 and in particular:
 - that residents are concerned about the community

centre and housing being in the same building

- that the Executive should foster a community led initiative
- that the timetable should be delayed by six months to allow proper consideration of practical solutions.

Note: The above recommendation stands referred to the Executive for

consideration.
