### RECOMMENDATION

1. That Dulwich Community Council considers whether or not to hear a late deputation from a group of residents from Holmdene Avenue regarding the proposed increase in controlled parking zone (CPZ) charges.

### **BACKGROUND INFORMATION**

- 2. The Chair has been notified of the late deputation request. In accordance with community council procedure rule 7.4 (6) the chair has the discretion to accept the deputation as late and urgent after the normal deadline.
- 3. When considering whether to hear the deputation request, community council can decide to:
  - Receive the deputation at this meeting or a future meeting; or
  - That the deputation not be received; or
  - Refer the deputation to the most appropriate committee/sub-committee.
- 4. A deputation shall consist of no more than six people, including its spokesperson. Only one member of the deputation shall be allowed to address the meeting for no longer than 5 minutes. After this time members may ask questions of the deputation for up to 5 minutes. At the conclusion of the questions, the deputation will be shown to the public gallery where they may listen to the remainder of the open section of the meeting.
- 5. The deputation states:

We are concerned that Southwark Council is considering increasing the parking fees for Holmdene Avenue for next year. Parking fees were only intorduced here in January 2011. It is unfair that the Council is proposing an increase already. The Council has not sought the views of residents on this proposal. We object strongly to this proposal and urge Cllr Barrie Hargrove, the cabinet member responsible for the proposal, to reconsider. We also seek an assurance that we will be consulted and our views will be given due weight before any changes are made to the parking fees for Holmdene Avenue.

## **Holmdene Avenue**

6. A deputation request has been received from a group of residents from Holmdene Avenue. The purpose of the deputation is to address councillors on the matter of the increase CPZ charges.
