Police are in receipt of an application from the above to vary a Premises Licence under the licensing Act 2003

The hours for licensable activities as per the application are as follows.

Live Music: Mon-Tue 11:00 to 23:00
 Wed-Sat 11:30 to 00:00
 Sun 12:30 to 22:30

Recorded Music: Mon-Wed 11:00 to 00:00
 Thu-Sat 11:00 to 02:00
 Sun 12:00 to 00:00

Dancing: Mon-Wed 11:00 to 00:00
 Thu-Sat 11:00 to 02:00
 Sun 12:00 to 00:00

Refreshment Mon-Wed 23:00 to 00:00
 Thu-Sat 2300 to 02:00

The premises to be open to the public.

The premises have offered a number of control measures as part of their application however the wording of each is essential to negate any ambiguity.

1. When the premises are in operation and the terminal hour as per the premises licence is greater than 00:30 then premises will employ SIA registered door supervisors on a ratio of at least One (1) supervisor to Fifty (50) persons but with a minimum of two and must also include at least one female. They will be employed at all times after 21:30 and the terminal hour that the premises are in use under this licence. They will be provided with hand held metal detection units in order to ensure searches are carried out in respect of all admission including members of the public or performers and their assistants. A mechanical counting device will be used in order to ensure the maximum accommodation limit of the premises is not exceeded.
2. That signs shall be displayed in the entrance foyer to the premises that state 'Drugs Free Zone' and 'No Search No Entry, Management reserve the right to refuse entry'
3. That all matters relating to drugs shall be in accordance with the Metropolitan Police Best Practice Guide on the handling of drugs in pubs and clubs
4. That suitable notices shall be displayed and announcements made requesting people to leave the premises in a quiet and orderly manner so as not to disturb local residents
5. That a CCTV system be installed at the premises and be maintained in good working order and be continually recording at all times the premises

- are in use under the licence. The CCTV System must be capable of capturing an image of every person who enters the premises.
6. That all CCTV footage shall be kept for a period of thirty one (31) days and shall, upon request, be made immediately available to Officers of the Police and the Council
 7. That you shall require any regular and external promoters or other third parties hiring the premises to complete the 'Venue Hire Agreement' provided by Southwark Police Licensing unit and, once completed, you shall ensure that a copy of the agreement is provided to the Police and Licensing Unit a minimum of fourteen days prior to the date of hire.
 8. That a Personal Licence holder is on the premises and on duty at **all** times that intoxicating liquor is supplied.
 9. There shall be no new entry or re-entry to the premises after 00:00
 10. That the Premises Licence holder and/or Designated Premises Supervisor join and support a local Pub Watch Scheme should there be one in existence for the area in which the premises is located.
 11. Customers shall use no outside area after 22.00hrs other than those who temporarily leave the premises to smoke a cigarette. Those who do temporarily leave for this reason shall be the subjected to the requirement of a further search.

Hi Licensing,

The EP Team object to this application for a premises license variation.

Reasons

- In 2012 there have been 6 complaints so far regarding noise from the Great Exhibition.
 - 30.03 - noise from beer garden - 2 complaints
 - 24.04 - noise from beer garden
 - 29.05 - music noise (not specified)
 - 05.07 - music noise (band)
 - 22.07 - band playing in external area.
- The pub has large glass windows to the Crystal Palace Road frontage, the application does not detail any noise containment works for the windows.
- To the Crystal Palace Road frontage there are no proposals to install a noise noise lobby.
- No noise lobby is planned for the door to the beer garden/courtyard.
- The part of the application form that describes the steps that will be taken to promote the licensing objectives does not detail how noise nuisance will be controlled.
- This licensed premises is in an area that is almost exclusively residential.
- It would appear that the current licensee already has scant regard to thier obligations to neighbours and to the detail of what is permitted under their current license.
