# Notification of Objections by Councillor Jonathan Mitchell, East Dulwich <br> Concerning Proposed License Variation No.: 838498 re: "The Great Exhibition" Public <br> House, 133 Crystal Palace Road, East Dulwich 

To: Roy Fielding, Licensing Unit Hub 2, Floor 3, Regeneration Department, 160 Tooley Street, London SE 1 2QH.

## General Background

(i) This public house is situated at the north-eastern junction of Crystal Palace Road, Underhill Road, and Whateley Road. On each of the remaining three corners of this junction are residential properties. This is one of East Dulwich's residential areas.

The nature, scale, and impact of the changes applied for are out of keeping with the nature of the location, and are more in line with the many public houses, restaurants, and wine bars in the commercial areas of East Dulwich such as Lordship Lane and the Market area of North Cross Road. The General Objection is that the Applicant is endeavouring to turn this public house from a quiet, comfortable and orderly place, into a mecca of music and entertainment with a Market in place within the premises at the busiest times of the week. There might be an argument for such changes if this public house was in a different location in or near to the commercial quarter of East Dulwich, but it is not, it is situated in a residential area.
(ii) The Proposal to add an "internal courtyard" has already been carried out, as on a recent visit last week I went into the Courtyard where I found that decking had been put down, tables and chairs, and lighting and other services were in place, and available for use. My own conclusion that the Courtyard was already in use for the consumption of alcohol, other drinks and food was confirmed when I spoke to a male member of staff on duty who confirmed that fact.

I also drew the conclusion that, if the changes being Applied for were granted, this Courtyard open to the sky for the main part, would provide a useful "cooling-off" area for dancers or those who needed fresh air or a smoke, thus avoiding even larger numbers from spilling out onto the already overcrowded street and pavement areas. It follows that the noise nuisance emanating from this area of the public house will exacerbate the already intolerable levels coming from additional parts of the premises.
(iii) Along the Eastern edge of the site is a dividing wall between this public house and number 250 Underhill Road a residential home. Almost directly in line with the rear windows of the kitchen and rear door to number 250 (albeit on the other side of the wall within the premises of the public house) is a converted bottle store called the "gin house". This is currently in use by customers of the public house, who can exit from the main large bar, walk through the "Courtyard", and sit in the gin house to smoke.

I am unable to say of what materials the gin house (smoking area) is constructed but I express concern about the appropriateness of the current arrangement on fire risk, planning, and health and safety grounds, to say nothing of the pollution of the neighbours premises, and the nuisance to the residents at both 250 Underhill Road, and the rear of 90 Darrell Road, and the other premises in the immediate area.
(iv) The northern edge of the public house's property is a residential property in Crystal Palace Road. The Western side in Crystal Palace Road has a large open area with seating and tables, and the Southern side in Underhill Road has a smaller seating area with tables. Both these areas are directly facing family homes. If we also include the Courtyard and "gin yard" smoking area on the Eastern side, this public house has three sides providing a constant loud noise nuisance to neighbouring residential properties.

## OBJECTIONS:

1. That the extensions asked for in Variations 1 and 3 should not be allowed for the reasons that a substantial increase in the already unacceptable noise nuisance and disorderly behaviour will take place. Sleep disturbance for children, key workers (such as a fireman and others), elderly people, those who wish to keep their windows open at night (but are presently unable to do so because of the noise going on at unacceptably late times of the night), and others, is a major problem.

Some of the causes of noise disturbance from this public house include:
(a) noise of music and raised voices, with doors left open;
(b) insufficient control by staff of people in outside areas, which includes not just normal or extended hours, but at times well outside a 30 minute "consumption" time and late into the night. This is compounded because the later it gets and the quieter the neighbourhood becomes, the louder the chatter, laughter, arguments, and disorderly behaviour seems by contrast to be;
(c) people milling around from one part of the outside of the premises to another;
(d) people using the bin storage alleyway adjacent to number 349 Underhill Road in which to urinate or misbehave;
(e) on early Friday and Saturday mornings unacceptable noise begins early as people arrive and start setting up market stalls (etc.) on the premises;
(f) in addition to the general milling about outside the premises described above, there are people spilling out into the road causing a road safety hazard;
(g) the large bottle bins, which always seem to be wrongly kept on the pavement, are filled with large quantities of bottles at unacceptable times late into the night and early in the mornings.
2. That Variation 2 should not be allowed because 30 minutes is far too long, especially as the staff make no effort to keep people quiet, or ensure they finish their drinks and leave the area.
3. That the already existing "Courtyard" be kept as a place where no consumption of alcohol or any drinks or food takes place, and that no variation of the Licence is made in relation to this area.
4. That no Variations are granted to permit increased opening hours, and that no Variations are granted to vary the timings on Bank Holidays.
5. I agree with the suggestions Councillor James Barber has set out in his Formal Objection to the Variation Application.

The application to open until 2am/2. 30 am Thursdays, Fridays and Saturdays is particularly ridiculous for such a quiet family residential. area and will further increase the noise and disorder local residents have already been experiencing. As a quiet family residential area with high numbers of children any late night noise will impair their ability to do well at school.

This pub has many seats and tables directly facing family homes and has already been causing much upset with late night noise.
I. can see no merit in removing or amending conditions. 109, 110, 127, 1.63, 167, 168, 177 or 178.

I'm very concerned at the proposal. to amend condition 4 to create a courtyard for people to drink in without a noise report to show that no noise would leave the premises above the ambient background noise levels.

I also strongly object to any proposals to vary opening hours on bank holidays. Invariably bank holidays are Mondays and usually a normal school./Working day afterwards. Making any noise and disruption to people in this quiet neighbourhood unacceptable.

I would like to formally object to the proposed extension of operating hours for the above premises (to 2.30am on Thur/Fri/Sat) on the basis of prevention of nuisance.

This pub is inarguable in a residential area containing many elderly people and families with young children. Whilst very happy to have a neighbourhood pub, the current operating hours can see increased noise nuisance and disturbance to neighbouring streets up until approximately 11.30 pm . Dear Roy,
We, the residents of Great Exhibition, 193 Crystal Palace Road have applied for an variation to their premises incense (reference 838498) to allow opening until 2.30 am with music and dancing Thursdays, Friday and Saturday nights and opening until 12.30 am with music and dancing the rest of the week, and we would like to make representation on the basis of the prevention of public nuisance.

As things stand currently, the noise escaping from the Great Exhibition, when entertainment activities are held (Music and Pub Quizzes) and most importantly, when the pub's customers are free to sit , drink and smoke in the beer gardens outside our house without restriction or time limit (creating excessive noise audible beyond the existing opening hours), is depriving us of sleep and interfering with our right to sleep both during the week and at weekends. As our dwelling is connected to the pub, vibration and noise easily passes through the structure of the building as well as from outdoor areas. I repeat, noise from the pub's outside area, usually shouting or loud voices is especially noticeable at night and can be heard until and beyond 00:00.

The noise as things currently stand is undeniably causing a statutory nuisance and we urge you to ensure that all current licence conditions are being adhered to. The fact that, in our view, there is evidence that current license conditions are not being adhered to, means that the application for a license extension should not be granted. We have endeavoured to resolve the matter informally. However, as this approach has failed, we would like to provide all necessary evidence so that you may enact your legal powers to serve an abatement notice requiring the nuisance to stop. Separately to this objection, we will therefore be applying for a review of the current license agreement.

We would like you to consider the following concerns in our representation / objection to the proposed variation:

- In our view the terms of the existing license are not currently being adhered to, with public nuisance through noise currently extending beyond the pub's opening hours;
- The pub, since it was taken over by new management, has become very noisy: the doors and windows are left open (which may help for ventilation) but causes a lot of noise for neighbouring properties. This is in contrast to, for example, The Actress ( 90 Crystal Palace Road), where the doors are shut from 10 p.m. and there is no access to the outdoors areas (smokers have to use the space outside the front door which is staffed by an accredited security person). There seems to be
no equivalent at The Great Exhibition where people are free to sit , drink and smoke outside without restriction or time limit (beyond the existing opening hours);
- The smoking area /courtyard is already a considerable source of noise going late into the night. The space is not enclosed by a roof (otherwise it couldn't be used for smoking) so the noise is highly audible late into the night. In addition, it seems that the courtyard to the right of the bar area (referred to as the GIN YARD) is not currently covered by the licensing agreement and this is creating considerable noise. The variation seeks for this additional bar outside to be part of the license agreement (indicating that the GIN YARD currently in use is non-compliant within the terms of the current license); that will significantly increase the existing problem of noise;
- The immediate vicinity of the corner of Underhill Road and Crystal Palace Road is wholly residential and it is not an area where there is any tradition of late-night noise;
- There are already problems with drunk and rowdy people leaving the Great Exhibit after midnight. Extending weekend opening times until 2.00 a.m. will mean that increased disturbance is caused to residential neighbours for longer into the early hours of the morning (hugely disruption our ability to rest in between work days and at weekends);
- Waste management has been really poor since The Great Exhibition opened. For weeks at time, bins with general waste and bottles have been left only a few meters from our front door (on the street and not within the pub premises) leading to smell or other effluvia and insects arising; from which we have found to be a statutory nuisance. Despite notifying the pub that this is not acceptable, this unsightly waste has been left outside our house on several occasions.
- Parking in the local area has been affected by The Great Exhibition and this proposed license review will only make matters worse;
- Property values in the area will be affected negatively by a noisy premises, with such late opening hours making the neighbourhood less attractive to residents and prospective residents.

So far we have directed our complaints directly at the management of The Great Exhibition, repeatedly requesting to have a meeting with management to discuss the extent to which they are currently not compliant with the terms of their existing license. Although we have communicated by phone and face to face on a number of occasions, management have not been forthcoming and we have been left with no resort but to start to reporting disturbances daily by calling the 24 hour hotline on 02075255777 to report the problem and keeping a noise diary detailing the date and time of noisy events.

Finally, we feel very strongly, that:
(i) The proposed extension to the license should not be granted and we would like the right to attend any future hearings to make our case by appointing a representative.
(ii) A review of whether existing 'The Great Exhibition' license conditions are being adhered to should be undertaken, and would be in the interest of the public, and wellbeing of the local residents and the local community as a whole;

I am writing to register my strong objection to any extension of the license 838498 to the Great Exhibition pub on Crystal. Palace Rd.
My objection is on the basis of PREVENTION OE NUISANCE.
I have lived in the vicinity of this pub for over 17 years. The neighbourhood is a quite, residential area with many parents of young children as well as many elderly people.

Since the change of ownership of the pub, (renamed from Crystal. Palace Tavern to Great Exhibition, and the use of the former bottle store to the rear, the noise levels have increased exponentially. This part of the pub backs exclusively onto residential gardens.
The sound of crowds shouting and generally making noise now acompanies us and our neighbours every evening, both in our gardens and in our houses, even if we close all. windows and doors. This situation is becoming intolerable. I would seek for the use of this yard to be returned to storage and not to be used as an area for drinking and music.
This new use totally disregards our rights as residents to enjoy living in our own homes.

There have been further problems with drunken and rowdy behaviour from people Leaving the pub around its present closing time.

The granting of any extension of these opening hours would make all of the above much worse than it is now, and would be totally out of keeping with the area

## RE: ANONYMOUS OBJECTION TO LICENSING ACT 2003 APPLICATION NUMBER 838498

I write to formally object in the strongest terms to the above application on the grounds of the prevention of nuisance and the prevention of crime and disorder.

My husband and BRoad, in the immediate vicinity of The Great Exhibition public house which is the subject of the above application. My property directly faces the pub's beer terrace and a main entrance, both of which are a matter of metres away.

I believe that the extended license will cause a serious nuisance to the surrounding residential area and that I will be directly and negatively affected if it is granted, in whole or part. This is compounded by concerns I already have with the current activities of the pub which, at times, are antisocial and potentially overreach the owner's existing license.

The pub that preceded The Great Exhibition, the Crystal Palace Tavern, was a quiet, unobtrusive and positive local feature. It sat easily amongst its neighbours and generally caused no problems for the community. Since the pub was refurbished its activities have increased drastically. These have already proved to be a nuisance to my husband and $I$, as I know they have for many other residents.

A quiz night now takes place every Tuesday and a band night every Thursday. The quiz master's microphone is so loud that his voice is an audible annoyance inside my house; likewise, the noise from the musicians is always unacceptably high, on occasion involving brass instruments and drums. Although these events take place inside the pub the double doors that face my property are almost always left wide open, allowing the sound to carry clearly in to the surrounding streets at night and in to my home. On the extremely rare occasions that the doors are kept closed, due to the pub's thin glass windows, the noise still travels unacceptably in to my home. The events continue past 11.00 pm and have, on many occasions, made it difficult for me to sleep. In surrounding streets that are otherwise quiet in the evenings, these activities stand out and are an unwelcome source of nuisance.

This summer alone, on separate occasions my husband has called the police, as well as Southwark's nuisance telephone line, in the small hours of a weekday morning (past 12.30am) to report groups of drunken customers who have not dispersed from the pub after an event. Customers loiter after closing hours and talk loudly, often shouting, without consideration for local residents who are trying to sleep. Extending the license would fuel this existing problem with customers leaving later in a more drunken and rowdy state, having been drinking for even longer. To date, I have seen no evidence of The Great Exhibition taking responsibility for its activities and asking its own customers to disperse after closing hours and be considerate to neighbours. There is"a small A4 notice on the exit door, but this is evidently not adequate. The fact that they wish to open even later with license for potentially more nuisance activity when they have not proved themselves to be considerate neighbours within the remit of their existing license is worrying.

My bedroom faces the front of the pub. On many nights I am disturbed, typically just as I am trying to get to sleep at c.11.30pm, by the pub's staff after closing hours dragging around and securing their wooden tables and benches on the terrace at the front of the pub. Although the noise is temporary, lasting 10 minutes or so, it is yet another unacceptable disturbance and nuisance in the middle of the night when most people are trying to sleep. If the licence was extended then this daily closing activity would take place at 00.30 am on a Sunday night, and 2.30 am on a Friday morning which is not fair, reasonable or acceptable.

The local area is an entirely residential one. It is filled with families - some very young - and individuals whose daily routine typically involves waking for work between $5.30-6.30 \mathrm{am}$. If opening hours were extended on a Thursday night to 2.00 am customers would, from experience, only disperse by 3.00 am - just a couple of hours before our community would be waking to begin their working day.

Notably, there are other pubs in the immediate vicinity that thrive with more 'normal' opening hours and far greater consideration for their neighbours. These include The Actress, an extremely wellliked and established pub. The Actress closes its doors after 10.00 pm and, after this time, it only allows customers outside to smoke, not drink. This is done under the supervision of their door staff who usher customers back inside, preventing them from gathering and causing noise disturbance So, too, The Actress does not seek to host loud, raucous musical events which cause distress to its neighbours. It appears to respect the area in which it is situated. In contrast, the Great Exhibition's customers continue to drink, smoke and talk loudly well after 10.00 pm outside the building with absolutely no attempt from the pub's manager to bring them back inside. This pub's focus appears to be firmly set on its own interests, rather than those of the community.

Our local residential streets are not a high street. There is no tradition for a pub promoting music (live or recorded) and dancing late in to the night in this area whatsoever. If customers wish to drink and dance to loud music late in to the night there is an ample supply of such bars and pubs on nearby Lordship Lane which is a main, non-residential road and where late licenses therefore have their place.

The mere fact that the owners of The Great Exhibition would even consider it appropriate to make this application demonstrates that they have absolutely no understanding of, or interest in, the local community. This application would have zero benefit to local residents and is entirely out of sync with the life of our community. I can only see that the main objective of the application is to increase the pub's profits.

The pub certainly has the potential to exist peacefully within the community. I, and my neighbours, enjoy a glass of wine there on occasion after work, or lunch at a weekend with friends or family. However, this current application does not reflect a desire to serve the needs or wants of me or my neighbours.

I would urge you to reject this application and, furthermore, would welcome an investigation in to the current concerns raised above about the existing activities of The Great Exhibition.

Good to meet you today. To recap, I called your office in early spring to express my concerns that the local pub under new management were using what had in the past been a bottle store, a private area as a beer garden called the 'Gin Yard' . This beer garden is at the corner of two rows of residential gardens and the noise of people drinking and shouting as they progressively get drunker is preventing us from sleeping and ruining the quality of our homes. this is an area of families, aged people and young professionals and the nightly din of a large crowd of people in the gaxden late into the night and the disturbance it causes is very upsetting.

I spoke to Jane Tear, who assured me she would visit the establishment and check to see if the garden was permitted. I called her several times as the summer progressed and she repeatedly said she would address these issues. I do not know if she did, she left me a message and $I$ have repeatedly left voicemails for her but now learn she has been on leave, although her message does not say this. Is the Gin Yard legal and if not can it be closed so that the neighbourhood can once again enjoy some peace?
I. completely object to the the granting of any extension to their licence on the basis of prevention of public nuisance. Apart from the garden issue the management allow drinkers to sit on the seats outside long after they have closed. People have urinated and vomited against the wall of my house in the early hours of the morning and are very noisy and rowdy, a group of revellers kicked one of the newly planted trees over the other night. the street is littered with bottles and cans in the morning. It is unthinkable to allow a pub in such a residential and peaceful area a licence until 2 am or until midnjght during the week and later on bank holidays. They have the windows and doors open until and beyond closing time allowing noise to escape and have installed a very loud PA system audible from adjacent streets. ## Application by the Great Exhibition Pub (ref. 838497) for a licence variation

I am writing to object to the application by the Great Exhibition Pub (ref. 838498) for a variation of its licence to allow late opening hours and live music. This is on the grounds of prevention of nuisance. Such a licence is inappropriate to the pub's surroundings and allowing it would have a detrimental effect on the neighbourhood.

I live immediately opposite the pub, with lounge and bedroom windows opening immediately onto it, and I am already suffering from the noise it creates. Patrons are allowed to drink in the outside areas until the pub closes and they frequently have loud music playing inside the pub which can make it difficult to hold a quiet conversation or watch television in my lounge. I fear that continuing such music late into the night would make sleep difficult in the neighbouring properties, many of which contain children.

My sleep is in fact already suffering. It is now a regular occurrence for groups of people to mill around the pub after closing. This is a quiet area and late at night their talking and laughter appears amplified, making it very hard to sleep through. Just last Saturday a group of around ten people were hanging around in the street until after one o'clock. On occasion these groups have been considerably larger. One Thursday a number of weeks ago there were several dozen young people congregating for well over an hour after an event night finished. On both of these occasions, members of the pub staff were present but made no discernable effort to move people on or keep them quiet.

On a Friday/Saturday this problem is compounded by the fact that the noise begins again very early the next morning, as the pub's outside space is turned into an 'artisan's market'. This means that those people who live next to the pub only get six hours respite from pub-related noise.

Not only do the groups milling around outside create noise, they also spill out onto the street, creating a road safety issue. I have also encountered a member of one group urinating in the alley where my block's refuse bins are stored.

It is worth stating that I am not objecting out of dislike for pubs or because I am out of touch with the times. I am 34 years old, a social drinker and regular frequenter of pubs and bars with late licences, music and dancing. I like such places. It is simply that the Great Exhibition is so clearly in the wrong location to have such a licence. Nor is it necessary as there are a number of late venues open to people nearby should they wish to continue drinking on a weekend.

I am also not resistant to change and was genuinely pleased when I saw that the Crystal Palace Tavern - which I used to regularly frequent - was being given a face-lift. Far from being a positive benefit to the local community, however, this change is having a real detrimental impact on this quiet residential area. I now look fondly back to the quiet, scruffy but community pub that was there before. I am aware that other establishments manage to co-exist well with their neighbours, by adopting noise reduction measures, limiting outside use late in the evening and having proportionate opening hours. Unfortunately those who run the Great Exhibition are making little effort to do likewise.

I hope that this email is helpful and ask that it is logged as a formal objection on the grounds of prevention of nuisance. I would be grateful if you could let me know of any public hearings or Council meetings where this is being discussed, so that I might be able to attend.

Firstly let me say how much I like the new pub; I have been there many times over the past few months and it is a great improvement on the CPT.

However, the current location and design of the pub and its popularity means that it already makes a ot more noise than its predecessor. This is particularly the case on Tuesday evenings when they run the quiz and I can actually hear the questions from my bedroom at approaching 11pm. There have also been weekday nights when they have live music. Due to the outside area of the pub being completely open, having doors to the main area of the pub open and the fact that they don't seem to stop people sitting in the outside area later in the evening (as I believe that the Actress does for instance) the noise levels are not insignificant. And once people are disbursed from the pub (which currently seems to be between $11: 30$ and midnight) it is often noisy as they make their way back through the residential streets.

I appose to the application filed under reference $\mathbf{8 3 8 4 9 8}$ on the basis of the prevention of nuisance.

The noise levels have increased significantly since the change to the present ownership of the establishment in question. I notice that the staff and patrons also deposit waste in and around the bins which are for use of the residents of the flats, and there less parking spaces avallable following the increased volumes of patrons.

I am writing to request the above application is REFUSED.
The area proximate to the pub is entirely a residential area, a couple of corner shops, no evening establishments open at all, even the chip shop closes at 9.30 pm .
So, it's entirely houses and flats which already bear the brunt of the noise from music, antics of the drinkers sat outside and the loud, jovial people who leave the pub often quite late.
I have had someone leave vomit in my front yard and a few times people have peed behind my hedge, by time my children tell me about this of course the people have gone, but it's all due to people going to pubs and drinking too much.
There is late opening already available for revellers on Lordship Lane, 30 yards away, there is no need to extend the 'partying zone' to include this neighbourhood.
The pub has been there for 140 years and it has never been a nightclub-type establishment.
Any decision on the licensing for Great Exhibition has surely to consider the local population? My $3 x$ children aged 4, 6 and 8 , share the big room at the front of our house. Since the pub changed hands earlier this year they are being kept awake at night as it is.
At least I can tell them the noise will stop in a couple of hours (as things stand now). But to have to wait until the early hours of the morning before I can be sure that my children have peace enough to sleep, and therefore I can sleep, is not reasonable.
Although we are disturbed by the noise, we realise it is a pub and pubs do close at 11 pm , so we have something to look forward to on particularly noisy evenings.

Currently there is increased noise due to live music and DJs, when there is live music I can hear this in my garden and at the back of my house (my house faces the pub).
This means the doors are being left open, probably for ventilation, but this does impact the local populace.

The existing pub, since changing-hands, has proven most popular. I wish the owners the best of luck in all sincerity, but to extend opening to formidable town-centre times will completely destroy what's left of the peace and quiet we already have come to look forward to, almost daily, in this house.

Subject: Premises Licence application 838498 - The Great Exhibition

## Dear Sir/Madam

I am writing to object to licence application 838498 - The Great Exhibition - which seeks to extend the opening hours and create a new bar and food service area, as well as relaxing other licence conditions. I am writing on behalf of myself and my partner. We ask that our names, address and contact details be kept anonymous and redacted in any published documents unless required by a public inquiry.

Please acknowledge receipt of this email.
We live at which is approximately 60 metres from the great Exhibition. We are therefore directly affected by the existing noise from this pub and would be adversely affected by any relaxation of the licence as proposed in the application.

The Gtreat Exhibition is located in an entirely residential area and any increase in opening hours will have an adverse affect on local residents, the local area, and the public amenity derived from being able to live free from oppressive noise.

We would like to object on four main grounds:

1. The prevention of nuisance
2. The prevention of crime and disorder
3. Public safety
4. The protection of children from harm

## The prevention of nuisance

The immediate vicinity of the corner of Underhill Road and Crystal Palace Road is wholly residential and it is not an area where there is any tradition of late-night noise. Since opening in its new incarnation of The Great Exhibition, the pub is very noisy:

- the doors and windows are frequently left open which causes a lot of noise for neighbours in the surrounding area;
- the pub is an old building with no modern soundproofing;
- the pub puts on live music and recorded music on a regular basis;
- the pub has an outdoor smoking courtyard which is particularly noisy and remains open while the pub is open.

There seems to be no time restriction on existing use of the outside space (at the front ir in the rear courtyard) - people are free to sit, drink and smoke outside without restriction or time limit (beyond the existing opening hours).

The smoking courtyard is already a considerable source of noise going late into the night. The space is not enclosed by a roof (otherwise it couldn't be used for smoking) so the noise just escapes out making life unpleasant for those living nearby. Having an additional bar and food service area outside, as proposed in the application, would significantly increase the existing problem of noise.

## The prevention of crime and disorder

There are already problems in East Dulwich of low level crime and anti-social behaviour
associated with late night drinking. Most of this is confined to the bars and pubs on Lorship Lane, SE22. Allowing the licence change would mean that the people who become rowdy, abusive and/or who commit acts of vandalism (such as the recent destruction of a tree on the corner of Silvester Road and Crystal Palace Road) would be doing so for longer and there antisocial activities would be concentrated in this residential area.

## Public safety

While I am not aware of any problems relating to public safety to date associated with the Great Exhibition, the opportunity for people to drink longer into the night would increase the possibilities of alcohol-related violence and property crime/vandalism in the area. It is a residential area, there are no routine police patrols and no security staff at the pub.

The health impact from noise should also be taken into account. Loss of sleep through noise would harm the health and quality of life for all who live in the vicinity.

## The protection of children from harm

There are many families with young children in the area. The increased noise from extended opening hours and increased use of the rear courtyard would make it more likely that children's sleep would be disturbed, thereby harming their health and their performance at school.

## Summary of main points

- The area around the Great Exhibition is a residential neighbourhood.
- The existing use of the pub already causes significant problems of noise due to use of outside areas and the leaving open of doors and windows.
- Allowing extended opening hours would have a significant negative impact on the reasonable expectations of local people to live in an area with out loud noise late into the night.
- Allowing the use of the courtyard for a bar and food service area would significantly increase the problem of noise in the local area.
- Extending the licensing hours would increase the likelihood of crime and anti-social behaviour.

We therefore oppose the application. Indeed, we would actually like to see a review of the existing licence conditions because of the problem of noise caused by the operation and activities of the Great Exhibition

Dear sir/madam,
I live a block away from The Great Exhibition and am formally objecting to the application:

1. To Extend the permitted hours for all licensed activities except Live Music to Midnight on Sun - Wed, 02:00 on Thurs - Sat.
2. To add provision of facilities for dancing for the same hours as above.
3. To remove conditions $109,110,127,163,167,168,177 \& 178$.
4. To vary internal lay out of the premises to add a courtyard for the consumption of alcohol and
5. To include non standard timings for Bank Holidays and New years eve.

Like many people in the area I am fond of this pub and enjoy a drink there myself from time to time. However, I cannot support an application that seeks to extend licensing hours into the early hours of the morning. The immediate area surrounding the pub is wholly residential and for those living close to the pub the impact of an extended late license would be significant and negative.

My specific objection is concerned with noise levels of people leaving the pub, having had a good few drinks, late at night and early morning. I live in a ground floor flat on the corner of two streets - as people pass on their way home, having had a good night out they will, of course, be a noise nuisance for those of us hoping to have a peaceful, undisturbed night's sleep. The problem is exacerbated by the corner location of my home - pub customers will be passing along both streets, sometimes in high spirits, at silly hours (as late as 2.30 am Thursday - Sunday).

I also wonder about noise carrying from the pub for those who live closer than I - surely the sound of music and customers will be heard beyond the premises (even with pub doors and windows closed)? In addition, there's very little detail about the planned 'courtyard'. Would the courtyard be an outdoor/uncovered space (like the terrace at the front) - if yes residents need more information about proposed opening hours and use of that space due to the impact increased noise levels may have on their lives.

I genuinely wish the Great Exhibition well but pub business should be remain restricted to more neighbourhood friendly opening hours due to its very residential location.

I am writing to object to the proposed extension to licensing conditions for the Great Exhibition Pub in East Dulwich.

I live opposite the pub, at and will be directly, negatively affected by the proposed changes.

The area in which the pub sits is highly residential, and as a result it is important that the proprietors of the Pub are considerate neighbours.

In summary I understand the application to contain the following:

- Opening hours until 12.30am Sunday to Wednesday, and 2.30am Friday to Sunday
- Dancing until 30 minutes before the above times, with recorded music.
- Live music until 11pm Monday \& Tuesday, midnight Wednesday to Saturday, and 11.30 pm Sunday.

I note that section 315 states that drinking should finish in external areas at 11.30 pm . That however will be irrelevant when progressively more drunk customers move to external areas to smoke or get fresh air. The cross-roads is otherwise largely quiet, so people shouting in the early hours of the morning will carry, and disturb the peace.

The above provision (315) is already in excess of that enjoyed by other similarly located pubs such as The Actress, which closes its outside areas at 10pm. Since The Great Exhibition has opened they have made no attempt to encourage their customers to disperse at night. Beyond a note on the door, they equally have made no effort to encourage their customers to keep noise to a minimum whilst outside.

While the pub, being engaged in the hospitality industry, may find the proposed hours part of a working day, the vast majority of residents in the surrounding homes will keep more typical office hours. This will involve rising for work between 6 \& 7am. The proposal that on a Friday morning customers of the pub would be dispersing 3.5 to 4.5 hours before this is in no way reasonable. The opening hours across the week propose that there would be non activity from the pub during night time hours for a maximum of 5.5 hours before people begin rising for work. This is again unreasonable, and it is hard to see how this could be seen as of benefit to the local community.

Live music to date has included drums, electric guitars and brass instruments.
As a nearby resident I feel that the existing provision for this is not appropriate to the pub's location. I would expect that were I to rehearse a 4 piece band complete with amplifiers until 11 pm or midnight on a weeknight (or weekend) within my home, my neighbours, would be extremely unhappy, and Southwark's noise enforcement team would instruct me to desist. My home has double glazing, which reduces noise travelling externally, the pub does not.

Similarly the pub requests to essentially turn the venue into a nightclub, with dancing into the early hours of the morning. I am unable to bring to mind any such venues that have large single glazed windows taking up the larger part of the wall on two sides, as is the case with the pub. The building was not created for this purpose, and is unsuitable for this use. Similarly the location, being surrounded on all
sides by private residences, is not appropriate for an establishment of that nature. I fail to see how the proprietors expect that the noise generated will not disturb local residents.

The above concerns relate to the license application. The nature of the application, and its lack of consideration for the local community, are consistent with the behaviour of the pub's proprietors to date. Below are examples where they have shown that they seem to have no concern for their impact on local residents, nor have they shown themselves to be proactively seeking to be 'good neighbours'.

I note provisions in the proposed license that presumably exist in the current license, namely 310, 340 (both of which relate to keeping doors \& windows shut) \& 342 (placing speakers externally). The managers of the pub have failed to adhere to these on a number of occasions:

- The double doors facing Crystal Palace Road have frequently been left open over the summer, increasing noise levels when a quizmaster is using a microphone, or the bands are playing.
- The pub at one point invited a travelling DJ ('the middle class disco') to set up on a trailer outside the pub and play music during the day. This was at such a level that it was clearly audible in my house, despite my windows being shut. When I went across the road to ask them to turn it down, the response of the barman I spoke to was to the effect that they thought they'd set it up and see if anyone complained. It is this attitude which makes me concerned that the owners of the pub are unconcerned as to any effect their actions may have on the local community.
