RECOMMENDATION

1. That the planning committee agree that funds totalling £945,187 be released from the listed legal agreements associated with developments in the Peckham and Nunhead community council area and the northern part of Livesey ward, which lies in the Bermondsey and Rotherhithe community council area, to deliver a programme of 28 projects (detailed in section 12 of the report) to enhance open spaces, public realm, roads and transport connections.

BACKGROUND INFORMATION

- 2. Planning obligations are used to address the impacts caused by a development and contribute to providing infrastructure and facilities necessary to achieve sustainable communities. In order to achieve this, the council enters into a legal agreement with a developer whereby the developer agrees to provide planning contributions and/or enters into various planning obligations.
- 3. The proposed programme of projects has been prepared by identifying all section 106 (S106) money available in the Peckham and Nunhead community council area and the northern part of Livesey ward.
- 4. Opportunities to seek a strategic way to bring a number of separate historical S106 legal agreements together have been sought in order to deliver a holistic programme of streetscape projects in the area.
- 5. The projects detailed in Appendix 1 of this report must meet the stipulations of the legal agreements, which in many cases have been quite specific as to how the funds may be spent or utilised.
- 6. The planning projects team (previously known as the frameworks and implementation team) have developed and delivered a number of successful programmes funded by S106. Bankside and Bermondsey areas saw in the region of £1.2 million and £1.7 million respectively invested in local improvement schemes and Walworth recently benefitted from improvements to three local parks. This report takes a similar approach and seeks to create a programme of improvements across the Peckham and Nunhead community council area.

KEY ISSUES FOR CONSIDERATION

- 7. In order to ascertain what projects could be delivered from the available S106 monies, a mapping exercise was carried out to understand the distribution of unspent S106 monies by "purpose" (community facilities/environmental improvements/traffic and transport/open space etc).
- 8. Having mapped the existing monies, a list of project proposals have been drawn up in partnership with officers from each relevant council department. Further consultation will be undertaken with relevant stakeholders as appropriate.
- 9. The list of S106 available for the Nunhead and Peckham community council area and the northern part of Livesey ward detailing amounts available per development is shown in Appendix 2.
- 10. S106 funds are used to mitigate the impact of development in an area. Often the council needs to plan projects in advance to meet the additional requirements of a development. The capital programme 2011-21 report, agreed by council assembly on 6 July 2011, supported the use of S106 funds for projects already within the approved capital programme. The capital programme includes those projects considered to be high priority by the cabinet. There will still be instances where S106 agreements define specific local projects for which funds must be used, and community project banks will be reviewed when considering the application of S106 funds, so that local priorities are not overlooked.
- 11. The total cost of the scheme is £945,187 which is drawn from a variety of S106 agreements.

Policy implications

- 13. All projects will comply with Southwark council's draft Peckham and Nunhead Area Action Plan. This plan has been developed by consulting and working closely with local communities and other key stakeholders in order to produce a vision for the area.
- 14. The programme has been prepared in consultation with the traffic and transport team, housing, parks and the public realm division of environment and housing to align council policies. The programme is focused largely on the physical street scene and public realm but also includes parking and transport projects, a community development project and a carbon reduction project.

Community infrastructure project list (CIPL) consideration

- 15. CIPL for each of the community council areas were approved at their respective community council meetings in April and June 2013. The CIPL shows the local priorities for the expenditure of relevant S106 and future local Southwark community infrastructure levy (CIL). These identified projects should be carefully considered in the case of releasing monies from any S106 agreement.
- 16. The programme of projects responds to the CIPL for the area. The most recent CIPL for Peckham and Nunhead community council is in Appendix 3 of this report and available at: <u>http://www.southwark.gov.uk/info/200152/section_106/796/current_project_bank_i</u> <u>deas</u>
- 17. Five projects (numbers 3, 6, 8, 17 and 25) from the CIPL have been identified and put forward for S106 expenditure.
- 18. CIPL is not being considered for phase 1 of the athletics track at Southwark Park as £134,479 S106 funding for this has been drawn down separately. CIPL can not guide expenditure which has set S106 requirements such as tenant management organisation changes or the defined improvements to mitigate the waste transfer station.
- 19. It is proposed that S106 is used to pay towards dropped kerbs as part of the Nunhead outer London fund (OLF) project, see project 16. The Nunhead OLF project is already responding to two CIPL ideas by delivering environmental improvements to Nunhead Green and installing lighting projects on Evelina Road and Nunhead Green.

Community impact statement

- 20. The programme of projects is designed to enhance the attractiveness of the Peckham and Nunhead community council area and the northern section of Livesey ward as places in which people choose to live and work. By implementing these environmental, transport and community facility projects in the area, the council is improving the environment and social sustainability of the area, providing high quality public places which local residents and workers can use and which promotes the potential for interaction. Improving interaction between different social groups enhances trust and creates the conditions to forger stronger networked communities.
- 21. A number of projects focus on increased accessibility for wheelchair and push chair users, for example, providing dropped kerbs on routes to Queens Road railway station.
- 22. Other projects focus on providing more for people to do outdoors, for example by providing outdoor equipment such as table tennis tables in open space.

Resource implications

23. The resource implications are outlined above and summarised in the finance concurrent below. To deliver this programme council costs will be recharged on a project by project basis where appropriate.

Equal opportunities

23. This programme of projects has been designed to be fully accessible to all, without prejudice or discrimination.

Consultation

24. All ward councillors have been consulted on spend in their respective wards. The chairs and vice chairs of each of the community councils affected have been consulted and no further comments have been received.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

S106 Manager

- 25. All the contributions totalling £945,187 have been received by the council and are available for the environmental and transport improvements.
- 26. The proposed allocations are in accordance with their respective legal agreements, particularly those with specific requirements such as changes to traffic management orders and the improvements at Manor Grove, Eagles Close and Gerald's Close. The improvements will provide some mitigation for the associated development.

Strategic Director of Finance and Corporate Services

27. This report is requesting for the planning committee to authorise the allocation of £945,187 S106 funds, secured via several legal agreements, towards 28 allocations and 26 regeneration initiatives across the borough, as detailed in section 12 above.

- 28. It is noted that the related funds from the specified agreements have been received by the council and are available towards the programmes. Any on-going operational and maintenance costs will need to be funded within existing departmental revenue budgets.
- 29. Any staffing and other costs connected with this recommendation to be contained within existing departmental budgets.

Director of Legal Services

- 30. The proposal is to release monies from a number of S106 agreements for a variety of projects including the enhancement of open spaces and public realm and the improvement of road and transport connections.
- 31. The council is not permitted to spend any S106 monies except in accordance with the specific terms of the original agreement. The report refers to 28 different agreements where unspent monies are currently held which are considered to be relevant to the proposed expenditure.
- 32. The policy tests set out in regulation 122 of the Community Infrastructure Levy Regulations 2010 provide that planning obligations must be (1) necessary to make the development acceptable in planning terms; (2) directly relate to the development; and (3) fairly and reasonably relate in scale and kind to the development
- 33. Each agreement has been reviewed and it is considered the proposed expenditure accords with both the terms of the relevant agreement and also the relevant policy test.
- 34. The report also outlines the steps that have been taken concerning consultation and particularly the requirement to consult with community councils in accordance with part 3H of the constitution.
