Subject: EPT objection to TEN application - 70 Newington Causeway - 5/6th April 2014

Dear Licensing,

The Environmental Protection Team have reviewed the TEN application made by Mr. Kofi Berchie for a 'social event - such as party & social gathering' at Floor 5, 70 Newington Causeway, SE1 6DF on Saturday 5th April from 18:00 to 02:00 the following day. Licensable activities sought are for the sale by retail of alcohol, the provision of regulated and the provision for late night refreshment.

After reviewing the application and the premises history Environmental Protection raise objection to this TEN application for the following reasons;

1) Prevention of Public Nuisance

The premises is a disused office block and as such is not constructed/insulated to appropriately contain regulated entertainment noise, especially when continuing through to the sensitive times of 02:00. If this TEN goes ahead I have concerns regarding the potential noise disturbance this event could cause to surrounding residents.

2) Public safety

Southwark Council Environmental Health department have serious concerns regarding Health & Safety standards at the premises and as such the safety of visitors to the venue if this TEN is permitted. A fire Risk Assessment was undertaken by Nigel Williams dated 23/11/2013 on behalf of Mr. Kofi Berchie for Victorious Restoration Power Ministry, 5th Floor, Lancaster House, 70 Newington Causeway, London, SE1 6DF.

The following significant issues (those that have been identified as being very high priority and high priority) were stated as needing to be addressed as a matter of urgency;

It is the duty of the responsible person to action any significant findings, and as far as Southwark Council's Environmental Health teams are concerned these matters have not been addressed and as such very serious public safety concerns are still held with regards to this venue continuing to be used as a licensed premises.

With regards to max occupancy of the premises, the report detailed the following;

"There is a full occupancy figure of approximately 150 persons which includes visitors and staff. This figure has not been verified against the combined escape capacity of the protected fire exits and stairs for the whole building. The building has two escape stairs, each of which discharges directly to the outside and fresh air. However, the entrance door to the fifth floor lobby of the east stair (front) is of restricted width and has will therefore have a lesser capacity than the main stair. The Responsible Person has been advised by the assessor to urgently increase the width of the exit door to the stair lobby to at least 1050 mm in order to allow sufficient escape capacity to this stair, should only one stair be available in the event of fire. Until this is completed the Responsible Person should limit the number of persons on the fifth floor to not more than 60."

Despite the full occupancy figure being stated to the fire assessor as 150, this TEN application seeks to permit a max number of 200 people at the premises. This number is in excess of the previously stated max number of 150, and well in excess of the max capacity of 60 outlined in the Fire Risk Assessment. This demonstrates that the applicant has paid no attention to the content and urgent recommendations made within the Fire Risk Assessment.

To summarise, the Environmental Team raise objection to this TEN application on prevention of public nuisance and public safety grounds. The aforementioned Fire Risk Assessment is attached to accompany this objection.
