Report title:		Cleaner Greener Safer: Funding Reallocation

RECOMMENDATION

 That Camberwell Community Council approve the re-allocation of a total of £100,080 to one new project and as part of the 2016-2017 programme, as set out in Appendix 1.

BACKGROUND INFORMATION

2. Cleaner Greener Safer (CGS) is part of the London Borough of Southwark's capital programme. Between 2003 and 2015 £4.37m has been made available local residents in Camberwell to apply for awards to make their local area a better place to live. The programme attracts hundreds of proposals ranging from a few hundred pounds for bulb planting to brighten up open spaces to tens of thousands of pounds to create community gardens. These projects often introduce new ideas such as outdoor gyms in public spaces, community gardens, public art and energy saving projects which not only make the borough cleaner, greener and safer but greatly contribute to a sustainable public realm by involving residents in the funding process and in the delivery of projects.

KEY ISSUES FOR CONSIDERATION

- 3. Appendix 1 highlights fourteen projects which have a total under spend of £100,080 and recommendations for the reallocation of £30,000 to a new project in South Camberwell.
- 4. It is recommended that Ballcourt Denmark Hill Estate, project reference [105560], is cancelled and the remaining £33,800 is reallocated to alternative projects. The CGS allocation was match-funding towards the total cost of the new multi-games court which was built as part of the Bessemer Grange Primary School development. This was on the basis that there would be an on going agreement for community access to the facility. The funding was not required to meet the build costs and the school has agreed to community access without a financial commitment.
- 5. It is recommended that the under spend of £7,000 from Old English Rose Garden in Brunswick Park, project reference [105889], is reallocated to projects where additional funding is required.
- 6. It is recommended that the under spend of £1,300 from Grosvenor Estate playground repairs, project reference [106424], is reallocated to projects where

additional funding is required.

- 7. It is recommended that the under spend of £1,200 from Kevan and Laird House uplighters, project reference [106431], is reallocated to projects where additional funding is required.
- 8. It is recommended that the under spend of £1,800 from Poets Corner-Landor House play area, project reference [106442], is reallocated to projects where additional funding is required.
- 9. It is recommended that Hillcrest bulb planting, project reference [106449], is cancelled and the under spend of £800 is reallocated to projects where additional funding is required. Bulb planting took place in the proposed area in 2014.
- 10. It is recommended that the under spend of £600 from Grosvenor Estate water butts, project reference [106426], is reallocated to projects where additional funding is required.
- 11. It is recommended that the under spend of £7,500 from Glebe Estate cycle lockers, project reference [106434], is reallocated to projects where additional funding is required.
- 12. It is recommended that the under spend of £8,000 from W.O.W. wheels, project reference [106444], is reallocated to projects where additional funding is required.
- 13. It is recommended that the under spend of £1,280 from Ada Road entrance Brunswick Park, project reference [106429], is reallocated to projects where additional funding is required.
- 14. It is recommended that the under spend of £1,100 from Glebe Estate playground (north), project reference [106436], is reallocated to projects where additional funding is required.
- 15. It is recommended that £9,000 from Champion Hill Estate cycle lockers, project reference [106591], is reallocated to projects where additional funding is required. There are no suitable locations for cycle lockers on the estate.
- 16. It is recommended that the project Sunray Avenue lighting the green, project reference [106599], is cancelled and the remaining £8,500 is reallocated to projects where additional funding is required. The proposed works were rejected at consultation by stakeholders and the project is no longer feasible.
- 17. It is recommended that the under spend of £18,200 from Laird House car park lighting, project reference [106576], is reallocated to projects where additional funding is required.
- 18. It is recommended that £30,000 from the total funding to be reallocated from Ballcourt Denmark Hill Estate, project reference [105560], is allocated to a new project to install an outdoor gym on the same estate. This will provide opportunities for healthier lifestyles for residents of the area.
- 19. It is recommended that the remaining £70,080 is reallocated as part of the 2016-

2017 CGS programme.

Policy implications

20. None.

Community impact statement

- 21. The roles and functions of community councils include the promotion of involvement of local people in the democratic process. Community councils take decisions on local matters including environmental improvement and community safety as well as consultation on a wide range of policies and strategies that affect the area.
- 22. An explicit objective within community councils is that they be used to actively engage as widely as possible with, and bring together, Southwark's diverse local communities on issues of shared or mutual interest. The Cleaner Greener Safer programme is an important tool in achieving community participation.
- 23. In fulfilling the above objectives that community councils have of bringing together and involving Southwark's diverse local communities, consideration has also been give to the council's duty under The Equality Act 2010 which requires the council to have due regard when taking decision to the need to:
 - a. Eliminate discrimination, harassment, victimisation or other prohibited conduct;
 - b. Advance of equality of opportunity between persons who share a relevant protected characteristics and those who do not share it;
 - c. Foster good relations between those who share a relevant characteristic and those that do not share it.
- 24. Of particular regard are issues of age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
- 25. Having due regard to the need to advance equality of opportunity is further defined in s.149 as having due regard to the need of:
 - a. Remove or minimise disadvantages connected with a relevant protected characteristic;
 - b. Take steps to meet the different needs of persons who share a relevant protected characteristic;
 - c. Encourage persons who share a relevant protected characteristic to participate in public life or any other activity in which they are underrepresented.

Resource implications

- 26. This is the reallocation of existing CGS funding that was originally awarded in 2012/2013, 2013/2014, 2014/2015 and 2015/2016. CGS funding is devolved to Community Councils to spend on suitable projects.
- 27. All professional fees related to the project are also treated as the capital costs of the project. Where projects are awarded as a grant to organisations, the community council award letter will not include the professional fees which will

be charged direct to project costs.

- 28. CGS projects must be completed within two years of award of funding. Projects that are unlikely to be completed within two years will be reported to community council and available budgets may be reallocated to other projects. Revenue costs not covered by maintenance or the contractual liability period will fall upon the asset owner. The business unit will be notified of the likely costs before the schemes proceeds, in order to secure permission to implement the scheme.
- 29. After the defects and liability period, or three year maintenance period in the case of planting works, all future maintenance is assumed by the asset owner, for example housing, parks, highways, or in some cases external asset owners. Therefore, there are no revenue implications to the public realm projects business unit as a result of approving the proposed allocation.
- 30. The total expenditure and sources of funding for the scheme will be monitored and reported on as part of the overall capital programme.

Consultation

31. All CGS projects require consultation with stakeholders, including the project applicant, local residents and tenants and residents associations where appropriate.

SUPPLEMENTARY ADVICE FROM OTHER OFFICERS

Director of Law and Democracy

- 32. The allocation of the Cleaner Greener Safer capital fund ('CGS') is an executive function, delegated by the Leader to community councils.
- 33. Community councils are 'area committees' within the meaning of the Act and executive functions can be delegated to them by the Leader.
- 34. This report is recommending that the Camberwell Community Council approve the reallocation of available funds from the 2012-2013, 2013-2014, 2014-2015 and 2015-2016 programme as specified at appendix 1 to the 2016-2017 capital funding allocation. The power for this function is detailed in Part 3H paragraph 11 of the constitution which states that community councils have the power of "Approval of the allocation of funds to cleaner, greener, safer capital and revenue schemes of a local nature, using the resources and criteria identified by the cabinet".
- 35. The appropriate cabinet member approved the funding for the 2012-2013 programme in October 2011, the 2013-2014 programme in September 2012 and the 2014-2015 and 2015-2016 programme by virtue of his powers under Part 3D paragraph 2 of the constitution. Where funding needs to be reallocated the community council approval being sought here is therefore the appropriate constitutional step in the process.
- 36. Community council members also have powers under paragraph 12 of Part 3H of the constitution to oversee and take responsibility for the development and implementation of the local schemes.

37. In allocating funding under the CGS community councils must have regard to the council's equality duty set out in section 149 of the Equality Act 2010. The report author has demonstrated how those duties need to be considered in the body of the report at paragraphs 33 to 36 in the community impact statement.

Strategic Director of Finance and Governance

- 38. The report requests the approval of Camberwell Community Council for the reallocation of a total of £100,080, originally allocated to projects under the CGS programme, to other projects in the 2012-13, 2013-14, 2014-2015, and 2015-2016 CGS programmes, as set out in Appendix 1.
- 39. The strategic director of finance and governance notes that the re-allocation of the CGS funding will be contained within the existing departmental capital budgets for CGS programme allocated as part the council's capital programme.
- 40. Staffing and any other costs connected with this recommendation to be contained within existing departmental revenue budgets.
