Local parking amendment

A local parking amendment (LPA) is small project to change an existing parking restriction or to introduce a new one.

These tend to be carried out in locations where we have had a request to look at dangerous or obstructive parking and where small lengths of restrictions could provide a solution.

Request

In June 2016 the council received a request from a resident of Kerfield Place who raised concerns about obstructive parking adjacent to the private parking places during the day.

Location

Kerfield Place is within the South Camberwell (L) controlled parking zone which operates Monday to Friday 8.30 am – 6.30 pm.

There are two private parking places adjacent to the public highway.

Investigation and conclusions

This part of Kerfield Place was thought to be private and not part of the South Camberwell (L) CPZ.

Further investigation has confirmed that two sections of the carriageway outside Nos.7, 10 and 11 are private and remainder is public highway.

At present there are no restrictions adjacent to the private parking spaces and this results is vehicles parking and obstructing the access to the private spaces.

Recommendation

Based on our investigation and conclusions, the council are recommending, as shown is drawing below, That a single yellow line is introduced adjacent to the private parking spaces to prevent obstructive parking.

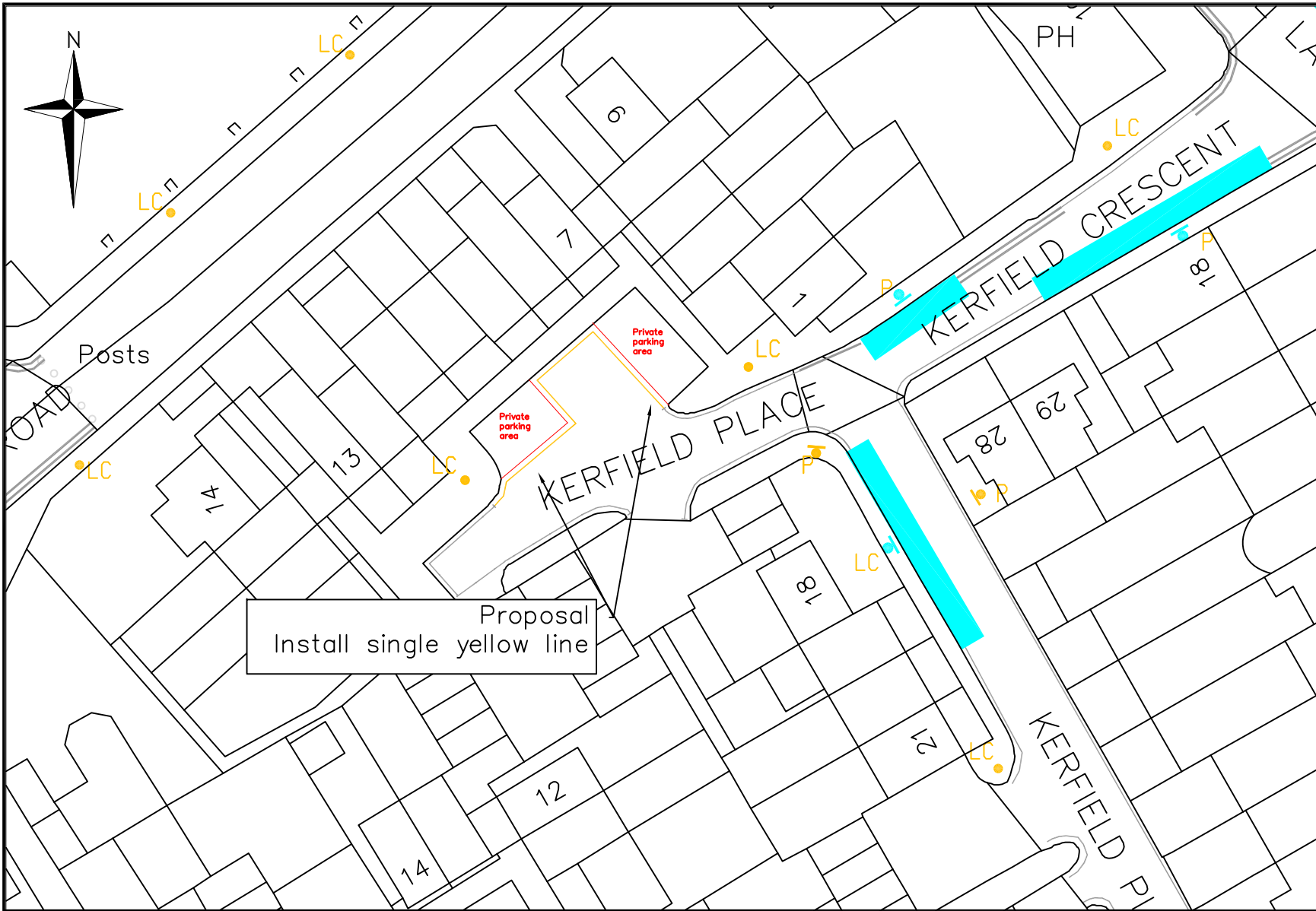
A detailed design drawing of the proposal is provided within this document.

Next steps

Should the community council approve this local parking amendment, it is expected that statutory consultation will commence in November 2016.

Following the statutory consultation period, the council will make arrangements to install the restrictions (road marking and signage at the location).

Should objections be received during the statutory consultation period, these will be presented at the next community council meeting for determination.
