To amend condition 135 of the Premises Licence to read; "Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons sitting at tables shown blue on the attached plans or those taking table meals there and for consumption by such persons as ancillary to his meal." The amended plans are attached showing tables marked blue where the applicants wish to provide informal dining and offer drinks without the need for a full meal. Customers in this area will be seated and served by waiter or waitress and substantial food will be available to anyone who wants it.
To delete condition 127 which is an outdated condition of no effect. Or of not deleted, it should be amended to reflect the changes to condition 135.
The premises have traded for over a year and are well respected and enjoyed by the local community. The premises is a restaurant that wants to have a degree of flexibility in the way that it provides its offering. The applicants respectfully submit that the proposed variation will not have any negative impact on the licensing objectives.
