Police are in possession of an application from the above for a variation to their current licence 851276.

The application seeks to increase the hours for licensable activities and opening hours.

I note that the premise sits within the Elephant & Castle major town centre, as defined by Southwark's statement of licensing Policy. The closing time for what is described by the applicant as a restaurant would be 01:00 on the Friday and Saturday nights as per policy.

The application has asked for a terminal hour of 03:00 on both Friday & Saturday Nights.

Although this venue is located in a major town centre as per the licensing Policy, it should be noted that it sits beneath and in very close proximity to a number of residential dwellings. As per the original application in 2016 I am of the opinion that this is not a suitable location for a premises to be open to the public until 03:00. It is highly likely that patrons leaving the venue at time would cause considerable noise nuisance to local residents.

I also note the application is for the provision of regulated entertainment and has previously been described as a restaurant with Karaoke Bar. This also could be a potential issue with noise complaints. Although the venue is currently conditioned only to supply alcohol to those seated with a substantial table meal.

The major concern from the Police is the potential ASB issues caused by patrons leaving, and any related crime and disorder associated with the extended permitted hours for the supply of alcohol.

It is for these reasons that I recommend that the application to vary the premises licence is refused.

	On SATURDAY 6th JANUARY 2018, I was on duty in full uniform in the company of PC												
	321MD O'MAHONEY and PC 464MD ANDREWS. We patrolled in a marked police vehicle												
	with a call sign of MD49N. I am the Police Sergeant of the Licensing and Night Time Economy												
	Team, a partnership team tasked proactively with patrols and visits of licensed premises on												
	the borough. One of the objectives of NTE team is to reduce victim with injuries and acquisitive												
	crimes to make Southwark a safe place for people to enjoy the night time economy offered												
	from all venues.												
	I had been informed by licensing officers at local authority, that a premises at 144 Eagle Yard												
	SE1, may be opening later than their licence hours permitted them.												
	At approximately 0240 hours, we visited the premises, and parked the vehicle directly outside												
	the premises. The premises was open, and I could see people inside the venue, on checking												
	the licence it should be closed at 0000 midnight on Friday and Saturday nights. There was a												
	sign on the door displaying open. A male security door supervisor exited the venue with												
	another male. He returned to inside the venue shortly afterwards and the sign on the door was												
	turned to closed. We alighted the vehicle and went inside where I could see approximately 20												
	people who appeared to be customers sitting at tables drinking and some dancing. There were												
	bottles of Corona lager on the bar about ¾ full. The male behind the bar area came over to me												
	and it was explained we were conducting licensing visits. I asked if he was in charge and if he												
	was the DPS. He said he was the manager and produced his personal licence. I asked if he												
	could show me his premises licence and he showed me a summary version of this. He was												
	unable to produce the full premises licence. The manager was asked what time he should be

closed on Friday night, and he replied 12 o'clock. I asked why he was still open, and he replied because it had been quiet and stayed open. He said he knew he should be closed at 12 o'clock. I asked what time he served the last alcoholic drink and he said about 0220. As PC O'MAHONEY took the details of SIA door staff PC ANDREWS and I asked to view the CCTV. There is a loft ladder at the rear of the premises that leads to a mezzanine area, where the CCTV is. The manager and a female staff member showed the CCTV and they were asked how far back it had recorded, as the condition on the licence stated it should be immediately available to officer and kept for 31 days. The CCTV appeared to only have recorded back to 23rd December 2017, a period of two weeks. As we talked I could see the premises was emptying out although there were still patrons inside the premises. As we stood in the bar area, the manager said he was likely to be applying to be DPS there, and the name is going to change to Borondo's. PC O'MAHONEY confirmed the breaches of the licence and then completed a S19 Criminal Justice and Police Act 2001 closure notice with guidance. The manager said he would call the engineer and ensure the CCTV was in working order. We then left to continue our patrols. The venue was visited again on Sunday 7th JANUARY 2018 at approximately 0030 and it was closed on that occasion.

Southwark's Environmental Protection Team (EPT) have reviewed the premises licence variation for 'Corporation Ponce', Arch 144, Eagle Yard, Walworth Road, SE1 6SP.

The variation application seeks to extend the following licensable activities;

Live music (indoors): Friday and Saturday 14:00 - 02:30. (Currently restricted to 23:30). Recorded music (indoors): Friday and Saturday 14:00 - 02:30. (Currently restricted to 23:30). Late night refreshment (indoors): Friday and Saturday 23:00 - 02:30. (Currently restricted to 23:30). Sale of alcohol (on the premises): Friday and Saturday 14:00 - 02:30. (Currently restricted to 23:30).

Opening hours: Friday and Saturday 09:00 – 03:00 the following day (Currently restricted to 23:30).

No changes are being requested between Sunday and Thursday.

EPT STANCE

EPT have reviewed section M part d) of the application form. No new measures are outlined on how operations will be controlled to prevent public nuisance. This section is filled with the conditions on the existing licence.

The application form does not advise what type of premises this is. EPT believe it to be a restaurant that now seeks to turn into a late night vertical drinking venue with live and recorded music and open late on weekends.

No information has been provided on the noise insulation standards of the railway arch as to whether this unit is able to contain live & recorded music levels, especially late into the night when background levels will be lower and when neighbouring residents will be sleeping. Nor is there any information on how the operator will control patrons leaving the premises late at night / early in the morning to ensure public nuisance will not occur.

The hours proposed exceed the Southwark Licensing Policy 2016-2020 suggested opening hours within the Elephant and Castle area (table 2).

EPT note that the premises has applied for numerous TENs to open until 3/4am in the past, however these applications were only ever for alcohol only. No live or recorded music was applied for under these TEN applications and as such these TEN events do not provide an accurate representation of this premises opening late at weekends.

EPT are also aware of numerous previous noise disturbance / public nuisance complaints from neighbouring residents regarding late night patron use for licensed arch premises in Eagle Yard and as such have concerns over the suitability of these arches in this location operating late into the night due to the high potential to cause public nuisance.

Taking into account the above, EPT raise objection to this application.

On behalf of the Director of Health and Wellbeing (incorporating the role of Director of Public Health) for Southwark (a responsible authority under the Licensing Act 2003) I wish to make representation in respect of the above.

This representation is made in respect of the following licensing objective(s):

- The prevention of crime and disorder
- Prevention of public nuisance
- Public safety

The applicant requests to vary their current licence to extend the sale of alcohol until 02:30 on Fridays and Saturdays and for opening times until 03:00 on Fridays and Saturdays.

The applicant's current license permits the sale of alcohol until 23:30 and a closing time of 00:00 on Fridays and Saturdays and this is in line with what is recommended in Southwark's Statement of Licensing Policy. The applicant has not provided any justification for the extension of hours requested and since the applicant has described this premises as a restaurant / café the hours requested are, in my opinion, not appropriate for this type of venue.

Additionally, although this premises is not located in a cumulative impact policy area, it is located within one of the geographical areas that the council monitors due to high rates of alcohol related harm, crime and disorder. The attached report shows that this premises is located in a hotspot for alcohol related rowdy behaviour (page 3), alcohol related harassment and common assault (page 4) and alcohol-related assault with injury and serious wounding (also page 4).

Recommendations

I recommend this application is rejected.



Introduction

The purpose of this document is to provide the reader with an overview of recorded alcohol-related **violence and disorder** in Southwark and its Cumulative Impact Policy (CIP) areas, and to help inform decision on proposed changes to CIP conditions set out in Southwark's **Licensing Policy**⁸.

Summaru

As shown by the map below, Southwark has three • CIP areas and three • monitoring areas 9. As requested by Southwark's Licensing Committee, • Shad Thames has been included in this report.



The table below shows the proportion each area accounts for of the borough total. It shows that in most instances, the proportions do not change much from one financial year to the next. One exception worth mentioning is the 6.4 percentage point increase from FY15/16 to FY16/17 in non-domestic, alcohol-related Violence. The figures behind this change show a 12.8% increase in the CIP areas total against a borough-wide decrease of 7.2%.

Of the six CIP and monitoring areas, Borough and Bankside accounts for the largest proportion of alcoholrelated reports.



- 0% of alcohol-related violence;
- 0.3 % of non-alcohol related violence.







Application to vary a premises licence

I write with regards to the above application to vary the premises licence submitted by Ponce's Corporation Limited under the Licensing Act 2003, which seeks to vary the following licensable activities:

- To extend live music and recorded music (indoors) on Friday and Saturday from 23:30 to 02:30 the following day
- To extend late night refreshment (indoors) on Friday and Saturday from 23:30 to 02:30 the following day
- To extend the supply of alcohol (on the premises) on Friday and Saturday from 23:30 to 02:30 the following day
- Overall opening times shall be on Sunday to Thursday from 09:00 to 23:00 and on Friday and Saturday from 09:00 to 03:00 the following day

To amend condition 843 which states:

843 - That on Fridays and Saturdays one SIA registered door supervisor shall patrol the outside the areas of the premises between the hours of 21:00 and **00:00** to monitor the patrons and number of smokers outside the premises.

To read as follows:

843 - That on Fridays and Saturdays one SIA registered door supervisor shall patrol the outside the areas of the premises between the hours of 21:00 and **03:00** to monitor the patrons and number of smokers outside the premises.

The premises is described within the operating schedule as 'Corporation Ponce' is neither a nightclub nor a bar but is simply a small licensed restaurant, accommodating a maximum of sixty (60) diners seated at tables. The venue does not have a dance floor or any available floor space between the tables and chairs for dancing'

My representation is based on the Southwark Statement of Licensing policy 2016 - 2020 and relates to the licensing objectives for the prevention of crime and disorder and the prevention of public nuisance.

This premise is situated within a the Elephant and Castle Major Town Centre and under the Southwark Statement of Licensing policy 2016 – 2020 the latest appropriate closing times for restaurants and cafes on Sunday to Thursday is 00:00 hours and for Friday and Saturday is 01:00 hours.

The premises is very close to local resident's who could be disturbed by patrons leaving the premises late at night. I object to the granting of the extended hours asked for within this application under the prevention of crime and disorder and public nuisance licensing objectives as the operation of the premises and of people leaving the premises even later at night could impact upon local residents living nearby and in the surrounding streets. The management would have no control of patrons that have left the premises and the possible impact of any rowdy and anti-social behaviour or crime and disorder.

Furthermore the hours applied for are in excess of what it deemed appropriate for this area within the statement of licensing policy and the applicant has offered no further control measures within the operating schedule to address the licensing objectives should the licence be granted.

I therefore submit this representation and welcome any discussion with the applicant to consider the above representation
