Consider the 23 representations as summarised in Table 1 received during statutory consultation relating to the proposal to extend existing parking zone 'H' (permit parking bays and double yellow lines) in the Rotherhithe area and install at any time waiting restrictions across the rest of the Rotherhithe study area. It should be noted that some representations provided more than one ground for objection. ii. Reject each of the objections included in the correspondence, summarised in Table 2, for the reasons given in Appendix 1. iii. Instruct officers to write to each person who made representations to inform them of the council's decision. iv. Instruct officers to make the necessary Traffic Management Order. v. Instruct officers to proceed with extension of parking
