Non-strategic Traffic and Highway improvement

A non-strategic traffic and highway improvement is a small project where the council proposes to modify the existing Highway layout. This may include changes to waiting and loading restrictions, traffic calming, improved crossing facilities etc.

Under Part 3D of the council's constitution, the Cabinet Member is responsible for Transport Issues: To decide to implement a traffic and highway improvement project, subject to statutory consultation.

Background / Request

As part of their Road Modernisation Plan, Transport for London has identified several locations where improvements to the highway would reduce bus journey times.

This request is to:

Extend hours of operation of existing single yellow lines along Rotherhithe New Road on approach to the bus stop by Luxford Road from Monday - Saturday from 8am to 6.30pm to Monday - Saturday from 7am to 7pm

Location



The stretch of Rotherhithe New Road and including Luxford Street are located within the None N CPZ which operates Monday – Friday between 8am and 6.30pm.





Investigation and conclusions

- Southwark Council commissioned Conway Aecom to undertake waiting and loading surveys to determine the extent of vehicles parking on the single yellow lines
- The surveys were undertaken during one weekday morning and evening and one weekend morning and evening from 7am to 9am and 5pm to 7pm
- The results of the survey showed few vehicles waited or loaded inside and outside the survey times
- The survey also highlighted that vehicles would park during the existing hours of operation, suggesting that enforcement could be improved

Recommendation

Based on site survey and investigation, it is recommended to extend the hours of operation of existing single yellow lines on the south side of Rotherhithe New Road (near its junction with Luxford Street on approach to the bus stop) from Monday - Saturday between 8am and 6.30pm to Monday - Saturday between 7am and 7pm.

This proposal is subject to Traffic Management Order (TMO) statutory consultation. A TMO is the legal mechanism the council as traffic authority uses to control aspects of the way that the highway is used. They provide the legal backing to signs and road markings used on the highway and allow them to be enforceable.

A detailed design drawing of the proposal is provided within this document.

Next steps

Should this non-strategic Traffic and Highway improvement proposal be approved, then arrangement will be made to carry out statutory consultation.

Following the statutory consultation period, the council will make arrangements to install the restrictions (road marking and signage).

Should objections be received during the statutory consultation period, these will be presented to the Cabinet Member for determination.
