

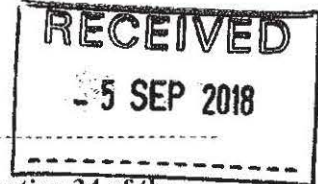

Operation during the night on weekends is to be kept as closely supervised as possible to maintain all good aspects of the operation running to council and police standards.

We ensure to keep close communication with residents to tackle immediately any nuisance originated by our premises or patrons

A competent security company with SIA licensed staff is always employed for operation after 2200 hours

b) The prevention of crime and disorder

No external promoters events to the public

Fully operating CCTV system to be in use in accordance with condition 788

Events such as weddings, engagements, family celebrations etc are normally held on weekends

c) Public safety

SIA licensed staff is employed from 2200 hours in accordance with condition 843 until premises are vacated and patrons dispersed from the immediate area

d) The prevention of public nuisance

Music levels are kept in line with a sound limiting device

Sound levels in the ground floor are kept lower to avoid disturbing residents and hourly checks are held to ensure no scape of sounds comes from the premises.

e) The protection of children from harm

Children are not permitted in the premises after 2300 Hours.
