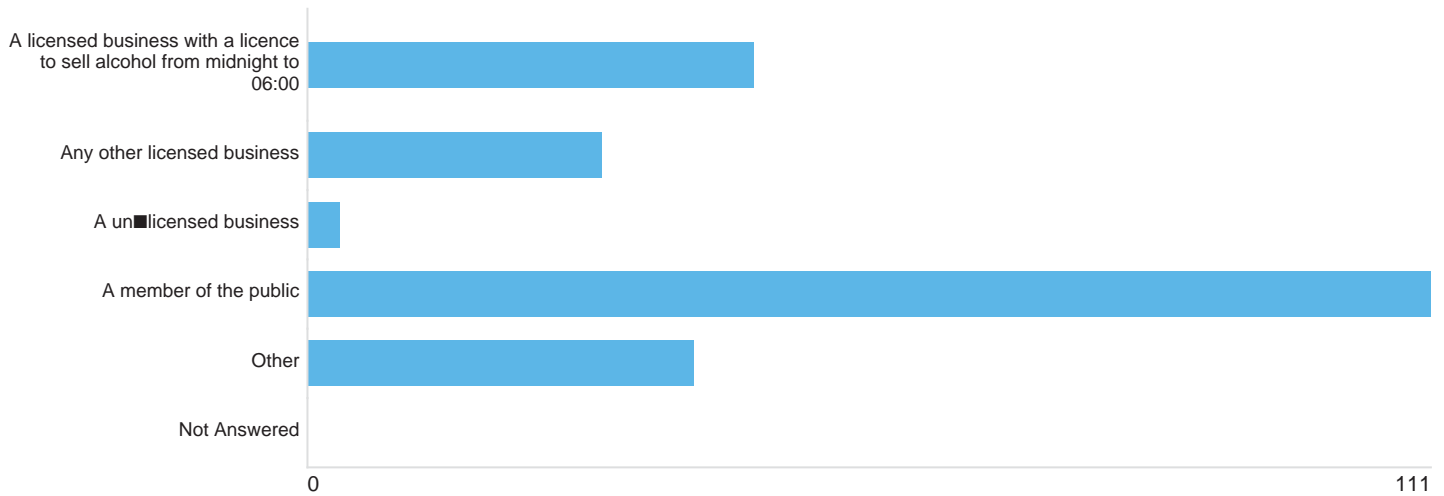

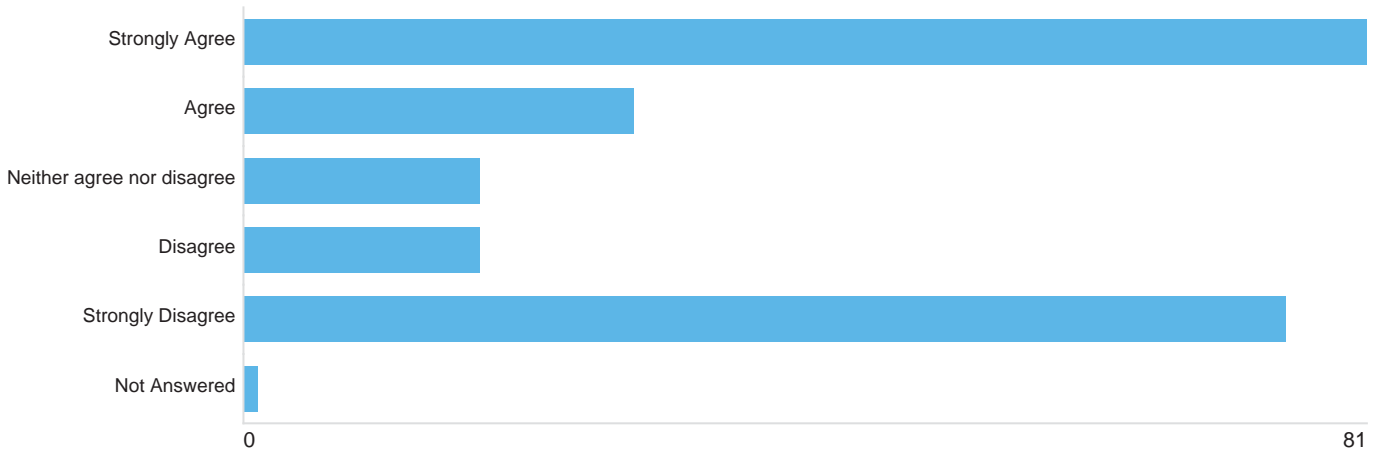

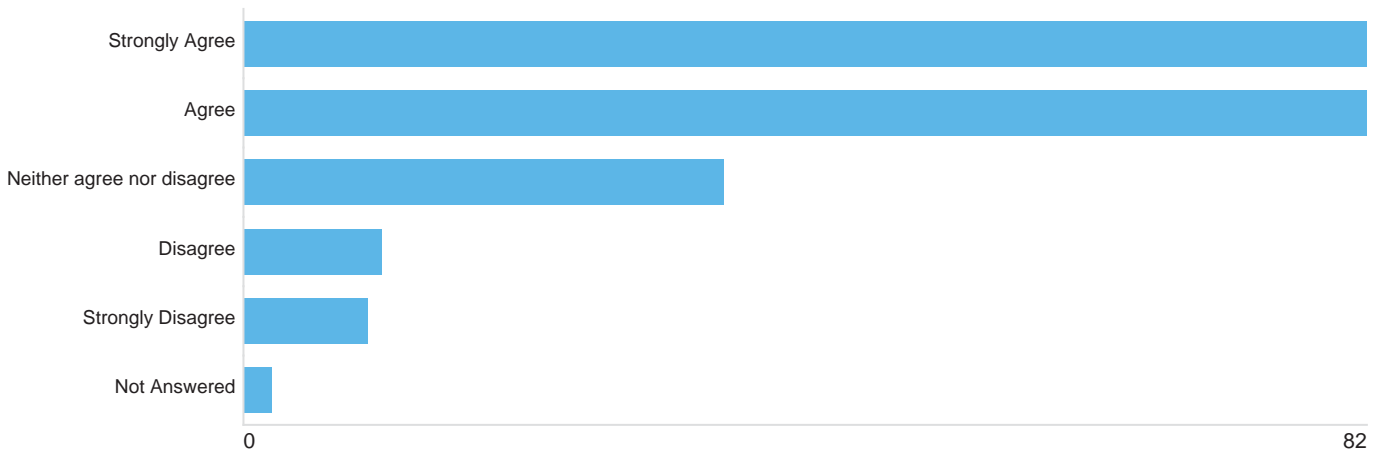

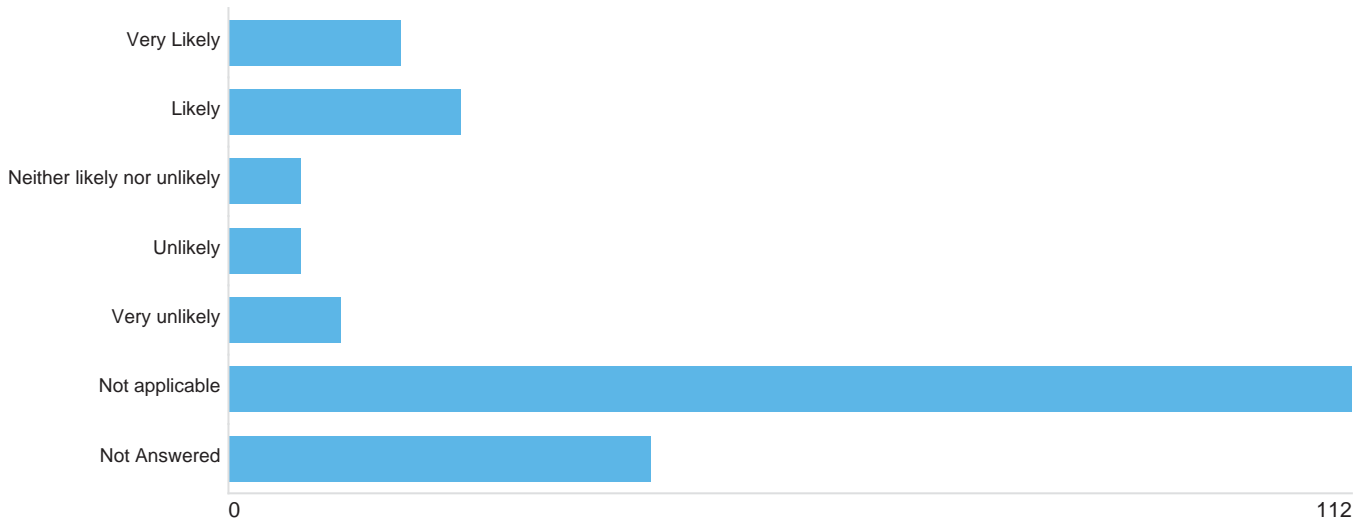

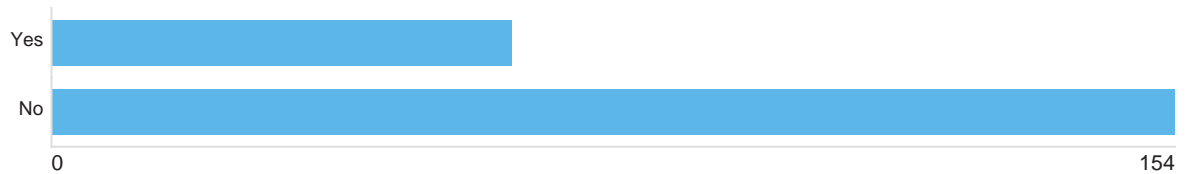

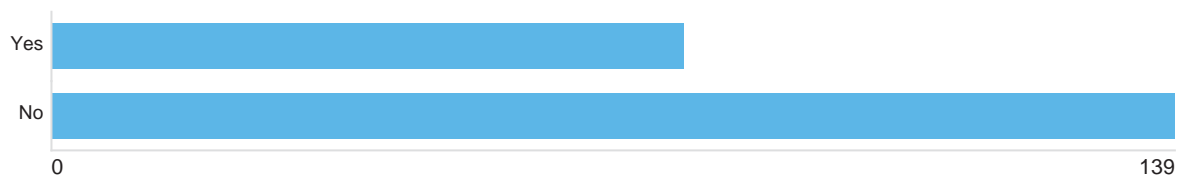
Question : There is the option to apply a 30% discount for businesses in certain categories. How do you think this discount should be applied?

No discount for any business selling alcohol late at night



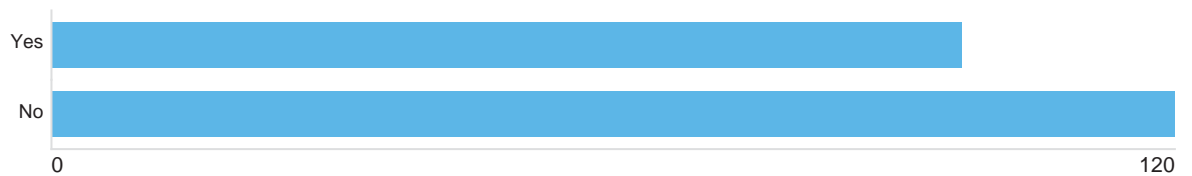

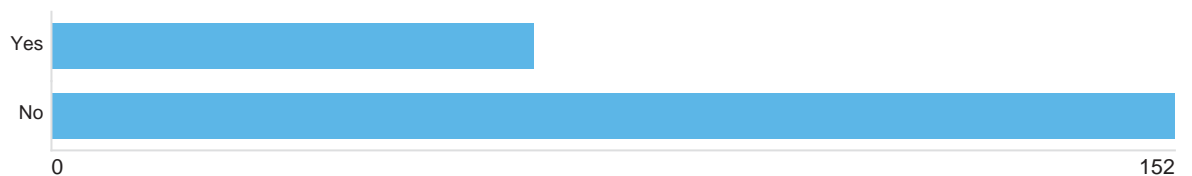

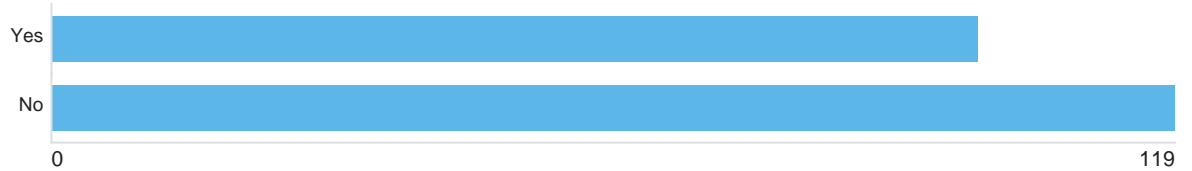
Question : What is your preferred option for the allocation of potential money received through the Levy?

70% to Met Police and 30% to Council



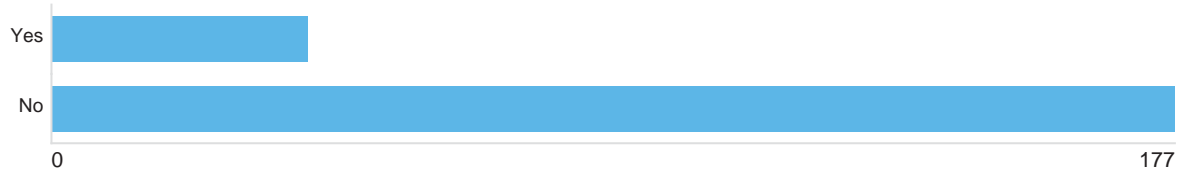
