Dear Sir/ Madam,
I am a resident and have been for 29 years. I have been made aware of the above Licence application for Belair House. I wish to object to the terms being asked. I live backing onto fields which are open to Belair House with sound carrying across the field. I am also Chair of Turney Road Residents Association and am aware of the other licencing allowed to other event premises such as the Sports Clubs and the Art Gallery (see below). What is being requested is out of line with these. I am surprised they have shown no attempt to engage with the local community through the local Resident Associations.
I object personally because:
 The proposed licensing hours of Wednesday - Saturday till 2.30am (live and recorded music and alcohol till 2am) and Sunday till 00.30 am are totally inappropriate for this family area and, would constitute a significant noise nuisance well into the early hours. We sleep at the back of the house as do many families with young children and the sound carries across the fields.
Besides this I support the email sent on 28 th August by Road Residents Association with whom I work closely.
To highlight her arguments
1. The many sports clubs in the area all close by 11pm with exceptional late nights to

(agreement dated 26/03/2019). The conditions attached to the DPG application are sensible, considerable and detailed.

2. There had been no engagement by the applicant with either the residents of Burbage Road, Turney Road or Dulwich Village or The Dulwich Society, despite all of these being thriving and active associations.

Other social facilities in the area:

Have codes of conduct for their entertainment activities, agreed with the resident Associations

Inform all residents of one off events which will take place after midnight well in advance

Provide emergency telephone numbers for these events which are manned by those on site.

- 3. The dispersal of people at the end of the night is likely to have an impact on crime, parking, and traffic during the normally peaceful hours.
- 4. It is a condition of the current licence that windows are kept closed to prevent noise travelling, this has not always been complied with. Examination of the Southwark environmental complaints register will testify to recent noise complaints. Whilst this is a new operator I am concerned that there are no guarantees that they will be able to meet this requirement.

I also strongly support the suggested considerations for the Licencing agreement for Belair House that is set out in Louise Woods email.




