### 4. Details of association of the above premises with serious crime, serious disorder or both

#### Incident

On 9<sup>th</sup> February 2020, officers were called to a fight inside the premises CCTV shows a number of people fighting within the VIP area and on the dance floor. Security were unable to contain the fight and the club had to shut. On arrival of the first officers on scene, as customers are leaving a male was seen attacking people with a brandy bottle in the courtyard. Officers challenged him at which he went towards them and was tasered to protect officers and members of the public. Others continued to fight in the yard area of the premises. During the incident, a number of fights occurred inside and out and a police officer was assaulted inside the premises by a male grabbing the officer by the throat and squeezing. He also attempted kinking out and had to be restrained by a number of officers. The customers were dispersed from 516 Old Kent road a large numbers went into McDonalds next door where a number of other fights occurred. The incident continued for over 30 minutes and took a large number of police resources including dog units to bring it under control. (Crime reports, officers Body Worn Video, CCTV from venue & CAD reports attached) Police have already received a complaint regarding this incident from a local resident and he mentions a similar incident two weeks prior. (Email redacted and attached)

#### Previous History of Venue.

The premises has only just re opened after a review submitted in December 2019. This was for a violent assault inside. The premises was visited a number of times by officer from the Night Time economy team and had remained closed during this period when the interim steps were in place.

On the 25<sup>th</sup> January 2020, a fight occurred at the premises at 01.40hrs and a male was assaulted. The premises could not provide the CCTV at the time which is a breach of the licensing conditions.(Crime report attached)

On Saturday the 30st November 2019 at approximately 03:00 fight started inside the premises, the victim was close to DJ booth. It appears he was knocked unconscious and believes was struck with a bottle due to serious injuries sustained

On Saturday the 1<sup>st</sup> September 2018 at 04.00hrs, a fight started inside the premises and security removed all parties from the venue, once outside two customers removed from K-Che were stabbed on McDonald's car park. Witnesses believe it was a result of retaliation from the fight inside.


From December 2018 to December 2019 twelve crime reports of violent incidents have occurred associated with the premises including Four (4) for Grievous Bodily Harm (GBH), Four (4) for Actual Bodily Harm (ABH), One (1) assault on Police, One(1) common assault, One (1) Robbery and a Crime related incident for a Fight inside the premises.

The area in proximity to the premises has suffered from considerable amount of Violent incidents, Anti-social behaviour and calls for police accidents, which we believe the premises, has been a contributing factor to.

They have a number of control measures on the licence that do not appear to be restricting the crime and disorder associated with the premises and the continued violent incidents inside and outside the premises are putting police officers and members of the public at risk.

The addition of further conditions as interim steps in my opinion is not appropriate considering the seriousness of the disorder. I recommend that the licence is suspended pending the full review.

**I am giving this certificate because I am of the opinion that other procedures under the Licensing Act are inappropriate in this case because:**

**On Saturday, the 29th February 2020 at approximately 03:35 fighting started inside the premises. The premises had to stop trading as security were unable to gain control and police were called. On arrival of the first officers, a group was fighting in the yard area, one male was armed with a brandy bottle attempting to hit people. He then went for officers who tasered him. A number of other customers were attempting to get at officers who had to call for urgent assistance, and draw batons and incapacitant spray in an attempt to restore order and defend themselves. One officer was assaulted on the dance floor area by a customer who attempted to strangle him while the officer was trying to clear the premises. A further fight and disturbance occurred in McDonalds nearby as large crowds had been dispersed from the premises.**

**A standard review is deemed inappropriate due to serious nature of the incident and the risk of future incidents causing injury to officers or the public.**

**The premises was subject to a Section 53a review submitted in December 2019 following another serious incident inside, and have had a number of serious assaults over the last 12 months which included a police officer sustaining an injury.**

**I am of the opinion that action is required to prevent further crime and disorder and to protect the public.**

On Saturday 25th January 2020 I was on duty in plain clothes and was the driver of a Southwark Council marked vehicle , I was in the company of Pc Ducker 2494AS. My duties include attending various licensed venues on the Borough of Southwark and ensuring that they are complying with their licence conditions. At 0155hrs a call was circulated via our personal radios to a fight outside the nightclub venue known as K-CHE 516 First Floor Old Kent Road SE1 5BA. We made our way to the venue and upon our arrival two males had been detained for fighting by a number of officers, the officers had the incident under control at this point and we entered the court yard area and requested to speak to the duty manager or dps. We waited in the open yard area for the manager to attend, whilst stood in the outside court yard we smelt the distinctive odour of cannabis, I can confirm the smell to be cannabis as I have encountered the substance a number of times through my career as a police officer. I was able to trace the smell to patrons of the club who were stood in the smoking area, the club adjacent to K-che was closed. We stood for a few minutes and no members of staff approached the smoking area. We continued to monitor the area and after a few minutes a member of security then went upstairs and spoke to those involved. We were then joined by a female who identified herself as the duty manager and we viewed the id scanner in her presence, a male who identified himself as the promoter of the evenings event and gave his name as [Redacted] At 0209hrs a female exited from the inside of the club , she was being carried by her friends and was unable to walk she was clearly heavily intoxicated to the point that she could not care for herself, her friends placed her on the stairs to the smoking area and she dropped her head , there was a member of security stood next to her and the promoter [Redacted] appeared to talk to her friends, he went away and then returned with a bottle of water for her, I did not see anyone approach the female who I could identify as medically trained. The females friends assisted by [Redacted] then took hold of the female and carried her out of the venue by holding onto her arms, at this stage she was still unable to walk unaided . We concluded our visit and left the venue where we were told that the two males who had been fighting had been arrested .
