# 10. Reports from the Police safer neighbourhood teams and & Dulwich community update on community safety issues

DCC received reports from the SNT and Dulwich community wardens concerning ward priorities and panel meetings for this month.

#### College

Sgt Jackson presented priorities for College ward in Sgt Warran's absence

#### Ward priorities

- Gangs and anti social behaviour
- Tackling motor vehicle crime
- Youth engagement
- Robbery in the area is down
- 12 arrests were made for burglary, intent to supply drugs and for assault

#### **East Dulwich**

Sgt Jackson presented

#### Ward priorities

- Youth engagement includes continuing a scheme called 'Every child matters'
- Motor vehicle crime still dealing with motor theft and other domestic issues
- There's been a reduction in burglary dropped by 30%
- E-newsletter is distributed frequently and hard copies are available at Dulwich Library

Questions were raised about the recent shooting incident in East Dulwich. Sgt Jackson explained there is still an ongoing investigation and therefore could not provide any further information at this stage.

#### Village

Sgt Jenkinson presented

#### Ward priorities

- Tackling robbery, burglary and antisocial behaviour across the ward at the same time concentrating on certain areas – like the Herne Hill area
- Police analysts are currently carrying out crime surveys relating to antisocial behaviour which are then referred to Southwark's anti social behaviour unit (SASBU)
- Community Pay Back scheme work revolves around Dulwich Park
- Vehicles being damaged in Beckwith Rd and Herne Hill SNT have identified the individual who will be formally charged shortly
- Young people can now text their views to the police
- A police survey will take place at Dulwich park every Sunday so people don't have to attend the police station which is part of community policing
- Feedback from a recent survey shows the majority of residents felt safe in Village ward

#### **Community wardens update**

DCC received update from Sue Hunter (Community wardens). Members noted the tasks undertaken by wardens in addition to their normal patrols:

- Wardens will also be on bikes shortly in line with the police currently in training at the moment
- Visual audits / walkabouts e.g. Lordship Lane, Dawson Heights (dog fouling & littering)
- Ongoing sting operations around the transport Hubs
- Recently issued 39 fixed PCNs (penalty charge notices) during the course of a day, 138 intelligence reports and 375 environmental reports
- Continued focus on engaging with local businesses and local schools

#### 13. Dulwich Village traffic calming

DCC received a report on the results of the consultation carried out during Dec 08. It was noted that the Council received over 500 responses – a 10% response rate.

DCC notes some of the residents' comments below:

- loss of car parking spaces
- speed humps will put disabled people at a disadvantage & increase noise pollution
- preferable to have more flashing speed signs or install more speed enforcement cameras
- raised zebra crossings has no effect on traffic calming etc
- re-visit 30 mph zone speed camera on Gallery Road

#### **DECISIONS:**

- That Dulwich community council take note of the consultation results and next steps for the project including the additional consultation that may be required in Pickwick, Aysgarth and Boxall Roads.
- Members asked officers to reconsider the position for Pickwick Aysgarth and Boxall and to try to find satisfactory solutions which do not involve humps or cushions in these roads.
- 3. That DCC take note of additional consultation that will be required for Gallery Road on the resurfacing design.

# Cleaner greener safer programme

This year's cleaner greener safer programme - 2009/10 was formally launched at the meeting. CGS is a capital programme which has been running since 2003/04 and over 900 projects have been approved most of these are within the Dulwich community council area.

Area management officers from environment and housing (Todd Strehlow and James Salkeld) were on hand to distribute information to residents and displayed 'before' and 'after' photos of schemes that received funding in previous years.

#### Below are examples of suitable ideas:

- Parks, community gardens, landscaping, tree planting and wildlife areas
- Children's playgrounds, youth facilities, ball courts and cycle tracks
- Security measures (such as lighting and fencing), pavements and tackling grot spots

Below are examples of what will not be considered under this programme:

- CCTV as this has revenue costs and is not always the best solution to anti social behaviour issues
- Ideas that do not create permanent and physical improvements e.g. workshops, festivals, salaries, computer equipment, maintenance and internal works on housing property

## Report on facilities concerning Dulwich Community Hospital – update

Susanna White and Jonathan McShane (Southwark PCT) presented

A consultation by Southwark Primary Care Trust (PCT) is now available to view and comment on. The document refers to transforming Southwark's NHS which is about improving your health and delivering high quality accessible primary and community services over the next 10 years, including the service model for Dulwich Health and Social Care.

Main points raised at the meeting included:

- More access to GPs
- Manage effectively long term illness
- How NHS Southwark will change health care services
- Proposing four networks of care i.e. centres which are community based at different locations in the Borough – primary care networks and GPs can locate their practices at different centres

The officer (SW) urged people to respond to the consultation. Page 24 of the document refers to Dulwich network of care services.

Questions / views expressed by residents

- What are the future plans for the beds will they be removed and placed elsewhere?
- Other services in the Borough will fail and suffer because the focus will be Dulwich Community Hospital
  - The officer (SW) response: huge investment will be going into GP services and not all GPs will be based at this Health Centre
- The questionnaire mentions nothing about intermediate care or beds
- Finance related issues are not detailed in the consultation paper is Lift Co, (the private sector partner for DCH) still financing this?
   Officer response: Currently this is still the arrangement
- Having no beds for intermediate care cannot be an improvement in health care
- Voiced concerns about Seldoc (South East London doctors co-operative), and Melbourne Grove medical practice
- An impartial independent body would be better to do this consultation rather than Southwark PCT
- Why are there no questions in the consultation about the services that will be scrapped

**Officer response:** This consultation is about what they are proposing for DCH which is not a replacement hospital

Officers agreed to look into the issues particularly concerning Seldoc and to ensure there is increased access for people. The officer stressed that there are no proposals to close down GP practices in the area.

#### Southwark Car Club

Officers from Highways (Andrew Downes & Diana Bunyan) presented

A car club differs from hiring a car through a hire company like Hertz or Avis because:

- you can have it for just for an hour if you want
- your licence and all the insurance issues are already dealt with and it's parked a short walk from your home
- There are currently 2,800 car club members
- It's for people who just need a car occasionally and don't want the expense and hassle of owning and running one
- People who currently run a car are doing a medium to low mileage - e.g. less than 8,000 miles per year
- People who don't own a car, but would like to have access to one for occasional use
- Two-car families, who wouldn't need their second car if they could sometimes hire one for an hour or two
- Businesses which use pool cars or staff's own vehicles for business trips could use car club vehicles instead
- In most car clubs, members have the choice to book online, by text, or by telephone - some car clubs have on board computers in the vehicles so you can extend, or make new bookings, during use

The street car club bays (listed in the officer's report) in the Dulwich community council area were approved for implementation which will be subject to the necessary statutory procedures. Members asked officers to forward plans showing the bay locations to relevant ward councillors and to consider any comments from Members as to the precise locations of those proposed bays.

#### **RECOMMENDATION(S)**

1. That the proposals for responding to the Sustainable Communities Act are agreed as set out in paragraphs 8 – 10.

#### **BACKGROUND INFORMATION**

- 2. The Sustainable Communities Act 2007 introduced a new procedure for councils to make proposals to central government via the Local Government Association (LGA), to promote the sustainability of local communities (economic, social or environmental well-being). Councils are required to work with local people to identify and agree proposals.
- 3. Councils have been invited to submit new proposals to promote the sustainability of local communities by the deadline in July 2009.
- 4. The requirements for proposals are that they:
  - promote sustainability proposals must require action by central government, and can include proposals for the transfer of functions from one body to another
  - establish or recognise local panel(s), which must include "representatives of persons from under-represented groups" to be consulted before proposals are made to central government
- 5. While there is no guarantee that proposals will be short listed by the LGA and Secretary of State for Communities and Local Government, it is important to develop a strong business case (setting out how it will benefit the local community, and addressing legal and financial considerations); and garner support from the LGA, Department for Communities and other councils.
- 6. The approach of the Department for Communities and Local Government to the provisions of the Sustainable Communities Act may be summarised as follows<sup>1</sup>:
  - the government assists councils and communities to act proposals need to be specific and not already enabled by well being powers
  - it is not a means of agreeing additional expenditure
  - the government will look at the broad cost and benefits of proposals

- the government will take into account existing policy positions
- 7. Councils will need to guard against putting forward proposals that are already in our gift. Ministers are often quoted saying that councils should look to their existing powers to solve issues, rather than turn to government, most often citing the **well-being power**. It will therefore be important to manage expectations about what the act can deliver.

#### **KEY ISSUES FOR CONSIDERATION**

- 8. It is recommended that the council's approach be split into three main stages:
  - I. Identification of 'themes' for potential proposals, based on what local people have told us and through discussions with the Overview and Scrutiny Committee, Southwark Alliance and its thematic partnerships and members of the council. It will be important to spend time assessing the potential of developing proposals that are viable legally and financially, and crucially are not already within our gift (see paragraph 7), to ensure that expectations are not unrealistically raised.
  - II. Wider consultation based on but not restricted to the themes identified: sustainability is such a broad topic that providing suggested themes will provide a 'way in' for the community to engage, whist still enabling them to come up with other ideas.
  - III. Establish or recognise a local panel and consult them, prior to a report to council assembly to agree the final proposals. The regulations require councils, before making proposals, to establish or recognise one or more panels of representatives of local persons and to consult them about each proposal. The guidance does not prescribe the 'how'. We cannot specify at this stage what panel/s should be established or recognised, as this will depend on the type of proposals that are developed.

#### **RECOMMENDATION(S)**

- 1. It is recommended that the following items are approved for implementation (detailed in appendix A)
  - A) a 30 metre extension of at any time waiting restriction (double yellow line) on the south side of Hillsboro Road at its junction with East Dulwich Grove.
  - B) a school keep clear outside the main pedestrian entrance / exit of the school on the southeast side of Hillsboro Road adjacent to No.38

#### **BACKGROUND INFORMATION**

- 2. In 2007 the council was approached by the bursar of Alleyn's School about the possibility of installing road markings to assist emergency service vehicles, traffic flow, deliver access and pedestrian visibility in proximity to the school entrance in Hillsboro Road.
- 3. A proposal notice was published in April 2008 for waiting restrictions on both sides of the road at the junction with East Dulwich Grove, adjacent to the school car park entrance and new school keep clear markings.
- 4. Network development received a number of objections to these proposals. All objections were made by local residents and the main reasons for objection were based upon loss of uncontrolled, residential parking in Hillsboro Road.
- 5. Network development engineers reconsidered the site and using AutoTrack software established that vehicle movements would be eased with waiting restriction on the south side only. It was noted that the school keep clear was still required.
- 6. An additional site visit with two ward members and the school bursar confirmed the above measures would meet the requirement to improve pedestrian sight lines, provide sufficient turning space for school delivery vehicles but reduce the impact upon local residents through the loss of uncontrolled parking.
- 7. The network development amended the proposed drawing and carried out informal consultation with all properties in the vicinity of Hillsboro Road in November 2008 (consultation area shown in appendix B).
- 8. Five responses were received, all of whom supported the proposals in principal

however one was on the condition that resident permits were installed. This is not an option being considered for the location at present.

#### **KEY ISSUES FOR CONSIDERATION**

#### Proposed at any time waiting on the south side of Hillsboro Road

- 9. The waiting restrictions (detailed in appendix A) are the minimum length required to provide unobstructed access to the school's delivery road. Parking on both sides of the gates and road had previously led to double parking and deliveries being made in the road.
- 10. The waiting restrictions will also assist in vehicles passing one another when entering/leaving Hillsboro Road from East Dulwich Grove
- 11. It is also recommended that a white, advisory access marking (H-bar) is installed adjacent to the school carpark entrance.

## Proposed School Keep Clear outside the main entrance to Alleyn's Junior School on Hillsboro Road

- 12. The proposed school keep clear (zig-zags) (appendix A) will prevent stopping during the hours 8am 5pm, Monday to Friday to assist pedestrian visibility directly adjacent to the school gate where parking is undesirable.
- 13. Ward members requested that the road markings be installed at the minimum, permitted length and asked if they could operate during term time only.
- 14. Officers have proposed that the restriction is the minimum length allowed by the regulations (25.5m), however the phrase 'term time only' is not a permitted variant the Department for Transport and cannot be used on the proposed sign.

#### **POLICY IMPLICATIONS**

- 15. The recommendations contained within this report are consistent with the polices of the Pep and associated Local implementation plan (Lip).
- 16. The proposals will support the council's equalities and human rights policies and will promote social inclusion by: encouraging walking and improving safety of all road users.

#### **COMMUNITY IMPACT STATEMENT**

9. The policies within the Pep are upheld within this report have been subject to an Equality Impact Assessment (EqIA).

#### **RESOURCE IMPLICATIONS**

10. The Head of Public Realm has confirmed that any costs arising from implementing the proposals, as set out in the report, will be fully contained within the existing budget.

#### **CONSULTATION**

- 11. The consultation details are discussed in the body of the report has been carried out.
- 12. Should this report be approved a made notice will be published in accordance with statutory process.
- 13. The road network and parking manager has been consulted on the proposals and has no objections.
- 14. No consultation or comment has been sought from the borough solicitor & secretary or the chief finance officer.
