

1. Introduction and welcome by the Chair

The Chair welcomed members of the public, Council Members and officers.

2. Apologies

Apologies were received from Cllr Thomas. Apologies for lateness were received from Cllrs Zuleta and Pursey.

3. Disclosure of Members' Interests and Dispensations

No interests or dispensations were declared.

4. Items of business the Chair deems urgent

There were none. The Chair announced the Street Action team workshops will take place next month.

Announcements

5.1 Groundwork Southwark

gave information on Greening Southwark programme as part of Southwark in Bloom.

5.2 Willowbrook Centre

offers training on planning issues for local people. Cllr McCarthy was keen to include planning training on how residents could put forward objections on a future agenda.

6. Minutes and Matters arising from the previous meeting

Amendment of minutes of meeting of 28 February 2005: Page 15 – first question after Recycling item – Cllr Moore (not Cllr McCarthy) asked if Tricia Watson was working with Borough Market to maximise recycling

With that amendment, the minutes were agreed and signed by the Chair.

6.1 Matters Arising

Boughton House deputation

Information was available from Robert Read, Manager Southwark Anti Social Behaviour Unit

Information had been received on Section 106 monies as follows:

- there are two agreements relating to the Tabard Square development.
- there were no specific obligations for Broughton House but Balin, Brenley and Eynsford Houses have been identified with £75,000 available towards environmental improvements.

Peter Davies asked about a letter Cllr McCarthy had written to Keith Broxup on Community Wardens on Tabard estate. This will be followed up.

Mary Geraldine Harmsworth Park

A kiosk is to be built in Mary Geraldine Harmsworth Park and there will be a formal presentation to the Friends of the Park meeting on Thursday 12th May, 7.00pm at St. Jude's. All welcome.

Tenants Handbook distribution

Pauline Benington confirmed a few days after the last meeting that the handbooks had been delivered to her estate.

Main Business

7. TfL Buses – Andrew Boag - Appendix 1.

Questions followed:

Q: Why did TfL extend 168 route to Tesco, why not Asda - only 500 yards further on? Coaches are allowed in a lot of supermarket car parks.

Andrew Boag:

- TfL is trying to provide extra service along Old Kent Road.
- It is easier to turn bus round by Tesco's.
- Asda would have to give up part of car park to TfL for bus turning and did not approach TfL for buses to terminate there.
- Buses and car parks do not mix well.
- At East Dulwich, Sainsbury's car park was designed for buses to turn round there.

Q: As well as passenger numbers, what are figures for payment on bendy buses?

A: Aim to take away cash payments on buses

- 80% do not use cash; only 20% pay cash
- Believes majority of passengers are honest
- Enforcement is being increased more revenue inspectors are being recruited
- A team of 6-8 inspectors will surround a bus and check all passengers

Peter Davies: The road at Asda is wide enough for buses to stand and turn. Isn't having large teams surrounding bendy buses, indicative of a large number of fare dodgers?

Liz Justice: why isn't it possible to transfer tickets from one bus to another - e.g. why can't ticket be valid for an hour from sale?

A: Oyster card works that way. If you make number of separate journeys amounting to more than £3, the cost of a one day bus pass will be charged.

Cllr McCarthy: Bus drivers should be told to give way at roundabouts.

9. Tag and Beacon trial in Congestion Charging Zone in part of Bankside area - Appendix 2.

Jeremy Evans (TfL): the beacons will not be too intrusive on the streetscape. Agreed with Southwark officers to review streetscape and rationalise signage. Equipment will be removed in spring 2006.

10. Borough Spending Plan – Kendal MacKay – Transport department - Appendix 3.

Questions followed:

Q: The crossings across Southwark Bridge Road and Southwark Road take a very long time to change and many parents use these to take children to school. Children are walking in the road.

A: TfL control phasing of pedestrian signals and also maintain Southwark Bridge Road (red route). Will take up with TfL. All concerns should be sent to Kendal MacKay and he will forward to the right person.

Q: Lives next to Tate Modern where there is very bad traffic. Since November 2001, has been writing to council and Members re a coach / van sign obscured by a TfL sign. Has been told TfL must agree to their sign being moved.

A: Kendal MacKay will take this up with appropriate officers/TfL.

Cllr McCarthy: TfL must be consulted to move this sign – vehicles turn into street and cannot reverse out of it.

Clare Armstrong: How can 20 mph limits be enforced? Traffic often exceeds 20 mph limit.

A: The intention with 20mph roads/zones is they should be self-enforcing.

- Some measures work better than others eg humps, raised tables, etc.
- There is a need to consult with local residents before these are installed and residents may oppose some measures.
- Transport department currently investigating other measures available to enforce 20 mph limit e.g. camera technology (TfL use these).

11. Education item – officers available to answer questions

Mick Daniels (Assistant Director) is responsible for raising standards and works with staff, governors, local authority officers to improve schools;

Terry Reynolds (Head of Performance and Achievement School Improvement Service) works with staff and governors.

Adele Morris:

- parent of 11 year old.
- Southwark does not have one community school that meets national average.
- Only schools in Southwark that compare in attainment are church schools and Bacon's College.
- Primary education is very good eg Cathedrals school.
- Applied to six schools and was not offered one place.
- Has now been offered a place at Geoffrey Chaucer.

Terry Reynolds:

- To compare community schools in Southwark with similar schools nationally is a difficult picture.
- Some Southwark schools are doing well when compared to other schools.
- Generally, primary schools are performing well and secondary schools badly.
- Very mixed picture at both levels.
- Improvements are slow secondary schools are improving at faster rate than national rate.

Cllr Moore: Comparing our bad schools with other bad schools, are they less bad?

Terry Reynolds: No, compared to similar schools (where many children do not have English as a first language/ high number of free school meals, etc) those schools fare better than our schools. Our worst schools face much more challenging circumstances compared with similar schools. Can't compare good schools with our challenging schools. Mick Daniels:

- LBS use many government initiatives to address poorly performing schools.
- Face challenging circumstances (complexity of needs).
- Geoffrey Chaucer has to deal with many, complex needs.
- Plan to turn Geoffrey Chaucer and Joseph Lancaster into an all age academy to open in 2008.
- Academy supported by sponsor, Ark, a charitable trust. Ark will invest £2m in project; government will provide another £25-27m.
- Ark has innovative ideas to transform schools.
- Ark will hold public meetings over next few months.
- They organise small schools within schools.

Sylvia Morris (Head teacher at Cathedrals):

- Cathedrals school is well above national average.
- Does not select intake yet pupils perform very well.
- The reputation of the two nearest local community schools has not moved in the past 10 years.
- Members are very concerned and it has been agreed that Cllr Pidgeon will meet with Sylvia Morris, Cllr Stanton and others.
- The lack of good secondary schools for children in the area is undermining of all hard working primary schools.
- Parents are forced to send their children outside of borough.
- What can be done to improve reputation of two local community schools?
- How will you encourage parents of high achieving pupils to stay in borough?
- Parents are very distressed and cannot wait until 2008.

Anne Worsley (Chair of Governors of Geoffrey Chaucer school):

- Agrees with Sylvia Morris very frustrated at standards of Geoffrey Chaucer
- Geoffrey Chaucer is performing badly compared to schools in similar circumstances. Why?
- Could be deprivation? Many children do not have English as a first language.
- 11 year old pupils are illiterate and have to taught to read
- There are systems in the school but things are not being done to required standards
- Can't get these things done as Chair of Governors so what can local authority do?
- Has visited Ark objects of charity on website
- International project and deal with very challenging children and Borough and Bankside is very deprived area
- Educational professionals

Cllr McCarthy: this requires further discussion. Borough and Bankside has four of the best primary schools but no decent secondary schools.

Adele Morris: Why are two new secondary schools being built at Elephant and Castle and Surrey Docks?

Cllr McCarthy: Because of extra demand. Lewisham children are in the majority at Bacon's City Technology College and LBS do not control access.

Mick Daniels:

- Very familiar with Anne Worsley's concerns and shares them
- Need to turnround Geoffrey Chaucer; the main responsibility rests with governing body and LBS supports governing body
- Geoffrey Chaucer is part of community of schools in Community Council area and wants other schools to support Geoffrey Chaucer and improve it. Welcomes more involvement

12. Police Update

Sgt Steve Dutton: introduced Sgt Russell Jones who will be working with Arthur Hazel in Chaucer ward.

- Warned of increase in bogus charity collectors for Barnardo's and Tsunami. There have been two arrests.
- Three arrests on Tabard estate for possession of weapon, cannabis and crack
- Patrols have been increased around Lant Street
- On Peabody estate, complaints re anti social behaviour and now working with Anti Social Behaviour Unit to issue ASBOs.
- Carried out operation at Ministry of Sound arrested 10 bogus taxi drivers all charged and taken to court
- Vagrancy complaints have issued first ASBO against one vagrant (spider tattoo on neck) and he is banned from area
- Dealing with two other vagrants and seeking ASBOs
- Distraction burglars are new problem in this area distract elderly by pretending to be from utilities

Questions followed:

Ted Bowman: bogus collectors at door should show some ID

A: Don't know if they are bogus and could have bogus ID cards

Adele Morris: warned of a smart woman who knocks on doors and says she has locked baby in car and needs money. She is believable and well spoken. There are still drug dealers operating in St George's Gardens.

Tim England gave an update on Community Wardens:

Currently Wardens are providing patrols in both the Pool of London and Bankside area. These two schemes both have external funding from Better Bankside and Pool of London and will continue operating within existing boundaries during 2005/06. The Community Warden service is currently consulting with staff and partners on restructuring the way the service is delivered. The proposed new structure will see a Community Warden Scheme within each of the Community Council areas that will provide additional cover across the whole borough. Until the restructure has been agreed and completed, schemes will continue to operated within existing boundaries At this point in time the Community Wardens Service is not aware of any non-Council wardens schemes. If any are in operation please let Tim England have details.

Regarding PCSOs, Community Wardens work in partnership with the police on a daily basis; wardens across Southwark are tasked with providing patrols in crime hotspots and hold daily briefings with the Police. The PCSOs are also tasked via local intelligence and work in close partnership with wardens, providing support when required and sharing information on crime and antisocial behaviour hotspots.

The PCSOs generally form part of the safer neighbourhood teams, who are in some cases operating in areas where wardens are patrolling. However, tasking is coordinated via the Borough Intelligence Unit to ensure that efforts are not duplicated.

13. Cleaner, Greener, Safer 2005/06 – Tim England - Appendix 4

Questions followed:

Cllr Zuleta: when projects are proposed for C,G,S the project must flag up revenue implications.

- Rockingham Estate Play Association was awarded C,G,S money in 2003/04 to build extension but now has problem securing revenue funding to run the scheme.
- REPA is a very good project but now there is a problem to keep it open.
- Community Council does not have revenue money to allocate locally.
- Revenue implications must be met by those proposing scheme

Cllr McCarthy: Councillors will do what they can to save REPA but C,G,S is for capital projects, not revenue.

Cllr Zuleta: It's a brilliant project but need to know revenue implications of any bids.

Questions followed:

Q: All projects are short of revenue funding and can't access it. Could Community Council allocate revenue funds next year?

Cllr McCarthy: officers to investigate how revenue money can be accessed.

Q: If revenue is needed, should projects not apply for C,G,S funding?

Cllr Zuleta: Application should be submitted but revenue implications must be flagged and taken into account.

Q: REPA already has summer activities planned.

Cllr Zuleta: When funding was given, there was no information on revenue implications, members should have been alerted this was an issue.

Adele Morris (REPA Trustee): REPA has been going for 30 years. REPA has been unsuccessful in its bids for revenue funding. At time of C,G,S application thought revenue funding was not an issue.

Cllr Zuleta: still need to flag revenue implications.

14. Blue Plaques - Appendix 5

The three nominees for Borough & Bankside

- Elizabeth Newcomen whose charitable trust has helped children since the 17th century
- **Cross Bones Graveyard** final resting-place for 'Winchester Geese' or prostitutes from the brothels of Bankside
- **Rose Theatre** built in 1587, the Rose was the first theatre on London's Bankside and the fifth in London

15. Public Question time and Information items

Southwark Living Streets 020 8693 2618

Improve Borough High Street Southwark Living Streets - 6.15pm Monday 13 June 2005. Street audit of Borough High Street between Southwark Street and Harper Road - meet outside the Slug and Lettuce and finish at the Ship pub. Group will be looking at crossings, pavements, lighting, street furniture and the general streetscape.

Q: Who is responsible for closing off roads (and now footpaths) without prior notice? (eg LAD Construction notice - part of Trundle Street to be closed for building works commencing 9 May 2005).

Closing Comments by the Chair

The Chair thanked everyone for attending and contributing to the meeting. A meeting to consider planning matters followed on from the general meeting. The next general meeting is on Wednesday 8th June 2005 at Charles Dickens School.

This part of the meeting closed at 9.15pm

After a short break, Members considered two planning items:

Item 1: Report for the approval of release of section 106 funds to the implementation of Southwark Street Gateway Improvements (works).

To seek authorisation to use monies from the S 106 Agreement for St Christopher House (No 1) Limited and St Christopher House (No 2) Limited totalling £380,000, towards the works contract for Southwark Street Gateway project

Antonia Simpson presented report for comment from the Community Council prior to being sent to main Planning Committee on 17 May 2005 for decision.

The S106 money would be used to improve the appearance of the Eastern and Western bridges on Southwark Street. Members' support was requested for these improvements. A working group composed of LBS, Land Securities, TfL, Network Rail, Better Bankside and Allies and Morrison had carried out consultation.

Members asked questions.

Alastair Huggett reported that the consultation that had been carried out had shown that residents were very positive about the proposals. Details of consultation would be included in future reports.

Cllr Pursey moved that Borough & Bankside Community Council were in agreement with the proposals contained in the report that will be submitted to Planning Committee

Seconded by Cllr Zuleta

This was carried.

Item 2: Bankside and bear gardens conservation area report

Sarah Gibson presented a report on proposed boundary change and renaming of Bear Gardens conservation area to the Bankside and Bear Gardens Conservation Area and presentation of the draft appraisal document.

The proposals are to extend the area.

Cllr Zuleta asked if consultation had been carried out on the impact of declaring a Conservation Area?

Sarah Gibson: consultation will be carried out on the draft appraisal.

Lyn Meadows: If Members approve the draft extension of the Conservation Area, this will be consulted on and come back to Community Council.

Cllr Pursey moved Borough & Bankside Community Council agreed to: The proposed boundary change (to include Bankside) and the draft conservation area appraisal were approved for public consultation.

The Bear Gardens Conservation Area would be renamed to the Bankside and Bear Gardens Conservation Area

Seconded by Cllr Zuleta

This was carried.

TfL Buses – Andrew Boag

Key objectives for buses

"People's experience of travelling by bus must be transformed ... Buses must be reliable, quick, convenient, accessible, comfortable, clean, easy and safe to use and affordable."

"It is expected that between 2001 and 2011 there will be a 40% increase in both passenger numbers and service provision" Source: The Mayor's Transport Strategy, July 2001

London Buses – Some facts

- 7,500 buses carry 6 million passengers each day
- Highest number of passengers since 1968
- Fastest rate of passenger growth since 1945
- 30% growth in passenger numbers 1999-2004
- 29% increase in night bus usage in 2003/04
- Highest operated mileage since 1963

Recent improvements

- More frequent buses on many routes, so shorter waiting times. Improved Sunday services.
- Many routes now at least every 12 minutes 'turn up and go' detailed timetables unnecessary
- We aim to provide bus services within 400m walk

Other Improvements

- Better facilities at bus stops shelters and parking restrictions
- More bus priority measures
- Improved bus driver training BETC scheme
- Improved regularity QSIs better than ever
- Lower exhaust emissions

Making it easier to get and off the bus

- Over 95% of buses in London now fully accessible (low floor and ramp). Will be 100% by the end of 2005-05-20
- Almost all routes in Southwark are already operated by low floor buses
- Buses must not leave garage if the wheelchair ramp does not work

Better and Easier to Understand Travel Information

- Spider maps
- Bus stop specific timetables

Innovations

- Ticketing Simple fares and Oyster card with cashless buses proposed from 2006
- All buses will have CCTV by end 2005-05-20
- Audible and visual announcem4nts on buses planned by 2008

Plans for improved bus services

- Route 168 recently extended from Elephant & Castle to Old Kent Road, Tesco
- Route C10 to be extended from Elephant & Castle to Canada Water, hopefully from March 2006
- C10 extension provides new links to Borough Station, Long Lane and Abbey Street. Route also diverted to serve St Thomas's Hospital

Environmental Improvements

- Working with bus operators to improve the environmental performance of the bus fleet
- Delivering the Mayor's Air Quality Strategy
 - All vehicles to be Euro II or better by end 2005-05-20
 - Now testing the first generation of zero emission hydrogen fuel cell buses
- Planning trials of six diesel electric hybrid bus on route 360 in Sotuhwark this summer
- Piloting of solar powered bus shelters and subsequent installation where mainspower cannot economically be provided

Conclusions

- Buses have got better
- More to do to keep pace with increase demand and new developments
- Any questions?

Tag and Beacon trial in Congestion Charging Zone in part of Bankside area

- Monitoring equipment at the roadside (the 'beacon') detects 'tags' in the windscreens of passing vehicles
- Established technology for charging on roads such as motorways and bridges
- Used around the world: UK (M6 toll road, Severn Bridge, Dartford crossing), Singapore, Australia, France, US, etc

Objective of the Trial

- To identify a more flexible, adaptable and user-friendly road charging system
- Preliminary trials have identified the potential
- So far has been used on specific stretches of road/motorway, e.g. bridges, toll roads TfL want to see how it works in a city with a 'zone'
- TfL have developed better equipment that suits urban streets and now wish to trail it

Summary of Trial

- Trial planned to take place from mid 2005 to spring 2006
- Trail area is based in Southwark
- TfL will approach organisations with fleets of vehicles for them to carry the tags
- The trail is just addressing the technology no actual charging using the tag
