## **Planning Meeting**

Minutes of the Bermondsey Community Council Planning Meeting held on Wednesday 31 August 2005 at Southwark Town Hall, Peckham Road, SE5 8UB.

#### 1. INTRODUCTION

Councillor Bassom welcomed members of the public and Members.

#### 2. APOLOGIES

Councillors Capstick, Stanton, Manchester and Kyriacou sent apologies for absence.

#### 3. DISCLOSURE OF INTERESTS AND DISPENSATIONS

Cllr Flannery declared a personal and prejudicial interest in Item 1/2 and said he would leave the room for that part of the proceedings.

# **4. NOTIFICATION OF ANY OTHER ITEMS THE CHAIR DEEMS AS URGENT**There were none.

#### **RECORDING OF MEMBERS' VOTES**

The Committee considered the items set out on the agenda, a copy of which has been incorporated in the Minute File. Each of the following paragraphs relates to the item bearing the same number on the agenda.

#### **DEVELOPMENT CONTROL (SEE PAGES 1 to 23)**

ITEM 1/1: 73 Southwark Park Road, SE16 – Full Planning Permission

**Proposal:** (05-AP-0630)

Use of ground floor as a cafe (incorporating internal extract duct that discharges at main roof level, and refuse storage in rear) - revised resubmission of previously refused scheme.

**Recommendation:** Grant

Cllr Bassom explained that this item had been presented to Councillors previously but had been deferred due to inadequate reports and plans.

The Planning Officer then introduced the item stating the premises would be changing use from retail to A3. It had previously been refused due to an unacceptable ventilation duct system. The item was recommended for approval but it was not clear how long the property had been vacant for or whether there had been any attempts to market it during that time. The quality of plans was below standard and it is still unclear how the ducting will work so that information should preferably be resubmitted. The Planning Officer then outlined the objections as per the report.

There were no objectors present.

The Applicant spoke for up to three minutes stating that the property had been vacant for 15 months. He added that rubbish would be kept at the back of the premises as opposed to the pavement and that he had lost 15 months of business already so was keen for a decision to be made.

There were no supporters present.

The Ward Councillor did not wish to speak.

Members then asked the Applicant questions about his ownership of the property in question and also the neighbouring property (71. He owns both); about a church running from number 71 (not aware of this); the quality of the plans (claims not to have been told to provide new plans even after the case officer visited his premises. Planning Officer disagreed); disabled access (wide door, not aware of DDA obligations but would replace entrance step with ramp); what he intended to serve (hot food also).

Cllrs Mann and Bassom asked the Planning Officer how, if at all, the Planning Department helps those from ethinic minorities with perhaps poor English understand their obligations when submitting applications (not sure, would note it), especially with regards DDA requirements (Cllr Bassom suggested a leaflet).

**Decision: REFUSED** due to the following reasons:

- a) Poor disabled access (S.1.6)
- b) Unacceptable loss of retail premises (S.1.4)
- c) Poor quality plans unusable for decision determination.

(Cllrs said the Applicant should note the requirement to make his premises accessible for those with disabilities in future.)

The meeting adjourned at 7.23pm and re-opened at 7.30pm.

ITEM 1/2: Creeds Wharf, Bermondsey Wall West, SE16 – Full

**Planning Permission** 

**Proposal:** (04-AP-1977)

Modifications to river wall and installation of fixed access ladder and steel pontoon in three sections.

**Recommendation:** Grant

Cllr Bassom announced that Members had looked at the reports and were not yet satisfied that the Applicant has discharged his statutory obligations to serve notice on all parties with a legal interest in the land. Ownership of the land was unclear and there was also speculation regarding the level and breadth of consultation.

**Decision: DEFER** for clarification of the above issues and re-consultation.

#### 1. **RECOMMENDATION**

1.1 For the Community Council to consider further ways to promote good community relations in their area.

#### 2. BACKGROUND

- 2.1 The London bombing incidents that shocked London in July have raised the profile of how local communities can promote tolerance and understanding, and encourage greater contact between communities.
- 2.2 This report sets out some of the things that have been happening in Southwark, not only to improve mutual understanding and contact across cultures and faiths, but also in relation to people of different ages and different abilities.
- 2.3 It also suggests activities that local communities might want to do together to further promote good community relations in the local area.

#### 3. RESPONSES TO THE BOMBING INCIDENTS

- 3.1 In the immediate aftermath of the bombings, the urgent concern has been to increase public safety and to ensure that there is not a backlash against particular communities. A joint statement from the Council and the police, endorsed by the Multi-faith Forum was issued to the press, and faith leaders, police and councillors joined together for the three minutes silence.
- 3.2 In terms of safety, the police and warden service immediately stepped up visibility patrolling on the Underground and at major transport interchanges. There has and continues to be close liaison between Southwark police and the Scotland Yard centrally around sharing intelligence. The inquiries into the incidents continues as a top priority.
- 3.3 To reduce the likelihood of any backlash, the police, the Council, the Southwark Multi-faith Forum, and community organisations from across Southwark's diverse communities have been meeting regularly to identify potential risks and put in preventative arrangements. While there has not been any increase in formal reports to the police of hate crime, a number of incidents have taken place. Some communities who are particularly

- visible because of their colour or dress are fearful of going out, and have been subject to verbal abuse and assault.
- 3.4 While agencies with key community organisations will continue to work proactively to address concerns across all communities, the incidents have highlighted that more needs to be done to improve community relations and help everyone to feel a part of this country.
- 3.5 There is already a lot to celebrate in each area of Southwark that is breaking down barriers between cultures and faiths, between generations, between those with disabilities and the wider community. The emphasis is on working together around issues that can unite us, and where differences can get in the way, bring people together to address misunderstandings and reduce potential conflict.
- 3.6 At a borough level, there are borough-wide initiatives like the annual Southwark Community Games, and the inter-faith concert planned for October. The borough hosts five of the eight London-wide inter-cultural festivals. The Southwark Somali Forum is helping the Somali community become more involved. The Multi-faith Forum brings together all the different faith groups in the borough. The Southwark Youth Council helps to promote dialogue among young people, and between young people and the wider community.
- 3.7 On 18<sup>th</sup> October, Southwark will join with other boroughs in a Home Office initiative to celebrate Citizenship Day. There will be stalls in main centres to encourage people to become a volunteer, a local Heritage Walk, and two Citizenship ceremonies at Southwark Town Hall.
- 3.8 There are also many activities taking in each Community Council. Some of the many examples are set out below. These may provide suggestions about what more could be done locally.

#### 1 PURPOSE

- 1.1 To seek authorisation for the release of £265,000 from the London Bridge Holdings Ltd Legal Agreement to fund the refurbishment of the Crucifix Lane complex of railway bridges in SE1.
- 1.2 To ensure compliance with the Council's Constitution, the Planning Committee is to consider the expenditure of funds over £100,000 secured through legal agreements under S106 of the Town and Country Planning Act 1990.

#### 2 RECOMMENDATION

2.1 That Committee authorise the release of funds totalling £265,000 from the Legal Agreement [number 41149 (File 87)] associated with London Bridge Holdings Ltd (More London Development), Tooley Street as a capital contribution to the cost of refurbishing the Crucifix Lane complex as part of the strategic Light at the End of the Tunnel programme for the regeneration of the viaduct which stretches across London South Central.

#### 3 BACKGROUND

- 3.1 On 19<sup>th</sup> August, 1999 the Legal Agreement for the London Bridge City Phase 2 & 3 master-plan (submitted by London Bridge Holdings Ltd) was completed providing the planning and development framework for the site bounded by Tooley Street, Battle Bridge Lane, English Ground, the River Thames and Potters Fields Park, SE1.
- 3.2 On 19<sup>th</sup> August 1999 the Planning Permission and the associated legal agreement were issued as the planning and development framework for a period of five years. The agreement makes provisions for and funding available to secure the sensitive regeneration of the area, including projects in the field of traffic management, environmental enhancement, access to training, community facilities, improvements to local parks and tourism. These projects are detailed in Schedule 3 "Site and Development Facilities" and Schedule 5 "Description of Matters to be Incorporated into the Highway and Environment Scheme" (Appendix 1 of this report) of the agreement.
- In negotiation with the developer, it has been agreed that monies initially set out for projects which are no longer deliverable such as the Butlers Wharf Chef

Training School and the Pool of London Ferry have been reapplied by the Council for other Schedule 3 or 5 purposes pursuant to sub-paragraph 4.1 or for such other purposes as may be subsequently agreed with the Developer in writing.

- 3.4 The Crucifix Lane project includes four separate components.
  - A. The physical refurbishment of Crucifix Lane Bridge including brickwork cleaning, anti-graffiti measures, parapet painting and anti-pigeon measures, and re-lighting.
  - B. The physical refurbishment of Whites Grounds East Bridge, including brickwork cleaning, anti-graffiti measures, carriage and footway resurfacing, parapet painting and anti-pigeon measures, and re-lighting.
  - C. The physical refurbishment of Whites Grounds West Bridge, including brickwork cleaning, anti-graffiti measures, parapet painting and anti-pigeon measures, and re-lighting.
  - D. The refurbishment and relighting of the extensive Druid Street parapet.
- 3.5 Southwark Council has worked in partnership with More London Developments to determine how to prioritise refurbishment of the myriad of arches that weave beneath the viaduct in Bermondsey and in the vicinity of their development. More London agreed to match-fund the refurbishment of Tanner Street bridge in 2004-5 which was budgeted to cost £225k, with a contribution of £150k by the Pool of London, and £75k by More London. The project came in well under budget owing to tight project management and efficiency gains resulting from best practise. More London have agreed to carry over their £75k funding which wasn't spent to the Crucifix Lane project.
- 3.6 Proposals have been made and funding secured from the Pool of London and the Bermondsey Community Council to transform Whites Grounds West bridge from a redundant section of highway into a youth park providing the only skate park facility in the north of the Borough. During the last 6 months, a client group comprising More London, London Borough of Southwark and Pool of London Partnership has organised a comprehensive programme of consultation to initially test support for the idea of a youth park in the space, and then determine what the youth would like to see built in the space. The consultation involved two comprehensive information drops to address in the area, public meetings and questionnaires, followed by a series of workshops with six local schools and colleges, all resulting in a unanimous vote for the area to be converted into a play space for young people. Local architects firm, DIVE architects, then worked up design proposals, which were exhibited at a highly successful community event held in the Whites Grounds arch itself on Saturday 12th March. An application to build the play space is currently seeking planning consent. This funding from More London will enable the initial cleaning of the bridge and will deliver vital enhancements to the area irrespective of whether the play space project goes ahead or not.

#### 4 FACTORS FOR CONSIDERATION

- 4.1 The bridges are situated in a central location, less than 500m from Tower Bridge and the adjacent riverside developments attracting extensive inward investment. Despite heavy investment to the north, the bridge paradoxically lies within the 10% most deprived wards in the country (Southwark Neighbourhood Renewal Strategy, July 2003¹). The bridge itself is responsible for preventing the spread of success and opportunity from the riverside redevelopments southwards, and acts as a physical barrier to pedestrians, economic activity, and ultimately investment.
- 4.2 The Tunnels and Arches Improvement Strategy<sup>2</sup> and the Cross River Partnerships' (CRP) 'Light at the End of the Tunnel' strategy<sup>3</sup> identify key priorities and upgrading options for the bridges within the Bermondsey viaduct. The Tunnels and Arches Improvement strategy identifies the need to prioritise the Crucifix Lane complex of bridges for immediate upgrade. The proposals tie in closely with the St Olave's Estate Environs Feasibility Study<sup>4</sup>.
- 4.3 The total scheme cost has been assessed by both Southwark Highways and the Term Contractor to cost £510,000. The costing of the scheme has undergone numerous amendments to achieve a balance between reducing the budget to a realistically achievable amount and providing for a high quality scheme which will last 25 years plus. The present total cost is considered by the client group to be a minimum to achieve a robust, high quality scheme for the bridge complex. Of this total cost it is proposed that section 106 funding of £265,000 be used for the project to match the Pool of London Partnership contribution of £245,000.
- 4.4 Funding of £755,000 is available from the Legal Agreement. Of this amount, £500,000 has been approved in principle by Members for the Unicorn Children's Theatre, subject to a further Committee report detailing the necessary changes to the legal agreement. This leaves £1,100,000 of the Hospitality Training School allocation available, subject to agreement by the Developer, for other projects in Schedules 3 and 5 (Appendix 1).
- 4.5 The refurbishment of the Crucifix Lane complex of bridges would create a dramatic improvement to the north south link between the riverside and the Bermondsey hinterland south of the viaduct. The bridges are currently in a dilapidated state of repair with the dark, uninviting passageways deterring footfall and creating a perceived and actual fear of crime. The proposed improvements build on best practise built up in-house engineers over the last 4 years to design out crime and improve the aesthetic environment in the spaces beneath the

viaduct. Recent successful bridge projects delivered in the Borough include Tanner Street, Shand Street, Barnham Street, Brunswick Court, and O'Meara Street. Plans to improve the route beneath the viaduct at Crucifix Lane also tie in directly with the recent regeneration of the adjacent St John's Churchyard, and the St Olave's Estate Environs project which has secured funding to create a new attractive pedestrian and cycle link and pocket park along Druid Street North with a new toucan crossing connecting the viaduct.

#### 5 FINANCIAL RESOURCE IMPLICATIONS

- 5.1 Pursuant to Agreement No. S106/41149 London Bridge Holdings has paid £2,500,000 out of the total sum of £10,000,000 payable under the agreement for specified projects under Schedules 3 and 5 of the Agreement..
- 5.2 Of the £2,500,000 paid to the Council, the sum of £1,725,000 has been allocated for various schemes leaving a balance of £775,000 still available.
- 5.3 In negotiation with the developer, it has been agreed that monies initially set out for projects which are no longer deliverable such as the Butlers Wharf Chef Training School and the Pool of London Ferry have been reapplied by the Council for other Schedule 3 or 5 purposes pursuant to sub-paragraph 4.1 or for such other purposes as may be subsequently agreed with the Developer in writing.

#### 6 LEGAL AGREEMENT

- 6.1 The Legal Agreement attached to the planning permission for the More London master-plan was completed on 19<sup>th</sup> August 1999 and was amended to include the Greater London Authority Headquarters Building Section 106, dated 19<sup>th</sup> January 2000.
- The S.106 Agreement has been varied by a Deed of Variation dated 13<sup>th</sup> December 2004, and by negotiation with the developer under which funds amounting to £1,875,000 have now been allocated for non-specified purposes under Schedule 3 subject to Developers Agreement for the specific use.
- 6.3 Compliance with S106 of Town and Country Planning Act 1990 and Circular 1/97 "Planning Obligations". The More London legal agreement was negotiated in accordance with the above legislation and guidance. The use of part of the money to fund the improvement of public open space adjacent to the site would be appropriate within the terms of the Act and Circular.

# 7 CONCURRENT REPORT FROM THE BOROUGH SOLICITOR AND SECRETARY

7.1 The report recommends that the Committee authorise the release of Section 106 funding of £265,000 from the Legal Agreement associated with the More London development to make a capital contribution towards the refurbishment of the Crucifix Lane complex of three railway bridges.

- 7.2 The Legal Agreement attached to the planning permission for the More London master-plan was completed on 19 August 1999 and has subsequently been given effect and/or varied by agreements dated 15 June 2000 and 13 December 2004.
- 7.3 The master-plan agreement as well as the subsequent agreements giving effect and/or varying the master-plan agreement were negotiated in accordance with section 106 of the Town and Country Planning Act 1990 and Circular 1/97 guidance. The use of part of the re-allocated funds to support the refurbishment of the Crucifix Lane complex of three railway bridges would be appropriate within the terms of the Act and the Circular.

#### **8 EQUAL OPPORTUNITIES**

8.1 The refurbishment of the Crucifix Lane complex scheme has been designed to be fully accessible to all, without prejudice or discrimination.

#### 9 LOCAL AGENDA 21 (SUSTAINABLE DEVELOPMENT) IMPLICATIONS

9.1 During the design and consultation process, the sustainability implications of the scheme and the materials to be used were considered. As many existing materials as possible will be re-cycled and re-used within the design. Careful selection of method statements for the cleaning will be chosen to ensure existing brickwork and structures are not damaged.

#### 10 COMMUNITY COUNCIL

- 10.1 Under the Council's Constitution, the Community Council has an opportunity to comment on the expenditure of funds over £100,000 their comments (if any) are then included in the report to the Planning Committee.
- 10.2 This report will be presented in public at the Bermondsey Community Council on 3<sup>rd</sup> October.







#### APPOINTMENT OF LEA REPRESENTATIVE GOVERNORS

#### 1. Purpose

1.1 To consider the appointment of representatives to serve as LEA governors.

#### 2. Recommendations

2.1 That the Community Council appoints individuals to serve as School Governors.

The attached appendix lists:-

- (i) Any governors wishing to be appointed for a further term of office at their current school and who have sustained their membership through appropriate attendance at governing body meetings during their previous term.
- (ii) Current vacancies in primary schools within the Community Council's area. Any specific requirements by the schools concerned are listed.
- (iii) Applications from new candidates for governorship, selected from the applications received by the Governor Development Service (GDS) in accordance with any expressed preference by the candidate, stated skills requirement or recommendation by a specific governing body and/or proximity to the school in question.

There are two types of application form:- (i) issued by GDS to local residents, and (ii) issued by the School Governors' One Stop Shop which specifically recruits candidates with management experience from large organisations who are interested in serving in Southwark. Both forms are of equal status and GDS contacts all applicants before submitting them to the Community Council.

3. GDS will provide at least two candidates for each vacancy where sufficient applicants are available. Members who wish to view the entire list of applicants currently held in advance of the meeting are invited to contact Kathy Brabston or Nicole Galea in GDS on 020 7525 5109 / 5252.

#### 4. Factors for consideration

4.1 The Council previously made governors' appointments using the following working principles:-

- Nominees should be sought from as wide a field as possible. All potential nominees will be asked to complete a self nomination form. Those seeking renomination are also asked to complete the form.
- Where a self-nominee is not already known to the appointing panel or to officers of the LEA, the Governor Development Service will establish personal contact with the individual before the nomination is submitted to the panel.
- iii Appointments should be made according to at least one of the following criteria:
  - The applicant has given evidence of interest and involvement in the social and/or educational community in Southwark.
  - The applicant's skills and experience would benefit the school [particularly were a school is in special measures etc].
  - The applicant is specifically requested by a governing body, particularly where there are no other suitable nominees.
  - Any preferences expressed by the applicant to serve as a governor of a particular school or in a specific geographical area.
