Camberwell's young people took top spot in the 2005 Southwark Community Games, beating off stiff competition from the other community council teams.

Southwark Community Games is a year round programme of sports coaching in schools, parks, estates and kick about areas, run throughout the eight community councils. The games also offer young adults 16 years and above, sports training, leading to qualifications in coaching and part time employment. Last year over 10, 000 young people participated and 193 young adults were trained.

The competition for 2006 will start soon. Every school in the borough will be involved and there will be 300 training places for young adults. Ten community sport coaches will also be involved. Tenants Associations – helping with your housing matters

Tenants' and residents' associations (TRAs) are often linked to council estate properties but anyone can establish a TRA for their street. A TRA is a group of people in the same area who have got together to form an organisation to look after their interests. Recognised TRAs are entitled to receive funding from the council, be represented at their local area-housing forum, and are consulted on matters affecting the local community.

TRAs hold regular meetings and represent their members' interests to the council and other organisations. They often hold social events, which can be a good way of getting to know your neighbours. If there isn't a TRA for your area why not get together with your neighbours and start one. The strength of your TRA and how much it can influence decisions depends on people like you getting involved.

Request for information regarding Gate installations and Cycle barriers

Site: Chamberlain Cottages

Request: To install a pedestrian gate across the entrance

Recommendations:

1. The idea to install a gate is not feasible and should not be pursued.

2. Police, PCSO's and Camberwell Wardens be invited via Camberwell TAZ to ensure the Cottages area is part of patrols to deter criminal and antisocial behaviour.

Supporting Information:

Legal Services advise that gating off access to Chamberlain Cottages is not possible because: -

The access to Chamberlain Cottages is public highway. This means that the public at large has the right to pass and re-pass over it as of right. Gating off the access would be an unlawful obstruction of the highway.

The access could hypothetically be "stopped up", i.e. the Council could go through a legal process that could ultimately take away the designation of the access as public highway, but this cannot be done in this case for two reasons:

 The residents of Chamberlain Cottages have a common law right to access to and from their properties to the public highway. Hence the Council could never pursue a stopping up order that would remove their common law right. If the access were to be stopped up then the land that was stopped up
would be in full control of whoever legally owned it or, if no one owned it,
then its ownership would revert to frontages. This would mean that none
of the residents would have a guaranteed right of access to their
properties as the owners of the land could do what they wanted with it or
even charge for access.

Site: Garages – Hascombe Terrace

Between 8 Hascombe Terrace and 1 Evesham Walk

Request: To gate off the garages entrance

Recommendations:

- 1. Due consideration be given to the distribution and management of keys and possible future maintenance costs prior to proceeding.
- 2. Funding for the proposal be sought
- 3. From allocated funds legal services be employed to establish ownership, contact landowners and provide legal advice for installation to take place
- 4. Consultation take place with landowners and all relevant stakeholders
- 5. Design and implementation take place
- 6. Any land impacting on the access issue where ownership falls to Southwark, legal parking enforcement be pursued.

All subject to Community Council approval

Supporting Information:

A request was made for the garages to be gated off between 8 Hascombe Terrace and 1 Eyesham Walk.

Legal Services advise that gates could be installed on the basis that they were installed on the garage land where it meets the public highway and that all affected landowners consented to their installation. This is because the gates would restrict access to their property.

The Council could establish ownership and contact those landowners, however, there would be costs associated with this. Legal Services are instructed that they should not undertake any such exercise at this stage.

If gates were installed then they would have to be installed in such a way that they open inwards and on to the garage land as opposed to the public highway, (Section 153 Highways Act 1980).

Legal Services further advise that consideration be given as to who would be responsible for holding keys, distributing keys and the long term maintenance of the gates.

Legal Services advise that the installation of such a gate would be likely to require planning permission because of its location in a conservation area and that the advice of the Planning Department should be sought in this regard.

Estimated installation costs are £2500

Estimated legal costs are £1000

Site: Garages – Evesham Walk

Between 2 & 3 Evesham Walk

Request: To gate off the garages entrance

Recommendations:

- 1. Due consideration be given to the distribution and management of keys and possible future maintenance costs prior to proceeding.
- 2. Funding for the proposal be sought
- 3. From allocated funds legal services be employed to establish ownership, contact landowners and provide legal advice for installation to take place
- 4. Consultation take place with landowners and all relevant stakeholders
- 5. Design and implementation take place
- 6. Any land impacting on the access issue where ownership falls to Southwark, legal parking enforcement be pursued.

All subject to Community Council approval

Supporting Information:

A request was made for the garages to be gated off across the shared access adjacent to 3 Evesham Walk.

Legal Services advice stands as for the garages at Hascombe Terrace / Evesham Walk save that as the gates would be set back from the public highway

then there should not be an issue with the gates opening out on to the public highway.

Consideration would, however, have to be given to the extent of the ownership of 3 Evesham Walk and gates could not open back onto that land with out the landowner's permission.

Estimated installation costs are £2500

Estimated legal costs are £1000

Site: Hascombe Terrace cycle restrictions

Request: To install cycle barriers

Recommendations:

- 1. The idea to install cycle barriers is not currently legally feasible and should not be pursued.
- 2. The Councils Sustainable Transport Team Officer be contacted to discuss and explore with residents possible resolution to issues raised.

Supporting Information:


Legal Services advise that Hascombe Terrace is a footpath. (The map attached states that it is "footway" but the view is that this was not intended as a strict legal term, rather to indicate "access on foot only".)


Cyclists can therefore legally use the footpath unless or until a traffic regulation order is made forbidding cycling. Installation of cycle barriers is not legally possible at this stage.

If client officers decide that it is appropriate to apply for a traffic regulation order to restrict or prohibit cycles then the traffic regulation order could be either experimental, (i.e. a trial run to see if what is proposed has the desired effects), or permanent.

The process requires committee authority, would cost at least £2,000, (there would also be monitoring costs in the case of an experimental order and costs associated with making an experimental order permanent), and would take a couple of months to complete.

Any barriers installed would need to take into account the need for vehicular access (such as removals) to properties in Hascombe Terrace.

RECOMMENDATION(S)

- 1. It is recommended that the parking bays in Grove Vale only (Appendix B), are approved for implementation subject to the outcome of the required statutory procedures.
- 2. It should be noted that Grove Vale is a boundary road between Camberwell and Dulwich, it is recommended that both community councils are in agreement before any changes are made.

BACKGROUND INFORMATION

- 3. Parking Services received correspondence stating there were missing sign time plates in Grove Vale and therefore the current parking restrictions were not being enforced to the detriment of loading and unloading for some businesses.
- 4. After the new signs plates were installed and enforcement reintroduced a petition was received on the 21 September 2006 from the Grove Vale Traders Association containing 1061 signatures stating there was a lack of parking for customers to the Grove Vale shops.

KEY ISSUES FOR CONSIDERATION

- 5. The primary reason for the implementation of the parking places in Grove Vale, Derwent Grove and Elsie Road is to provide short stay parking facilities bays to assist local businesses. Any implementation of short stay bays in Derwent Grove and Elsie Road comes at the cost of removing unrestricted parking in residential streets. For this reason and in light of informal consultation, it is recommended to implement the short stay bays in Grove Vale only (appendix B) and not in Derwent Grove and Elsie Road (appendix C).
- 6. The proposals are consistent with the policies set out in the draft Parking and Enforcement Plan, which in turn reflects the Council's policy priorities as set out in the Community Strategy and the emerging Transport Plan.

RESOURCE IMPLICATIONS

7. Implementation of the proposals can be undertaken within existing budgets.

CONSULTATION

- 8. In October a proposal was presented to the Grove Vale traders association for their approval before the wider community was consulted. The association responded stating our proposals were too generous and would cause residents objections. The proposals were amended reducing the amount of proposed short stay bays on Derwent Grove and Elsie Road.
- 9. The amended proposals were sent to the traffic section of the council to seek their approval. The London Bus Priority Network Project Manager responded stating that Grove Vale forms part of the (Transport for London's) TfL's Strategic Road network and that any scheme proposed on the Strategic Road Network needs to be audited by Network Assurance to ensure the network is not disrupted.
- 10. The proposals were sent to TfL for approval. The Network Assessment Manager expressed concern about having parking on both sides of Grove Vale that were opposite one another. The proposals were amended to reflect that concern.
- 11. The final proposal was advertised in the area by erecting 13 street notices and delivering to approximately 70 businesses and residents in the immediate vicinity.
- 12. Parking services received 5 emails, 1 letter and several phone calls objecting to the amount of short stay bays being proposed. Many residents have parking problems within the area and are requesting a Controlled Parking Zone because of the problems created by the commuters to the East Dulwich Rail station. It is noted that as part of Congestion Charging complementary measures, the area around East Dulwich station and Lordship Lane was consulted via a two-sage consultation process during 2002 and 2003 and the results showed that the majority were against the introduction of a Controlled Parking Zone (CPZ).
- 13. Should the Community Council approve this item, statutory consultation will take place as part of the making of the Traffic Management Order. A proposal notice will be erected in proximity to the site location and a press notice will be published in the Southwark News and London Gazette. If any objections are received these will be resolved by the Community Council.
- 14. No consultation or comment has been sought from the Borough Solicitor & Secretary or the Chief Finance Officer.



Community Payback is here. Helping clean up your local area.

Every year communities across the country benefit from over 5 million hours of free labour provided by offenders. Areas can be "blitzed" – estates can be cleared of rubbish or graffiti, overgrown parks can be tidied up in a day; disused underground garages can be emptied of dumped rubbish and made safe.

All offenders are carefully risk-assessed before they are put on a community order. We would not have an offender who poses a high risk to the public working on this type of project and they will always be supervised.

Public protection the main objective. Any offender who is sentenced to a community rather than a custodial order could be asked to perform a period of unpaid work. Generally this type of sentence is given to someone who has committed an offence against the community. It could be a public order offence, shoplifting, criminal damage or high-level drink driving.

Unpaid Work - or Community Service as it was once known, has been in operation for over 30 years and is one of probation's most successful interventions. Offenders are sentenced by the courts to perform up to 300 hours of Unpaid Work for the benefit of the community. A sentence of Unpaid Work is often ordered by magistrates for offences such as anti-social behaviour, vandalism and graffiti.

Community Payback - is an initiative to involve the public in the selection of Unpaid Work projects that will be launched next month. Projects will still be determined and managed by local probation areas but there will be opportunities, through Community Councils and local Police Panels, for you to have your say.

Dog fouling campaign and Flag the poo!

Dog fouling has been identified as a resolution of Southwark residents though MORI polls, community concerning community councils, street action teams, Southwark Environment Forum, schools and Street Leader conferences.

Over the last 18 months the "Do we have to rub your nose in it?" campaign has aimed to reduce the amount of dog waste left in our streets and to encourage responsible dog ownership. It focuses on the dangers and antisocial aspects of dog fouling.

The campaign, still on-going, proved a huge success and involved:

- a high profile media campaign, "Do we have to rub your nose in it?"
- Posters on buses, bus shelters and billboards,
- 200,000 poop scoop bags have been distributed to residents free of charge. Available through Community Wardens, Housing Offices and Libraries
- "Dog and family fun days" organised throughout the borough,
- 450 dog bins have been installed throughout the borough, 100 on highways, 300 on housing estates and 50 in parks.
- Signage has been increased in areas where dog fouling has been identified as a problem
- Stencils have been sprayed on the streets in the most problematic areas reminding dog owners to pick up.

However there is still a number of dog fouling complaints. The worst affected areas are South Bermondsey, Peckham and Dulwich. Further action is required in order to target the persistent irresponsible dog owners in these areas.

As part of the campaign re-vamp the council has organised a series of "flag the poo" events. ENCAMS research shows that dog owners are more likely to change their behaviour if 'shocked' into action. The aim of "flag the poo" is to mark all the examples of dog mess found using brightly coloured flags. The idea is to dramatise and illustrate the extent of the problem to dog owners, and perhaps to shame the irresponsible ones into improving their behaviour.

The launch event took place in Dulwich Park on 3rd February and was a great success. There will be one Flag the Poo event per Community Council area. Those who continue to act irresponsibly can and will be fined. On the spot £50 FPN fines can be issued to anyone not seen clearing up after their dogs. Individuals can also be fined up to £1000 in a Magistrates Court.

Battersea Dogs has pledged their support to our campaign, as we would like to reinforce the fact that it is not the dogs - but the dog owners - who are the real problem.
