Present

Councillors Kim Humphreys (Chair), David Bradbury (Vice-Chair), Toby Eckersley, Michelle Pearce, Charlie Smith, Norma Gibbes, Lewis Robinson, William Rowe

1. Introduction and welcome by the Chair

Cllr Humphreys introduced himself, Council Members, Council officers and welcomed people to the meeting.

2. Apologies

Apologies were received from Cllr Sarah Welfare.

3. Disclosure of Members' interests and dispensations

There were none.

4. Urgent Items

Cllr Humphreys: Dulwich Hospital planning brief will come to meeting on 29 June - the planning department has extended the consultation period up to 27 May before going to Planning Committee on 5 July. Comments /observations made at next meeting will be considered by Planning Committee.

Chris Bull's reply to Cllr Humphreys' letter of 7 April about Dulwich Community Hospital was available at the meeting.

5. Minutes of previous meetings

Amendment to minutes of 6 April (page 9 of pack): it is Sydenham Hill not Sydenham Hill Road

Minutes were agreed from meetings of 21 February, 9 March and 6 April 2005 The Chair signed the minutes.

5.1 Matters Arising from the previous meeting

Heber and Goodrich schools – report is ready in draft and is awaiting Cllr Thomas's approval before it can come to Dulwich Community Council.

Pedestrian crossing at Adys Road – Safer Routes to Schools did carry out some safety measures but a pedestrian facility was not possible. Hayden Tuck will contact Cllr Welfare.

Blue plaques – the three nominated will remain, as they were very popular choices. Concerns raised by members will be taken into account.

Resurfacing of Underhill Road – Mr and Mrs Costello asked if it was possible not to reinstate cushions – these were put back a day or so after the meeting and a council officer has written to Mr and Mrs Costello about this.

5.2 Greening Southwark

Rowena Estwick from Southwark Groundwork announced that nominations for green areas in Southwark would be accepted (as part of Southwark in Bloom competition).

6. Deputations and Petitions

Ashwin Tanna on shoppers' parking hours along Lordship Lane:

- Representing traders, pedestrians, shoppers
- From 1 June 2005 onwards implementation will begin of new parking arrangements -
- south end of Lordship Lane drivers will be allowed to park in bus lane during off peak hours (weekdays) and all day Saturday
- North end parking will only be allowed 10am 4pm weekdays and all day Saturday
- Reason given is that as you enter Lordship Lane from Goose Green roundabout the road is too narrow and cannot park there.
- Widening of road will not happen until 2006
- 10 years ago, consultation by LBS on whether traffic lights should be installed at junction of Lordship Lane and East Dulwich Grove
- If these lights are installed traffic will run smoothly and improve pedestrian safety
- Proposal by north end traders to allow parking from 9am instead of proposed 10am, weekdays
- Traffic wardens should enforce 30 minutes parking
- Badge system for parking works in other places and similar should be introduced for Lordship Lane
- Consultation for no 37 buses has proposed that buses do not run along Melbourne Grove
- In mornings there is a lot of traffic at junction of East Dulwich Grove and Lordship Lane

Questions followed:

Cllr Pearce summarised main points:

- Is it planned to widen road?
- Is there a proposal to have lights and pedestrian crossing at East Dulwich Grove?
- Suggestion to have parking begin at 9am not 10am is better
- Wardens should be enforcing 30 minutes limit and good idea to have badges in cars
- Idea to have double yellow lines from East Dulwich Grove into Lordship Lane up to Elsie Road on both sides of road

Cllr Eckersley: Why would double yellow lines on both sides of East Dulwich Grove be in interest of traders or residents?

Ashwin Tanna: To reduce traffic congestion on East Dulwich Grove

Chris Mascord: Consultation will take place in July on double yellow lines on north side of East Dulwich Grove. Will include traders in north end of Lordship Lane. Also along Melbourne Grove on one side.

Chris Mascord:

- TfL has agreed to scrap weekend parking restrictions and implementation of this will begin in June between Goose Green and East Dulwich Grove
- Section between Goose Green and East Dulwich Grove is narrower than southern part of Lordship Lane and there is also more traffic (accessing East Dulwich Grove).
- It will be possible to widen road as footways are wide but need to check underground services. This is subject to bid from BSP
- It was proposed to have traffic lights but these would cost £100K.
- Re-routing of no. 37 bus down East Dulwich Grove will be monitored for 12 months but traffic lights will not be installed
- High volume of traffic around East Dulwich Grove will take parking out from one side of road to have two unrestricted lanes.
- Parking badges is a good idea CPZ visitors have similar tickets

Ashwin Tanna: by creating a bus lane along East Dulwich Grove, a lot of traffic will be created in East Dulwich Grove and Lordship Lane.

Cllr Bradbury: There was consultation some years ago about traffic lights at junction of East Dulwich Grove and Lordship Lane. Other measures put forward by TfL eg roundabout at Goose Green, pelican crossings. Traffic lights not put in.

Cllr Smith: would like action on monitoring and enforcement of 30-minute limit on parking on Lordship Lane. The card idea should be looked at.

Cllr Pearce: Wardens must enforce 30 minutes parking rule in Lordship Lane. Can Southwark Parking Clientside direct contractors to maintain constant presence?

Tony Stefano: Will contact Mr Tanna to discuss these issues. Will check if card system can be introduced for visitors' parking and Southwark Parking Clientside to investigate if parking warden contractor can maintain constant presence in Lordship Lane.

There was some discussion on whether 30 minutes parking time was enough and whether wardens were enforcing this (eg Ken Pearson reported all day parking between Frogley and Northcross Roads, Ashwin Tanna reported parking in bus lanes).

Agreed to ask Terry Dale if it is true that wardens are not enforcing 30 minutes parking limit between Frogley and North Cross Roads.

7. Bus matters

No. 42 bus route test will be trialed this month. It will go along Sunray Avenue, along East Dulwich Grove to Sainsburys or hospital.

Route 37 is going out to consultation in June for route to go along East Dulwich Grove, Lordship Lane and then to Peckham.

Route 185 – bus lane hours along Lordship Lane will be removed on Saturdays from June/July.

Route 3 – changed frequency on 30 April 2005 – see letters received from TfL and Mayor of London – pages 16 and 17.

Questions followed:

Lynn Walker, Shirley Plummer and others on No. 3 bus:

- petition of over 300 names was ignored by Mayor of London
- long waits for buses in Herne Hill
- drivers also ignore request stops eg in Croxted Road
- Buses now very crowded and can't get on them
- Bus stop opposite Croxted Road should be moved as bus drivers do not stop
- Some bus shelters face property rather than road.

Chris Mascord: All bus stops along South Croxted Road and Croxted Road will be upgraded with funding from TfL, to be made accessible for disabled. Shelters installed by London Buses but Croxted Road one will be looked at.

David Cianfarani: red buses should be better; No 201 relieving some of pressure. Problems exacerbated by traffic lights in Herne Hill.

Cllr Eckersley: evidence needs to be collected. Could we employ consultants as "mystery shoppers" and be trusted by TfL? Is there a mechanism for this?

Chris Mascord – yes can do that. Will provide costings.

Q: What is happening re no 12 bus stands?

Cllr Humphreys: agreed course of action and will go to full Council Assembly and petition to TfL but there has been no Council meeting since then. There will be a deputation to next appropriate council meeting. Relevant people will be invited.

Herne Hill bays

Cllr Bradbury: what is happening with this - has the responsibility between LBS and LBL been resolved?

Chris Mascord: Southwark can now take it forward. Lambeth deals with maintenance from Sunray Avenue to lights. The consultation took place two years ago and LBS can write the Traffic Order and send it to LBL.

8. Borough Transport Spending Plan – Sally Crewe – Appendix 1 LBS received £3.8m in total for 2005/06. Many of projects from last year will be looked at again for suitability to include in 2006/07 programme.

Questions followed:

Cllr Eckersley: Do you welcome a more formal Community Council input such as Community Council resolutions (on top of individual forms)? This could be discussed at next meeting

Sally Crew: 29 June is too late for this year's bid process. Will provide more information on schemes funded in current and previous years and list of bids for BSP for 29 June. Executive members make final decisions on the bid.

John Paine (Crystal Palace Community Association): Has been pressing for traffic and speed restrictions in Jasper Road and these will cost £28K.

Cllr Humphreys: This scheme is funded from Dulwich Community Fund and more information will be sought.

Cllr Pearce: Concerned about accessibility; the biggest accessibility issue is access to train stations and getting onto trains. Safety, accessibility and cleanliness are needed now not in 20 years time.

Sally Crew: this is for TfL to deal with and is expensive. LBS should assess this and communicate it.

Q: Can Calton Avenue / Court Lane junction be consulted on using BSP money?

Sally Crewe: This would have to be a bid for next year's BSP programme.

Cllr Rowe: The Community Council needs to give a steer and feed into planning process earlier. **See Members' decisions.**

Sally Crew: noted, although guidance from TfL is received late.

Paul Reynolds: due to election, Southwark Transport Forum was cancelled. Lambeth was awarded funds for improving accessibility to stations. National interchanges will be prioritised but it will also go down to the local level.

Q: Underhill Road resident on rat running. Requested release of consultation document (from 2002) on 13 April 2005 and served notice under Freedom of Information Act but has not received acknowledgement or reply. What are the plans for Underhill Road?

Deborah Holmes (Borough Solicitor): will take up Freedom of Information issue, as it has not been addressed within timescale.

Robert Johnson: 31 May 2005 is an inadequate timescale for return of forms.

As well as projects listed in decision, officers were urged to give weight to principal road maintenance. List of principal roads in Dulwich to be supplied.

David Cianfarani: border roads should get special attention as will shortly become strategic roads and LBL will not repair Herne Hill until 2007/08. The Herne Hill Street audit has been passed to LBL for action.

Sally Crew: Principal roads funding is based on condition surveys and there is no flexibility.

9. Cleaner, Greener, Safer programmes - Tony Stefano An exception report on 2004-05 programme was available at the meeting

Questions followed:

Members asked about the underestimate (and overspend) of the Dawson Heights path. Further information will be given on who made mistake and whether penalties can be enforced.

2005-06 C, G, S programme – Tony Stefano – Appendix 3

There was discussion on the distinction between capital and revenue. Cllr Pearce would like flexibility to fund one off revenue events. Also sometimes capital money is spent on maintenance issues. Vic Bisiker highlighted path and lighting maintenance and this could be treated as capital.

Cllr Humphreys: "Son of Community Fund" is expected in 2005/06 for revenue projects. There is some flexibility in the interpretation of criteria. There are grey areas with maintenance and some items need to be replaced.

Cllr Eckersley: need more joined up working - street audits should feed into C,G,S. There is a residual of desirable projects, which should come to June meeting. Lordship Lane audit on 12 May 2005 should be fed into C,G,S.

Keith Broxup confirmed Improvements to Playgrounds was a one off allocation.

Lynn Walker: There is a night bus stand outside of Christ Church. Visitors to church are being ticketed when parking at night bus stand but parking is permitted upto 8.30pm. Can original post with information be reinstated?

A break took place between 8.55 – 9.05pn

10. Equalities Scheme – Nathalie Hadjifotiou - Appendix 4

Questions followed:

Vic Bisiker: concerned about health of people particularly elderly on estate. Lewisham has better services and facilities for elders. Review of support for older people is needed.

Janet (Social Health professional): Southwark Housing department – cannot tell you which housing is "disabled accessible" e.g. width of doorways.

There are many people living in unsuitable housing as they are disabled or older. There is a lack of homes for disabled in Dulwich.

Nathalie agreed these issues will go on list to be considered. It is a challenge to have all housing accessible for disabled and elderly.

Q: Where do percentages in report come from?

A: Government database of national census 2001 contained an ethnicity question, religious affiliation and age. Information is available at ward level.

lan Holt: Is there any scope to factor in access to open space and natural environment. Why do only some ethnic groups access open space?

Nathalie: Assessment process e.g. parks / open spaces are they being used by everybody? Are there reasons for non-use? Park Ranger Service will target new groups to bring them in.

Cllr Smith: in 1950s / 1960's many people from Caribbean settled in South London and due to prejudice bought their own houses. Now many are elderly and can't maintain their homes. This large group should be looked at - there are many single, elderly in East Dulwich.

Nathalie: housing and owner-occupiers will be looked at

Cllr Pearce: this group need assistance, they are being robbed by cowboy builders.

Cllr Rowe: from a Dulwich perspective it would be interesting to talk to Southwark Alliance. The only part of Dulwich to receive Neighbourhood renewal funding is Kingswood estate.

Nathalie: Southwark Alliance is separately funded and would need to discuss this another time. It is government criteria and will end in 2006. There will be discussions on its future over the next six months.

11. Dulwich Community Fund – Donald Forde

The report was available at the meeting.

Comments and Questions followed:

Cllr Pearce:

- Walk of Faith was a fantastic day.
- The black churches work with young people and good ideas could be exchanged.
- Another event was requested.
- Focus on religious groups as support system.
- We need to engage and become more inclusive society.
- Reached people who do not normally get involved.

Cllr Humphreys:

- Streatham and Marlborough Cricket Club concerned about delays with planning.
- What is happening with Health drop-in centre for OAP's and young people on Kingswood estate?
- Sydenham Hill Wood Local Nature Reserve Fencing what is happening with fencing? Pre planning application meeting between officers and lan Holt is necessary.

Cllr Eckersley: requested further details on £3000 for yellow box junction at Calton Avenue/Court Lane

Donald Forde:

- Streatham and Marlborough Cricket Club Barry Causer, Project manager, is confident that it will be delivered on course and full time project manager has been appointed. Will find out latest.
- Planning permission was refused for SHW Nature Reserve but Ian Holt has now submitted new planning application on 16 May 2005. Will arrange meeting between planning officers and Ian Holt.
- Will provide details on yellow box junction

12. Soap Box Session/Public Question Time

Q1: Request to reinstate litter bin by entrance to Wildlife area in Crescent Wood Road

Tony Stefano: will deal with this.

Q2: Ken Pearson: Most vehicles speed above 20mph in Northcross Road and surrounding roads (all part of LBS 20mph zone). The speed cushions are

ineffective and do not slow the traffic. Can the Transport Group install a speed counter in Northcross Road by Fellbrigg Road? TfL provide money for monitoring.

Chris Mascord will look into this.

Q3: There is a small planning Notice in Alleyn Park and Park Hall Road on lamp post for installation of a 12m Vodafone telemast and has wrong address for Planning department – SE21 instead of SE17

Cllr Humphreys: It is normal to place planning notices on lamp posts and write to affected residents. Land ownership is irrelevant and cannot comment further as the matter may come to Community Council for decision.

David Cianfarani: concerned that some parking bays now are for 20 minutes parking not 30 minutes, eg Stradella CPZ and the hours are draconian (8.30 am – 6.30pm).

Ken Hoole: on behalf of John Paine (Crystal Palace CA): Bowley Close is a concern – will the facilities and services offered there be replaced?

Cllr Humphreys: This is responsibility of Southwark PCT. Unaware of details.

Cllr Eckersley: if there is specific letter unanswered by Chris Bull can chase up but need specifics to elicit answers.

Q: How can Southwark Sports and Social Club site best be used for whole area? Why is it not being utilised at present? What are plans for site?

Cllr Humphreys: It is being utilised at present. It was vandalised recently and needs to be made safe. It was originally run by Southwark Council and then by SS&SC but that body is unable to maintain site to level of lease conditions (Dulwich estate is freeholder). More permanent management arrangement is being created for future use of site. An update will be requested from Nigel Robinson who is dealing with this.

There were some questions about Dulwich Hospital planning brief.

Cllr Humphreys: it will be on agenda of next meeting.

Q: Concerned with Mayor of London's "urban" density being applied to parts of Dulwich.

Cllr Eckersley: Mayor has objected to LBS's plan to remove East Dulwich and parts of North Dulwich from "urban" density and add to "suburban" category. LBS response must be submitted by 17 June 2005. The Mayor may then withdraw his objections. If people are opposed to urban definition they should lobby the Mayor at end of June/early July.

Robert Johnson: Heritage Lottery Funded work will begin at Dulwich Park in June.

13. Members' Decisions

BOROUGH SPENDING PLAN

Cllr Rowe moved and it was agreed:

Dulwich Community Council requests that the following schemes be prepared by officers for inclusion in the BSP:

- Full review of traffic flow and calming in the Underhill Road / Melford Road / Wood Vale area – including interaction with the South Circular and Lordship Lane
- Junction improvements to
- Re-instate the left turn from London Road to Sydenham Hill
- Improve traffic flow at the junction of Lordship Lane and Dulwich Common
- Calton Avenue / Court Lane / Dulwich Village subject to further information on the current allocation under Safer Routes to Schools' improved safety scheme for this junction
- 20 mph zone for the North Dulwich triangle
- Dulwich Wood Avenue traffic calming
- Jasper Road traffic calming scheme to the extent not already funded

The Dulwich Community Council also requests that officers endeavour to attract maximum funding from all sources for maintenance of the borough's roads.

The Community Council also requests that it should be consulted formally at an early stage in the preparation process for future BSPs.

Closing Comments by the Chair

The Chair thanked everyone for coming to the meeting and announced the next general meeting is on Wednesday 29th June 2005 at Christ Church, Barry Road, SE22. The meeting closed at 10.00pm

CLEANER, GREENER, SAFER - EXCEPTION REPORT

Purpose

To update the Dulwich Community Council on four Cleaner Greener Safer schemes as requested at the last Community Council meeting on Wednesday 9th March 2005.

Update

Lordship Lane Shop Parade

Officers are drafting the delegated authority report to seek authorisation to transfer £42,750 of planning gain from the Section 106 agreement relating to the High Wood Barracks agreement to supplement funding for the Lordship Lane Shopping Parade Refurbishment project.

Northcross Road

The Darrell Road Community Centre has been booked for May 24th at 6pm to held a meeting with stakeholders to discuss identified options for refurbishment. Publicity regarding this meeting will be distributed to all stakeholders by May 14th.

Dawson Heights Path

The completed scheme cost is £24,355, i.e. £ 4,355 over the available budget and £ 10,784 over the original estimate. The following issues have been identified as the cause for the overspent:

- The length of the path was underestimated
- An error was made when the cost for the asphalt was calculated The consultant has apologised for the misunderstanding caused and for not discussing the revised estimate with the project manager until works were completed.

It has been proposed that three bollards are installed at the bottom of Donkey Alley to address the problem of cars accessing the pathway. These will cost £1,215, bringing the total project costs to £25,570.

It is suggested that the additional £5,570 are taken form the under spent of £8,000 accrued for the Paxton Green Greening scheme, now completed.

Holmedene Avenue Humps

The proposal to remove 3 sets of 4 speed cushions and replacing them with speed humps has been subjected to consultation and advertised on London Gazette, Southwark News and on site. Deadline for objections is end of May 2005.
