

14.	Southwark Sports Ground and Greendale		
	Officers gave a Powerpoint presentation on the Southwark Sports Ground and Greendale playing fields. Both sites are getting a much needed revamp, reported Nigel Robinson, from the Southwark's sports team. The sports ground has poor quality football pitches, tennis courts and cricket facilities, and Dulwich residents are concerned that the site has fallen into a state of disrepair. Nigel said that many of sports and leisure centres in the area are in need of improvements.		
	Contractors who specialise in sports ground maintenance, have been appointed to undertake a feasibility study to help decide the future use of Southwark Sports Ground. Nigel stated that already recent improvements have taken place to the Pavilion which is undergoing refurbishment, and improvements have been made to the changing facilities. There are now better catering facilities on site, improved security, and the ground's football pitches and cricket strips will be overhauled this spring.		
	The Chair thanked officers for their presentation.		
15.	Landfill Tax Credit Scheme		
	Officers gave a presentation on the above and an overview of the scheme. Tim Clee explained that Central government has given up to £50,000 worth of tax credits to local authorities to spend on environmental improvement projects.		
	The criteria for funding to assess your eligibility to receive funding will be based on whether it is a business, or a community based project. Bids must fall within the eastern parts of Village and College wards and all of East Dulwich Village.		
17.	Community Strategy Dulwich		
	Nathalie Hadjifotiou gave a presentation on 'Southwark 2016'. This is a ten-vear plan, that sets out what people wish their		

	borough to be like over the next decade, and what needs to be done to get there.
	Southwark Council and the Southwark Alliance, the local strategic partnership published a draft Southwark 2016 plan in November. The draft plan outlines the vision and priorities for the borough and to improve people's lives, helping them to become healthier, safer and to achieve their educational potential. It suggested making Southwark a place for people made up of mixed communities focussed around the eight community council areas.

Subject: Section 106 Planning Contributions

Background

1. Southwark Council has prepared a draft supplementary planning document, Section 106 Planning Contributions, to create greater transparency and openness in the way planning contributions are agreed with developers. It also aims to achieve sustainable development by outlining the contributions that are expected from developers to deal with the negative impacts of their developments.

- 2. Planning contributions are used to address the negative impacts caused by a development and contribute to providing infrastructure and facilities necessary to achieve sustainable communities. The council can enter into a legal agreement with a developer whereby the developer agrees to provide planning contributions. These contributions can cover a range of facilities and services including affordable homes, improved open space, funding of school places and provision of employment training schemes.
- 3. A supplementary planning document (SPD) provides additional information on planning policies in a development plan document or saved policies in the local development plan. SPDs fit into the new type of local plan called the local development framework that has been introduced by the Planning and Compulsory Purchase Act 2004.

Discussion

4. The section 106 process starts with the planning officer and developer negotiating and agreeing what s106 contributions should be attached to a planning permission. In order to give community councils an effective voice in how s106 money is spent then mechanisms to be used at the beginning of the process should be considered. This is the intention of the community project banks proposed in the draft Section 106 SPD. If the community councils approve projects to be included on their respective project banks, then these projects can be used by planning officers as a guide to existing local pressures when discussing proposals with

developers. This would take place before a decision is taken on whether or not to grant planning permission. This would improve the transparency of the negotiations and give planning officers important local knowledge that would help them to identify issues of local concern when discussing proposals with developers.

- 5. As the project banks are still at the proposal stage they can now be shaped to best suit needs. There are a number of ways in which this could be taken forward. The community project banks could be linked through the community councils with Cleaner, Greener Safer (CGS) or CGS projects could be included in the project bank. It could be that the CGS projects are a starting point for the project banks. Alternatively, a new list of projects could be developed that covered the full range of potential section 106 funding, over and above CGS issues.
- 6. Southwark's constitution gives delegated authority to the Director of Regeneration to approve the release of up to £100,000 of section 106 funding. For amounts above this, a report has to go to community councils for comments and then to Planning Committee for a decision. This is reflected in the draft Section 106 SPD.
- 7. A report seeking release of section 106 funding must show how the use of the funding complies with the respective section 106 legal agreement. This is because the section 106 funding is available by way of a legal agreement between the council and a developer. The legal agreement specifies the purpose of the funding while Government policy says it should be to mitigate the negative impacts of a development.
- 8. A change to the council's constitution would be required for the threshold of delegated authority to be altered to £1000.
- 9. The reports for release of s106 monies, whether they are by delegated authority or go to community councils and the planning committee, are more often than not at the end of the process. They are concerned with implementing projects previously agreed with the developer and written into the section 106 legal agreement. Trying to redirect the money for alternative projects at this late stage could incur legal costs, could be outside the scope of the respective section 106 legal agreement or require the agreement of the developer (which can be reasonably withheld).

1. Background

The Dulwich Community Council has received requests from residents asking that the possibility of a one-way system be introduced to John Ruskin Walk to reduce the amount of rat-running traffic, head on conflicts and speeding.

2. One-Ways Systems

This type of measure has been used within Southwark as a means of reducing traffic volumes in specific streets. Typically where the streets are narrow and/or are taking large volumes of traffic.

3. Council Policy

In terms of council policy we have no blanket policy on one-way or two way working. If the effects of a conversion accord with our objectives, then there would be no objections. The relevant policy objectives are (a) encouraging forms of transport other than the private car and (b) making streets safer for all road users, particularly children, pedestrians and cyclists. Conversely, if the effects conflict with our objectives (in particular if the effects were to speed up traffic or prevent safe cycle routing) then there would be problems.

Currently the council is looking at existing one-way systems with a view to either returning them to two-way or installing contra flow cycle facilities. This does not preclude the possible introduction of new one-way systems; only that careful consideration must be undertaken on a case-by-case basis before such decisions are made.

4. Issues for consideration

- Existing levels of traffic and vehicle speed Speed and volume data needs to be collected to assess if the street is show to be higher than average. This leads onto the next issue,
- Displacement of traffic this is a serious issue and as it may have an adverse effect on neighbouring streets. In order to access this speed and

- volume counts will need to be undertaken around the area as a whole. Consultation will also be undertaken to ascertain acceptance locally of possible side effects.
- Increased speeds one-ways do result in higher average speeds as there
 is no longer opposing traffic. This issue would require additional traffic
 calming treatment.
- Herne Hill CPZ review is nearing completion. It is recommended that Ruskin Walk have permit holder parking places introduced. This will eliminate the effects of long-stay commuter parking and reduce current occupancy levels, providing a greater number of natural breaks in the parked vehicles. Stretches of single yellow line for crossovers and passing areas are also proposed to further assist.
- Resources All items above, except the CPZ, will require the commitment of resources. Under current funding arrangements we would have to bid to TfL for funding or look to alternative sources as non is currently available.

5. Next Step

Currently we are undertaking consultation on the introduction of a 20mph zone in the North Dulwich area (note signage only). We have not asked specifically whether a one-way system should be introduced but rather ask for any additional comments/suggestion on traffic calming. This will be formulated into a report for the Community Council and Transport Planning in regeneration to consideration.

In terms of the introduction of the one-way, we suggest awaiting the introduction of the 20mph zone and then reviewing the existing calming measures.
