Local Implementation plan annual progress report

Officers from the traffic and transport group (Barbara Selby and David Moffat) were present at the meeting to explain that the transport planning team is set to start compiling its funding submission to Transport for London (TfL) for transport programmes in Southwark for 2009/10. This process feeds into Southwark's Local Implementation Plan annual progress report. Under the LIP APR, the Council will be bidding for money to fund a number of transport improvements in the borough, covering programme areas like:



- Local safety schemes
- 20 mph zones
- Walking
- Cycling
- School Travel Plans
- Local Area Accessibility and
- Bus Stop Accessibility

Officers stated that the consultation process started early this year so that residents, councillors and local interest groups are fully engaged in the process. The submitted schemes need to be approved by the Council's executive before their submission to TfL in June 2008.

Officers agreed to feedback to the Dulwich community council on the suggested transport schemes.

Supplementary planning documents (SPD) consultation on draft residential design standards

Simon Bevan from the planning policy team was present to talk about the consultation process for the SPD draft residential design standards. He said the Council are consulting on a number of supplementary planning documents at the moment which are taken into account when deciding on planning applications. These documents give further guidance on the detail of the Council's development plan which consists of the Southwark Plan and the London Plan.

The draft residential design standards SPD sets out what standard of design is expected from residential development.

This includes some of the following:

- Floor space for minimum size houses
- Quality of storage space, size of gardens or roof terrace etc.
- New homes built being brought up to the expected standard

Formal consultation deadline on this draft SPD has been extended until the end of January 2008. Officers agreed to keep people updated on the progress of the SPD.

You can also view the SPD documents at Chiltern House, the town hall, libraries, area housing offices and one stop shops. Southwark residents and community groups can request a copy free of charge from the planning policy team.

BACKGROUND INFORMATION

- 2. This report presents proposals for a number of local traffic management schemes, which are matters reserved to Community councils for decision.
- 3. The origins of the proposals are indicated in the annexed schedule.

KEY ISSUES FOR CONSIDERATION

- 4. The reasons for the proposed traffic schemes are set out in the Appendix B.
- 5. The proposals are consistent with the policies set out in the draft Parking and Enforcement Plan, which in turn reflects the Council's policy priorities as set out in the Community Strategy and the emerging Transport Plan.
- 6. The proposals will support the Council's Equal Opportunities Policy and will promote social inclusion:
 - by providing improved access for emergency vehicles and residents
 - for disabled drivers
 - increasing parking provision

RESOURCE IMPLICATIONS

7. Implementation of the proposals can be undertaken within existing budgets.

- 8. Preliminary consultation of the occupants of properties directly affected has been undertaken where appropriate.
- 9. Should the Community Council approve the item, statutory consultation will take place as part of the making of the Traffic Management Order. A proposal notice will be erected in proximity to the site location and a press notice will be published in the Southwark News and London Gazette. If there are objections the proposal, or a modified proposal will be re-submitted to the Community Council.
- 10. The Head of Transport Planning (Regeneration Department) and the Head of Parking Services (Environment and Leisure Department) have been consulted on the proposals and have no objections.
- 11. No Consultation or comment has been sought from the Borough Solicitor & Secretary or the Chief Finance Officer.
