Urgent items	<p>The following announcements were made –</p> <ul style="list-style-type: none"> i) Martin Cakebread of the local Conservative Party handed in a petition containing more than 700 names. The petition called for Rotherhithe police station to be manned 24 hours a day, 7 days a week. ii) Chair announced that free poop scoop bags were distributed at the Flag the poo event on Saturday 18 March in Southwark Park. iii) Chair said that Rotherhithe Community Council would like to congratulate Rebeka Clark who was recently named Southwark's woman of the year. iv) Further to previous discussions on King George's Field. The issue was being looked at by Katie Nicholls the community outreach officer. She was consulting with residents and could be contacted on 020 7525 1598 or katie.nicholls@southwark.gov.uk

Members' interests and dispensations	<p>Councillor Neale declared an interest in the community fund item –</p> <ul style="list-style-type: none">i) Rotherhithe Peninsula Fun Rides. <p>Councillor Anne Yates declared an interest in the following community fund items –</p> <ul style="list-style-type: none">i) Youth Music Technology workshops in the Canada Estate Hall.ii) To hold a Green space-Park it event in Southwark Parkiii) For a St Georges Day fete outside on the estate

Public questions raised	
<p>Qs 1-3</p>	<p>199 bus service ? Andrew Boag from Transport for London said, that they wanted to extend the 199 service to Bermondsey and they need to find a bus stand in Bermondsey town centre.</p> <p>Reliability ? Andrew hoped it would improve, adding that operators have incentives to run services as accurately as possible.</p> <p>Service from Rotherhithe to Camberwell ? Andrew said that would be difficult. A service had recently been extended from Nunhead to Surrey Quays.</p>
<p>Qs 4-6</p>	<p>Bus conductors ? Andrew (TfL) said that only 6% of passengers pay cash on buses these days and that had been the main purpose of conductors. They were not Police / security guards but they were often targets for assault. Statistics show that assault levels were higher on buses with conductors.</p> <p>Security ? CCTV was now fitted to all buses and bus services had their own dedicated Police who patrol routes throughout London. There were both uniformed and plain clothed officers.</p> <p>Bendy-buses ? Andrew said that the Mayor was reviewing the service but they had been very successful. It was an economical way of carrying passengers and there were no plans to reduce the number of bendy-buses at the moment. He added that they had been around for 4/5 years and were not considered for every route.</p>
<p>Q7</p>	<p>Displays at bus stops ? Andrew said there were no plans to install new devices in the short-term. Some of these had proved unreliable. But millions of pounds were being spent on improved technology, which would result in a new system with GPS (Global Positioning System) being installed, a few years from now. The aim was to start with existing stops and then extend beyond that.</p>
<p>Qs 8-9</p>	<p>Bus service around the loop ? Andrew said that this was a tricky situation and he understood why residents wanted it. He said he thought a longer journey bus route may be used but then local services might suffer. He added that there was a need for greater reliability for existing services.</p> <p>Cyclists problems with bendy-buses ? Andrew said that drivers received special training for the bendy services including awareness of other road users. There were natural concerns over the longer buses turning left and affecting cyclists but he was not aware of any increase in accidents.</p>

<p>Q10</p>	<p>Lorraine Smith said she had written to TfL with a complaint about a man spitting on the bus. There was also the problem of people eating food on buses. TfL had been unhelpful and said some needed to eat for medical reasons.</p> <p>Andrew said he was surprised with TfL's response and that there were signs discouraging people from eating hot/smelly food on public transport. He said the drivers were not there to police the bus but if there was a problem they could call for help on the radio. Also CCTV is there to identify offenders. Andrew added that in Bexley they have a shop a job scheme in the local newspaper.</p>
<p>Q11</p>	<p>Alan from the community said that all buses have ramps. However, in his experience with a patient and wheelchair, so many of them either do not work or the driver refuses to use the ramp. He added that he had been told to get off a bus in Peckham.</p> <p>Andrew said that should not happen. He asked residents to keep a log of such incidents so they could be investigated and any offending vehicle/driver identified.</p>
<p>Q12</p>	<p>Martin Cakebread said that on Jamaica Road cars drive 24/7. Was there any compromise possible on the bus lane operation ?</p> <p>Harun from Transport for London said that if those times were specified then there was no scope for a change. If there were other issues then contact TfL.</p>
<p>Q13</p>	<p>David Meagher said that buses should have machines that give change. It was unfair that passengers should have to pay extra in some circumstances.</p> <p>Andrew said that was unlikely to alter as they were trying to encourage people to use Oystercard pre-pay.</p>
<p>Q14</p>	<p>Disruptions caused by utility companies ?</p> <p>Harun (TfL) said if more than one company was working there was a programme for scheduling under the Traffic Management Act.</p>
<p>Q15</p>	<p>John from the community asked about the idea of a St George's Day celebration ?</p> <p>Darryl Telles (South Bermondsey Partnership) said that residents were in favour of this. There have been troubles in the past with extremists using the flag but that should not stop events on the day. Other national days were celebrated so this should be re-claimed with an emphasis on traditional English values and positive changes that have occurred within our society. A number of family activities were being planned.</p>

Movement and Well-being Centre	£800	For Awareness Through Movement, Reflexology, Reiki, Indian Head Massage and other practitioners who are beginning with or want to extend their practices. These people will provide their services for a low or zero fee in order to gain experience and recognition
Drum Club	£800	For an end of year trip to the theatre for the club members.
1 st Southwark Park Brownies	£800	For a mural to be painted on the outside wall of Scott House by a local artist with previous experience and also by the girls in the brownies.
South East Lions	£500	To coach football teams in segregated age groups, teaching new ball skills and discipline skills. Also for them to make new friends. This activity plans to tackle obesity by providing a fun, healthy activity locally.
Education 2000 Employment Training Organisation	£700	To set up a website for the organisation to reach those areas which are otherwise unreachable. This will enhance of the company of the organisation.

The Friends Of Southwark Park	£1000	To hold a Green space-Park it event in Southwark Park. The young Friends have been selected to hold one of these twelve events and they will design plan and deliver this free event by young people for young people.
Hornafrik Integration Project	£1000	For a sporting and Educational programme that will involve the Somali youth and integrate them into mainstream youth activities and train Somali children to access wider services.
Southwark Cyclists	£1000	Rotherhithe Peninsula Fun Rides. A series of 10 Saturday and Sunday guided family rides around the paths, parks, riverside and other attractions in the Rotherhithe Peninsula
Hawkstone T/RA Association	£1000 (1,500)	For a St Georges Day fete outside on the estate. With everything free and fully insured.

Tideway Sailability	£1000 Contribution (15,000)	To celebrate 25 th anniversary with increased training and membership and special events. Also the PCT outreach team will be there in order to invite local disabled people into sailing.
Canada Estate TRA	£700	Youth Music Technology workshops on the Estate Hall. Work with {Police and local residents to organise a series of workshops to teach local youths to play instruments and record. We need this audio workstation to help us deliver this. Youths will have ownership of project and would one activity that they look forward to.
Ilderton School	£800	Family Learning Activity Trips Project; To take parents and their children to participate in weekend day trips. Fun and educational visits that they may not otherwise have chance to engage with for socio-economic reasons Encourage to make new friends and enhance community cohesion and local support networks. We will use three minibuses which are currently jointly owned by a consortium of Southwark primary schools.
Friends of Russia Wood Docklands	£1000 (1250)	To replant three trees of heaven threatened with destruction in the playground of Alfred Salter Junior School. They will be expertly uprooted by specialists and re-planted two hundred metres away on the open green in Russia Dock woodland. The trees have historical importance and were planted when the school was built.
Parents' Support Services . Old Jamaica Road SE16	£800	To provide information and give support to parents/ carers and their children, who are experiencing exclusion and are under-achieving in schools. Training volunteers to support parents.
