BACKGROUND INFORMATION

In accordance with council assembly procedure rule 3.9 member's question time shall not exceed 45 minutes. During this time, members may not question any one executive member or committee chair for longer than fifteen minutes.

Members are limited to one question at each meeting.

Questions will be taken in the following order: the leader and the deputy leader and executive member for housing management, followed by the remaining executive members. The borough solicitor will rotate the order in which the different political groups ask questions of the leader and deputy leader (CAPR 3.9(10) & (11)). Questions to executive members other than the leader and deputy leader will be rotated according to member's respective portfolios.

Executive members and committee chairs have discretion to refer a question to another executive member if this is appropriate.

Responses to member's questions will be circulated on yellow paper around the council chamber on the evening of the meeting.

The Mayor will ask the member asking the question if they wish to ask one supplemental question to the member to whom the question was asked. The supplemental question must arise directly out of the original question or the reply. Therefore, supplemental questions to the leader or other executive members are not free ranging.

No question shall be asked on a matter concerning a planning or licensing application.

Note: In accordance with council assembly procedure rule 3.9(10) & (11) (prioritisation and rotation by the political groups) the order in which questions appear in this report may not necessarily be the order in which they are considered at the meeting.

1. QUESTION TO THE MAYOR FROM COUNCILLOR MARTIN SEATON

Can you confirm on what date you first went on record apologising for your remarks about black school children as executive member for education and do you consider this consistent with having apologised "immediately"?

2. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR JELIL LADIPO

Does the leader believe that making an unfortunate public comment, for which an apology is given, should bar a person from holding high public office in the future?

3. QUESTION TO THE LEADER OF THE COUNCIL FROM COUNCILLOR FIONA COLLEY

Is the leader satisfied that, with the exception of the Nunhead Green community centre, all other council owned community halls and centres are safe for the public to use, and can he confirm when the executive will take a decision on the community halls review?

I would like to thank the executive member for housing for his response to my question on the March 28 2007

Contained within that response you stated that the council used compulsory purchase orders (CPO's) against landlords in the private sector to ensure that these homes are brought back into use. Could Councillor Kim Humphreys please say how many CPO's have been used against landlords in the private sector since he became deputy leader and executive member for housing management. He has stated that as at April 2006 there were approx 2790 of which 496 were empty for more that 6 months. Are there more up to date figures?

11. QUESTION TO THE DEPUTY LEADER AND EXECUTIVE MEMBER FOR HOUSING MANAGEMENT FROM COUNCILLOR DOMINIC THORNCROFT

- 2. The cost of amending or covering up the signs, as outlined in the statement; and.
- 3. The estimated cost of any moves to uncover or amend again these signs?
