<b>Members' interests and dispensations</b>	Cllr Flannery – personal but non-prejudicial interest in traffic management decisions (friends live nearby) Cllr Capstick – personal but non-prejudicial interest – lives nearby Cllr Bassom clarified that being a blue badge holder did not prejudice her

Public questions raised	
<b>Comment</b>	Cllr Flannery wished to congratulate London on the success of the Olympic bid
<b>Q1</b>	Do Cllrs Bassom and Kyriacou consider Malborough Grove Community Garden a valuable asset to the borough?
<b>A1</b>	Cllr Bassom: Not seen garden or plans for it. Would encourage full and meaningful consultation with residents however. Cllr Kyriacou: Been there; personally opposed to green space being built on. Will push for consultation.
<b>Q2</b>	Perturbed by the state of the roads. Are qualified people monitoring them? Also, would like better qualified people to lay the pavements and roads.
<b>A2</b>	(Kendal MacKay) Some roads owned by Transport for London (TfL). Every year the Council puts forward their Borough Spending Plan (BSP) bid to TfL. Between now and 2007 the Council will be putting together a roads improvement programme. There are many competing priorities and a limited budget. The strategy is to enable the Council to forward plan, which is something not done currently.
<b>Q3</b>	Could some sort of facility be placed at Southwark Park for the over 10 year olds?
<b>A3</b>	(Cllr Flannery) Often TAs do not want these facilities when consulted. Funding was secured for a sports cage between Marden and Layard squares; tried to get a skate park at the end of St James' Road but residents did not want it, despite the money having been secured. Local school playgrounds are also being opened up for local children to use. This is not just a problem for Riverside ward; it is a borough-wide problem and a borough-wide solution is being worked on. Dulwich Park was a success; skate parks are expensive though...around 250K.
