5	<b>AGREED:</b> That the minutes of September 7 2005 (General) and August 31 2005 (Planning) are true and accurate recordings of those

<b>Members' Decisions</b>	<b>AGREED:</b> To re-appoint Mrs J Sterry as school governor to Kintore Way Nursery School and to defer any decision on the appointment of Ms I Lynch to Alma Primary School pending her attendance at the next governor meeting in the autumn.
<b>Members' Decisions</b>	<b>AGREED:</b> The release of funds totalling £265,000 from the Legal Agreement [number 41149 (File 87)] associated with London Bridge Holdings Ltd (More London Development), Tooley Street as a capital contribution to the cost of refurbishing the Crucifix Lane complex as part of the strategic Light at the End of the Tunnel programme for the regeneration of the viaduct which stretches across London South Central.
<b>Members' Decisions</b>	<b>AGREED:</b> The traffic schemes (waiting restrictions and disabled parking bays) in Leathermarket Street, Spa Road and Anchor Street as detailed in the agenda.
<b>4a</b>	<b>ACTION:</b> To report back at the next meeting on whether the gates at Spa Park will be locked at night. Also, to find out if the plans were altered, as there appears to be three more sets of gates than planned and the fence is lower than expected.
<b>4a</b>	<b>ACTION:</b> To report back on whether the medical building at Site A will be ready before the rest of the site is complete in 2007.
<b>8</b>	<b>ACTION:</b> To follow up the possibility of relaying services via an audio link to the Astley Cooper TA Hall for surplus worshippers of the Old Kent Road mosque; this would be to alleviate tensions between residents and worshippers and in consideration of both parties comfort and rights. Also to consider that the start of Ramadan this week is likely to mean a further influx of worshippers.
<b>11</b>	<b>ACTION:</b> To follow up reports that cars are being repaired on pavements in Blue Anchor Lane. (Illegal and requires enforcement action)
<b>11</b>	<b>ACTION:</b> To ask the Transport group to look at how feasible it would be to turn Blue Anchor Lane into a one-way street; residents say it is regularly congested with traffic and accidents are likely to happen if they have not already.
