#### £377,000 to help make Bermondsey better

Fifteen projects, designed to make Bermondsey cleaner, greener and safer, were given the funding go-ahead at this meeting.

The largest cash injection of £56k went to Swanmead football pitch to bring about much needed playground improvements. Setchell Estate, Paterson Park and Whites Ground were granted a combined £105k to also bring youth amenities up to scratch.

Money was given to schemes designed to kick-out crime and anti-social behaviour, such as new lighting for Leather Market Gardens and Hamilton Square, gates for Oxley Close to keep out scooters and CCTV for New Place Jamaica Road.

The benefits of public art to enhancing the area was recognised with £30,000 towards a mural in Tooley Street and an additional £25,000 to the Blue Market Art project.

Also, £15k went the Motor Project@Bermondsey, £15k for hanging flower baskets and £3,000 for an estate map for Stephenson Crescent Estate.

#### **Bermondsey Spa update**

Spa Park is one of the first sites to undergo transformation in the Bermondsey Spa regeneration programme. Work on this site is expected to finish on time in December 2005, when residents can expect a peaceful oasis plus much needed facilities for young people. The Park will remain closed to the public until the redevelopment is complete.

Hyde Housing Association has now received full planning permission for work to site E next to Old Jamaica Road. Work will start in September and the development includes 101 new homes and a GP surgery for eight doctors.

## **Community safety update**

Drop in surgeries are to be held at Blue Beat office on Market Square. Details are being finalised but two sessions a week are planned.

Following a police operation in May, the number of robberies committed by people on push bikes has reduced significantly.

Residents were concerned about anti-social behaviour and intimidation caused by youths on the Four Squares Estate and called for more action. Members recognised concerns and promised concerted efforts to alleviate problems. Here are some measures.

The neighbourhood housing office is establishing estate officers who will have a high profile presence and powers to issue fixed penalty notices for anti-social behaviour. Anti-social behaviour information leaflets will be distributed to all households.

The December 19 Bermondsey CC meeting will move to early autumn with a focus on tackling crime and anti-social behaviour.

New security door entry systems will be installed in Four Squares – Lockwood Square and New Place in October and November, with Marden and Layard Square to follow.

#### Southwark on the move

The council is currently producing its five-year transport plan for Southwark - also known as the 'Local Implementation Plan'. The plan will set out a package of transport improvements from 2005 until 2010 and will incorporate both council priorities and the Mayor of London's plans for transport. The plan will include road safety, walking, cycling, parking, school travel, environmental concerns and an assessment of equality issues.

A strategy and questionnaire will be produced in July 2005 for public consultation throughout the summer. The council and the Mayor will approve the final plan in the autumn influenced by your views and contributions.

#### A new academy for Bermondsey

A new city academy school to replace Geoffrey Chaucer Technology College and Joseph Lancaster Primary School has been proposed for Bermondsey.

The plans mean that the existing two schools would close on August 31 2008 with the new academy opening on September 1 2008. All pupils in these schools would transfer to the new academy.

All city academies are required to have a specialism and this one will focus on music, performing arts and technology – building on the expertise of Geoffrey Chaucer Technology College.

Public comments received during consultation in July will be reported to Southwark Council's executive this autumn. If the council gives the go ahead they will publish notices about proposed closures and there will be a six-week period this autumn for formal comments. The final decision rests with the Department for Education and Skills. If the new academy is not granted, the existing schools will not close.

### Beating the blue badge burglars

A scheme has been put in place to stop cars with disabled blue badges being broken into overnight and the badges stolen.

Blue badge holders with parking bays outside their homes were given overnight passes, invalid during daytime hours, so deterring would-be badge thieves.

Latest developments: the council agreed a new scheme for blue badge holders on July 14. Blue badge holders will be given a permit containing their vehicle registration number. With the permit useless to anyone other than the car owner, thieves should be given the boot once and for all.

Details of the new scheme will be sent to all blue badge holders in the next few weeks.
