Making 21st century Peckham work for you: Peckham Area Action Plan

Area Action Plans exist to provide a planning framework for areas that require significant change. The central area of Peckham is identified as an action area in the draft Southwark Plan (Unitary Development Plan) and planning policy officers are inviting the community to put forward their views on how Peckham can change for the better. Decisions about the final route of the proposed Cross River Tram will obviously have an effect on the planning of the area and will need to be integrated with the regeneration strategy as a whole.

Your voice: John Gorsuch, street leader

"Being a street leader is satisfying and worthwhile and I believe they've helped make my area cleaner, greener and safer," said John Gorsuch, a street leader in Nunhead and Peckham Rye, speaking at the community council.

Street leaders are ordinary people who volunteer to keep an eye on the neighbourhood. They report problems like flytipping, graffiti, abandoned cars, damaged trees and dog mess to the council using a freephone number and digital camera.

They receive a monthly progress report, a quarterly newsletter and are invited to street leader conferences.

John says his calls have always been dealt with efficiently and he's been encouraged by the changes he and his colleagues have made to their community over the years.



"If you are the type of person who cares about your environment, then save your phone bill, become a street leader and report these concerns to make your local environment a better place for everyone," said John.

More than 300 adults and 150 schoolchildren have signed up as street leaders.

St Mary's Road Conservation area

St Mary's Road has been designated a conservation area by Southwark Council because of its landmark buildings and open spaces. This means that buildings cannot be demolished or significantly changed.

Residents at the community council were unhappy about this because facilities such as St Mary's church do not meet the needs of a 21st century community. Reverend Olu Adams said: "It is good to cherish the past, but we shouldn't forget about the future."

The community council noted a formal objection to the scheme.

Parking needed to boost local trade

Local traders are unhappy about parking provision on Evelina Road, saying it is detrimental to business.

Ophelia Bellio, local trader, expressed the need for a balanced approach to town planning and parking – restricting car use to lower pollution on one hand, and on the other, providing suitable parking to support local businesses and their customers.

"Shoppers need to be encouraged to shop locally and the council can help with this by suspending parking restrictions and monitoring the effects and producing an action plan for the area, which includes parking and other modes of transport," she said.







'Southwark 2016' is an ambitious 10-year master plan which sets out the borough's hopes and vision for the future, and what needs to happen to achieve them. It guides the work of the council and all the other statutory agencies in the borough such as the PCT and police as well as the voluntary, faith, business sectors and partnerships.

A draft plan has just been published following more than 40 meetings during the spring and summer of this year with community groups, pensioners, business groups, public authorities and community councils.

The latest on the Peckham controlled parking zone (CPZ)

In response to residents' concerns over the Peckham CPZ, there has been an: introduction of resident, visitor and business permits; removal of the voucher parking system; introduction of pay and display meters and shared use parking in appropriate locations; permit discounts for motorcycles and gas/electric vehicles; installation of disabled bays.

Council officers Tim Walker and Nicky Costin also responded to the points raised in the community council resolution of September 20 2005:

Support short-stay free parking for Bellenden Road shopping parade (enforced by CCTV/traffic wardens)

- Install two parking bays outside Bellenden Road shops.
- Short stay parking bays with 30 minutes free parking.
- Vehicle owners not returning within two hours face enforcement carried out by parking attendants. CCTV not possible.

If Wingfield Street residents are against permit parking in their street they should be removed from existing CPZ

- Remove Wingfield Street from CPZ; remove eligibility to purchase resident permit.
- Reduce single yellow lines where safe and practical and sign any remaining yellow lines.
- Introduce double yellow lines at corners to provide clear junctions.
- Change designation of other uncontrolled bays within the CPZ.

Noted range of views expressed by residents from section of Chadwick Road to west of Bellenden Road and believe further consultation needed on options for this section of road

Initial questionnaire showed majority support for CPZ extension.
 Proposal drawings and letters sent out in September; responses indicated majority in the street against the CPZ. CPZ will not be extended into Chadwick Road.

Asked for justification of increased price of residents permits and hourly parking rates

- Annual resident parking permit, in 'B' CPZ, held at £76 since 2003. £84
 reflective of cost of administration and enforcement. 60p/hour
 vouchers in operation in Peckham for 12 years with no increase to
 reflect actual costs.
- Decided that annual resident permits will cost £84; pay and display meters will be £1.20/hour and off-street car parks to remain at 60p/hour.

Seeks urgent clarity on the decision maker regarding the CPZ, given that councillors have previously made such decisions

Under terms of council constitution, the decision maker is the Strategic Director for Environment and Leisure. After much discussion councillors drew together the communities concerns into a formalised resolution.

Statutory consultation on the report will take place between January 12 2006 and February 10 2006. All representations must be received by November 22 2005.
