The meeting opened at 7.05pm.

6. **Confirmation of minutes from the last main meeting**

RESOLVED: That the minutes of the meeting held on December 15 2008 be agreed, with the addition of Councillor Bates' name to the list of apologies.

7. **Deputations:** There were none.

8. **Police & Wardens:**

Sergeant Julia Croft (from Newington Safer Neighbourhood Team (SNT):

East Walworth Ward – Ward Panel priorities were anti-social behaviour in Augustus Court, Innis House, Barlow and Congreve estates. The SNT conducted a survey with the Council of public perceptions of safety in Burgess Park, and the main issue was lighting; the SNT have subsequently visited the park with the Crime Prevention Officer. The SNT has worked with the Council on Barlow and Congreve estates and conducted weapon sweeps. The communal area at Innis House was cleared by a Community Payback team for the community to use again. The SNT visited Victory House Church to talk to the youth club, which included a question & answer session; this was followed by a talk to the congregation about vehicle crime.

Faraday Ward – Ward Panel Priorities were youth anti-social behaviour in Portland Street. The Diamond Team and the Community Wardens will work to rehabilitate convicted offenders. The SNT will join a Burgess Park Youth Community meetings to conduct a mapping session to improve the park. There will be a Crime Surgery at Inspire on Monday 16 February at noon in InSpire, between 11am and 1pm. Steve Brown will be taking over the team from Mark Stevens.

Newington Ward - Ward Panel priorities include drug misuse and anti-social behaviour in Pullens Buildings, anti-social behaviour in Delaune Street and speeding in 20mph zones. The next Ward Panel will be on March 25 2009 at 7pm in Walworth Police Station.

Meetings have been held with the community around Eagles Yard and Castle Resource Centre. The mobile police station has been parked in Lorrimore Square.

A mobile police station will visit Kennington Park Place on Saturdays between 12 noon and 3pm; Stopford Road on Sundays between 11am and 1pm, and; Hillingdon Street on Sundays between 1:30pm and 3:30pm.

9. Community input to the Southwark's Local Safeguarding Children Board (LSCB)

The local LSCB was set up as required by the 2004 Children Act and additional statutory guidance in 2006; it is a partnership body with strategic responsibility for ensuring arrangements are in place to protect children. Already members of the LSCB are from the Council's Children's Services, the Primary Care Trust, hospitals, the police, the Probation Service, the Courts Service, Community Safety, Housing, and from schools and voluntary organisations, but there is a need to develop a stronger relationship with the community.

The LSCB agrees child protection procedures and monitors their use, and ensures that professionals and volunteers in child protection receive effective training, it reviews cases where a child dies; both when child protection issues are involved and all children. The Board also oversees private fostering, trafficking of children and comments on licensing applications. Finally, the Board communicates with the public about child protection.

In the light of the tragic events in Haringey, there has been increased scrutiny of the Board's work, and a loss of confidence in child protection services. The Government has charged Lord Laming with a review of the Boards nationwide, together with the Third National Joint Inspectors' report on Safeguarding Children.

Work is being carried out in Southwark to strengthen the Board, ensures its independence from member agencies, thus allowing all participating agencies to be held to account. In the Joint Area Review in 2008, the Board was judged as 'good', together with the work of agencies safeguarding children. More inter-agency work will be carried out to ensure the quality of frontline work with children & families.

Now, as one of the priorities for the 2009-10 Municipal Year, officers are looking for ways of involving the community and young people more in the work of the Board.

A number of questions and comments were made:

- Mr Beedell asked if Southwark was understaffed like Haringey? Malcolm Ward responded that staffing levels are always a worry, but Southwark employs the maximum number of staff permitted by the staffing budget. There is a shortage of suitably qualified and experienced social workers in the child protection field. No staff have been seconded to Haringey.
- A resident said that the Haringey 'At Risk' register had not been passed on to hospitals, has Southwark's register? Malcolm said that it had not, but there was a 24 hour phone number for concerned professionals to ring to access necessary information from the register.
- Mr Yureten asked what the criterion was for taking children into care: Malcolm responded that this was laid down in the Children Act 1989; the threshold is where the child was in danger of significant physical or emotional harm.
- Mr Yureten asked how children from muslim families were fostered or looked after whilst in care: Malcolm said that social workers were required to respect children's faiths, and children would be fostered in environments where their religious needs can be met.
- Mr Yureten asked if foster parents were checked; Malcolm responded that foster carers were checked rigorously. Standards are slightly lower when family members foster a child.

- Mr Yureten asked why Southwark did not train its own social workers; Malcolm responded that the Council could not afford to provide a 3 year full-time course, or 2 year post-graduate course, but sometimes officers train part time. Some staff come from abroad, but they have equivalent qualifications.
- A resident asked if the Licensing Committee took any notice of comments from the LSCB; Malcolm said that as far as he knew, the Committee took notice of saturation or proximity to schools.
- Councillor Seaton said that the last meeting of the Community Council was a youth focused meeting, and it had been very dynamic, Members should be looking to start a Youth Community Council. Has the Board got to involve local communities or could representatives be elected by local Tenants & Residents Associations? Malcolm said that the community representatives would not sit on the Board itself, but on a Sub-Group which would scrutinise the work of the Board, and themselves appoint 3 members of the Board. At present, there are 3 voluntary organisation representatives.
- Mr Yureten suggested that Malcolm invite the Multi-Faith Forum to get involved; Malcolm said they had been invited.

10. Section 106 & Project banks

Community Project Banks can include projects for streetscape improvements, park improvements and play facilities. Funding comes from developers, who make Section 106 agreements with the council, to fund or provide projects to ameliorate loss of amenity caused by their developments.

A number of comments and questions were raised:

- Mr Beedell asked what happens when an amenity is lost due to a development; for example, a children's playground taken for housing. The Chair said that Section 106 funding was to mitigate problems created by developments, and the community needs to decide what needs to be done. Councillor Pidgeon said that Section 106 agreements would fund playgrounds. A resident said that the projects that people in the community had asked for should all be included in the project bank.
- Councillor Bates asked about Section 106 funding for the Largactyl Shuffle; he was informed that this was a trail from the Maudsley Hospital to the river, with sculptures etc marking different sections of the route. The Chair asked if the works had already been commissioned, but it was explained that the Project Bank contents were just ideas that were awaiting funding.
- The Chair asked if the Project Bank was closed. Jillian Houghton informed him that this is a trial, to establish the process and then tweak it to ensure efficiency. Most Community Council areas were still in the trial process. When all areas have been through the process, it is intended to accept new ideas.
- The Chair asked if proximity was the priority in selecting projects for Section 106 funding. Jillian told him that this was so, with some exceptions including education, which can be used in adjacent community council areas.
- A resident asked if the process was closed, and if projects could be reconsidered. Jillian said that there would be logistical reasons why this could not happen and that ideas were not listed if they did not meet the project bank criteria or could not legally be funded through Section 106 such as maintenance.
- A resident asked if the entire Section 106 monies from developments within Walworth were ring-fenced to Walworth. Jillian said that this was true, except that projects might include the opposite side of the road from the Walworth boundary.
- A resident asked what percentage of funding per project was coming from Section 106. Jillian said that this is not yet determined and depends on development in proximity to the project idea. - Councillor Bates expressed his concern that Members had not been given enough details, and that Members had not been sufficiently included, prior to being asked to approve the projects listed for the bank. Councillor Pidgeon said that Members had been emailed twice.

Resolved: That Members approve the projects listed in the appendix to these minutes.

11. Cleaner Greener Safer 2009-10

The Cleaner Greener Safer scheme has now been running for six years, and a total of £2,036,143 has been awarded to Walworth to create environmental improvements based on projects proposed by residents. The total actually spent in Walworth is £1,348,907, which is 66% of the money awarded.

A list of projects in progress and completed is listed in Appendix 2.

The form for the forthcoming scheme is larger than past years, but there is plenty of guidance for applicants, and there are workshops run for applicants. Residents should note that no forms will be accepted after the closing date of March 16 2009.

Design works for the scheme give a unified appearance and approach to traffic management on this busy high road. On that basis it is not felt appropriate to give individual treatments to various junctions. Additionally, wooden planters require ongoing maintenance which Southwark is currently unable to adopt. <i>A possible approach for the applicant is to apply to Cleaner Greener Safer for hanging baskets along the Walworth Road to green the streetscape.</i>	1
